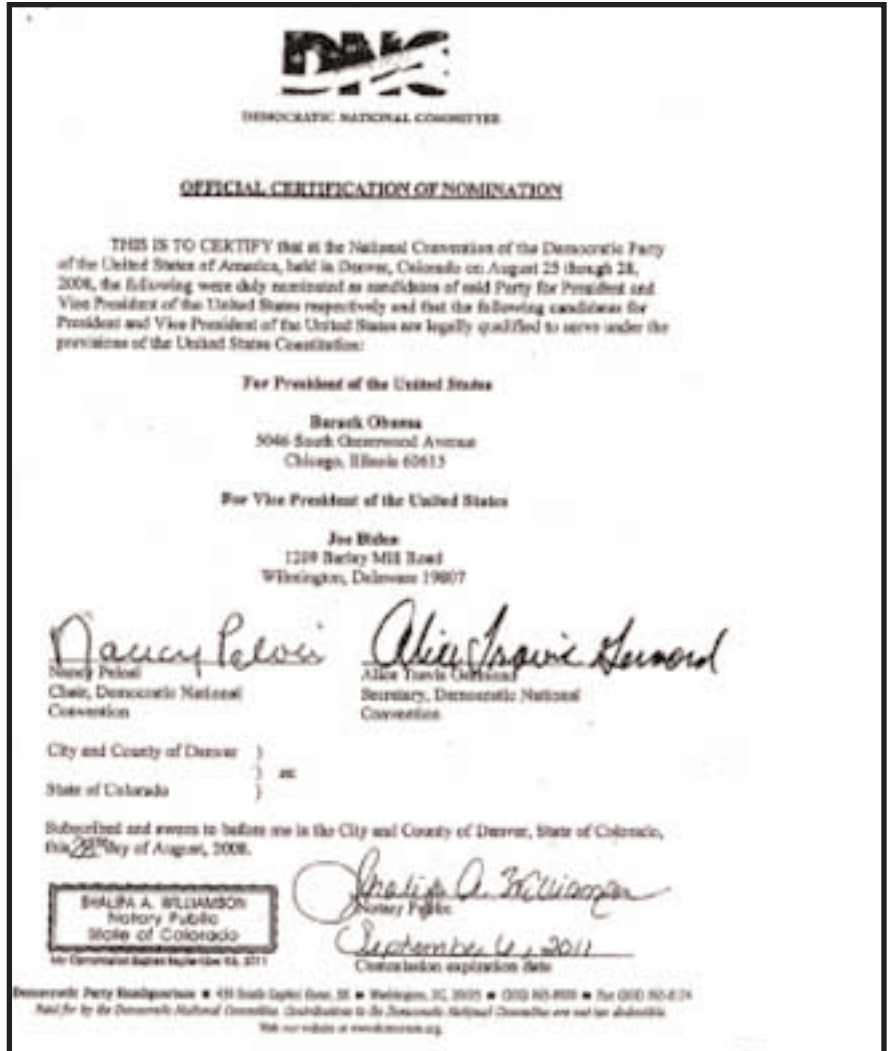
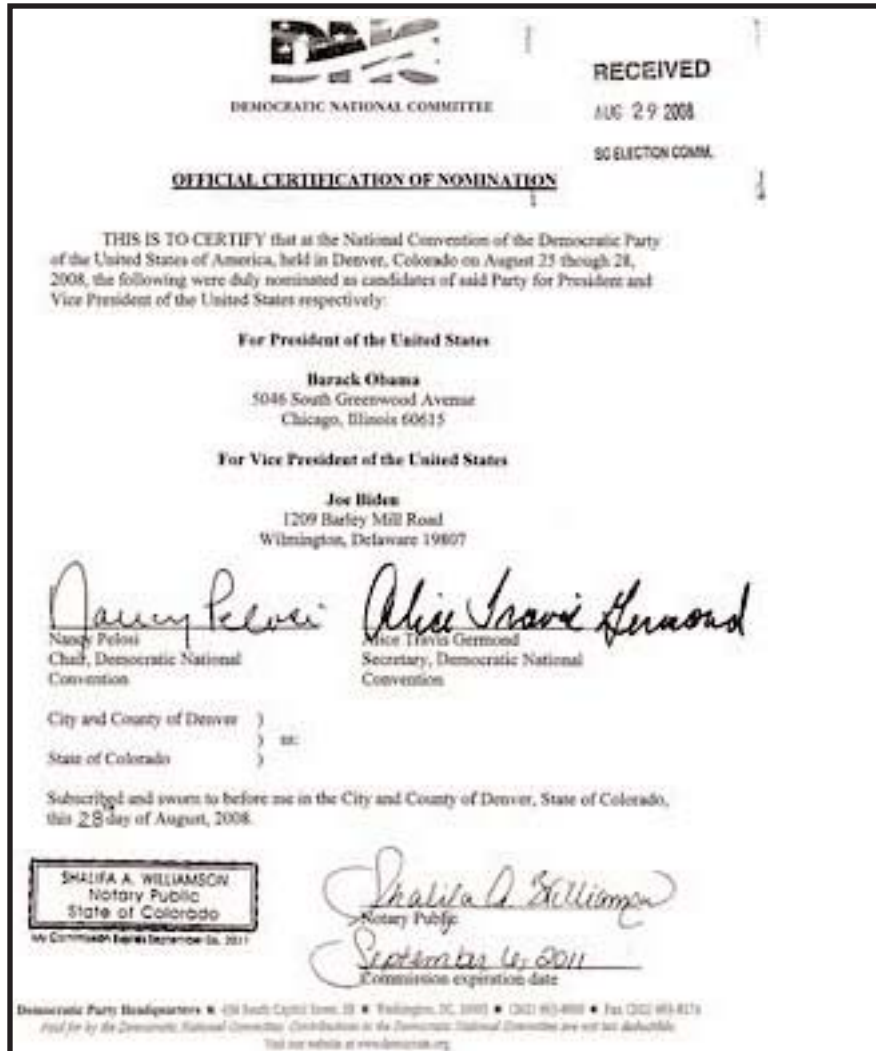

Election Fraud by Obama, Pelosi, Biden, et al



The MAN obtained copies of two documents [above] apparently prepared by Democrats to certify Barack Obama as their nominee for president in 2008 that suggest House Speaker Nancy Pelosi and the DNC knew there was an unresolved issue with his eligibility under the U.S. Constitution.

The first [on the right side] includes a verification that Obama and Joe Biden, then-candidate for vice president, "are legally qualified to serve under the provisions of the United States Constitution." This one was for the Hawaii election office.

The second form appears identical, down to a typographical error in "through." But the verification of eligibility under the requirements of the U.S. Constitution is gone. That form went to all 49 other states.

The DNC drafted, signed and notarized these TWO slightly different versions of their Official Certification of Nomination documents. "One of those documents had complete legal language, and one of them was missing the text concerning the constitutional eligibility of Barack Hussein Obama [aka Barry Soetoro]."

The version which is absent any certification of constitutional standing for the office of president is the version that was filed with every state in the country except Hawaii, and the one used by the DNC to elect Barack Obama president.

Democratic National Committee spokesperson said they were aware of the two different versions, but declined to elaborate. House Speaker Nancy Pelosi, who signed both documents, has not commented; same for Obama at the White House. Do they think that only Hawaii insists that the President of the United States be qualified Constitutionally as a Natural Born American Citizen to hold the Office of President of the United States? The other 49 states don't care?

"The fact that TWO DNC Certifications exist, both signed, dated and notarized by the same individuals on the same day, means that a very real conspiracy to commit election fraud was under way, and since it took until six months after the election to uncover it, the conspiracy was indeed successful," wrote Williams, who was the first to acquire copies of the official documents. "Are you still wondering why Barack Obama has spent nearly \$1.5 million in taxpayer's funds to race Department of Justice attorneys around the country to stop all cases questioning Obama's eligibility before discovery can force Obama to open up his top secret life?"

Williams described the discovery of these documents as "actually very serious business. "We are talking about the top-down leadership of the ruling political party knowingly and wantonly defrauding voters by way of playing monkey business with fraudulent election documents."

They were signed by Pelosi as chair of the Democratic National Convention as well as Alice Travis Germond, the secretary of the Democratic National Convention at its nominating meetings in Denver a year ago.

The Constitution for the United States of America, Article 2, Section 1, states, "No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President."

The 1787 signers of the Constitution understood "natural born Citizen" as it was described in the 1758 book: The Law of Nations, or Principles of The Law of Nature applied to the conduct and affairs of Nations and Sovereigns, Book 1, Sections 212 and 215: § 212. Citizens and natives.... natural-born citizens, are those born in the country, of parents who are citizens. ... children naturally follow the condition of their fathers, and succeed to all their rights. ... The country of the fathers is therefore that of the children ... in order to be of the country, it is necessary that a person be born of a father who is a citizen; for, if he is born there of a foreigner, it will be only the place of his birth, and not his country.

We The People are seeking Quo Warranto to be issued in the name of the United States of America against a person who within the District of Columbia usurps, intrudes into, or unlawfully holds or exercises, a franchise conferred by the United States or a public office of the United States, civil or military". Prosecuting the Prosecutors is Justice!

MolokaiIssue: Whether a prosecutor may be subjected to a civil trial and potential damages for a wrongful conviction and incarceration where the prosecutor allegedly violated a criminal defendant's "substantive due process" rights by procuring false testimony during the criminal investigation, and then introduced that same testimony against the criminal defendant at trial.

Two men wrongly imprisoned for 25 years filed a lawsuit against prosecutors for fabricating evidence against them. The issue before the US Supreme Court of Appeals is this: Do Americans who have been framed by unscrupulous prosecutors for crimes they did not commit have a right to sue the prosecutors when the fraud is finally exposed?

According to the Obama administration, the answer is no. He says that local, state, and federal prosecutors must enjoy absolute immunity from citizen lawsuits ^ even when they sent innocent men to prison for life by fabricating incriminating evidence and hiding exculpatory evidence.

In this case, prosecutors in Iowa, solicited false testimony implicating two innocent teens in the murder of a recently retired police officer in 1977. At trial, the false testimony led to their convictions. They were sent to prison for life.

see Pottawattamie County, Iowa, v. McGhee and Harrington.

If I told you via email how I would like to respond to prosecutors like those in this case who frame innocent people with perjured evidence that they created, the Thought Police would surely visit me very very soon. However I wholly agree with the opinions stated below:

Prosecutors who actively participate in the pre-trial investigation of a case must be held to the same standard as police officers, detectives, and agents, who can be sued if they violate clearly-established constitutional rights.

"When law enforcement officers fabricate evidence with an intent to use it to deprive innocent citizens of their liberty, they violate the Constitution," writes Paul Clement, who is arguing the case for McGhee and Harrington.

"Absolute immunity does not apply to prosecutors' actions taken outside the advocacy functions." Respondent McGhee added that relief should be available under Section 1983 in cases such as this one to deter prosecutorial misconduct: otherwise, "prosecutors would be free to fabricate evidence during criminal investigations because they would know there was virtually no possibility of ever being punished, violating Defendant's substantive due process rights with impunity.

But, in 1976, the Supreme Court held in Imbler v. Pachtman that prosecutors have absolute immunity from liability for their official actions DURING trial. Thus, prosecutors enjoy immunity when they knowingly introduce false testimony during trial. However, prosecutor's actions that are taken BEFORE trial but are directly connected to the trial are another question, because, procuring testimony is not conduct that occurs in the course of the prosecutor's role as advocate.

In their brief on the merits, the prosecutors claim that fabrication of false testimony cannot violate the Constitution until the perjury is presented at trial and is instrumental in securing a conviction.

And that is just what happened in State of Hawaii vs George Peabody, so Maui Prosecutors and dog catcher Mark Marting, and Lt. Ribao/MPD can be sued.

Water Is SCARCE; Basis for WAR !

For most Americans, water is less expensive each month than cable television or having a cell phone. And yet the World Bank reports that 80 countries now have water shortages that threaten health and economies while 40 percent of the world — more than 2 billion people — have no access to clean water or sanitation.

Here are some other water facts ...

More than 1 billion people lack access to clean, drinkable water, according to The World Health Organization. About 5 million people die each year from poor drinking water and poor sanitation.

A prime cause of the global water concern is the ever-increasing world population. As populations grow, industrial, agricultural and individual water demands escalate. According to the World Bank, worldwide demand for water is doubling every 21 years.

Only 3% of all the water in the world is fresh water. However, of that 3%, two-thirds is locked up in icecaps and glaciers. In the end, we can only consume 1% of the world's water supply.

It takes 14 gallons of water to grow a pound of grain, 435 gallons to grow a pound of beef, 2,000 gallons of water to make one gallon of milk, nearly 20,000 gallons of water is needed to make one ton of steel.

In dry Northern China, the water table is dropping at over 3 feet per year. Some Chinese rivers are so polluted that they catch on fire. In India, water tables in some dry regions are also dropping very quickly.

And while you can substitute various alternate fuels for fossil fuels like crude oil, there is no substitute for water. This is a crisis that is spinning out of control around the world.

Don't be surprised if water is the next call for War.

And FOOD is becoming more scarce, too.

Right now, America has a surplus of food. The U.S. government predicted that record global production will boost inventories of corn and soybeans to a nine-year high in 2010. Global output in the year that ends May 31 will total 676.1 million metric tons, behind only last year's record 682.7 million, the U.S. Department of Agriculture said in a Jan. 12 report. Meanwhile, stockpiles of wheat are forecast to jump 19 percent to 195.6 million tons.

However, all we need are a few bad harvests to turn this around. That's what happened in the 1970s, when the world went from an abundance of food to large numbers of people starving.

The World Bank is already warning that some rice producing countries are facing shortages, and cereal prices could rise very quickly. Also, food prices tend to rise with fuel prices. [Molokai gasoline is at \$4.34 /gal now; and GMO, too]

Looking down the road, experts say that global food production will have to double to avoid a repeat of the food riots seen in 38 countries worldwide in 2008.

Our USA country has a lot of problems that need fixing. Too bad we're flat broke, and don't have money to tackle half the problems bearing down on us.

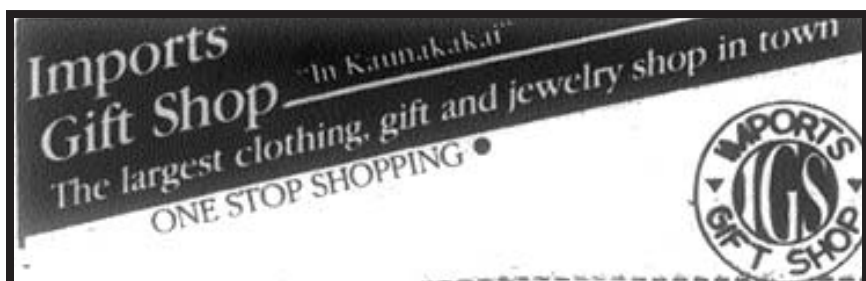
Some of America's debt numbers are quite stunning. The U.S. National Debt recently topped \$12.2 trillion. That's debt per citizen of \$39,854 and debt per taxpayer of \$112,648.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

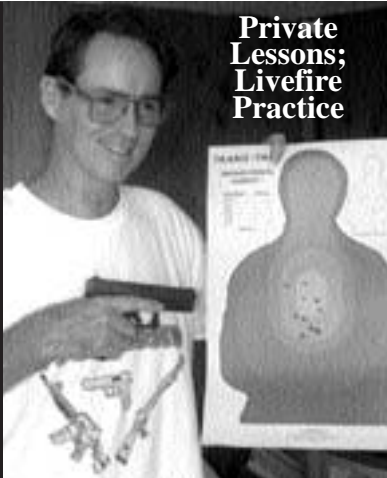

Year 2010: Who is Barack Obama or Barry Soetoro?



Three Unanswered Questions:

Was Barack Obama Born in Kenya?

Is He Really a Citizen of Indonesia?

Does the Constitution still Matter?

Electors are sworn to uphold it with their vote on December 15th in the Electoral College. But they must first know for sure that the candidates meet the Constitutional requirements for the office of President beginning with being a natural born citizen.

That's what Philip J. Berg has asked the United States Supreme Court to verify. The Supreme Court has asked for a response from Senator Barack Obama a long with the Democratic National Committee and Federal Elections Commission. And they have until December 1st to respond. Other cases have been filed asking for the same thing.

Not extreme. Not fringe. Just Constitutional.

Obama says he's qualified. But, Berg, multiple legal suits and a growing number of American citizens are saying: "Prove it." A basic, vital and Constitutional request.

Why won't Obama answer such a simple and essential request?

Exhibit A: The Grandmother's tape

Barack Obama's own grandmother said he was born in Kenya. While politicians are known for it, grandmothers seldom lie. It's recorded on tape:

"I was in the delivery room in [Mombasa,] Kenya, when he was born Aug. 4, 1961." – Sarah Obama, Obama's paternal grandmother

Exhibit B: No Original Birth Certificate

Experts have called the Certification of Live Birth posted online a forgery. Berg reported "It's clearly been altered," which invalidates it, according to the document itself. Add to this the Hawaiian law at the time which allowed people to register for this non-hospital short form certificate (without a doctor's signature) up to one year from the date of the child's birth.

Exhibit C: Indonesian citizenship

Only Indonesian citizens could attend Indonesian schools at the time Barack Obama attended the Indonesian school where he was registered as Barry Soetoro. His citizenship was listed as Indonesian, his religion as Islam, and his father as Lolo Soetoro, M.A. There was also no dual citizenship at the time. If he was adopted by his Indonesian stepfather, he would have forfeited any U.S. citizenship he may have had, just as when a child is adopted in America, he or she becomes an American.

Exhibit D: U.S. Law

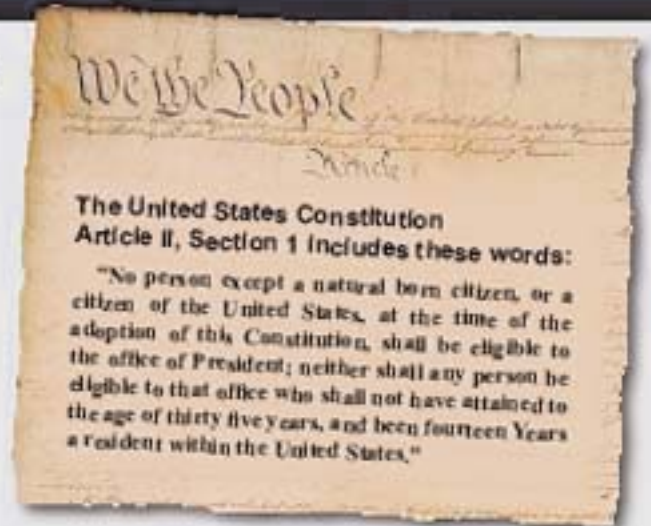
In addition, according to U.S. law pertaining to births abroad, from "Dec. 24, 1952, to Nov. 13, 1986," in order to register the child's birth as a U.S. natural-born citizen at the time of Obama's birth, he or she must be: 1. Born to two U.S. citizen parents; OR 2. If only one parent was a U.S. citizen at the time of the birth, that parent must have resided in the United States for at least 10 years, at least five of which must be after the age of 14.

Since Barack Obama's father was not a U.S. citizen and Obama's mother was only 18 at the time of his birth, she failed to meet the legal requirements of U.S. residency for at least five years after the age of 14.
