## Pu`u O Hoku Ranch Donates Development Rights

According to the Maui Coastal Land Trust (MCLT) Executive Director Dale Bonar last month, 2800 acres of East Molokai's Puu O Hoku Ranch will remain forever in open space and agriculture thanks to a conservation easement agreement between MCLT and ranch owner Lavinia Currier.

Why? Several honorable reasons are possible, but legally, a landowner who donates a conservation easement may be eligible for three federal tax benefits: a charitable income tax deduction under [I.R.C.] §170(h), a charitable gift tax deduction under [I.R.C.] §2522(d), and an exclusion of up to 40 percent of the value of the land subject to the easement from the landowner's estate for estate tax purposes under [I.R.C.]

Why not just write land covenants in their own land deeds instead of MCLT?

Dale Bonar said this: "Per the covenants question, its and issue of legal standing. When you put covenants on your lands it is only you (and your heirs) that have legal standing to enforce them. So if you sell the lands and a future owner goes against the covenants, neither the county, nor the neighbors can enforce against those violations... The federal and state regulations which permit Land Trusts to operate give them the specific legal standing to be a third party enforcer of those covenants....So our job as the land trust is to ensure that those covenants are ALWAYS obeyed and enforced, regardless of who owns the land."

What do you do when the lands are claimed by multiple parties, as in the case of Paul Kauka Naki who obtained a Judgment from the Supreme Court of Hawaii?

Dale Bonar's reply: The short answer is, we follow US law and title company guarantees of title. As far as the US legal system is concerned, the titles to Kainalu ranch are free and clear titles, and were insured by Title Guaranty.

We faced similar claims in our purchase of the Waihe'e Refuge lands here on Maui. Both Akahi Nui and the Sovereignty folks Mahealani Ventura Oliver works with have claimed title, although we have, according to US legal titles, clear title to all but six small Kuleana parcels. (Incidentally, the claims by Akahi Nui for all of Hawaii are refuted by the other sovereignty folks who do not recognize his claim as rightful King of Hawaii).

Since the "Supreme Court of the Hawaiian Islands" has no legal standing under US law, we cannot legally accept their claims, as we are incorporated under specific IRS tenets of US law and are required to follow US law. This does not mean we do not pay close attention to these issues, nor summarily reject any claim. Our policy on lands which have clouded titles (as determined by US Title Company research and US law) is to exclude them from any easements we do. On lands such as Waihe'e which we own, if any potential claimant for the clouded parcels comes forward we work them to perfect their claim, and if they do have a real claim, work them to either bring them into the conservation efforts, trade them for another more useful piece of land outside the conservation area, or purchase their interest.

Dale B. Bonar, Ph.D. has offered to discuss such issues in the future, and I presume he will exchange communications with any Molokai resident or land claimant on Molokai, so his contact info follows.

## Jacobs Medals At State Championships!



Adrian Jacobs, son of Mark and Ann Jacobs of Kalua Koi, blazed to a personal best time in his specialty event, the 100 Yard Breaststroke, at the recently completed Hawaii High School Athletic Association Local Motion Swimming and Diving Championships. The championships were held on February 22-23 at the Kihei Aquatics Center and the two-day event capped a great season for the Hawaii Preparatory Academy senior.

The trials for all of the events were held on Friday where Jacobs, seeded sixth in the event, blazed to a 1:01.07 clocking. The time earned him the second seed in the Saturday finals along side the state's top breaststroker for the past four years, Kekoa Tappara from Kamehameha Schools-Kapalama.

Jacobs and Tappara were locked in a tight battle from the start. Jacobs, a relative newcomer to tournament competition, managed to keep up with the much more experienced Tappara but the energy he expended eventually caught up with him in the second half of the race.

Tappara took a solid lead into the second fifty yards and despite a valiant effort to keep up, Jacobs tired from the frantic pace. His time in the finals was 1:01.18 while Tappara clocked a :57.66.

Tappara cruised to the gold medal and Jacobs managed to hang on for fifth place. In high school competition, only the top five of the eight swimmers in the finals earn medals and team points.

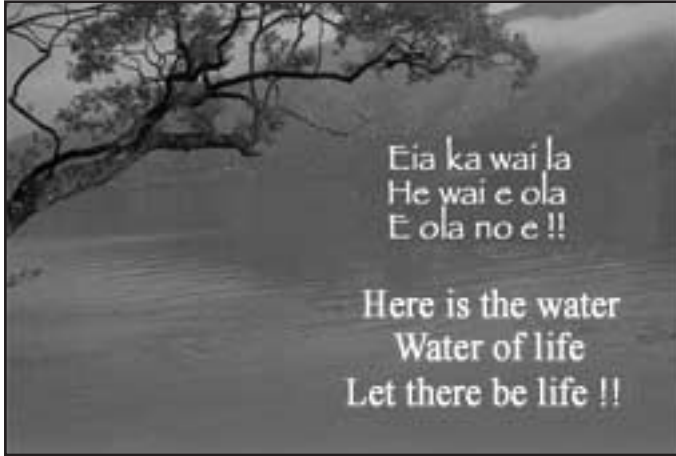
Jacobs also swam the breaststroke leg of the HPA 200 Yard Medley Relay team that placed second (8 team points) and the second leg of the 200 Yard Freestyle Relay team that placed fourth (4 team points.) All told, Jacobs had a hand in 13 of his team's 28 points. HPA placed third behind Punahou (73 points) and Kamehameha Schools-Kapalama (33 points).

Next up for Adrian is the long course season with age group championships coming up in June!

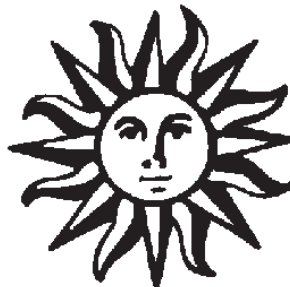

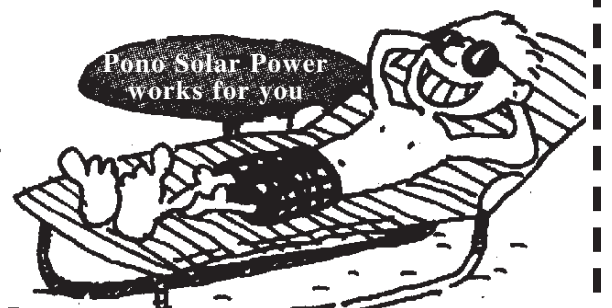

## U.S. Supreme Court-Fascists

By the end of the year we will know whether the nation's so called "Highest Court" will take upon itself the burden of considering -- for the first time in the Republic's history -- the constitutional meaning of the last ten words of the First Amendment, i.e., the People's Right to Petition the government for a Redress of Grievances?

These 9 inferior justices of the U.S. Supreme Court are also being asked to translate the 2nd Amendment right to keep and bear arms as being the a privilege and power of bureaucrats in the D.C. gun ban case of D.C. v. Heller, which argued that any gun ban -- no matter how sweeping -- could be constitutional if some court determines that it is "reasonable."

If the Supreme Court were to accept the Solicitor General's line of argument, D.C.'s categorical gun ban of virtually all self-defense firearms could well be found to be constitutional, even if attorneys in high offices acting as judges, say that the Second Amendment protects 'individual' rights."

The Solicitor General's suggestion that comprehensive gun bans are constitutional if some court determines they are "reasonable" was enthusiastically greeted by anti-gun zealots --Brady et al which praised Hawaii's anti gun rights laws, probably because it represents the lowest standard of constitutional review.

Thus, in contrast to other provisions in the Bill of Rights, which can only be trumped by 'compelling state interests,' the Second Amendment would be relegated to an inferior position at the lowest rung of the constitutional ladder, should the Justice Department prevail.

A national ban on all firearms -- including hunting rifles -- could be 'constitutional,' even if the Supreme Court decides -- on ample historical evidence -- that the Founders intended the Second Amendment as an individual right.

Rather than argue that 'shall not be infringed' is a categorical prohibition on government gun-banning, the administration has chosen to align itself with those who do not believe in self defense or civilian gun ownership.

I do not believe that the justices created by the Judiciary Act represent the ONE SUPREME COURT existing at the signing of the Constitution for the United States of America. If they are granted the jurisdiction to decide the meaning of the SUPREME LAW they will undoubtedly make themselves gods determining the fate of inferior beings.

How could anybody be happy about submitting the future of the republic to nine withered politicians purporting to sit as attorneys under the fantasy that they are the personification of the one supreme Court that existed before the Constitution for the united States of America was signed?

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

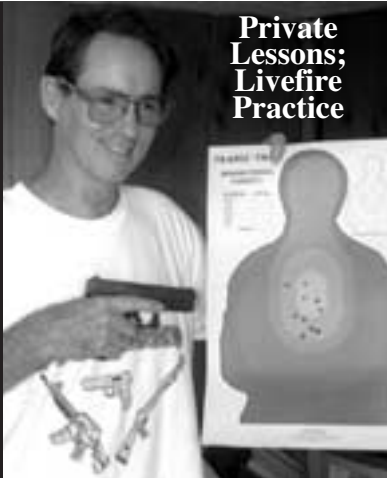

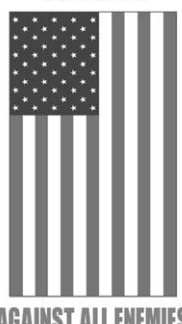

## NOTICE TO PROPERTY OWNERS COUNTY OF MAUI 2008 REAL PROPERTY ASSESSMENT NOTICES

Real property assessments for the County of Maui for the 2008 tax year have been compiled and are on file in the County assessor's office located at the County of Maui Service Center, Suite A16, 70 E. Kaahumanu Avenue, Kahului, Maui, Hawaii or at the Mitchell Pauole Center, Kaunakakai, Molokai, Hawaii. Property owners may visit the assessor's office to review the assessment of their property and to confer with the assessor prior to finalization of the assessment list.

A "Notice of Property Assessment" showing the taxable value of the land and improvements, if any, the amount of exemption allowed on the property and the classification assigned to the property will be mailed to property owners on or before March 15, 2008. If you do not receive a notice within ten days of this date, you should inquire at the assessor's office.

If you do not agree with the value placed on your property, or if you were not given an exemption to which you feel you were entitled, or if you do not agree with the classification assigned to your property, you may file an appeal with the Board of Taxation Review or the Tax Appeal Court. The deadline for filing appeals is Wednesday, April 9, 2008. All appeals must be accompanied by a deposit of the appeal cost. The cost for each appeal to the Board of Taxation Review is \$15.00. Appeal form and instructions are available from our office or on the website. For an appeal to the Tax Appeal Court, the cost is 5% of the taxes in dispute but not more than \$100.00 nor less than \$5.00. ## DRUG WAR SNITCHES are BAD

In Cleveland, Ohio, an informant for the DEA has been convicted of framing innocent people and getting them sent to prison. Informant Jerrell Bray staged drug deals with friends while investigators watched, but gave investigators the names of people not involved in the deals, then testified or gave sworn statements saying that the innocent people were the drug dealers. Bray managed to set up four people, including a woman who had refused to date him, while working under DEA agent Lee Lucas. It is unclear whether Lucas or other law enforcement personnel knew what Bray was up to, but a federal grand jury will meet next month to investigate obstruction of justice, perjury, and weapons charges against Bray "and others." Bray was sentenced to 15 years in prison on perjury and deprivation of civil rights charges, a sentence that will run concurrently with state time for shooting a man in a drug-related robbery. Ironically, Bray can gain a sentence cut on the federal time if he "cooperates fully."

## TSA CORRUPTION & the Drug War

In Atlanta, two Transportation Security Administration officers were indicted Tuesday on charges related to an alleged drug-smuggling operation at the Hartsfield-Jackson Atlanta International Airport.

TSA employees Jon Patton, 44, and Andre Mays, 24, and Delta employee Leslie Adgar, 42, are charged with conspiring to distribute narcotics and attempted distribution of cocaine and heroin.

They went down after they agreed to let a man smuggle two kilos of cocaine past security and onto a Delta flight to New York in exchange for \$8,000 in December. Unfortunately for the Atlanta trio, their smuggler was also a snitch for the DEA who set them up for two more runs, this time with fake cocaine and heroin. Charges carry a maximum sentence of life in prison and a fine of up to \$4-M.
