## Japan Tsunami Damage Is WakeUP Call for Hawaii

## Politicians -Bureaucrats Want Slaves

We can not be Sovereign People of our Constitutional Republic if we are dependent and beholden to politicians and bureaucrats. Are we Slaves?

How so? By showing how redundant and unneeded immense programs like TSA and FEMA and ATF and DEA etc are when the people already have the best possible working safeguard in place, i.e., armed sovereign responsible Citizens.

Of all people who understand this, officials understand them well, and know them so very well that they like to govern by dismantling those safeguards as a roadblock to what they are trying to do. They then introduce their own plans whether we like it or not.

How this impacts non-gun owner Americans is that corruption affects all Americans, the entire republic. Corruption would not take much root unless there first appears some sort of need or necessity. How this practice hurts America is by dislocating our liberty protections first and make it seem that conditions themselves are to blame and not political contrivance such as 9-11. Like punching holes in lifeboats just to create an apparent need for buckets to sell to the passengers.

The problem comes when corruption angers enough people, and the corrupt authorities feel the need to scuttle the entire ship just to get folks into their lifeboats. These government agents destroy a working safeguard of gun rights of and for the People, then try to substitute something that transfers wealth and power to themselves. Denial of this reality is our worst enemy at this hour.

The sad part is that too many Americans don't even notice and too many Americans are baffled as to how.

The key is not to remove guns for the sake of safer streets, but to remove gun control programs for the way back to smaller government. Safer streets will follow only after we have regained self-rule.

And the only way we're going to get these is by our insistence on integrity in public office, which, if rejected, calls for Armed REVOLT against Tyrants.

In fighting crime, there is no substitute for the armed citizen on the front line scene of the crime; there is no need for billions in costly programs to attempt that.

In America, assuming one is looking to us for a model, our freedom is a mainstream value, and it isn't guns that really holds on to it, except as a last resort. We are several steps from that and how? By dint of the fact that more college campuses, more states, more government organizations are affirming our second amendment on one realization: they think it is that the police cannot be everywhere, and that self-defense is a right. Well, these are both true, sure, but one thing more is being recognized: self-rule on the because-we-say-so platform.

Self-rule means that we say so, not servants, and when the servants begin to appreciate this and when they show they agree, you see the second amendment in action, its original action. Understand that what you are seeing is the counterpoint not of putting a gun to their heads, but of showing how costly and useless their political programs have been, bankrupting whole states and national treasury by silliness of ever substituting anything for the armed citizen.

Years ago, gun control proposed to make our streets safer, but did the opposite. It then became emboldened to take even more from us, and this is how we got where we are today: bankrupt. **Our slavery began with gun control.**

## ObamaCare's madness

ObamaCare's madness in its first year of implementation, which is why the American people continue to call for defunding, repealing and replacing it with more sensible reforms. Here are a few examples of the mayhem.

- More than half the states—28 and counting—are challenging the law in court, saying that it violates the constitutional rights of their citizens and the sovereignty of the states. A new study from the Senate Finance and House Energy and Commerce Committees found that as a result of ObamaCare, budget-strapped states face at least \$118 billion in unfunded mandates during the first 10 years after the law takes effect.

- Health and Human Services Secretary Kathleen Sebelius has handed out nearly 1,000 waivers to allow select companies, unions and states to escape, at least temporarily, some of the burdensome new insurance rules she has created. This is a continuation of the trend of the "Cornhusker Kickback" and the "Louisiana Purchase" that Senate Democrats used to get the law passed in the first place, and that so disgusted the American people.

- Independent experts have shown that the cost of health insurance will rise faster than it would have without the law. The Congressional Budget Office expects the price of a family policy in the individual market to be \$2,100 higher by 2016 than it would have been had the law not passed. In at least 20 states, it's now impossible to buy child-only health insurance because of Ms. Sebelius's onerous new rules.

- Seniors are at risk of losing access to physicians and medical care. Medicare actuaries say that the cuts built into the law will force as many as 40% of providers to eventually stop seeing Medicare patients or go bankrupt.

- Many thousands of people are already losing the health insurance they have now as companies are exiting markets for individual, small group and Medicare Advantage coverage.

- The former director of the Congressional Budget Office, Douglas Holtz-Eakin, says that the costs of ObamaCare are set to explode when employers opt to drop coverage and send their workers to the new, federally subsidized health exchanges for coverage. He estimates that this will drive up the cost of the law by \$1 trillion or more in the first 10 years.

The list goes on and on. It's time to stop the ObamaCare madness before it becomes another entrenched entitlement program.

To protect taxpayers and our health sector, Congress can begin by defunding ObamaCare at every opportunity. Next we need a president and a Congress that will vote to repeal the law and start over with sensible reforms. The stakes are high for the capacity of patients and doctors to choose and control their medical choices, and for all Americans' freedom and prosperity.

### THE TWO-CENT DOLLAR

After almost a century of inflation, today's dollar has less than 2 cents of the purchasing power that it had in 1913 when the Federal Reserve Board was founded. The dollar in 1913 was backed by gold, as the Founders including Washington specified, in keeping with the Good Book's standard for money.

But that effectively changed in 1933 when President Franklin D. Roosevelt made ownership of gold bullion illegal in the U.S., and in 1971 when President Richard Nixon severed the last anchor of dollar convertibility into gold for foreign banks. Our dollar is back by debt, more and more debt.....worthless.



## Why No Looting and Violence in Aftermath of Japan Earthquake-Tsunami

Japan's prime minister calls the 9.0 earthquake and the following tsunami the greatest crisis in Japan since World War II. Ten thousand people are feared dead. Millions are without power, and millions sleep outdoors in cold weather.

But we haven't seen looting, no gang violence, robbery, CPD. Why not? My final take on it is that Japanese culture and values and beliefs and the extensive crisis training of professional first responders and volunteers are the reasons for such an inspiring response by Japanese to their horrific crisis this week.



But others have their opinions: "Race is not an issue," Mike replied. "Third World countries like Haiti loot due to poverty. Japan is like America, an economic superpower. Plain and simple." "Poverty equals crime" is the standard "plain and simple" explanation, especially to the left. The analysis is grossly erroneous and misleading.

In the "economic superpower" called America, we see widespread looting following natural disasters, as well as during power blackouts, "civil unrest" and basketball team victory celebrations. If we attribute this to American poverty, what about Japanese poverty?

"Japan Tries to Face Up to Growing Poverty Problem," read the headline of a 2010 New York Times article. Here are excerpts:

"After years of economic stagnation and widening income disparities, this once proudly egalitarian nation is belatedly waking up to the fact that it has a large and growing number of poor people. The Labor Ministry's disclosure in October that almost one in six Japanese, or 20 million people, lived in poverty in 2007 stunned the nation and ignited a debate over possible remedies that has raged ever since.

"Many Japanese, who cling to the popular myth that their nation is uniformly middle class, were further shocked to see that Japan's poverty rate, at 15.7 percent, was close to the ... 17.1 percent in the United States, whose glaring social inequalities have long been viewed with scorn and pity here. ...

"Following an internationally recognized formula, the (Labor Ministry) set the poverty line at about \$22,000 a year for a family of four, half of Japan's median household income. Researchers estimate that Japan's poverty rate has doubled since the nation's real estate and stock markets collapsed in the early 1990s, ushering in two decades of income stagnation and even decline."

If Japan's percentage of people living below the poverty line is about the same as ours, and if poverty causes crime as Mike suggests, why isn't the crime rate in Japan about the same as ours?

San Francisco's Chinatown in the 1960s became one of the most impoverished areas in California. Public policy professors James Q. Wilson and Richard Herrnstein wrote: "One neighborhood in San Francisco had the lowest income, the highest unemployment rate, the highest proportion of families with incomes under \$4,000 per year, the least educational attainment, the highest tuberculosis rate and the highest proportion of substandard housing. ... That neighborhood was called Chinatown. Yet, in 1965, there were only five persons of Chinese ancestry committed to prison in the entire state of California."

Two low-income areas outside of Boston -- South Boston and Roxbury -- were featured several years ago in U.S. News & World Report. They had similar socio-economic profiles: high levels of unemployment; the same percentage of children born to single-parent households; and the same percentage of people living in public housing. But the violent crime rate in Roxbury, predominately black, was four times higher than that of South Boston, predominately white.

Culture and values explain why some countries and some communities experience crime, while others do not. This explains why many students from Asian countries outperform equally "disadvantaged" black and brown students from the same "underperforming" inner-city government schools.

Culture and values explain a 2011 article headlined, "New Zealand Police 'Sickened' at Looting in Quake-Hit City": "New Zealand police said ... they were 'sickened' at a spate of looting, email scams and bogus appeals for charity in the wake of the deadly Christchurch earthquake. ... Lootings and burglaries, including one at the home of a woman feared dead in the disaster, have also been reported, while fraudulent emails soliciting charity donations were also doing the rounds." The Japanese earthquake was over 8,000 times more powerful than the New Zealand quake earlier this year.

Culture and values explain why in Los Angeles, a city with a 46 percent Hispanic population and a 10 percent Asian population, one sees no Latinos or Asians holding up "Will Work for Food" signs. When South Korea played for soccer's 2010 World Cup, the Los Angeles Korean community received permits to view games on big-screen monitors in the streets near Koreatown. The police said the streets were more trash-free after the games than before.

Culture and values are not set in stone. They can and do change for the better -- especially when we accept responsibility and stop blaming bad behavior on poverty.

Plain and simple. Take responsibility for your actions, for your safety, for your health and welfare; do not depend on government; do not blame others.
