## JAIL for Judges

One of the most unthinkable evils is that judges in America are on the take. While unofficial, it has been estimated that approximately 30% of the cases are fixed somehow, and not necessarily by cash bribes. Bribes come in many forms, including vacationing judges by lawfirms and parties to a case, gifts, and campaign donations, etc.

How would JAIL4Judges cure this problem? It is not necessary to catch every instance of bribery involving judges to cut this activity short. J.A.I.L. does not concern itself with bribery, but rather acting on the bribery. For instance, if a judge is offered a bribe, and he accepts it, the enity or person offering the bribe will expect performance by the judge for the bribe. But when the judge goes to pervert justice by denying due process, or refusing to acknowledge the applicable law or constitutional principle, he runs the high risk that the case will be appealed to its last resort within the State, qualifying the party to bring the questions of lack of due process or willful violations of law before the J.A.I.L. Special Grand Jury that will prosecute the judge.

In such case, when judges no longer will risk their career and their retirement for a bribe, they will no longer act on the bribe. And when judges no longer act on bribes, those who bribe them will stop the bribing. JAIL4Judges is the only answer! -Ron Branson

[MAN note: The issue facing all American's is not what government can do, but rather what the government is doing to stop judicial tyranny, and basically the answer is "Nothing." There is better than a 100 to 1 odds that the government will cover up the evils of the judiciary rather than lift a finger to deal with its evil. This is done in the name of "Preserving the Integrity of the Courts." Look at case of newly appointed judge Richard Bissen, former Maui prosecutor!

Some opponents of JAIL4Judges note that the powers to limit the jurisdiction of the courts already exists within the Constitution. I agree. Indeed the Constitution says, "The judicial power of the United States shall be vested in ... such inferior courts as the Congress may from time to time ordain and establish." see Article III, Sec. 1.

Thus, excluding the Supreme Court, Congress possesses the constitutional power to close down every federal court in the country. This is likewise authorized in Article I, Sec. 8, Clause 9, "To constitute tribunals inferior to the Supreme Court." The power to create is the power to destroy! Further, Congress has the power to limit the court's jurisdiction, The Supreme Court shall have appellate jurisdiction, both as to law and fact, with such exceptions, and under such regulations as the Congress shall make.

Ok, fine, but what is the Congress or any government agents doing to stop judicial crime?

Obviously nothing is beeing done against judicial crime. Clearly, just having a remedy and being effective at stopping judicial corruption are two separate things.

That is why JAIL4Judges, the Judicial Accountability and Integrity Law is absolutly necessary now so that non-lawyers, the sovereign citizens of America, you and I, are protected from judicial crimes by being able to exercise our power over government to stop judicial crimes that we see daily in Hawaii. —MAN]

## The Status of Monk Seals on Moloka'i

There are, according to the Hawaiian Monk Seal Program, 30 seals on Molokai. They have had 5 babies last year in Kalaupapa. They prefer to pup on that peninsula for some reason, despite the fact the waters there are surrounded by large tiger sharks. The mothers whelp and wean their solitary child between 39 and 45 days. During this period of bonding, the mother never leaves the baby. She guards it without taking food or any kind of liquid (usually found in the fish) while the pup gains weight rapidly from her nourishing milk. When the Monk Seal mother reaches the point of starvation, she leaves the baby to fend for itself and returns to the water for a meal and to find a nice quiet beach on which to pull herself up by her flippers and rest.

Seals who have green mouths are covered in algae which means they have been in the water for a few days, perhaps returning from Kalaupapa or from Penguin Banks where they like to fish. It is difficult for seals to clamber over large boulders so they prefer beaches with long stretches of sand. Sometimes the younger, more timid seals hang out on small beaches with surrounding rocks for camouflage. [see photo above]

The most seals I have seen in one place are clustered around La'au Point. Usually about four, more or less, with seal tracks showing someone was there, sunning themselves to kill the algae; much as do the honu (turtles). They never venture into the brush, although on rough days when the surf and tide are both high they will rest at the vegetation line.

Most people are not aware that seals can attack [see photo below] and that it is a \$10,000.00 fine or six months in prison for harassing a seal. It is assumed that most people already understand their diminished privacy and their dwindling and polluted food supply. Yet still they enjoy their short lives and grace our shores with their mesmerizing presence. Our heritage.



## Young Whale Slashed Across Body Second Whale Freed from Debris & Nets

Humpback Whale calf with deep cuts on its back appeared to have been caused by propellers of a small fast-moving boat was photographed Monday, February 28 off the coast at Puamana, according to a Pacific Whale Foundation report. The injured whale has not been sighted since.

Also on Feb. 28, a Humpback Whale was sighted entangled in nets, ropes and other debris just two miles off Lahaina

Two coast Guard boat crews approached the 35-foot long whale with Humpback Whale National Marine Sanctuary personnel and eventually cut it free about 10 miles from Lahaina.

Humpback Whales arrive in Hawaiian waters beginning in November from their summer home, Alaska and return to Northern waters beginning in April and May. Last month, a second whale count at 65 sites around the state sighted 695.

#### READ IT AGAIN, PEOPLE ! THIS IS IMPORTANT!

What is the remedy against judges and government executives for their intentional acts of failing to adhere to clear black letter law?

No remedies, as long as we can't enforce such remedies. Most people believe we therefore have no remedy. However, we can enforce such remedies, and it is our constitutional duty to do so, and that means militia and exercising the 2nd Amendment right to keep and bear arms against government tyranny, but to prevail, enough other citizens must support us and become active militia to protect the Constitution and the rights guaranteed therein for all of us. Ultimately, armed revolt against government traitors is what it may come to.

The 1st Amendment Right of Petition is the basis of all others. It is designed to bring government to account under the law of the land, or by force using the right to keep and bear arms recognized in the 2nd Amendment if necessary, for the violation of other rights. It is so powerful that its free use will prevent the hostilities of war between government and governed and the mere promise to respect it can restore peace to warring factions because it is the instrument of justice under law. It is intended to subject government to the compulsory process of law when government does not want to fairly redress the grievance. It is so important that "law" without it, is "law without justice," and that is another name for oppression.

The Supreme Law of the land is binding on government. If either the people or government agents do not like certain constitutional clauses the remedy is to amend the Constitution, not have judges "interpret" it contrary to its express and contextual meanings. The Constitution contains its own terms for amendment, and "judicial fiat" is not among them.

The proper remedy for changing any "Constitutional clauses" is the amendment process. But I would not characterize the Bill of Rights as mere "Constitutional clauses." Unalienable rights are endowed by our Creator, and there is no moral process by which they can be wrested from their sovereign possessors. Especially in light of the Bill of Rights Preamble, I would view any attempt to "amend" any of the unalienable individual rights that are recognized and guaranteed in the Bill of Rights to be in and of itself an act of treason.

There are Four Boxes of Freedom-only four: Soap Box, Jury Box, Ballot Box, and Cartridge Box. They are best used in that order.

The military has a bigger, more powerful Cartridge Box, but, the Armed American Citizenry has millions of smaller, lethal Cartridge Boxes, each full of mini-Tyrant Wannabee Terminators. The Armed Citizens' Cartridge Box can be used with discriminatory precision and, therefore, is a final resort solution with real power-the ability to obtain a desired result.

As governments' agents continue to abuse citizens under the color of law, with the Judiciary's approval, governments' agents create more converts receptive to the idea of going for broke to restore the Constitutional Rule of Law by manifesting a lesson in Trigonometry 101, if the Right to Petition fails to yield a satisfactory redress.

In the interim, a growing pile of layer upon layer of unredressed grievances churn, fueling a rage of anger and alienation. Increasingly, more citizens are approaching zero intolerance for a judiciary that increasingly spreads a virulent form of an unconstitutional bubonic plague: The police can do just about anything they want in the name of public necessity or expediency, and, when their victims sue or defend their rights in court, they are sucker punched and their lawsuits and claims crash into a wall of incestuous police-prosecutor-judge relationships and police, prosecutors, and judges who hide behind their false immunities. Then, citizens experience a rare epiphany moment: The Right to Petition and Immunities are mutually exclusive and legal mortal enemies. What good is the Right to Petition when the wrongdoers cannot be held to account because they enjoy incestuous relationships with others in power and all in power rebuke the petitioners and hide behind their immunities?

The Cartridge Box is sanctioned by the July 4th Declaration of Independence and the Second Amendment which empowers the people to retain the pragmatic means to preserve the security of a free state. The core idea is that government is based on the consent of the governed, and when government violates the rules and rules oppressively the People have the right and the duty to rebel.

When the judiciary fails to function as a Guardian of Liberty, what is left? For men born to liberty, the yoke-even when feather light--is never an option.

The Bill of Rights is Mankind's greatest achievement. It is the high water mark of about 8,000 years of tumultuous, gut wrenching, utterly miserable, tragic, recorded human history trying to reach a reasonable accommodation between Government and Citizens. The Constitution's bright lines are supposed to separate Government's powers from Citizens' rights. When Government usurps its powers and refuses to redress a legitimate grievance, a calm peacefulness with an oppressive government cannot endure indefinitely.

The Bill of Rights that is suppose to hold this nation together as a nation under the Constitutional Rule of Law. The Bill of Rights was suppose to end, forever, the Executive's arbitrary rule. But the Judiciary has irresponsibly allowed the Executive, via the police and the prosecution, to function as outlaws, contrary to clearly established law. None of this is hyperbole. It is, sadly, a matter of public record. Thus, the words of Algernon Sidney increasingly have sobering meaning to growing numbers who have been abused by governments' agents: "This hand, enemy to tyrants, By the sword seeks calm peacefulness with liberty."


The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

Judges are impeachable. Furthermore, judges may be removed immediately for violating oaths of office, involvement in conspiracies, extortion, and failing to uphold their duty to the common law. Judges can also be arrested, they are not exempt from this nor are any other officials, including the President of the United States.

Do the people have the power to do this? Yes, the people have the power to do everything to defend our country against all enemies foreign or domestic politician, and government has no power to say otherwise. Fascist bureaucrats might send out its armed marauders, but a huge group of The People (Militia) armed with guns as guaranteed their Right to keep and bear arms by the 2nd Amendment is likely to stop them unless the governments decide that it is time to begin mass killings of all people who believe in the rights of Man. **Wake up ! Enforce the Bill of Rights !**
