

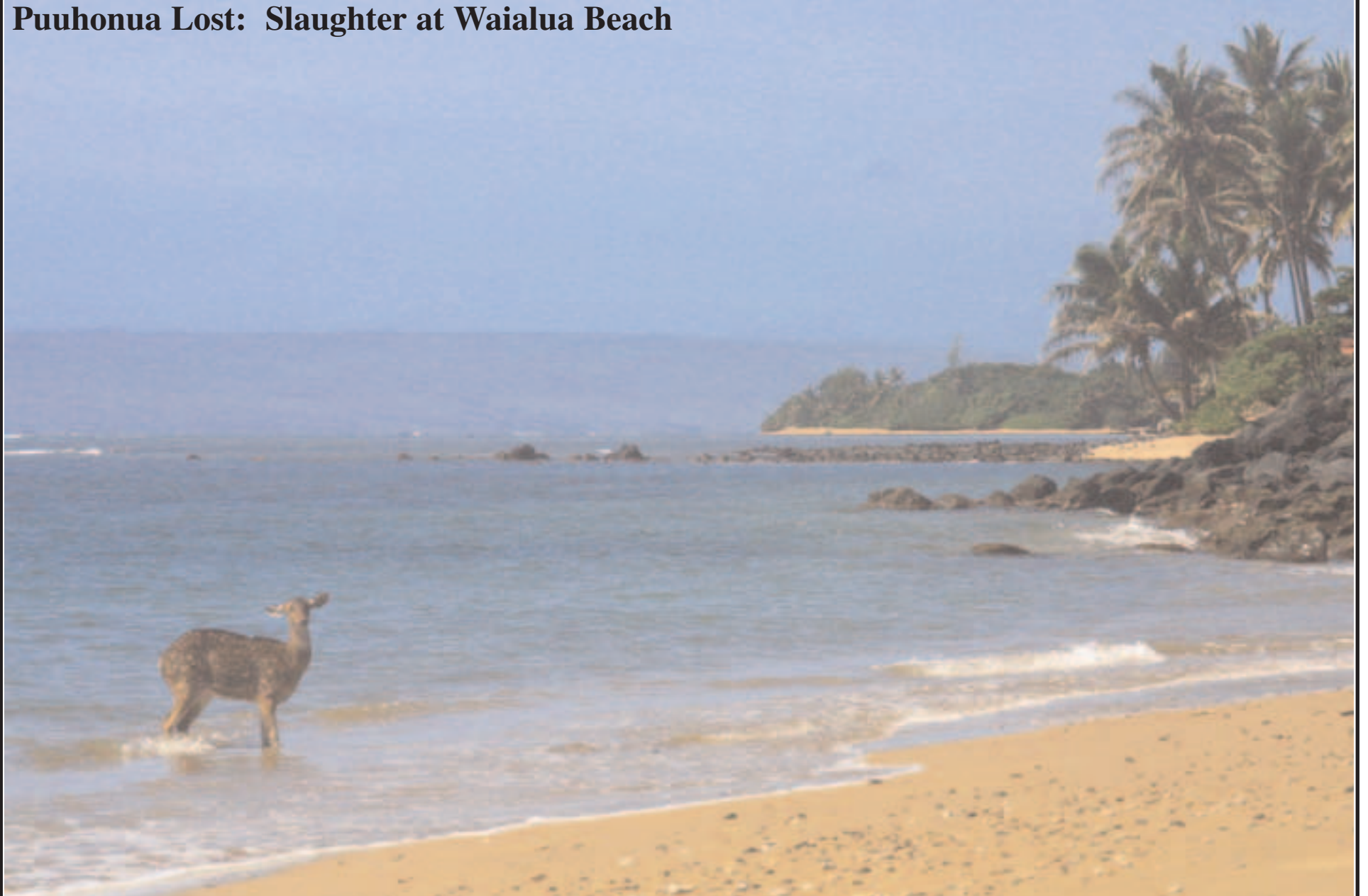

## Concerned Molokai Residents Have Many Problems with GOVERNMENT to Protest

The violence by our Police State of Hawaii is obviously prepared to send those RoboCop squads and sniper SWAT teams to Molokai to squash any protest activity that is not popular with those who would rule over the Sovereign People. It is more important than ever now to choose issues that justify possibly losing one's liberty or life, and not get suckered into supporting anyone's personal-power political agenda and newspapers like that observed over the past few weeks that benefited politicians.

Water access rights to the dwindling water resources of Molokai's single aquifer for the existing level of residential, commercial, and farming needs both east and west, and the urgent need to regulate this vital resource at sustainable levels by preventing excessive development and increases in population is an ongoing problem that requires great pressure on government to prevent bureaucrats from violating local rights, and increasing costs; and violating the purity of Molokai water with chemical additives like Fluoride.

Natural resources on land must be protected from "exceptions" being granted by government agents to "special people" or "special projects", e.g., that Wailau house with no EIS or consultation with Kamaaina; the fishpond scams; drilling water wells, and diverting streams; the Halawa Valley commercialism, and public access problems; protection of beaches and sea turtles from rampant ATV riders; government fails to protect shorelines from erosion such as at Kakahaia Park that

loses about 2-feet per year and trees and park benches are falling into the ocean; hunting areas and non-hunting areas cannot be effectively patrolled and protected from abuse by only one DOCARE officer, so at least one more officer is needed, and the hunters and fishermen and general public must actively prevent and protest abuses.

Cultural concerns for burial desecrations, such as the Mapulehu Glass House iwi that still need to be re-buried with respect are still being neglected. Government agents don't get the job done without public support/protests. And, why does it appear that exceptions have been made to recent large scale land clearing, and possible burial desecrations have been allowed to happen, and government seems to be hindering instead of enforcing the law?

Hawaiian Homestead lands in Ualapue and Kilohana may be opening up soon. How will this affect eastend? Ask about the HHL meeting for April 25.

There is the ongoing problem of alcohol and other drug abusers that devastate individuals and families and invites increased Police State enforcement [the government's solution that is worse than the drug problem]. Drug dependent people are not Sovereign, they are slaves.

Local diet choices promote diabetes, weight gain, blood and heart problems that debilitate and kill, when a vegetarian diet choice would avoid most health problems.

It is easy to become "micro" focused on important issues that originate on Molokai, and to forget the bigger picture of tyranny and oppression by the Police State gov-

ernment that are threats to Molokai people. County, State and federal government agents acting outside of the authority granted to them by Sovereign People, e.g., police use of excessive force, and corruption/malfeasance and obstruction of justice from MPD chief to Maui County prosecutors, collusion with lawyers, biased judges all of them violate their Oath of Office failing to uphold the Constitution and Bill of Rights, acting like our masters.

County/state government taxation of land is increasing as rich buyers drive up the prices, causing higher tax assessments against homeowners and farmers. The tax system by government is the tyranny here, driving local people off their own lands. Taxation is Slavery!

KU'E! The federal Patriot Act defines terrorist suspect as anyone who opposes government policy, people who mention the Bill of Rights and restrictions on government authority, or oppose War on Iraq. Concentration camps are ready! Citizen's gun rights against oppressive government [2nd Amendment] is outlawed just as Hitler did in Nazi Germany. **9-11 is TREASON!**

The IRS and Social Security are nationwide crimes against the Sovereign People who have forgotten that government agents are their servants, not their masters.

Educate government agents, protest their tyranny. Enforce the Bill of Rights against government! Defend individual sovereignty over our lives, our land and water resources, our rights to Life, Liberty, Property. —MAN

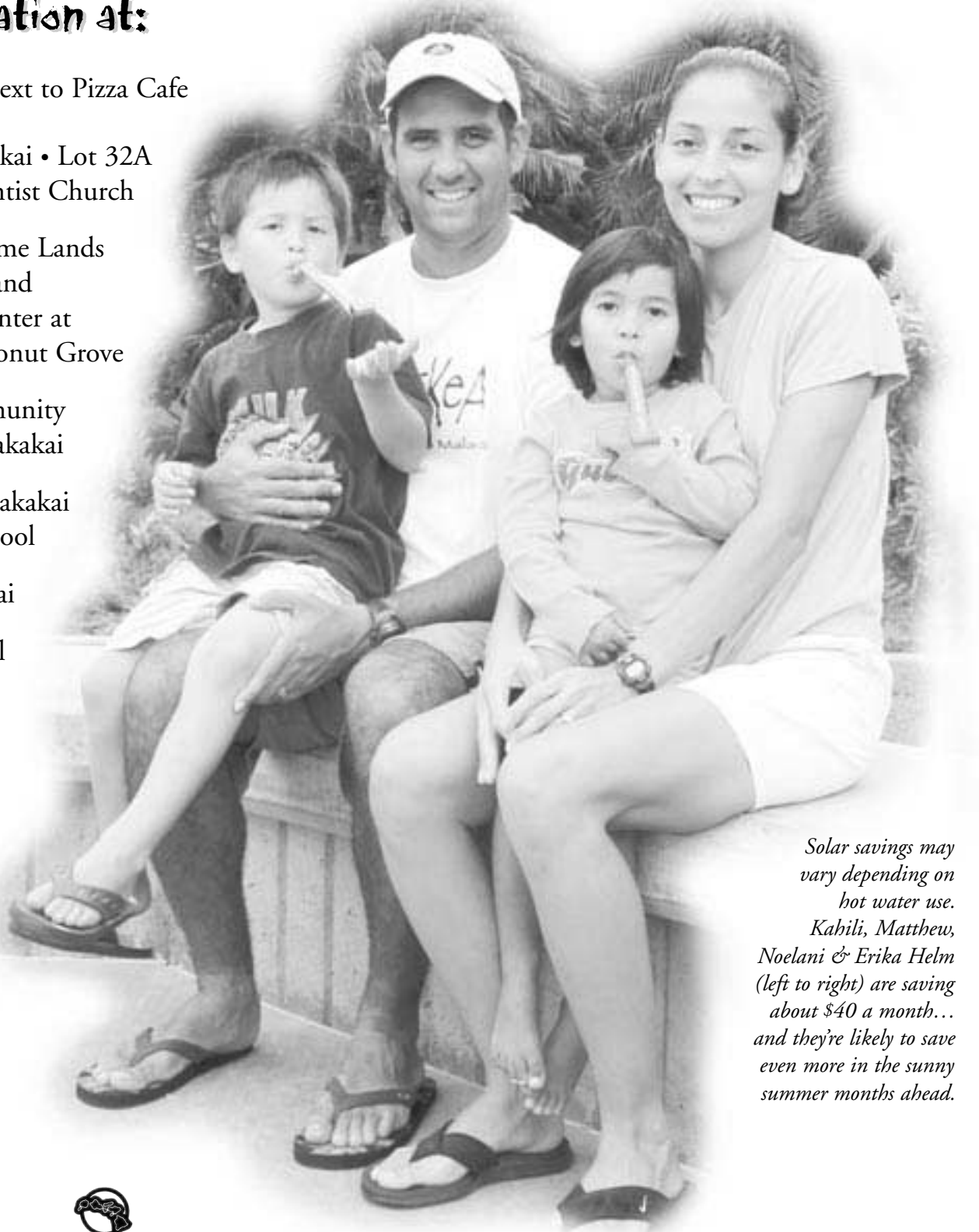

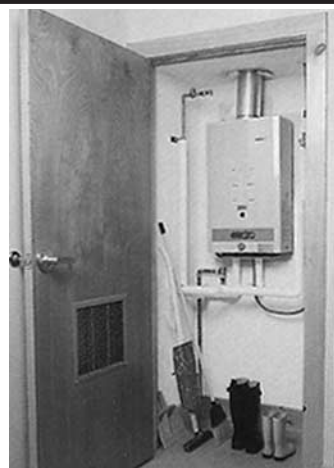
