# Leimana Naki's Mission: Malama Kahinapohaku Fishpond

report by George Peabody for The MAN

Raise fish, feed our community; Protect iwi burials; Education for Kanaka Maoli and immersion school na keiki, Kupuna, Visitors, local Handicapped cultural therapy.



With these goals in his mind and heart, Leimana Naki is struggling to malama the Kahinapohaku Fishpond historic site, and protect the burials and iwi from erosion. He has called for local Kanaka Maoli to kokua, but living and working the Hawaiian cultural ways of the past remain mostly his kuleana until he can recuit more participants. "Its hard being Hawaiian," he says as he perseveres along his path to "do the right thing."

Leimana Naki says that for almost 55 years he has lived and fished in East Molokai at a subsistence, basic food. But for the past two years, Leimana says he has been committed totally to living his Hawaiian culture, and caretaking the Kahinapohaku Loko ia at Moanui. He even gave up his income jobs so he was totally committed to this task, while his wife works jobs to earn some money for foods he cannot harvest from the reefs, and supplies needed for maintaining the fishpond educational site facilities.


Another facet of his commitment involves his ancestor' iwi, ancient burials next to the fishpond that he says are possibly of a royal lineage. [Leimana said he remembered names of Molokai Chief Kumukoa, Halai Mulehu and Kalaniahiikapa]



Besides ancient human bones, Leimana says his family found a carved palaoa niho [see photo] that he displayed to me, but he would not allow a photo of it. He said that it could have been washed from the eroding burials along the shoreline at the east end of this ancient

fishpond wall about 10 years ago. He says there were several Kumu and Opio with him at the time who witnessed finding it with the fishpond wall rocks fronting the ancient burials.

[ Ohana Kakou! According to historical reports, lei niho palaoa were worn mostly by high ranking members of ancient Hawaiian society on ceremonial occasions by men and women, and even in battle by men. This hook-shaped, whale-ivory ornament with a necklace of human



hair was originally worn by the ali'i (royalty) as a symbol of rank and authority. They were seen as embodying part of the essence and power (mana) of a man: when a leader was killed in battle, it was important for his enemies to take possession of his niho palaoa as well as his body in order to vanquish his spirit completely.]

Leimana exhorts everyone to respect the Hawaiian protocols of the fishpond wall and iwi burial here. He asked some tourists who came to look at the fishpond wall if they would walk on the wall. To his relief, this couple from Canada, Marylynn and Daniel, said the would not want to do that as it might disrespectfull or dangerous.



His only complaints are that some Molokai residents come to reap the harvest of his labors, without earning a share first. So he offers the opportunity to everyone, especially locals who seem to think this fishpond project is happening without great effort: "For those of you, get 8 hours a day, 40 hours a week work, food stamps, retirement pension, disability...you got something. Respect me, Leimana and Naki Ohana and the community for maintaning Kahinapohaku as volunteers. Don't come and bring your thrownet, fishing pole, chair and sit on the wall and fish.. The fishpond is culturally built, without cement, pohaku are fit together. You could fall, break you leg or neck, injure yourself. This is not a commercial place... It's CULTURAL. We welcome volunteers to work and give physical and spiritual help with Hawaiian protocol. Hookupu [donations] of money, food, clothing are also welcome." says Leimana.

Leimana will tell you the story of this fishpond Kahinapohaku to local Hawaiians, adults and children, even visitors from the mainland and foreign lands across the world who are interested in learning Hawaiian culture. "History, hands on reality, as it is being lived today on Molokai," he explains, "inspires some visitors to stay a while to malama and kokua in the restoration," he says.

His photo album is full of photos of people lifting rocks to the fishpond wall, paddling canoe, throwing fish net, weaving hats, Hawaiian culture that he has taught, no charge, " Aloha piha,all aloha, from the heart," he says.



"For burials existing at low lands or at sea level on Molokai, I am very concerned for Malama the kupuna, malama the iwi. In the 1950s, Kama'aina were aware of the burials and many skulls in the area. In the 1960s, myself, brothers and cousing fished in this area night and day, even then many iwi were recovered. My father and uncles took them and hid them in the valleys. I don't own the fishpond, but I'm there to malama the fishpond, and the iwi. That's my DNA, thats my claim to the fishpond," Leimana says, trying to find solutions to all the problems he faces on his mission. "As we know there's Global Warming and the possibility of water rising, maybe solve the problem of low water in fishpond now at minus tides, or we can dig out the sand that has filled in over the centuries?"

Leimana continues, "I don't own the fishpond, I'm there to malama the fishpond." Fifteen years ago, listening at a community meeting of fishermen and others speak of three important kuapa (fishponds) Kahinapohaku was chosen by the Naki Ohana to caretake, so I am here, now, committed to realizing that Hawaiian culture is today a living reality: Kahinapohaku Fishpond walls need to be restored; to malama ancient burial areas; and restore the stock of awa, hanai, ama'ama and moi. The teaching of Molokai Manaleo (our culture) to kama'aina and malahini, opio and kupuna are also priorities," he explains as he considers whether to install keep out signs, no trespassing, No entry, no poaching fish signs that he hopes won't be needed to ENFORCE instead of malama.

"Low budget? No budget!, Myself and ohana with the support of some of the community do our best to maintain and upkeep the area, following our ancestor's ways of living. It is not easy. It is hard to be Hawaiian, today," declares Leimana. But his proud and tireless efforts are evidence that heis walking the path of a living Hawaiian culture, not just talking about it.

Leimana ends our interview with a call to "All Molokai people interested in all volunteer "Aloha Piha" restoration and maintenance of this ancient fishpond, and revival of Hawaiian Fishpond operations as a living Hawaiian culture for modern-day, now, and for our Opio who are the future. Lets go forward with our living Hawaiian culture, together with aloha, for all of us."




Judges are impeachable. Furthermore, judges may be removed immediately for violating oaths of office, involvement in conspiracies, extortion, and failing to uphold their duty

# **DEVELOPMENT Witout WATER on Maui Threatens Water Resources**

While West Maui developers's pink construction cranes continue to put up more condos and houses for more people who use more water, upcountry residents have to curb their water use as we now have to do in Kihei. If the Iao Aquifer is pumping over its maximum use on a daily basis for an extended period of time, why, oh, why are houses and condominiums continuing to be built?

Won't all of these new residences need water to function? Does the County Council and the Maui Planning Commission think that we are going to find another reliable water source when the Iao Aquifer becomes salinated?

Whether or not the housing is affordable, at this point, is kind of beside the point. Affordability won't matter if there is no water. Santa Barbara County in California declared a moratorium on building in the '80s until water usage could be figured out. Many contractors and investors lost their businesses as a result. Ultimately, though, the primary issue – potable water – was addressed and no building was permitted until it was solved in a responsible way. It took years. There was no overnight solution.

I worry about the future of Maui. We are in a serious situation, but nobody seems to tackle the problem at its source – overdevelopment. Where will it end? Auwe! Elizabeth Poole. Kihei

# **BOOM BOX Automobiles Noise not Pono! Boom Box cars are anti-Hawaii-nei!**

## No INCOME TAX for **HAWAII** resident Employees

CONTINUED from page 2:.....only the Hawaii members of Congress and the inferior federal judges must make returns. They alone as individuals with respect to Congress and its authority to make law applicable to individuals.

Everyone must concede that the federal income tax law of 1894 was declared unconstitutional in 1895 in Pollock v. Farmer's Loan & Trust, 158 U.S. 601 (1895) because the tax was an unapportioned direct tax that had not been apportioned to the several states. The ruling in that case is clear:

Our conclusions may therefore be summed up as follows:

First. We adhere to the opinion already announced, - that, taxes on real estate being indisputably direct taxes, taxes on the rents or income of real estate are equally direct taxes.

Second. We are of opinion that taxes on personal property, or on the income of personal property, are likewise direct taxes.

Third. The tax imposed by sections 27 to 37, inclusive, of the act of 1894, so far as it falls on the income of real estate, and of personal property, being a direct tax, within the meaning of the constitution, and therefore unconstitutional and void, because not apportioned according to representation, all those sections, constituting one entire scheme of taxation, are necessarily invalid. Pollock v. Farmer's Loan & Trust, 158 U.S. 601, 637 (1895)

#### Why Is The Federal Income Tax Law So Complicated?

Congress has a lock on money paid through the federal Treasury, but to tax private money it must deceive those persons over whom it has no power. It does this by making people believe there is a requirement to file income tax returns. Complexity is how it does it. But REMEMBER, no matter how complicated the Code becomes the only persons who have to understand it are the federal employers who pay out government money and withhold some to pay the tax. All references to the filing of a return are made in the places that should be ignored in determining the actual law of income taxation. This means that the persons whose income is being taxed do not have to file returns or even pay the tax. The federal employer does everything but earn the taxable income. Everything done for government by its employees is "filed" and in government custody at all times. Besides the deceptive filing requirement Congress has come up with special filing status, deductions, special credits and exemptions to create a perceived need to file. All that complexity creates a tax liability where none exists and the persons who file returns are as guilty as Congress for the income tax mess, because there is no law that requires private persons to make and submit to the federal government written confessions [see 1040] that income taxes are owed. Once you are free from this imaginary tax burden you can start educating others, including an employer who has been taking your money to pay the "make believe tax".

#### **SUMMARY:** NO TAXATION on INCOME!

If you start with the power of Congress you will quickly see that the national government has no taxing power over the people doing purely local things in the states and may only tax people using the indirect excise tax. Congress has taxing power over its own employees under Article I, Section 8, Clauses 11, 12, 13 and 14, (the War Powers), and 17. Congress was given no power over ordinary people doing ordinary things in the states of the Union. Ask yourself: What power does the Congress have over a dentist filling cavities in Chicago? The answer is none. The state of Illinois can require a dental competence certificate and the City of Chicago a business license but what Congress can't control it cannot tax. If Congress has control over the source of your income you are subject to the income tax. Congress may impose direct taxes using the power to raise revenue, however, your own state would have to collect this tax from you and Congress has not imposed this kind of tax in over 130 years.
