## Kiele V Wreckage Drift to Molokai

Kiele V Wreck Drifts to Molokai

The diesel fuel tanks, cabins, fiberglass hull, and bar and galley of what was once a luxury sailing catamaran Kiele V drifted up on east Molokai shores early Monday morning last week. A helicopter was seen hovering over some of the wreckage on the edge of jungle near Moanui Beach.

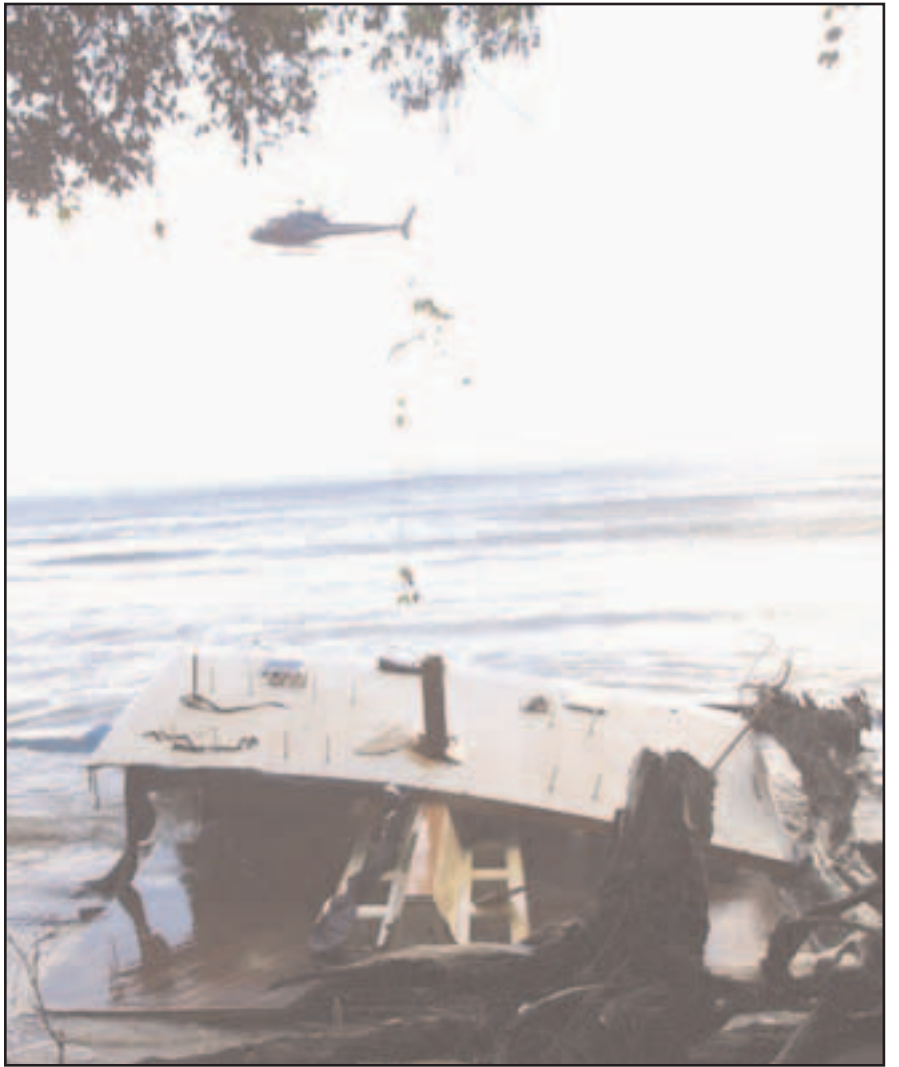
Disaster struck when the 90 feet tall mast of the 55-foot sailing catamaran Kiele V, operated by the Hyatt Regency Maui Resort & Spa, broke and the vessel was reported to be in distress. The boat was about three miles at sea during a sunset cruise off Kahana last week Sunday with 47 passengers aboard, when the mast broke and killed one man and disabled the vessel.

Two boats in the area Gemini and Teralani III responded to assist taking the passengers to Kaanapali Beach. Three people were taken to Maui Memorial Hospital. One man was killed.



"It didn't look like there was much damage to the boat," said Jason Moore, a photographer who was aboard Teralani III. "The mast went underwater with the sail and created an anchor effect."

Inexplicably, the Kiele V was abandoned, the Captain did not stay with the ship and the Coast Guard did not tow it to safety. It was so badly damaged by the



time it drifted down the Pailolo Channel to land on Molokai reefs, it looked like it may have been hit by a barge or cruise ship during the night.

The MAN as asked the Coast Guard why the vessel was allowed to be abandoned, drifting as a hazard to navigation, and pollution on Molokai. The Coast Guard said they couldn't release details about the agency's continuing investigation. [photos by George Peabody]

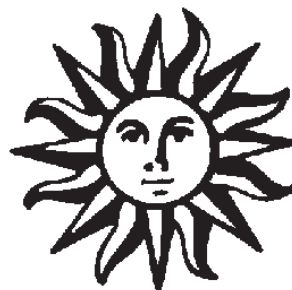

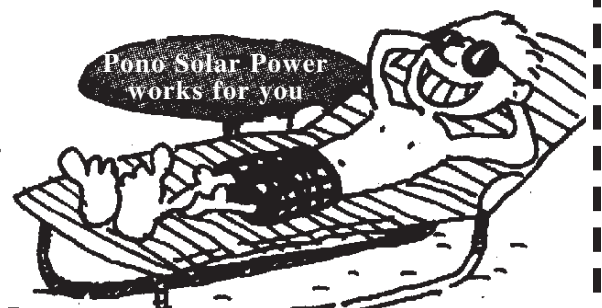

### Man shot by intruder posing as FBI agent

"A south Fulton County homeowner was shot early Monday by a masked intruder claiming to be an FBI agent, police said. The suspect kicked in the back door of the home on Hidden Court, in a subdivision off Welcome All Road, about 4 a.m., setting off the home's burglar alarm, Fulton police Cpl. Gary Syblis said.

The 53-year-old victim told police he got out of bed and heard the suspect coming up the stairs, yelling, 'FBI, FBI, FBI,' Syblis said. Syblis said the homeowner confronted the suspect, who was wearing a ski mask and dark clothing.

The suspect fired four times, striking the victim once in the stomach. The victim returned fire, possibly wounding the "FBI" suspect, who fled the home.

## Be Civilized: Carry a Gun

Human beings only have two ways to deal with one another: reason and force. If you want me to do something for you, you have a choice of either convincing me via argument, or force me to do your bidding under threat of force. Every human interaction falls into one of those two categories, without exception. Reason or force, that's it.

In a truly moral and civilized society, people exclusively interact through persuasion. Force has no place as a valid method of social interaction, and the only thing that removes force from the menu is the personal firearm, as paradoxical as it may sound to some.

When I carry a gun, you cannot deal with me by force. You have to use reason and try to persuade me, because I have a way to negate your threat or employment of force. The gun is the only personal weapon that puts a 100-pound woman on equal footing with a 220-pound mugger, a 75-year old retiree on equal footing with a 19-year old gangbanger, and a single gay guy on equal footing with a carload of drunk guys with baseball bats. The gun removes the disparity in physical strength, size, or numbers between attacker and a defender.

There are plenty of people who consider the gun as the source of bad force equations. These are the people who think that we'd be more civilized if all guns were removed from society, because a firearm makes it easier for a mugger to do his job. That, of course, is only true if the mugger's potential victims are mostly disarmed either by choice or by legislative fiat--it has no validity when most of a mugger's potential marks are armed. People who argue for the banning of arms ask for automatic rule by the young, the strong, and the many, and that's the exact opposite of a civilized society. A mugger, even an armed one, can only make a successful living in a society where the state has granted him a force monopoly.

Then there's the argument that the gun makes confrontations lethal that otherwise would only result in injury. This argument is fallacious in several ways. Without guns involved, confrontations are won by the physically superior party inflicting overwhelming injury on the loser. People who think that fists, bats, sticks, or stones don't constitute lethal force watch too much TV, where people take beatings and come out of it with a bloody lip at worst. The fact that the gun makes lethal force easier works solely in favor of the weaker defender, not the stronger attacker. If both are armed, the field is level. The gun is the only weapon that's as lethal in the hands of an octogenarian as it is in the hands of a weightlifter. It simply wouldn't work as well as a force equalizer if it wasn't both lethal and easily employable.

When I carry a gun, I don't do so because I am looking for a fight, but because I'm looking to be left alone. The gun at my side means that I cannot be forced, only persuaded. I don't carry it because I'm afraid, but because it enables me to be unafraid. It doesn't limit the actions of those who would interact with me through reason, only the actions of those who would do so by force. It removes force from the equation...and that's why carrying a gun is a civilized act.

The right of a citizen to bear arms, in lawful defense of himself or the State, is absolute. He does not derive it from the State government. It is one of the high powers" delegated directly to the citizen, and is excepted out of the general powers of government. A law cannot be passed to infringe upon or impair it, because it is above the law, and independent of the lawmaking power." [Cockrum v. State, 24 Tex. 394, at 401-402 (1859)]
