 - You supply your Social Security # to State Police

 - Each update - change of ownership through private or public sale must be reported and costs \$25 - Failure to do so you automatically lose the right to own a firearm and are subject up to a year in jail.
 - There is a child provision clause on page 16, section 305 stating a child-access provision. Gun must be locked and inaccessible to any child under 18.
- MPD or feds ATF would have the right to come and inspect that you are storing your gun safely away from accessibility to children and violations are punishable for up to 5 yrs. in prison.

The best way to fight this is to tell all your friends about it and spring into action. We all join a pro-gun group like the Colorado Rifle Association, hunting associations, gun clubs and especially the Gun Owners of America, the NRA, the Second Amendment Foundation for cumulative political power to stop this treasonous legislation from Obama regime.

FATHER DAMIEN To Be Recognized as a Catholic Saint in October, 2009

Priest who aided lepers in Hawaii to become saint

VATICAN CITY – A 19th-century Belgian priest who ministered to leprosy patients in Hawaii, and died of the disease, will be declared a saint this year at a Vatican ceremony presided over by Pope Benedict XVI.

The Rev. Damien de Veuster's canonization date of Oct. 11 was set Saturday.

Born Joseph de Veuster in 1840, he took the name Damien and went to Hawaii in 1864 to join other missionaries of the Congregation of the Sacred Hearts of Jesus and Mary. Nine years later, he began ministering to leprosy patients on the remote Kalaupapa peninsula of Molokai island, where some 8,000 people had been banished amid an epidemic in Hawaii in the 1850s.

The priest eventually contracted the disease, also known as Hansen's disease, and died in 1889 at age 49.

"He went there (to Hawaii) knowing that he could never return," The Rev. Alfred Bell, who spearheaded Damien's canonization cause, told Vatican Radio. "He suffered a lot, but he stayed."

De Veuster was beatified — a step toward sainthood — in 1995 by Pope John Paul II.

The Vatican's saint-making procedures require that a miracle attributed to the candidate's intercession be confirmed in order for him or her to be beatified. De Veuster was beatified after the Vatican declared that the 1987 recovery of a nun of the Sacred Hearts of Jesus and Mary was a miracle. The nun recovered after praying to Damien.

After beatification, a second miracle is needed for sainthood.

In July, Benedict declared that a Honolulu woman's recovery in 1999 from terminal lung cancer was the miracle needed for de Veuster to be made a saint.

The Vatican's Congregation for the Causes of Saints said Audrey Toguchi's 1999 recovery from lung cancer defied medical explanation. Toguchi, too, had prayed to Damien.

The Vatican announced the date for Damien's canonization and that of nine others. Five will be declared saints at a ceremony April 26, with the rest, including Damien, on Oct. 11.

Bell said Damien's concern for others was a model for all the faithful today, particularly the young.

"Father Damien's example helps us to not forget those who are forgettable in the world," he said.



NOTICE TO PROPERTY OWNERS COUNTY OF MAUI 2009 REAL PROPERTY ASSESSMENT NOTICES

Real property assessments for the County of Maui for the 2009-2010 tax year have been compiled and are on file in the County assessor's office located at the County of Maui Service Center, 70 E. Kaahumanu Avenue, Suite A-16, Kahului, Maui, Hawaii or at the Mitchell Pauole Center, Kaunakakai, Molokai, Hawaii. Property owners may visit the assessor's office to review the assessment of their property and to confer with the assessor.

A "Notice of Property Assessment" showing the taxable value of the land and improvements, if any, the amount of exemption allowed on the property, the classification assigned to the property, and the net taxable value of the real property will be mailed to property owners on or before March 15, 2009. If you do not receive a notice within ten days of this date, you should inquire at the assessor's office at (808) 270-7297.

If you do not agree with the value placed on your property, or if you were not given an exemption to which you feel you were entitled, or if you do not agree with the classification assigned to your property, you may file an appeal with the Board of Review or the Tax Appeal Court.

The deadline for filing an appeal is Thursday, April 9, 2009 (No Exceptions). The appeal must be hand delivered to the Real Property Tax Division by 4:00 p.m. and date-stamped on or before the deadline, or, if the appeal is mailed, it must be postmarked by a government postal service by April 9, 2009. All private couriers, private metered postage, and Pitney Bowes postage are not government-issued postmarks, and date and time the appeal is actually received by the real property office will be applied. An appeal cannot be lodged by facsimile transmission. If a receipt of the appeal is requested, please enclose a self-addressed stamped envelope.

All appeals shall be in writing and, at the time of filing, must provide the tax map key number, name, mailing address, phone numbers, and signature of the taxpayer. The taxpayer must also state the grounds of the appeal and total valuation claimed by the taxpayer for the property if the appeal is based upon the ground that the assessed value of the property is excessive. At the time of filing, the appellant shall include the \$50.00 filing fee required by ordinance. Appeal form and instructions are available from our office or on the website. For an appeal to the Tax Appeal Court, the cost is 5% of the taxes in dispute but not more than \$100.00 nor less than \$5.00.

County Secrets EXPOSED

Hawaii County secrecy policy confirmed, rescinded. [Molokai PD and Maui MPD need to be corrected, too, as they violate 1st Amendment Freedom of the Press rights of The MAN by their exclusionary and vindictive actions.—MAN]

A Hawaii Tribune-Herald article published today described a Big Island government policy implemented and now rescinded by the county Department of Public Works that sheltered employees from public scrutiny, denied reporters access to road projects and blackballed Internet bloggers.

The policy specifically instructed DPW employees not to give out information to bloggers Aaron Stene (The Kona Blog) and Damon Tucker (Damon Tucker's Weblog) and Dave Corrigan of Big Island Videonews.com.

The policy has been rescinded, but until there is a clarifying county-wide policy in place, there's no assurance that the public will have the access it should. The article indicates that a county-wide policy will be created.

Particularly objectionable is the blackballing of particular individuals by name, presumably on the basis of the content of their websites. On Molokai, the editor for Molokai's longest lived community newspaper since 1984 has been black balled by MPD chief Thomas Phillips since 1995, and state OIP has advised MPD/Phillips to give George Peabody access to MPD records by law, but Phillips et al find ways to continue their criminal and vindictive actions—MAN]

"There is no question this is not an acceptable media policy," said Hunter Bishop, public relations specialist for Mayor Billy Kenoi.

"It is not in effect. We do not support this policy," added Bishop, a former Tribune-Herald reporter who authored a popular blog before pulling it voluntarily when he started working for the county in December.

We are all entitled to public information, of course, regardless of the means of conveyance to our computer screens. This requires some adjustment in relationships between government workers and the public. Until government gets wired to the point where the information is automatically made available, there will be discomfort among those who still believe that their work products are government secrets. The inquirer may be a reporter, a blogger, or just anyone. Each deserves access to public information.

[Yes, even chief Phillips of MPD must comply with law, or be prosecuted.]

San Jose Man Dies After Police Tasing

Another taser death has been reported in the United States. In San Jose, California, a man in his twenties died last week Wednesday night after police shot him with a taser, the supposedly "non-lethal" defense weapon now being used widely, in Maui MPD too, by police officers nationwide. The death is the sixth to occur after the use of tasers by San Jose police since 2004. Scores more have died nationwide, and police have been warned that Tasers can be lethal to victims in certain circumstances.

San Jose police alone have killed six people with Tasers since 2004. How many people do they have to kill in San Jose to figure out that the Taser is not a non-lethal weapon?

Police will continue to use Tasers to kill (can you imagine tasing someone strapped to a hospital stretcher??) as long as they have these weapons and are not held accountable for their use.

When police officers are convicted of murder they might think twice about carrying Tasers. Until then, mahaalas.

NOW in CANADA:

Critics say the Mounties have used Tasers -- also known as Conducted Energy Weapons (CEW) -- too frequently and often zap suspects who pose no real threat. Such incidents include people trying to avoid paying fares on public transport and, in one case, an elderly man who was strapped to a hospital stretcher. 

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

Baby girl Makali'ahu Blessing Kaalo'ehukai Hewahewa was born on January 13, 2009 to Kahakuilaila Ritte-Camara and Kekoa Hewahewa. Baby Makali'ahu weighed 7 lbs. 10 oz. and was 20 inches. Baby's name Makali'ahu means "glowing cape", inspired from Kahaku's dream. Blessing explains itself, "our blessing." Ka'alo'ehukai -- "presence of sea mist", Koa's grandmother's name.

Molokai Ranch Condemnation Bill Expected to Fail

High tension, water worries for 1200 Kaluakoi/Maunaloa residents ensued after the Singapore-based GuocoLeisure Ltd. decided to shutter all its Molokai Ranch operations and, in turn, place 120 Friendly Isle residents out of work.

But Rep. Mele Carroll said she, along with some Molokai activists, want the state to attempt to save the island's wounded economy by either negotiating or wresting control of the ranch's land into the hands of local residents and the state.

Mele Carroll introduced a bill that orders Gov. Linda Lingle to negotiate for the purchase of GuocoLeisure and its subsidiary Molokai Properties Ltd.'s more than 60,000 acres, or one-third of the island, along with its other assets on Molokai. However, Carroll said she believes it's unlikely the measure will be heard this year, considering an ongoing Maui County lawsuit and the state's depleted coffers.

"At this time, obviously, there is no money to purchase it," Carroll said from her office at the state Capitol. "But it gets the conversation going to make this possible and gives the community some voice in their fate."

If the governor is not able to negotiate the acquisition of the land - as well as its ranch, two hotels, golf course and several supporting small businesses - Carroll's bill states that Lingle must wield the power of eminent domain to acquire the property.

Molokai Properties' alleged asking price is \$300 million, although company officials have said the property is not for sale. MCSC Executive Director Karen Holt said she thinks those seeking acquisition of the ranch can gather enough financing and donations to cover the price without using public funds.

Molokai Properties shut down the ranch and hotels last April after failing to win initial approval for the landowner's proposed master plan to develop 200 luxury homes at Laau Point.



Heavy Metal IS “Government”

Lawrence Livermore Laboratories has discovered the heaviest element yet known to science.

The new element, Governmentium (Gv), has one neutron, 25 assistant neutrons, 88 deputy neutrons, and 198 assistant deputy neutrons, giving it an atomic mass of 312.

US General and Vets Joins Lawsuit

Retired Maj. Gen. Carroll Childers has joined the legal case of Dr. Orly Taitz and others, which demands Obama prove his eligibility to serve as President. Childers served for 38 years in Vietnam, the Persian Gulf, Operation Desert Storm and other locations. He wrote,

An active-duty Army officer in Iraq has also joined a California lawyer's lawsuit intended to force President Barack Obama to prove he is a legal U.S. citizen, and qualified to serve as the commander in chief. "Until Mr. Obama releases a 'vault copy' of his original birth certificate for public review, I will
