McCarthy Bill Bans More Guns Than Clinton's Gun Ban

U.S. Rep Carolyn McCarthy introduced H.R. 1022, a bill with the stated purpose, "to reauthorize the assault weapons ban, and for other purposes."

McCarthy's verbiage warrants explanation. Presumably, what she means by "assault weapons ban" is the Clinton Gun Ban of 1994 on steroids. Congress allowed the ban to expire in 2004 for multiple reasons, including the fact that federal, state and local law enforcement agency studies showed that guns affected by the ban had been used in only a small percentage of crime, before and after the ban was imposed. And of course it was blatantly unConstitutional violation of 2nd Amendment.

Worse yet, McCarthy's "other purposes" will infringe gun rights more: H.R. 1022 will ban every gun banned by the Clinton ban, plus millions more guns, by classifying nearly every semi-automatic pistol, rifle, and shotgun as an "assault weapon". It will bring the gun ban extremists that much closer to their goal of total civilian disarmament so that law abiding Americans have no effective means to resist tyranny.

Today, it's "assault weapons." If that works, tomorrow it will be bolt-action, scoped "sniper rifles." After that, all handguns, because "only criminals" need concealed guns. After that, there will be too few gun owners left to fight off the total gun ban that is the anti-freedom lobby's "Final Solution."

The Constitution's Second Amendment prohibition against government interference in the "right to keep and bear arms" is the singular right that ensures all others. As noted by Justice Joseph Story: "The right of the citizens to keep and bear arms has justly been considered as the palladium of the liberties of a republic; since it offers a strong moral check against the usurpation and arbitrary power of rulers; and will generally, even if these are successful in the first instance, enable the people to resist and triumph over them."

Of course, only law-abiding citizens comply with such restrictions -- and at their own peril. Criminals don't care whether the weapon they're using comports with the 23,000 federal, state and local gun restrictions already on the books, but they do care whether their intended victim has a firearm. Indeed, extensive interviews with violent felons make it clear that they'd much rather prey on those who are least likely to possess a gun for self-defense.

"Laws that forbid the carrying of arms disarm only those who are neither inclined nor determined to commit crimes. Such laws make things worse for the assaulted and better for the assailants; they serve rather to encourage than to prevent homicides, for an unarmed man may be attacked with greater confidence than an armed man."

Again, no less true today than it has been throughout history.

Clearly, our Founding Fathers had it right. "To disarm the people is the best and most effectual way to enslave them," warned George Mason.

George Helm/Kimo Mitchell Remembered 30 yrs After Occupation of Kahoolawe

March 7, 2007 marks 30 years since George J. Helm, Jr. and Kim Mitchell disappeared. There have been many stories from various media outlets on the circumstances of their disappearance and on the legacy of George J. Helm, Jr.

It was George Helm's historic preservation and environmental lawsuit in Federal Court as president and co founder of Protect Kaho'olawe that became the catalysts of the eventual return of Kaho'olawe to the State and Maui County. It was through his passionate activism and a lot of public communication on issues like aloha aina, Hawaiian culture, Hawaiian language, and environmental issues back in the '70's that motivated many others toward the Hawaiian renaissance.

[More info by George Peabody] George Jarrett Helm, Jr. (Mar 23, 1950 - disappeared, March 7, 1977) was a kanaka maoli (Native Hawaiian) activist and musician from Molokai who amazed audiences by his ability to play fast, complex guitar music while singing in an "almost inhuman" vocal range; he was a powerful speaker, writer and "revolutionary" philosopher. George surfed, fished, farmed, loved, sang, worshipped and thought in the ways of old Hawaii., i.e., "Man is merely the caretaker of the land that maintains his life and nourishes his soul."

George Helm and Kimo Mitchell, disappeared while leading the occupation and eventual repatriation of Kahoolawe island to Hawaii and its people. Kahoolawe had been a U.S. Navy bombing target for 53 years until it was returned to the state in 1994.

January 30, 1977: a group landed on Kahoolawe in an attempt to gain greater public recognition of the struggle. Everyone was arrested except for Ritte and Sawyer, who stayed hidden on the island for 35 days, with limited food and water. Concerned for Ritte and Sawyer, and beset by vivid dreams and visions, George Helm with Kimo and Billy Michell, then set out by surfboard to assist them, but Ritte and Sawyer had already left the island. The three attempted to return to Maui despite high surf and a wound to George Helm's head. Helm and Kimo Mitchell were last seen near Molokini by Billy Mitchell, who was the only survivor of the group.

It was George Helm's historic preservation and environmental lawsuit in Federal Court as president and co founder of Protect Kaho'olawe that became the catalysts for the eventual return of Kaho'olawe to the State and Maui County. It was through his passionate activism and a lot of public communication on issues like aloha aina, Hawaiian culture, Hawaiian language, and environmental issues back in the 70's that motivated many others to become the Hawaiian renaissance movement.

A generation has passed since Helm sang, and occupied Kahoolawe and disappeared, but his legacy endures in the return of Kahoolawe for Hawaiian cultural and spiritual activities in perpetuity.

National ID Card Regulations Issued

Is this a free country or what?

The Department of Homeland Security released long-delayed requirements for the standardization of state identification documents Thursday. States must start issuing the new internal passports by May 2008, or else their citizens will not be able to board planes or enter federal courthouses. Civil libertarians say the requirement, known as the REAL ID Act, creates a national identity card that presents significant privacy risks to Americans. Many states oppose the rule as an unfunded mandate and an encroachment on states rights.

The regulations are complex, ranging from the kinds of documents required to get a license, how states databases will interact, the required elements on a compliant I.D. document's face, how states need to store copies of your breeder documents, and how states can attempt to deal with homeless people and other cases, such as judges, police officers who are to get special treatment and protections from this fascist scam.

While some expected Homeland Security to require the licenses to have smart cards or RFID chips, DHS instead proposes a 2D bar code (magnetic stripe) similiar to those used on many licenses. That information will not be encrypted.

DHS estimates that it will take only 44 minutes for a current driver's license holder to get a certified copy of their birth certificate, travel to the DMV and get a new license when it expires. No current driver's license holder will be allowed to renew a license by mail. They estimate the costs to states and individuals over 10 years will be \$23 billion.

Congress may move to negate this ruling by repealing the Act or allow states to apply for an extension until January 1, 2010. Hawaii could join twelve other states in rejecting the whole fascist scheme, but de facto governor Linda Lingle will not approve of such freedom thinking disloyalty to the Police State Bush Dictatorship.

War protestors arrested Nazi-style

"Police arrested three people early Monday during a protest of Iraq-bound Army vehicles at a Washington state port. Several dozen people showed up at the Port of Tacoma to protest the shipment of Stryker vehicles and other equipment from Fort Lewis. Caitlin Esworthy, Walter Cuddeford and Jeffery Berryhill were arrested for investigation of assault. Zoltan Grossman, a geography professor at Evergreen State College in Olympia who was observing the protest, said he didn't know what prompted the arrests. Esworthy is an Evergreen State student, and Cuddeford is a Navy veteran, he said. 'There were no rocks, no weapons. People were not carrying anything but signs,' Grossman said. 'We were on public space, on gravel, and there was a white line that police had told us not to cross. I didn't see any of the protestors cross that line.'



John Warner Defense Authorization Act

What Your Taxpreparer Won't Tell You: Income NOT taxable by Constitutional Law

26 CFR 1.312-6(b) does plainly speak of THREE types of income: 1) "all income exempted by statute"; 2) "income not taxable by the Federal Government under the Constitution"; and 3) income which is "includible in gross income under section 61." You can see the law for yourself on the IRS's own web site at:

Your tax preparer, CPA and tax attorney accepts as unquestionable IRS tax doctrine that "ALL income is taxable". (All of the tricks with deductions, deferments, credits, etc., are based on their ASSUMPTION that your income is taxable in the first place.) They believe that all income fits neatly into two categories: 1) Non-taxable: Income exempted by the statutes of the tax code; 2) Taxable: All other income.

But, IRS regulations clearly state that SOME kinds of income are non-taxable because of the Constitutional limits on taxation, so you're supposed to LEAVE OUT of the calculation of your taxable income because such income is, "under the Constitution, not taxable by the Federal Government." Your tax preparer should say "I didn't know it said that, and I'm not sure what income it's talking about," and, be curious enough to want to then go figure out what it means before continuing to pass himself off as a tax "expert." YOU now know something about tax law that all those highly-paid tax "experts" DON'T know.

It would be a MISTAKE to report such income on a tax return, or to pay taxes on it, if it is tax-exempt. This isn't a protest against the law; this is the government's own law books telling you how to properly COMPLY with the law, and to do that you are SUPPOSED TO leave out of your calculations any income you may receive which is non-taxable due to the Constitution limitations on taxation of income.

Are those Constitutional limits still applicable?

Yes. There have been no Constitutional amendments relative to Congress' taxing power. So anything that was, "under the Constitution, not taxable by the Federal Government" in 1956 (or 1925), is still not taxable today.

Do those in government WANT us to know how to OBEY the law? The IRS' "mission statement" says that their reason for existing is to help people "UNDERSTAND" and comply with their tax responsibilities. I did raise these questions, but the IRS agents would not answer. Since then, hundreds of people have sent letters to IRS officials, asking several basic questions about how we are to COMPLY with the federal tax laws. The last question was: "What types of income ... under the Constitution, is not taxable by the federal government?" Again, we got ZERO answers.

When I went to trial, I filed a motion asking the judge to inform the jury that "gross income" means all income, except for what is exempted by statute OR exempted by the Constitution itself. He refused to tell them that.

The IRS' own regulations say it--"under the Constitution, not taxable by the Federal Government" why don't their employees know about it? WHAT income is that?

In Federalist #45, James Madison the Father of the Constitution said that federal taxes would primarily apply to FOREIGN commerce, meaning trade which crosses country borders. Foreign trade income is taxable by federal government.

The Supreme Court ruled that because the Constitution grants Congress the general power to tax, AS WELL AS giving Congress specific jurisdiction over commerce with FOREIGN nations, the federal government can apply an income tax to a U.S. BUSINESS engaged in INTERNATIONAL trade [Peck v. Lowe, 247 U.S. 165].

Constitutionally, the income tax is only supposed to be applied to income which comes from "commerce with foreign nations", is my conclusion from that.

It is the job of the government's regulation-writers to make it knowable and precise; the law books themselves must specifically TELL us what our legal obligations are.

The regs specifically say that income which citizens and domestic companies receive from FOREIGN commerce "must be included in their gross income." It then mentions nonresident aliens, foreign corporations, and certain matters involving federal possessions (e.g., Guam, Puerto Rico), but nowhere does it specifically mention the DOMESTIC income of the average American. (The only time income from inside the U.S. was mentioned was when it was received by foreigners, which again constitutes international trade.) If that meant that income from international trade is taxable in ADDITION to domestic trade, the law would just say that Americans are taxed on income from "foreign OR domestic commerce". But doesn't, so its NOT the law.

Federal employees are one of the few Americans required to file and pay the IRS Income Tax. [Do you still voluneer to give 48% of your wages to the IRS ?]

Crimes of Politicians Must Be Stopped by The People (You are The Militia)

The crime on our streets is a tiny fraction of the crime in the offices of our politicians and bureaucrats - the massive majority of crime is committed by the criminal classes in power. Yes, the people have the power to do everything to defend our country against all enemies foreign or domestic politician, and government has no power to say otherwise.
