Hawaii Senate Bill 959 Attacks AKAKU -TV

This bill diverts a vital source of funding for PEG channels currently operated by Akaku: Maui Community TV, a private, nonprofit access organization that is locally accountable, nationally recognized and fully transparent.

Targets Maui, Molokai and Lanai for reduction of community access TV services. SB 959 would:

Silence the Free Speech of Maui County's community voices, and increase the State and County government controlled programs and messages.

Violate the Home Rule principle by overturning local decisions made in open public meetings in Maui County over a period of many years.

Divert community-based funds that are accountable with transparent local oversight in Maui Nui to opaque State agencies with decisions made on Oahu.

Create more centralized, less efficient methods to provide community access media for students, parents, teachers, faculty and staff on three islands.

Kill the Patriot Act TREASON

IRS Tax Not Needed. IRS FRAUD

"Strictly speaking, it probably is not necessary for the federal government to tax anyone directly it could simply print the money it needs. However, that would be too bold a stroke, for it would then be obvious to all what kind of counterfeiting operation the government is running. There is a great deal of chatter going on about "tax reform." Along with this dog and pony show the government drags out three or four times a decade comes all kinds of recommendations for alternative taxing schemes. None of this is new it's just a continuing smokescreen to pacify voters. One only need go through the Congressional Record back in the 1940s to see the discussions held by members of Congress on alternative taxing schemes.

Many desperate Americans are pushing for a "flat tax." Others are pushing for equally dangerous and unnecessary taxation on the fruits of their labor in the form of a national retail sales tax, consumption tax or value-added tax anything besides what is being enforced unlawfully now. But, is the income tax really an income tax? This is a very important legal point: The income tax is, therefore, not a tax on income as such. It is an excise tax with respect to certain activities and privileges which is measured by reference to the income which they produce. The income is not the subject of the tax: it is the basis for determining the amount of tax.

The Internal Revenue Service touts in all their propoganda that the fraudulently ratified 16th Amendment is what gives them the authority to impose a federal income tax. Seems they're at odds with at least one U.S. Supreme Court decision Stanton vs. Baltic Mining Co., 240 US 103 (1916): ... by the previous ruling, it was settled that the provisions of the 16th Amendment conferred no new power of taxation but simply prohibited the previous complete and plenary power of income taxation possessed by Congress from the beginning from being taken out of the category of indirect taxation to which it inherently belonged ..." In other words, the 16th Amendment did not give Congress any new power of taxation.

As the income tax becomes more and more oppressive, Americans are becoming desperate for any replacement. Be careful what you wish for especially any alternative taxing scheme which will only continue to feed the unconstitutional Federal Reserve banking system. No direct taxation is needed to fund the federal government. Not a penny of your income tax, whether you are a Democrat, Republican or any other party, funds the federal government. That "bacon" being brought home to your district by your favorite Congress-critter is done through borrowing debt heaped on the backs of your children and grandchildren for all their lives.

Your federal income tax dollars are also hijacked in "transfer payments" to the World Bank, the United Nations and the International Monetary Fund all grossly unconstitutional. There isn't a scintilla of authorization in Art. 1, Sec. 8 of the U.S. Constitution that allows Congress to steal from you to ship hundreds of billions to foreign banks, organizations or governments.

NOTICE OF PUBLIC HEARING MOLOKAI PLANNING COMMISSION

The Molokai Planning Commission for the County of Maui hereby gives notice that it will conduct a hearing on May 11, 2005, commencing at 1:00 p.m., or as soon thereafter as is practicable in the Meeting Hall, Mitchell Pauole Center, Kaunakakai, Molokai, on the following:

Amendment to Chapter 302 Special Management Area Rules for the Molokai Planning Commission

1. Section 12-302-26, Special Management Area Rules for the Molokai Planning Commission, is amended to read as follows:

“§12-302-26 Appeal of director’s decision. (a) Appeal of the director’s decision may be made to the commission in writing not later than ten days after the receipt of the director’s written decision. The appellant shall state the reasons for the appeal and submit an administrative fee as established in the county budget. The commission may reverse and remand the decision to the director if the [appellant sets forth facts or law of a convincing nature demonstrating clear error or manifest injustice] substantial rights of the appellant may have been prejudiced because the decision is:

(1) Based on clearly erroneous findings of material fact or erroneous application of the law; or

(2) Arbitrary or capricious in its application; or

(3) A clearly unwarranted abuse of discretion.

(b) Appeal of the commission’s decision may be made to the circuit court of the second circuit as provided for in the commission’s rules and chapter 91, HRS, as amended.” [Eff 8/5/99, am and comp] (Auth: HRS Chapter 91, §205A-49) (Imp: HRS §205A-49)

2. Material, except source notes, to be repealed is bracketed. New Material is underscored.

3. Additions to update source notes to reflect this amendment are not underscored.

4. This amendment to Chapter 302, Special Management Area Rules for the Molokai Planning Commission, shall take effect ten days after filing with the Office of the County Clerk.

The subject public hearing will be conducted in accordance with the Hawaii Revised Statutes, the Maui County Code, and the Rules of the Molokai Planning Commission. Information pertaining to the subject application are on file at the Maui County Department of Planning, 250 South High Street, Wailuku, Maui, the Office of the County Administrator, Mitchell Pauole Center, Kaunakakai, Molokai, and the Molokai Public Library, Kaunakakai, Molokai.

All testimony regarding the subject application may be filed prior to the date of the hearing by providing 15 copies of said written testimony to the Department of Planning or may be presented at the time of the hearing.

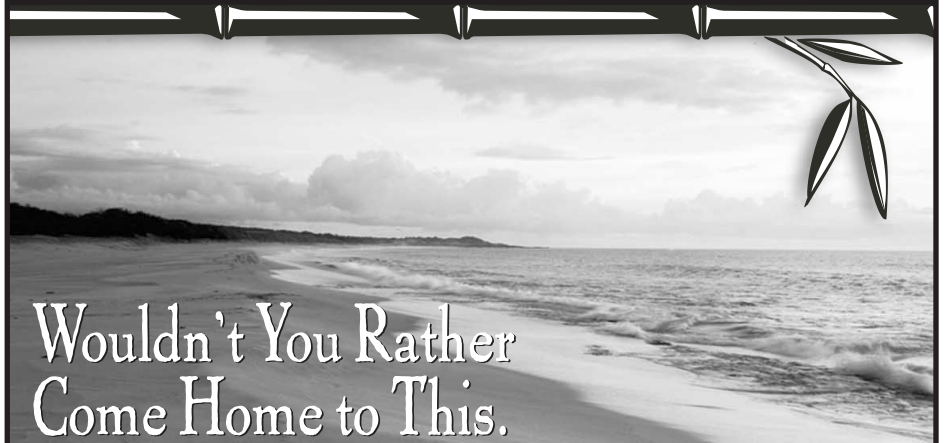
Eddie Aikau Show April 16, KGMB 5 pm

30-minute highlight show of the 20th anniversary Quiksilver In Memory of Eddie Aikau Big Wave Invitational. Staged at Waimea Bay on December 15, 2004, the event was held in epic 20-35 foot surf and was won by Kauai's Bruce Irons.

ALSO, April 19th, at 9 p.m. a one-hour documentary on Aikau's life with never-before-seen footage, Aikau's music, family interviews, photos, surfing footage, and commentary, 'Eddie Aikau - Hawaiian Hero' will air a second time on Saturday, April 30th, at 9 p.m.

Born in Kahului, Maui on May 4, 1946, Aikau was the third of six children. After the Aikau family moved to Oahu, Aikau became one of Hawaii's most respected big-wave riders, most notably at Waimea Bay, where he was also the appointed lifeguard. Aikau saved countless lives on Oahu's treacherous North Shore, but sadly lost his own during the ill-fated 1978 voyage of the Hokule'a double-hull canoe.

His life is celebrated each winter at Waimea Bay in the Quiksilver In Memory of Eddie Aikau Big Wave Invitational and his life story is now presented in Arnone's 'Eddie Aikau - Hawaiian Hero'.

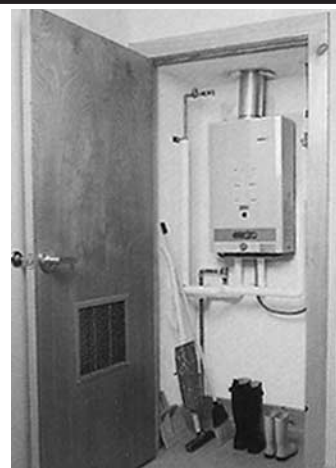
