## Lingle Teaches SOS Parents: How to Be A Dictator



## Lingle Arrests Protestors

Yes, dictator Lingle Lingle who calls herself Governor of Hawaii but acts dictatorially disregarding the Hawaii Constitutional rights of The People, ordered Furlough Friday protestors sitting in at the outer office reception area to the Office of Governor, to be arrested, and two were hauled away in handcuffs.

Who can be against education for the kids? Apparently Lingle is, and that is why parents are angry about Hawaii's shortest-in-the-nation school year aren't giving up on a weeklong sit-in at the governor's office where Lingle avoids them.

Such unConstitutional arrests in Hawaii of peaceful protestors will mean more bad publicity for the state, as Lingle demonstrates her omnipotence and sheriffs do her bidding like good Nazi soliders just following orders instead of putting Lingle under arrest and removing her from office for her criminal behavior.

The latest AP story making its way around the globe reveals the sad situation of Hawaii's educational system while defining Linda Lingle as the key obstacle to getting the kids back in the classrooms: "We know that she holds the power of the purse. She's the one who can release emergency funds to get rid of the furloughs for this school year," said Jill Tao, 45, who has two sons in public school. "We're parents. We're tired of having our children furloughed. We want it done now."

Thirteen days have been lost in the current school year, with four more furlough days slated in the coming weeks.

Another 17 days off are scheduled for the school year that begins in the fall.

So far, 14 people have been issued citations for trespassing, and Lingle on Tuesday warned the protestors they risked arrest if they continued to try to remain in the office lobby overnight.

Later, two University of Hawaii students who remained after closing hours were arrested while eight others were handed trespassing citations, according to protester Marguerite Higa.

On the local news front, David Shapiro's op-ed on the editorial page of the Honolulu Advertiser says Gracious candidate now grumpy incumbent: Lingle's mishandling of sit-in invites all the blame for furloughs.

Dictatorial and unConstitutional acts by Lingle must be arrested. But for now, imagine how much better things might have turned out if Lingle had met with the group to politely listen to their concerns and explain side of the story. And all she has to do is walk out the front door of her office and sit down and talk.

Unfortunately, Lingle remains unwilling to meet with very concerned parents who have demonstrated their commitment to Hawaii's public education with great sacrifice for over a week. Instead Lingle the Dictator orders her soldiers to treat the People like criminals, and violate their liberty under color of law.

Lingle arrests patriotic American parents in Hawaii who are peacefully petitioning for redress of their complaints about education furloughs of teachers. # Washington, D.C. Gets Medical Marijuana

## What will the DEA do now?

The District of Columbia City Council Tuesday unanimously approved regulations for a DC medical marijuana program.

Under the measure approved by the council, DC residents who suffer from HIV, cancer, glaucoma, or a "chronic and lasting disease" will be able to possess up to two ounces of marijuana in a 30-day period after presenting a doctor's recommendation. Patients will not be able to grow their own medicine, but will be able to purchase it through one of five medical marijuana distribution centers. Patients, designated caregivers, and distributors will register with the city Department of Health and be provided with ID cards.

Distributors will be limited to growing no more than 95 plants and must be located at least 300 feet from schools. The original version of the legislation had a 1,000-foot location restriction, but that was reduced after advocates said it would make it nearly impossible to find suitable locations in the city.

"This legislation seeks to avoid problems while assuring the District moves forward with a medical marijuana program that is based on evidence and best practices," said council member David Catania, chairman of the Health Committee.

The measure must be voted on again next month, and then approved by Congress under DC Home Rule law.

## 4/20 Was National Weed Day

Tuesday was 4/20, National Weed Day -- or whatever you want to call it -- and America's Cannabis Nation celebrated it with clouds of marijuana smoke on college campuses and city parks across the land. This year, 4/20 felt a little different, with attendees buoyed by a sense of impending change and the suit and tie wearing movement worriers a little less concerned about how mass pot parties will play with the public. It wasn't just clouds of pot smoke in the air, but the scent of looming increase in freedom and liberty, too, was palpable.

More than 10,000 people rallied in Denver and another 10,000 or so did so 35 miles away at the University of Colorado in Boulder. Hundreds more at the University of California at Santa Cruz celebrated with a mass light-up at 4:20pm. San Francisco's Golden Gate Park hosted thousands more happy puffers, while in Washington, DC, the party was inside. Well-attended 4/20 events also took place in Seattle and Boston, while smaller celebrations took place all across the country, including dozens of college campuses.

This year's 4/20 events come as the sense of momentum toward legalization grows palpable, with a legalization initiative headed for the November ballot in California and polling above 50%. There is a chance the whole West Coast could vote to free the weed this fall.

Prominent drug reform movement leaders like former Seattle Police Chief Norm Stamper of Law Enforcement Against Prohibition (<http://www.leap.cc>) published pieces urging 4/20 celebrators to put down the joint for a moment -- and pick up the pen. 4/20 is not just a party, but a time to stoke activism as well.

I say I hope you will show this same level of excitement and enthusiasm when there is something on the ballot, so they can use marijuana without fear everyday and they should be supporting organizations that will help them. We rely on grassroots support from people who are passionate about the issue, and many of them like 4/20. While we would prefer a more buttoned-down approach, we don't discourage anyone from getting involved in other ways. We just ask that they do so with a focus on what is going to help and improve our chances.

It's great there's a big turnout and people see how diverse it is and how much support there is for changing the law. 4/20 may have come and gone this year, but the sense of imminent victory apparent at the events will linger into the election season. Next year, 4/20 may be about celebrating the first major step toward national pot legalization -- winning a victory in California, and maybe Oregon and Washington, too.

# U.S. Special Forces Committing War Crimes, Coverup

War crimes committed by US Special Forces in Afghanistan: Wake up, Americans! Where is YOUR OUTRAGE ?

It was early morning on February 12, 2010, in the village of Khataba, Afghanistan. A local family was celebrating the birth of a child. Suddenly, gunfire erupted from a nearby rooftop striking two men, two pregnant women, their unborn children and an 18-year old girl. The two men appear to have been killed instantly. The women were injured and bled to death because the gunmen would not allow them to be taken to a local hospital. Other family members were forced out of the home and detained. The gunman were U.S. special Ops troops.

Realizing that they had killed seven innocent people, the Americans immediately began to create what would become a series of false stories and fabricated incidents. They would destroy evidence of this war crime and ultimately attempt to blame the killings on the Taliban. The cover-up was premeditated, intentional and criminal. So far, none of the perpetrators have been prosecuted, with the effect that the civilian death toll has skyrocketed, and this leads to endless recruitment opportunities for the Taliban.

By not demanding that our country's own war crimes be investigated and punished, we become complicit in them, so **SPEAK OUT, AMERICA !**

U.S. Special Operations troops had shot and killed these innocent people.

**Two months later, on April 4, 2010, ISAF issued a news release, apparently drafted by Canadian Brigadier General Eric Tremblay, admitted the following:**

- 1. Its forces had killed two innocent men and three women**
- 2. There had been no fire fight, those killed were unarmed.**

General Tremblay continued obscuring the truth by stating: While investigators could not conclusively determine how or when the women died, due to a lack of forensic evidence, they concluded that the women were accidentally killed as a result of the U.S. Special Ops snipers firing at the men.

Tremblay lies. Obviously, any lack of forensic evidence was solely the result of the U.S. military's refusal to collect such evidence. It had absolute control of the crime scene for more than seven hours.

Mohammed Tahir, the father of the 18 year Gulalai, told investigators that he witnessed American troops taking photographs and he saw one soldier with a knife trying to extract the bullets from his daughter's body. Other witnesses present included Sayyid Mohammad Mal, who is the Vice-Chancellor of Gardez University. His son was engaged to Gulalai.

ISAF officials revealed that the troops involved were American special operations forces and were either from Delta force, or more likely from Navy Seal Team 6. They were operating in Afghanistan under the immediate authority of Vice Admiral William McRaven, Commander of the Joint Special Operations Command. Ultimately the troops were under the command of Admiral Eric Thor Olson, the head of U.S. Special Operations Command, MacDill Air Force Base. Admiral Olson remains sequestered in his Tampa, Florida headquarters.

The evidence is overwhelming that there was a cover-up of these killings. Admiral Olson needs to detail who was involved in this and who knew about it. No official who had any knowledge or complicity in any of the false statements deserves to still be in either ISAF or the U.S. military.

What occurred in the aftermath of these seven killings was a carefully orchestrated cover-up. The level of detail and the number of military officials who would have to be involved, is evidence of a systemic effort to blame the Taliban and others for civilian killings carried out by American special operations troops.

The killings and the cover-up, and the refusal to prosecute those responsible, may fuel the insurgency. On March 26, 2010, The New York Times published an article by Richard A. Opiel. Based on interviews with ISAF officials at Bagram prison, The New York Times was able to confirm that most of the Taliban prisoners in American custody had joined the Taliban to avenge the arbitrary arrests, prison abuses, killings, bombings and other outrages that have been carried out by American and ISAF forces.

Why is there silence from the American Embassy in Kabul. U.S. Ambassador Karl Eikenberry's refusal to speak out regarding this coverup should destroy whatever credibility he has left, and he should be removed immediately.

**Molokai's Forum For Freedom**

**Magistrate Leslie Kobayashi Nominated by Obama to Honolulu Federal Bench**

Here we go again, another fascist anti-gun rights attorney appointed to be a judge: L.E.K.

Barack Obama has named Magistrate Leslie E. Kobayashi [aka LEK appears next to your case number if you let her trespass on your sovereignty] to the US District Court for Hawaii, says an announcement from the usurped White House. If approved by the US Senate, Kobayashi will fill the vacancy created when Chief District Judge Helen Gillmor ascended to senior status last year. Kobayashi, 52, has served as Magistrate since 1999.



Hawaii's leading anti-gun rights criminal Senator Dan Inouye said that "Magistrate Judge Kobayashi is an individual of unquestioned character and a sound choice for the federal bench. Her experience as an attorney and magistrate judge have shaped her legal perspective and given her an eye for justice. I am confident in her ability to preside over the court with fairness and compassion."

Notice Inouye says nothing about whether Kobayashi has ever or will ever support the limitations on government powers defined by the Constitution for the United States of America, or the Bill of Rights, or the Right to Keep and Bear Arms, or to respect the Rights and Sovereignty of We The People. And what the hell does Inouye know about good character? He is a bad example! The only thing Inouye and these judges know is the power of being UNQUESTIONED, because they are TYRANTS and DICTATORS acting under color of law and committing SEDITION against United States Citizens.

"When the Colonies were first settled, attorney was synonymous with the evil Solicitors-General of the Crown and the arbitrary Justices of the King's Court, all bent on the conviction of those who opposed the King's prerogatives, and twisting the law to secure convictions. The king's justiciars were his servants doing his will alone. see FARETTA v. CALIFORNIA, 422 U.S. 806 (1975)

The Constitution for the United States of America the Supreme Law of the Land does not create "justices." Only "judges" are mentioned and the judicial power is vested directly in the ONE COURT.

With the "Fugitive Slave Act" the "commissioners" were created as attorneys to do legally what judges could not do lawfully.

Subsequently, judges have availed themselves of this legality and now the commissioners are called magistrates interchangeable with the corrupted judges as has happened here in Kobayashi's appointment from her status as magistrate.

"Trespass on the Case" is a criminal act equivalent to treason. The court attorneys routinely commit sedition under 18 U.S.C. § 2384.

Prior to her appointment as magistrate judge, Kobayashi was an associate attorney, partner and managing partner with the Honolulu firm of Fujiyama, Duffy & Fujiyama. She also served as a Deputy Prosecuting Attorney in Honolulu from 1983 to 1984. She is a 1983 graduate of the Boston College School of Law. She received her BA from Wellesley College in 1979.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!






