## Hawaii Joins other States in Flying the POW/MIA Flag

National League of Families Prisoner of War and Missing in Action (POW-MIA) flag will now be flown with the U.S. and Hawaii state flags at the state capitol and on the grounds of the headquarters of the state department of defense on certain holidays, per law Act 40 passed April 20.

The bill's intent is to recognize and honor the extraordinary heroism of the brave men and women who risked or sacrificed their lives or their freedom in the past, as well as those who place their lives in harm's way on a daily basis in Afghanistan and Iraq.

The flag will be flown on Armed Forces Day (third Saturday in May); Memorial Day (last Monday in May); Flag Day (June 14); Independence Day (July 4); National POW-MIA Recognition Day (third Friday in September); and Veterans Day (Nov. 11).

Other days, the POW-MIA flag may be flown. At any time, if the U.S. and Hawaii state flags are flown on the same halyard, then the POW-MIA flag must be flown under the Hawaii state flag. If they are on separate halyards, the POW-MIA flag must be flown under the U.S. flag.

## Legislature Protects Crime: passes SB2121, dises SCR91

When criminality becomes a way of life in a society, over the course of time they create for themselves a legal system that authorizes crime and a moral code that glorifies crime. —paraphrased from "The Law" by FREDERIC BASTIAT.

**The final day of the 2010 legislative session resulted in more protection for criminals and other special interests.**

1. Tax increase: The so-called "barrel tax" increases the tax on each barrel of petroleum products by a dollar. The oil tax hike will increase gasoline and electricity costs, with its \$22 million annual proceeds going to the state budget.

2. SB2121 is the shielding complaints from public records law. Complaints against dentists, barbers, doctors and other professionals will be shielded from the public records law unless the complaints are investigated and found against the professional. With few resources in this tight economy, most complaints may remain invisible, valid or not.

3. SB2159 - Raises fees for traffic tickets and violations to \$20 from \$7. SECTION 1. Section 287-3, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows: ...the traffic violations bureaus may collect a fee, not to exceed \$20, of which \$18 shall be deposited into the general fund and \$2 shall be deposited into the judiciary computer system special fund.

4. SB 2650 - Prevents any reorganization of the Department of Human Services. The governor can develop and implement an eligibility-processing operations division pilot project, but only for Oahu.

5. HB 1868 - Prohibits civil service employees who accept an appointed position from returning to their civil service positions more than one year later. Provides an exemption for employees covered by collective bargaining agreements that allow for a longer leave of absence to be granted.

6. Angels' SCR91 A domestic violence resolution designed to make sure judges stick to the law and not grant criminal batterers child custody, got stuck on House Speaker Calvin Say's desk. Judges don't like being told to comply with law, and this technical holdup benefits judges: the letter 'C'. The resolution is an 'SCR' but Speaker Say's office says it should be labeled 'SR' because the House is not involved. SCR91 calls for an investigative child custody task force made up of Senate members, no House members. There are questions though on whether that really makes a difference.

"The survivors are hurt, they're really hurt. If you look at some of the testimony they really put themselves on the line coming forward, going public with some of their stories. So it's disappointing," said Dara Carlin, Angel member.

Sen. Chun Oakland says interested lawmakers will still form the task force, just without the formal legislative stamp of approval. The informal child custody task force is set to have its first meeting at the end of May.

## Does Maui Real Property Tax Collector Own Molokai ?

Landowners and other tax critics in Maui County are telling the Maui County Council members they should not increase property tax rates, and should not lower the homeowners' exemption from \$300,000. And some Molokai residents are questioning under what authority RPTax is imposed on landowners who stand to lose their property if they do not pay the RPTax.

"The Law of the Land is that a right cannot be taxed, and possession of land is a right," concludes Molokai resident George Peabody. He has warned some Molokai residents, and they have successfully removed their property from the County's list of private lands scheduled to be auctioned May 25.

RPTax increases are being considered because, with property values slumping 10%, Maui County is facing a significant decline in RPT revenue, its biggest source of operating revenue. The 2011 budget proposed is \$524 million.

Maui Tea Party President Brett Glass said it was a "misrepresentation" for the county to say that taxes would stay the same or go down at the proposed rates.

John Henry said he is cutting back expenses because his small business is struggling. "I just don't see the same thing happening in our tax system and our government," he said. "I know [County] can find more expenses to cut out."

"Housewife and quilter" Penny Dant said lower taxes is the only way to get out of the recession. Tony Fisher advocated changing the system from taxation on current market value, to taxation on the original sales price, because the current system penalizes the long-term resident as property values go up over time.

Homeowners are facing a property tax rate increase being considered by the council up to \$2.50 per \$1,000 of a property's assessed value (now at \$2).

### Dear RPT and Maui County Councilmembers:

The assessment methods and the RPT itself are unconstitutional and in violation of the Hawaii State Constitution, and the Constitution for the United States of America because the right to own property is a RIGHT, and a right cannot be taxed. The RPT Division cannot show me therein any valid authority for such Real Property Taxation and methods of assessment and you are therefore precluded from such action. 18 USC 01, and 247, and extortion 18 USC 872, and 873 and fraud 18 USC1341.

Furthermore, Real property taxes are antithema to the concept of sovereign individuals in a free society. We are Sovereign individuals in the United States of America, therefore I cannot lawfully be required to pay real property taxes, and fees for exercising my rights to acquire and possess property, a right guaranteed by the Constitution for the State of Hawaii, and the United States of America, and a Right shall NOT be TAXED is the LAW.

We are Sovereigns who own land in "allodium." That is, the government does not have a financial interest in the my land, nor any authority to impose real property tax by which they claim my land. Only those enumerated powers granted to the government agents as stated in the Constitution for the United States of America are the limits of powers that public servants must to follow to insure the rights of Sovereigns, We The People.

Pursuant to the United States Constitution and the Hawaii Constitution, the owner of private property has a protected right to own, enjoy and/or sell his property. This understanding is one of the foundations on which our liberty is based. As James Madison wrote, "As a man is said to have a right to his property, he may be equally said to have a property in his rights."

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. THAT TO SECURE THESE RIGHTS, GOVERNMENTS ARE INSTITUTED AMONG MEN, deriving their just powers from the consent of the governed. Therefore we see that the ONLY PURPOSE of government is TO PROTECT OUR RIGHTS. Furthermore, the consent of the governed is necessary, i.e., government must be operating on the authority delegated from the individual whose rights are to be protected. I have never granted to anyone the authority to tax my property.

This precludes anything not in the category of "protecting our Rights"-- and, of course, ALL rights are INDIVIDUAL Rights. And it certainly precludes "real property tax" by which county government bureaucracies are illegally and unConstitutionally financed today. I either own my property, or [ see page 2 ]

### Dear RPT and Maui County Councilmembers:

.....continued from page 1: .....I either own my property, or I rent it from the government, purchasing only the privilege of occupying said property. I hereby declare that I own my property, so **do not tread on me.**

But with your unConstitutional Real Property Taxation, if I don't pay your property tax, the government will remove me from my property just as the landlord would remove me from an apartment if I did not pay the rent for which I have voluntarily contracted. But I never contracted with Maui County to pay RPT. Do I really own the land if someone can take it away from me simply because I don't pay them for the use of my own property? You have no jurisdiction to impose any tax on my private real property!! See the UCC 1-308, reserving all rights to me.

The Constitution declares that a capitation tax is a direct tax; and, both in theory and practice, a tax on land is deemed to be a direct tax.

Is Real Property tax a direct tax? For, if it was not a direct tax, it was admitted to be rightly laid, within the first clause of the eighth section of the first article of the Constitution, which declares 'that all duties, imposts and excises, shall be uniform throughout the United States:' But it was contended, that if it was a direct tax, it was unconstitutionally laid, as another clause of the same section provides, 'that no capitation, or other direct, tax shall be laid, unless in proportion to the census, or enumeration, of the inhabitants of the United States.' If it be a direct tax, it is unconstitutional, because it has been laid pursuant to the rule of uniformity, and not to the rule of apportionment.

"To lay with one hand the power of government on the property of the citizen, and with the other to bestow it on favored individuals... is nonetheless robbery because it is done under the forms of law and is called taxation." - U.S. Supreme Court -- Loan Association v. Topeka (1874).

Now, Maui County Councilmembers, do you respect the LAW ?

And furthermore, we people owe no county or city or State or Feds anything for our owning our homes and allodial rights to land, because no Right can be taxed nor a fee required to exercise any Right. RPTax is fraud and violates a multitude of constitutional provisions, both state and federal, along with dozens of state and federal statutes to force we Sovereign people to pay any penalty such as real property tax for exercising our right to own property and home.

Furthermore, the only being other than the owner with proprietary interests in land is the Creator. Thus, we Sovereign people have allodial rights, not the government. (See USC Title 42, Section 1982) In fact, government seldom has proprietary interests, as government in fact owns nothing.

Why do you lose your home to property taxation? Because taxation is slavery. Slaves do not own anything, and we are all slaves according to the present regime who are taxing everything, even our homes!

Our Constitution does not allow such tyranny! And we must NOT relent to it. "But, when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them [we people] under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security." -- Unanimous Declaration of Independence July 4, 1776

We people must live and die as Free and Sovereign, or die as Slaves to taxation tyranny and treason.

Therefore, as a Sovereign Individual, I protest these so called Real Property Taxes, as they are obviously an illegal RICO operation. Councilmembers must have taken an Oath to uphold the Constitution and therefore each of you must stop your RPT illegal RICO activity, or you are liable in both your official capacity and your personal capacity, and I reserve my rights to an action at law against each of you, if necessary.

Instead of RPTaxation Slavery, just send me a Bill for Services!

Governments rationalize property taxes by saying that the money is needed for government services such as police, fire, schools, roads, etc, and that RPT is a convenient way to collect the funding, i.e., the end justifies the means approach to government funding. But that is no excuse because the government can send a bill for services to each Sovereign and free person without encumbering real property and making us slaves in our own homes without any rights even to own property.

THEREFORE, it is obvious that no justification exists for Real Property Taxes against free and Sovereign people, because the County can send a bill for services provided by the City's public servants to each Sovereign person instead of making us slaves in our own homes via the unConstitutional and evil Real Property Tax. ## Does Dunbar Own Kainalu? Warning Letter Sent to DLNR

DUNBAR Kainalu Forest Watershed Acquisition, Phase II (Maui County, HI) \$1,500,000. This grant provides additional funds to Kip Dunbar for the acquisition of a perpetual conservation easement over 614 acres of forestlands on the eastern end of the Island of Molokai at Kainalu Ranch.

But a question of ownership has been sent with documentation to warn the State DLNR and federal funding sources that Paul Kauka Naki-Cullen et al of the Naki Ohana is claiming ownership stemming from Royal Patents records.

### WARNING NOTICE of Possible State Complicit in FRAUD Land Titles and GRANTS

Dear Laura Thielen, DLNR, Linda Lingle, et al:

**BEWARE:** There is significant evidence of **FRAUD** in land titles regarding Molokai watershed forestry 614 acres claimed by one Kip Dunbar dba Kainalu Ranch et al and \$1.5 million grant for an easement over lands he claims under fraudulent LP3730. From federal Fish and Wildlife Services notice, to wit: "DUNBAR Kainalu Forest Watershed Acquisition, Phase II (Maui County, HI) \$1,500,000. This grant provides the additional funds necessary for the acquisition of a perpetual conservation easement over 614 acres of strategic watershed on the eastern end of the Island of Molokai'i. Stretching from the summit almost to the ocean, this connected parcel follows the traditional Hawaiian land delineation and management system or ahupua'a...."

The 614 acres in question is part of RP1140 to Daniela Napela, and that land title follows down our genealogy and heirs of today of the Naki Ohana living on Molokai, one Paul Kauka Naki-Cullen et al. Contrast this truth to the claims of Dunbar et al using corrupt Land Pat 3730 which is a fraudulent title because Sam Kekoowai the real heir to these lands NEVER conveyed title and the records included with this WARNING NOTICE even show certified that Kekoowai did NOT participate in any of the recorded but fraudulent documents and land transfers and power of attorney assigns.

These lands belong to heirs of Daniela Napela from Royal Patent 1140, and a lawsuit to Quiet Title to these lands is soon to be filed based on RP1140 and the genealogy of my family who are the rightful owners of these Ahupuaa. A similar lawsuit is pending now in Maui 2nd Circuit Civil No. 05-1-0148 [1], to protect the land rights of our Naki Ohana, which I, Paul Kauka Naki-Cullen, do solemnly swear and affirm under the laws of the United States of America in accordance with 28 U.S.C. § 1746 that the DECLARATION of TRUTH and FACTS, and the New Evidence in support of my statements and claims, are all true and correct to my personal knowledge, information presented, and sincere belief.

Therefore: Please do NOT become complicit in FRAUD; respect my landowners' rights.




