Theft Charge for Moloka'i TSA Screener

The THIS IS WHY WE SUFFER from TSA/HOMELAND SECURITY?

A Transportation Security Administration employee has been charged with felony theft after he allegedly stole \$16,000 from the backpack of a visitor at a Moloka'i airport checkpoint, according to a criminal complaint filed in U.S. District Court yesterday.

Michael Gomes is charged with a single count of acting as a government employee to "wrongfully convert to his own use money and property of another having a value of greater than \$1,000," according to the complaint.

Gomes, a screener, was terminated from his job on Tuesday, the TSA said. He is the third TSA screener to be charged with felony theft by federal authorities this month.

On March 3, Benny Arcano and Christopher Cadorna were charged in a complaint with felony theft for allegedly stealing yen valued at more than \$1,000 from the suitcases of Japanese tourists during 2004 and 2005.

Both men are scheduled to enter pleas before U.S. Magistrate Judge Barry Kurren today at 10 a.m.

Nico Melendez, a TSA spokes-man based in California, declined yesterday to comment on the charges but said that TSA has "a zero-tolerance policy for theft."

In Gomes' case, an Island Air passenger flying from Moloka'i to Honolulu reported to TSA on Feb. 8 that an envelope containing \$16,000 in cash that was stuffed into a backpack and sealed in a cooler was missing, according to the complaint.

Special Agent Keith Edwards of the TSA Office of Inspection and Investigations learned that Gomes was the only screener assigned to search checked baggage at the time the passenger checked his luggage in on Moloka'i.

Gomes told Edwards he took the money after searching the man's baggage and had spent \$2,500 paying off personal bills, according to the complaint.

The rest of the money, \$13,500, was being kept in his house, Gomes told investigators, according to the complaint. Gomes eventually turned the money over to Maui County police, who are responsible for law enforcement on Moloka'i.

In a statement, U.S. Attorney Ed Kubo said federal employees must be held to a higher standard.

"We're very intent on showing that anybody who has a position of public trust will be held to a higher standard and if they attempt to take things, that type of corruption will be dealt with harshly in federal court," he said yesterday. "The public's focus should be on the great work of the overwhelming number of TSA employees in Hawai'i. I don't think a few bad apples should ruin the perception for the entire bunch."

Assistant U.S. Attorney Ron Johnson, who is prosecuting the case for the government, declined comment yesterday.

Terror Watch Lists Trips up Marine's Homecoming from Iraq

Twenty-six reservists returning to Minnesota from Iraq are forced to leave a comrade at the Los Angeles airport because the government had put his name on a list of potential terrorists.

Marine Staff Sgt. Daniel Brown has just spent the past eight months serving his country in Iraq, only to return to the United States and find out his country had placed him on a watch list as a possible terrorist.

A ceremony was waiting Tuesday at home in the Twin Cities for Brown and 26 other Marine military police reservists returning from the war. But Northwest Airlines wouldn't let him on the plane in Los Angeles. His name was flagged on a federal no fly list.

As he worked with airport staff to gain permission to fly, the other 26 Marines arrived back in Minnesota on schedule. But rather than meet up with their families located just minutes from the Minneapolis-St. Paul International Airport, they opted to wait on a bus. "We don't leave anybody behind," said Marine 1st Sgt. Drew Benson. "We start together, and we finish together."

Brown eventually got on another plane, but obviously TSA is a fascist police state operation that does nothing to make America safer or the skies more friendly. It was created with Homeland Security and the Patriot Act on the basis of lies about 9-11.

Arrested for Self Defense Hawaii?

Police screwed up again, arresting a man on Oahu for defending himself.

A 25-year-old Makiki man was arrested by police March 19 in a homicide investigation of a fatal stabbing inside his residence.

Lt. Bill Kato said the arrested man told police he and his girlfriend did not know the stabbing victim, or why he was at their apartment, who had forced his way into their apartment and shoved her down. The man grabbed a kitchen knife and stabbed the intruder in the chest. He was released pending further investigation.

The medical examiner's office identified the dead man as Gregory Hunter, 26, died of injuries to the heart and lung due to a stab wound to the chest.

The city prosecutor's office will not pursue charges, saying the man acted in self-defense. Peter Carlisle said the man "was justified in the use of deadly force to protect himself and his girlfriend from death or serious bodily injury. In my opinion, it was a very easy call."

Under Hawai'i law, the man was justified in defending himself, Carlisle said, although police did arrest him on suspicion of murder then released him pending further investigation.

[The MAN notes: Law-abiding citizens have the choice to defend themselves and their families in the face of attack without fear of criminal prosecution and civil litigation. The "Castle Doctrine" removes the "duty to retreat" if an individual is attacked in his or her home, vehicle, place of business, or any other place he or she has a legal right to be; furthermore, victims of violent crime may use necessary force to defend themselves against the attacker. So police were wrong to arrest the victim!]



New Orleans Mayor Renegs on Gun Rights

Law-abiding citizens of New Orleans who were forced to relinquish their legally owned firearms to the New Orleans Police Department (NOPD) will have to wait, indefinitely, to regain their property. New Orleans officials revealed they have not returned any firearms, as Mayor Ray Nagin and the city have yet to set up a return process.

"Mayor Ray Nagin continues to deny freedom by denying lawful citizens their Second Amendment rights," stated NRA Executive Vice President Wayne LaPierre. "First, he confiscates law-abiding citizens' firearms and lies about it. Then, he fails to comply with court orders. Now he refuses to return the legally owned firearms to their rightful owners by dragging his feet. It's a disgrace."

After denying the illegal confiscation for months, on March 15, 2006, Mayor Nagin and the NOPD conceded in federal court that they do have seized guns stored in locked steel containers. The city then agreed in court to a process by which law-abiding citizens may file a claim to receive their illegally confiscated firearms.

However, a New Orleans official handling the gun confiscations stated that no guns have been returned because the NOPD requires background checks, and the city has not set up a process. The official acknowledged, "We've been told it was going to happen weeks ago and still hasn't been done."

NRA-ILA Executive Director Chris W. Cox stated, "During a time of chaos and lawlessness, Ray Nagin took away the only means of protection law-abiding citizens had, and by delaying necessary and appropriate action to right this wrong, he blatantly continues to disrespect New Orleans citizens. The Mayor's contempt of court, his contempt of the Second Amendment, and his disrespect of the law-abiding gun owners of New Orleans is shameful."

Crimes of Politicians Must Be Stopped by The People (You are The Militia)


