## GMO and Round Up Damage Crops, Livestock, and People

Don M. Huber, Professor Emeritus, Purdue University wrote to Secretary Vilsack for a very simple reason: we are experiencing a large number of problems in production agriculture in the U.S. that appear to be intensified and sometimes directly related to genetically engineered (GMO) crops, and/or the products they were engineered to tolerate - especially those related to glyphosate (the active chemical in Roundup® herbicide and generic versions of this herbicide). We have witnessed a deterioration in the plant health of corn, soybean, wheat and other crops recently with unexplained epidemics of sudden death syndrome of soybean (SDS), Goss' wilt of corn, and take-all of small grain crops the last two years. At the same time, there has been an increasing frequency of previously unexplained animal (cattle, pig, horse, poultry) infertility and spontaneous abortions. These situations are threatening the economic viability of both crop and animal producers.

Incidence of high infertility and spontaneous abortions in the various animal species is becoming more common. Often, all previously known causes of these conditions can be ruled out as factors for these particular farm operations (Attachment 2). Detailed examination for the newly recognized organism has shown its presence in all of the cases examined to date. Koch's postulates have been completed for animals to verify the cause/effect relationship with this newly culturable organism. A search for the source of animal infections revealed a high population of this newly discovered electron microscopic sized organism in soybean meal and corn products. The organism appears compatible, and probably synergistic, with other microorganisms such as *Fusarium solani* fsp. *glycines*, the cause of SDS of soybeans and also with gram positive bacteria. The organism also is in a very high population in Goss' wilt infected corn caused by the gram positive bacterium *Clavibacter michiganensis* subsp. *nebraskensis*.

Although most corn hybrids have been genetically resistant to Goss' wilt, preliminary research in 2010 demonstrated that the application of glyphosate herbicide, or the surfactant from glyphosate formulations, nullified this resistance and rendered them fully susceptible to this pathogen (Fig. 1). This disease was commonly observed in many Midwestern U.S. fields planted to RR corn in 2009 and 2010, while adjacent non-GMO corn had very light to no infections in spite of the high inoculum present in no-till crop residues (Figure 2). The increased Goss' wilt in 2010 was a major contributor to the estimated almost one billion bushels of corn 'lost' last year (based on USDA August estimated yields and actually harvested crop reported by USDA in January) in spite of generally good harvest conditions.

Increased severity of plant diseases after glyphosate is applied (Fig. 3) is well documented and, although rarely cited, the increased disease susceptibility is the herbicidal mode of action of glyphosate (Johal and Rahe, 1988, 1990; Johal and Huber, 2009; Schafer et al, 2009, 2010). The loss of disease resistance in Roundup Ready® sugar beets when glyphosate was applied prompted researchers at the USDA sugar beet laboratory to include a precautionary statement in their paper, e.g. "Precautions need to be taken when certain soil-borne diseases are present if weed management for sugar beet is to include post-emergence glyphosate treatments" (Larson et al, 2006).

The loss of genetic resistance in Roundup Ready® corn hybrids to Goss' wilt (*Clavibacter michiganensis* subsp. *nebraskensis*) (Figs. 2, 3), synergistic relationship of the newly recognized electron microscopic organism causing infertility and abortions in animals with gram+ bacteria, and high populations of the new EM organism in RR corn leaves and silage creates a concern for the deregulation of Roundup Ready® alfalfa which is productive in many areas only because of its genetic resistance to bacterial wilt caused by *Clavibacter michiganensis* subsp. *insidiosum*. This disease could make alfalfa unprofitable for production and, if the EM organism is associated with it in alfalfa as it is in corn, also unsafe for animal feed and their products such as milk for human consumption. The loss of alfalfa, the United State's most valuable forage crop and fourth most economically important crop, could strike a mortal blow to struggling dairy and beef operations.

Extensive research has shown that this potent tool for weed management, glyphosate, is also a strong immobilizer (chelator) of essential plant nutrients to impair nutrient uptake, translocation, and physiological efficiency at only a fraction of the labeled herbicidal rate (Ekers, Ozturk, Cakmak, Zobiolo, Jolly et al., 2004). Glyphosate is a powerful biocide to harm beneficial soil organisms important for nutrient recycling, N-fixation, nutrient availability, and natural disease control (Kremer & Means, Zobiolo et al, Dick et al) with a resultant increase in diseases of corn, soybeans (Fig. 3), wheat and other crops. The close relationship between mineral nutrition and disease severity is well documented (Datnoff et al, 2007). These activities can have deleterious effects on plant nutrition, disease susceptibility, and nutritional quality of the crop produced.

Deleterious effects of GM crops also are vividly demonstrated in reports from livestock producers in the U.S. Although some of these reports are anecdotal because of limited analytical techniques to verify the cause, some producers have been able to resume economical operations by changing feed sources to non-GMO crops. Replicated independent research is needed in this area, especially in light of the serious toxicological concerns raised recently that show potential human and animal toxicity from very low levels of residual glyphosate in food/feed that are many times lower than permitted in U.S. food and feed products (Seralini et al., 2011). The recent Indian Supreme Court's independent analysis and Ruling that GMO egg plant posed a significant health risk to humans needs further evaluation in the U.S. (AgroNews, 2011).

Based on the scientific evidence currently accumulating, I do not believe it is in the best interests of the agricultural producer or consuming public for regulatory agencies to approve more GMO crops, particularly Roundup Ready® alfalfa and sugar beets, until independent research can establish their productivity when predisposed to potentially severe diseases, the irrelevance of the new EM organism, and their nutritional equivalency. In my letter, I asked the Secretary to allocate the necessary resources to do this, and requested that he exercise the utmost caution in deregulating these crops until such findings resolve the concerns expressed in the letter, if they do.

## Could You Protect the Justice System, Punish Crooked Attorneys & Judges? Hawaii Supreme Court Wants Molokai Disciplinary Board Applicants by April 30

The Hawaii Supreme Court needs non-attorneys from Molokai to be applicants to fill six non-attorney positions on the Hawaii Supreme Court's Disciplinary Board that punishes bad legal professionals, and investigates allegations of attorney misconduct and incapacity.

The new terms are due to begin on July 1 and last for three years. The positions are not compensated, but the judiciary reimburses board members for their travel costs. The judiciary is seeking applicants from Molokai and statewide.

The application deadline is April 30. Send a letter stating why you want to serve on the Disciplinary Board, and your resume to: Mr. Gayle Lau, Nominating Committee, Hawaii Supreme Court Hawaii, PO Box 26436, Honolulu, Hawaii, 96825-6436.

Complaints about attorneys from Hawaii residents are routinely dismissed or ignored because Board members are in cahoots with attorneys. The only time punishment is administered is when too much embarrassment for the Hawaii Bar Association and Judges is the result of criminal behavior or practices that cannot be swept under the rug. Punishment is usually minor and just a PR scam.

Recent example of lax enforcement of protections and punishment comes from a Big Island case: Civil No. 08-1-0426 ICA No. 30730, EWM Investments v. Brian Kaniela Naeole. Maui attorney Thomas Leuteneker representing the EWM Investments was sanctioned "five hours of pro bono services" for lying to the Court about why he failed to file a pre-trial statement instead of the Motion to Set Aside Order of Dismissal, according to legal papers on file. The dismissal favored defendant Naeole against EWM Investments. Rule 6 of the Hawaii Rules of Professional Conduct provides for sanctions against attorneys.

By his own words, according to the REPLY BRIEF on file, "...Mr. Leuteneker admits to untimely filing [14 days from order of dismissal] a Motion to Set Aside Order of Dismissal...."

Naeole's brief states that "MR. Leuteneker's reliance on section [t] of Rule 12 in furtherance of his deceptions reeks of desperation. In his desperation to cover up his willful bad behavior, Mr. Leuteneker would have this court believe that section [t] allows the lower court to exercise jurisdiction it no longer has because he failed to comply with the rules...is both desperate and absurd."

"For too long, Rule 56 of the Rules of Civil Procedure has been used to deny Hawaiians, especially those without means and skills, full and fair opportunity to protect their rights to the "sacred inheritance of their Kupuna" [their aina]..."

"This court [ICA] should, indeed it must, a) send this case back to the lower court with orders to correct its error and reinstate its order of Dismissal. b) Sanction Mr. Leuteneker in order to discourage others like Mr. Leuteneker from engaging in similar misconduct and c) admonish the lower court for encouraging misbehavior by its officers." [attorneys & judges & clerks, et al]

## Hawaii Tax Protests!

A legislative hearing on several different tax increase proposals attracted scores of people to a hearing in the state Capitol auditorium.

Senate Ways and Means has put a two-year increase in the statewide general excise tax, from 4 percent to 5 percent, into a massive tax reform bill, which also includes reducing exemptions to the tax enjoyed by construction, shipping, airline and small businesses. The tax increase proposal includes increased tax credits designed to ease the tax burden for lower-income families.

Lowell Kalapa, of the Tax Review Commission of Hawaii, opposed both ideas, saying either way the cost of the tax would be passed on to consumers or would increase the cost of doing business and force some businesses to close.

But Alan Johnson, chief executive officer of Hina Mauka, a nonprofit substance abuse agency, said cutbacks in state funding have led to many people needing drug treatment being placed on wait lists. He said the cutback of treatment funds can lead to other costs to government, including law enforcement and incarceration costs when a drug addicts commit crimes.

The various tax increase proposals, together with spending reductions on items including state worker payroll, health benefit and retirement costs, and a new tax on pension income, will be negotiated by House and Senate into a state budget for the remainder of this fiscal year.

## New Akaka Bill ?

Believe it or not! US senators to consider "New" Akaka bill

U.S. Senate Committee on Indian Affairs is holding a meeting to consider legislation granting federal recognition of a Native Hawaiian government.

Sen. Daniel Akaka of Hawaii said if approved, the measure would advance to the full Senate. Akaka said it's his priority to put Native Hawaiians on equal footing with Native Americans and Alaska Natives.

Similar legislation failed to get a vote in the Senate last year following 11 years of efforts by Akaka to get it passed.

## Wind Power for Oahu Scam! Stop SB367 at the Hawaii Legislature, now!

There's a bill that needs to be stopped: SB367, which would dip into our pockets for the profit of Big Landowners. We need to change the direction that the state is moving in—and return power to the people instead of big moneyed interests. There are alternatives to the Neighbor Island wind project—in fact, alternatives that will produce continuous energy and don't need those long, expensive undersea cables.

I'm not sure that HECO customers understand that they will be on the hook for the costs of the proposed undersea cables to bring Neighbor Island power to Oahu. And not just Oahu ratepayers, but all HECO customers.

It is not just Honolulu's electricity customers who will share the as-yet-unannounced costs of this \$1 billion cable. As the legislation is currently written, all HECO ratepayers would share in these costs - including those residents of Lanai and Molokai who, while not receiving any of this wind-generated power, will share these costs as they see their home islands become an industrial wind power plant for Oahu.

Despite HECO's claims to the contrary, SB367 does not balance risk. It allocates that risk - and all recovered costs - onto ratepayers.

SB 367 SD3 HD1 would create a PUC regulatory structure for undersea cables whereby ratepayers would carry all of the risk and the utility would make all of the profit.

Last year the Public Utilities Commission (PUC) ruled that both FirstWind (Moloka'i) and Castle & Cooke (Lana'i) had to file with the PUC by March 18, 2011 term sheets laying out the cost of wind energy.

FirstWind defaulted and did not file a timely excuse. Almost 2 weeks late, FirstWind asked for an 8 month extension.

\* The argument that Big Wind is the only answer is also in dispute. The Big Wind EIS Preparation Notice said that there are two alternatives, Big Wind with planning and Big Wind without planning.

Numerous comments to the EISPN challenged this.

DBEDT Office of Planning (March 1, 2011): "it is necessary for the draft EIS to explore alternatives"

US Environmental Protection Agency (Feb 28, 2011): "We recommend analysis of additional alternatives as early as possible"

Rather than rush thru a bad piece of legislation, we should wait until it has been determined whether Big Wind makes sense, and if so, under what conditions.

The state's energy direction should not be determined by those big companies that will profit while passing the risk on to the rest of us. Some have described this as "privatized profit and socialized risk," though I'm not too fond of the phrase.

There are alternatives that languish while this Neighbor Island wind project advances in the Legislature. In the next article, I'll mention what's happening with some tidal power projects elsewhere. Note that wind power is intermittent.

Aside from the problems with the undersea cable proposal, we need to keep in mind that there are alternatives, many of which could make much more sense for Hawaii. Tidal power, wave power and Ocean Thermal Energy Conversion (OTEC) provide continuous power. They are also out-of-sight and don't meet with NIMBY objections nor ruin Hawaii's attraction for tourists or make life miserable for residents.

Finally, this wind project may not be producing for some time. More from the Maui News article:

What is not clear is when the cable (or the Neighbor Island wind power plants) would be completed. DBEDT often suggests 2014, but its partner, the U.S. Department of Energy, has said 2020 in public meetings.

We could be stuck with it and paying for it while better alternatives could have come on line in about the same time frame.

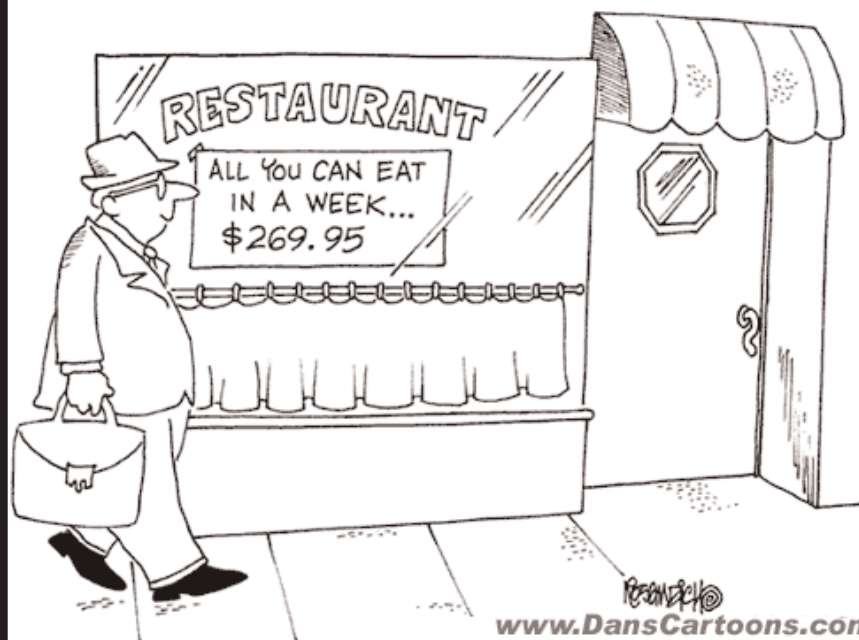
