Vote Coming on Obama's Radical Left-Wing Ideologue Nomination to Fed Judge Gunowners' Rights Threatened, Again! Money buys Obama-appointments!

Any doubt that President Obama is more anti-Second Amendment than perhaps any president in history can be laid to rest in the light of the characters he has nominated to the federal judiciary.

Obama's latest nominee for a U.S. District Court post is John McConnell, a Providence, Rhode Island, trial lawyer. In terms of being an activist for the far left, McConnell is right in line with Obama's Supreme Court picks—Justices Sonia Sotomayor and Elena Kagan.

It comes as no surprise that leading gun control proponents in the Senate support McConnell: he has contributed hundreds of thousands of dollars to liberal, anti-gun candidates over the years, including Obama and Rhode Island's two senators.

In fact, it appears that McConnell's chief qualifications for this post are his generous contributions to liberal candidates and his long relationship with former Rhode Island attorney general and current Senator, Sheldon Whitehouse.

However, even in a world where political backers are often selected to fill openings for judgeships and other federal jobs, the size of McConnell's contributions sets him apart from other nominees. In 2008 alone, for example, McConnell gave over \$120,000 to Democrat candidates.

He also served as treasurer of the Rhode Island Democratic State Committee, which raises the question of whether he could serve impartially on the federal bench.

McConnell's views on the Constitution are also extremely troubling. In written questions that were part of McConnell's confirmation hearings, Senator Tom Coburn (R-OK) asked the nominee if he believed the Second Amendment and the Bill of Rights protected fundamental rights. McConnell responded evasively and refused to declare what he considered to be fundamental, individual liberties.

Of course, McConnell repeatedly insisted that he would be "bound by applicable Supreme Court and First Circuit precedent" on Second Amendment issues. But nothing in the Heller and McDonald decisions necessarily preclude an anti-gun ideologue from ruling that almost any gun law short of a total ban on firearms—including gun owner registration, purchasing limits, waiting periods, private sale background checks, and more—is consistent with the Constitution.

Obama Birth Certificate Just Does Not Fit, and raises more questions that lead to only one conclusion: Obama is NOT Constitutionally qualified to be POTUS, and he has committed FRAUD to usurp the Usurp the Office

For instance, the state of Hawaii's former Health Department chief Chiyome Fukino is the one official who, back when Obama's long-form birth certificate was guarded more securely than the nation's nuclear launch codes, supposedly examined the mysterious document and reported back to the state's governor, and to the nation, that the president did indeed have a birth certificate and she had seen it!

But just two weeks before Obama finally released his "birth certificate," Fukino was interviewed by NBC News' national investigative correspondent Michael Isikoff, who reported that Fukino told him she had seen the original birth certificate and that it was "half typed and half handwritten."

Problem: The document released with great pomp and ceremony by the White House was entirely typed. Only the signatures and two dates at the very bottom were "handwritten." What Fukino described was clearly a different document. But don't yell at WND for that "paranoid birther" story – you can thank NBC for that one.

Meanwhile, more questions are surfacing about the Obama birth certificate that was supposed to end all the controversy. (Remember, before April 27, only 38 percent of Americans believed Obama was telling the truth about his birth.)

For starters, Jerome Corsi, WND senior staff reporter and author of "Where's the Birth Certificate" (which hit No. 1 on Amazon's bestseller list a full month before its upcoming May 17 release), has spent the last week investigating the matter in Hawaii. It turns out a private detective in Honolulu claims employees of the state Department of Health forged three Hawaiian birth certificates for Barack Obama to "screw with birthers." And one of them is a dead ringer for the document released by the White House.

Then there's the question of why the right-hand margin of Obama's official Hawaii birth certificate includes the very same tell-tale scribbles found in a clearly fraudulent document posted on the Internet about a year ago – a "Hawaii" document that alleged he was born in Kenya.

Then – reminiscent of the blogger analysis that sacked Dan Rather for trying to pass off a document clearly created in the age of computers as a decades-old typewritten record – two Web document experts reveal various anomalies in the Obama birth document, including a trick typewriters are incapable of performing.

All that is new on WND this week. And the coming days will see even more questions, revelations and contradictions that demonstrate the issue of Barack Obama's legal eligibility to be president of the United States is still very much alive – just as national polls taken AFTER his April 27 document release prove.

When it comes to Obama's birth certificate, right now Americans have basically two choices:

1. Believe that Barack Obama – after years of toying with the America people, millions of whom according to polls doubted his official nativity story and wanted the truth regarding his birth, his past and his loyalties – was simply playing games with the public, allowing military heroes to go to prison, allowing millions in tax dollars to pay lawyers to block release of his birth certificate, and so on, all for some craven political advantage.

2. Believe that there may have been a real reason Obama adamantly refused to release his birth certificate for years – because he had something real to hide, and still does. And that perhaps the latest birth certificate – a copy of a copy of a document, posted on the Internet like the last one – is fraudulent.

Neither choice is very palatable to center-right America that wants a president who is both honest – and legal. Stay tuned.

Effective January 24, 2003, the Bureau of Alcohol, Tobacco, Firearms and Explosives (BATF) was transferred under the Homeland Security bill to the Department of Justice. The law enforcement functions of ATF under the Department of the Treasury were transferred to the Department of Justice. The tax and trade functions of ATF will remain in the Treasury Department with the new Alcohol and Tobacco Tax and Trade Bureau.

Crimes of Politicians Must Be Stopped by The People (You are The Militia)



Bin Laden's Son criticised Obama for Arbitrary Murder



Osama Bin Laden [54] was unarmed when he was Murdered in Cold Blood by US SEALS last week, and his son is angry.

The sons of Osama Bin Laden have criticised the US authorities for carrying out his "arbitrary killing".

A statement given to the New York Times newspaper said the family wanted to know why the al-Qaeda leader had not been captured alive.

Relatives who survived the 2 May raid in Pakistan should be freed, it said.

Another statement appeared on a jihadist website saying the burial of Bin Laden at sea "demeans and humiliates his family".

Osama Bin Laden was shot dead by US special forces during a raid on his home in the Pakistani town of Abbottabad.

The statement printed by the New York Times was attributed to Bin Laden's fourth son, Omar Bin Laden, who has repeatedly distanced himself from his father's ideology.

The statement said that in absence of a body or photographic evidence, the family were not convinced he was dead.

But if he was dead, it said, they were questioning "why an unarmed man was not arrested and tried in a court of law so that truth is revealed to the people of the world".

Humiliation

They argue Bin Laden's killing had broken international law and that figures such as former Iraqi President Saddam Hussein and Serbian President Slobodan Milosevic had been given the chance to stand trial.

"We maintain that arbitrary killing is not a solution to political problems and crime's adjudication as justice must be seen to be done."

The family said they were demanding an enquiry into why Bin Laden was "summarily executed without a court of law" and demanded the release of his three wives and several children, who are believed to be in Pakistani custody.

The statement also said the US decision to bury Bin Laden's corpse at sea had deprived the family of performing religious rites.

It said US President Barack Obama was "legally responsible" for clarifying "the fate of our father" and that the sea burial "demeans and humiliates his family and his supporters".

The CIA said it did not tell Pakistan about the raid in advance over fears it would jeopardise the mission. unilateral criminal action ordered by Barack H. Obama for public relations show time and look like a hero: Obama Murdered Osama! Our hero ?

in Laden, aged 54, was the founder and leader of al-Qaeda when he worked for the CIA. He was accused by President W. Bush et al to have ordered the two airplane attacks on New York Twin Towers [and Bldg 7] and Pentagon on 11 September 2001, as well as a number of other deadly bombings, all of which Osama Bin Ladin denied.
