## New “Landfill” site Consolidates Future Trash by Mount Opala But, Metals Rejected Appear in “Secret Places”



Molokai residents, County rubbish service and commercial rubbish trucks are bring all their never ending supply of materials to the new landfill situated next to the now completed and shutdown Mount Opala. But the related problem of metal junks, appliances, water heaters, auto bodies and frames, rusted pipes being rejected at the new facility is manifesting itself out into the “hidden from sight” but vehicle accessible brush areas [photo at left] and ravines of our rural community because the Kalilikane Metal Recycle site is full up and must be shipped out before more can be allowed in. The Greenwaste recycling chipper was back in operation last week trying to catchup after being out of commission for a while. Also, the new recycle site [bottom photo] is not completely constructed yet, but the aluminium can baler and glass and plastics and waste oil operation continues as efficiently as possible in the old location near the weight station entrance.

## Obama Terrorist List Proposed as Anti-2nd Am Justification

TERRORIST Lists Are the NEW Anti-2nd Amendment boogieman  
Proposed amendments to the 1968 GCA could destroy 2A - at a little publicized hearing for 5/5/10 [TOO LATE NOTICE not by accident!!]

Sen. Frank Lautenberg, D-N.J., introduced legislation last year to prohibit people on any terror watch list, or who are known to belong to a terrorist organization, from purchasing guns. The bill would authorize the attorney general to deny sale or transfer of firearms to known or suspected terrorists. But it has been struck down by gun rights advocates who said it would breach citizens' constitutional rights.

The bill would also amend the GCA provision (18 U.S.C. § 922(g)) that enumerates several classes of persons who are prohibited from shipping, transporting, possessing, or receiving a firearm or ammunition, so that it would include persons who were the subject of terrorism-related determinations. The bill would amend the GCA provision (18 U.S.C. § 922(d)) that prohibits any person from transferring a firearm to any prohibited person to include any person who was the subject of a terrorism-related determination as well. In addition, the bill would amend the NICS background check provisions (18 U.S.C. § 922(t)) to reflect that the Attorney General would have this new discretionary authority under the proposed 18 U.S.C. §§ 922A and B. The bill would make similar amendments to the provisions of the GCA governing the processes by which federal firearms dealer licenses are issued and revoked (18 U.S.C. §§ 923(d) and (e)).

With regard to NICS denials of firearms transfers or state-issued firearms permits based upon terrorist watch list hits and subsequent determinations by the Attorney General, the bill would amend the Brady Act (P.L. 103-159) to allow a denied prospective transferee to request from the Attorney General the reasons for the denial, but it would also give the Attorney General the authority to withhold those reasons if he determines that such a disclosure would compromise national security. The bill would make a similar amendment to the Brady Act in regard to correction of erroneous information.

Furthermore, the bill would amend the GCA provision that addresses erroneous denials (18 U.S.C. § 925A), to allow any person denied a firearms-related transfer or permit to challenge that determination in U.S. court within 60 days of that determination. This proposed amendment would require the court to sustain the Attorney General's determination upon a showing by the U.S. Government a preponderance of evidence standard that the determination satisfied the proposed provisions described above (18 U.S.C. §§ 922A and B). The proposed amendment would also allow the court to rely upon summaries or redacted versions of documents underlying those determinations, if those documents contained information that could compromise national security, but it would also allow a court to review the full, undisclosed documents ex parte and in camera at the court's option or on the motion of the petitioner (denied person). The proposed amendment would also allow the court to determine whether the summaries or redacted versions of the documents were fair and accurate representations of the underlying documents; however, it would not allow the court to overturn the Attorney General's determination based on the full and un-redacted documents.


"Membership in a terrorist organization does not prohibit a person from possessing firearms or explosives under current federal law," the GAO report states. "However, for homeland security and other purposes, the FBI is notified when a firearm or explosives background check involves an individual on the terrorist watchlist."

This "dangerous loophole" in the system is "stunning and infuriating," Sen. Joe Lieberman, chairman of the Senate Homeland Security and Government Affairs said at last week's hearing on anti-gun rights amendments he wants to the federal Gun Control Act.

The committee held a hearing to discuss the merits of a law barring people on the many U.S. watch lists from purchasing guns.

"We are simply not doing all we can to stop terrorists from buying guns," said Lieberman, a Connecticut fascist stooge and terrorist himself.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!


