

## Ka Hula Piko Moved to New Location in Kaunakakai Draws Large Crowds, Saved Costs, and “More Convenient”



Molokai residents and visitors gathered at Mitchell Pauole Center in Kaunakakai last weekend to enjoy the annual Ka Hula Piko. Formerly, the event was held near the beach next to the old Kaluakoi Hotel. With the economy in an Obama-spiral down, logistical costs of the westend location for sponsors, vendors, visitors, and local residents became a significant consideration for 2010.

With Hawaiian music entertainers, slack key players, hula dancers, cultural exhibits, the 2010 John Kaimikaua Ka Hula Piko was a real success now being located in Kaunakakai.

Adjusted for inflation, gross tax receipts have only risen **40%** in the last 39 years. However, total government spending increased **2,600%** over the same time period!

## Molokai Clubhouse in trouble, again, will shut down June 30 from Budget Cuts



The Molokai Clubhouse, the only facility left standing on the island providing various support services to those with mental illness, was about to be closed down at the end of last year. The Lingle Administration, as part of its slash-and-burn budget reductions, had eliminated all the employees.

Concerned Molokai AdvertiserNews.com readers and Disappeared News.com readers made phone calls along with advocates and supporters of the Clubhouse and got one job reinstated on the very last day of the year.

According to the minutes of the State Council on Mental Health and reports from Maui advocates, the Molokai Clubhouse is in danger again, and it needs further intervention or it will shut down on June 30.

First, there is no money allocated for rent past June 30. All the good work on the building repairs and fundraising of the Honolulu Metro Rotary Club will have been for naught if the facility gets can't pay the rental fee.

Second, the one remaining employee is carrying a caseload of about 70, according to a report, and has many duties related to operating the Clubhouse and keeping it going. That's too much even without the additional duties.

The state needs to hire back one social worker or an aid to divide the work. I hear about "dragging their heels" and other delays. With the unemployment situation as it is, there must be many candidates to choose from. Of course, I don't know what the bureaucratic issue is, just that the cutbacks need to be reversed if the Mookai Clubhouse is to be saved and critical mental health services continued.

I suggest calling on Linda "Slash & Burn-Shaloha" Lingle at 586-0034 and that will get you someone in the Constituent Services office at State Capitol. Of course, if you happen to have Lingle's personal cell phone number, better yet.

Calling the Department of Health has historically not reversed any of their shutdown plans. For example, it took the intervention of Governor Cayetano to reverse the DOH decision many years back to close the Diamond Head Mental Health Center, a critical facility serving a large population in that area.

## Obama Nominates ANOTHER anti gun rights socialist radical to US Supreme Court: Congress MUST vote NO on Elena Kagan

Dear Congress: Please vote NO on Obama's nomination of Elena Kagan to US Supreme Court. The next justice of the Supreme Court will almost certainly preside, during the next thirty years, over dozens of cases which could very well chip away at the DC v. Heller decision, telling us which gun laws the court views as "constitutional" and which "unconstitutional."



But Kagan's views on the Second Amendment are no mystery. Elena Kagan says that foreign law can be used to interpret the U.S. Constitution in "some circumstances." Considering that most of the world does not respect the freedoms that are protected in our Second Amendment, this is a bad sign. Also, records at the Clinton Presidential Library in Little Rock, Ark., evidence that Elena Kagan drafted an executive order restricting the importation of certain semiautomatic assault rifles.

She was also part of the Clinton team that pushed the firearms industry to include gun locks with all gun purchases and was in the Clinton administration when the president pushed legislation that would close down gun shows.

Bloomberg News reported on May 13 that while working for Justice Thurgood Marshall, Kagan urged him to vote against hearing a gun owner's claim that his constitutional rights were violated. Kagan wrote that she was "not sympathetic" toward the gun owner's claim.

After the Supreme Court supported the individual right to keep and bear arms in the Heller case, Kagan was forced to concede that the 2nd Amendment is an "individual right." But that did not stop her from supporting anti gun rights policy and lobbyists at the Brady Campaign.

According to WeeklyStandard.com (May 6, 2009), she is so far to the left she has lamented that socialism has "never attained the status of a major political force" in our country.
