[Remember, in July of 2008, the Department of Health and Human Services and the Department of Homeland Security declared that their goal was to vaccinate every man, woman and child in the United States against the Avian Flu, starting, as they so chillingly put it, with those who want it, there is no reason to think that this is not what lies in store for us under martial law, i.e. militarized medicine.

How is flu vaccine created? Incredibly, the CDC prepared a "seed stock by April 24, just 10 days after the previously unknown disease was identified. Here's is what it takes to prepare a seed stock:

"Scientists first have to decide which flu strains to use in the vaccine-they typically pick three, based on predictions of how the virus will evolve by next year. (It's still unclear whether they'll include the swine flu in next year's seasonal flu vaccine.) They then inject the strains into chicken embryos, wait for them to multiply, and extract them several days later to create a so-called "seed stock."

AFTER the seed stock is produced, they inject the [viral] strains into lab animals, followed by any necessary adjustments to the stock. (Haste can have a price: During the swine flu outbreak of 1976, 500 people who got vaccinated developed a disease called Guillain-Barré syndrome, and 25 of them died.)

Once researchers have finalized the vaccine, they repeat the embryo injection process millions of times. So even if they finalize the vaccine in June, it will take at least until September to produce the first 50 million or so doses. Producing all 600 million doses-enough to give Americans the usual two shots-would take months longer.[No safety testing in humans is involved in this program?]

WorldHealthOrganization raised the alert level to Phase 5, the start of a Pandemic, on April 29. WHO then changed the name of the current "Pandemic" from "Swine Flu" to "H1N1Influenza" because the name "caused an unwarranted clampdown on pork trade".

Linda Lingle, complicit quisling of Zionists and Neocons [9/11 etc] who claims to be governor in Hawaii, said that WHO was considering raising the alert status of the "Pandemic" to Level 6 soon.

In Reality, it a Political Pandemic!

Justice Comes to Peru Tyrant, finally!

Alberto Fujimori, the former president of Peru, was sentenced last week by that country's highest court to 25 years in prison for organizing and covering up two massacres committed by the Colina army detachment in the early 1990s. Ostensibly an anti-terrorist army detachment, the Colina group killed at least 50 Peruvians in nine separate incidents, including 15 people killed while attending a barbecue in the Barrios Altos neighborhood of Lima and nine students and a professor from La Cantuta University who were kidnapped and killed.

Independent Institute Senior Fellow Alvaro Vargas Llosa--a native of Peru intimately familiar with its political travails--lauded the sentence: "It is extraordinarily fitting that, despite the disruptive actions carried out by Fujimori's party since he was extradited to be tried for human rights violations and corruption, and the campaign of intimidation against the prosecutors, the families of the victims and judges, the court handed him a long sentence."

More broadly, the conviction and sentencing of Fujimori offer new hope that political leaders who destroy their country's institutions will face legal responsibility for their actions. "In many ways, the history of Latin America has been one succession of strongmen who did just that," writes Vargas Llosa. "Fujimori's sentence sends the message that the tradition does not have to be honored forever."

Drug Wars Corrupt Cops/Judges Stories

1. In El Paso, Texas, a Texas district court judge was indicted last week on charges he took cash bribes and asked for sex from defendants in exchange for his help making felony cases go away. State District Court Judge Manuel Barraza was indicted on four counts, including mail fraud, wire fraud, and lying to a federal agent. Local prosecutors are now reviewing about 100 drug cases he dismissed. Barraza is out on bail pending trial, but has been suspended from his \$140,000 a year job.

2. In Brownsville, Texas, a US Customs and Border Protection officer was arrested April 2 on charges he took bribes to allow vehicles carrying drugs and illegal immigrants to pass through his border checkpoint. Officer Raul Montano Jr., 34, faces charges of bribery, conspiracy and smuggling illegal immigrants and conspiracy to import and possession of cocaine. According to a criminal complaint filed the same day, Montano would tell another person when he would be inspecting a certain lane on the Brownsville Gateway bridge and that person would relay the information to waiting smugglers on the Mexican side, who would pass through with people and cocaine.

3. Two Philadelphia police narcotics squads are being reorganized as part of an effort to better supervise the officers involved. The move comes as one of those squads, Squad 9, is the subject of ongoing federal and local investigations after the Philadelphia Daily News ran a series of articles exposing numerous allegations of illegal acts by Narcotics Officer Jeffrey Cujdik and his cronies. Squad 9 is being dissolved, with its members being dispersed among the 10 remaining dope squads. Cujdik was first accused of lying on search warrant applications to gain access to suspected drug houses and of becoming too close to his snitches. Then, last month, the Daily News ran articles from 14 immigrant convenience store owners alleging Cujdik's squad ransacked their stores, ate food, stole goods and cash, then arrested them for selling small plastic bags that could be used to hold drugs. The Cujdik gang would typically cut the wires to surveillance cameras at the beginning of those raids.

4. Detroit police officer pleaded guilty April 2 to tax evasion in the theft of more than \$2 million worth of cocaine from a police evidence room. Officer Vincent Crockett, 50, had faced more serious charges of cocaine possession and embezzlement, but a police chemist who would have been a key witness in the case died last year, leaving federal prosecutors with a weak case. In his plea bargain, Crockett admitted to evading 2007 income taxes on \$72,000 he received as the result of "an illegal act."

5. TSA guard gets popped in Palm Bay, Florida, arrested April 8 on charges he dealt in drugs and guns. Officer Timothy Monroe was being held on \$750,000 bond after being arrested as police raided his home, seizing drugs, guns and "piles of cash." Police found marijuana and enough cocaine to trigger a federal trafficking probe, "bags and bags" of marijuana, a variety of firearms and "loads" of ammunition. Monroe quit his TSA gig last Thursday.

6. In Brownsville, Texas, a US Customs and Border Protection officer pleaded guilty to bribery, alien smuggling, and drug trafficking charges. Sergio Hernandez, 40, has been jailed since he was arrested January 28. Hernandez admitted letting cars carrying contraband drugs or people pass through his lane as he inspected incoming traffic on the Free Trade Bridge at Los Indio between June 2008 and January. Hernandez, a full-service corrupt border official, pleaded guilty to conspiracy to bring illegal immigrants into the US for private financial gain, accepting bribes to do so, as well as conspiring to possess with intent to distribute 15 kilograms of cocaine, and accepting \$150,000 in bribes to do so. As part of his plea deal, he also forfeited \$85,520 in cash seized from his home after his arrest.

7. In San Juan, Puerto Rico, a husband and wife police team pleaded guilty to federal drug trafficking charges. Jose Garcia and Jacqueline Torres Cruz were indicted by a US grand jury in February along with two other police officers in the 2007 robbery of a drug dealer. According to prosecutors, the couple conspired to rob the dealer and sell 18 pounds of cocaine themselves. Prosecutors are recommending seven years for Garcia and four for his wife.

New Anti-gun rights Law Proposed

Bill empowers attorney general to forbid firearms for those 'suspected dangerous' people tagged by Obama Gansters in his Dictatorial Regime.

A new gun law being considered in Congress, if aligned with Department of Homeland Security memos labeling everyday Americans as potential "threats," could deny firearms to pro-lifers, gun-rights advocates, tax protesters, animal rights activists, and a host of others – any otherwise lawabiding people already on the expansive DHS watch list for potential "extremism."

Rep. Peter King, has sponsored H.R. 2159, the Denying Firearms and Explosives to Dangerous Terrorists Act of 2009, which permits the attorney general to deny transfer of a firearm to any "known or suspected dangerous terrorist." The bill requires only that the potential firearm transferee is "appropriately suspected" of preparing for a terrorist act and that the attorney general "has a reasonable belief" that the gun might be used in connection with terrorism.

Gun rights advocates, however, object to the bill's language, arguing that it enables the federal government to suspend a person's Second Amendment rights without any trial or legal proof and only upon suspicion of being "dangerous."

"It would deny citizens their civil liberties based on no due process," objected Larry Pratt, executive director of Gun Owners of America. "A 'known terrorist?' Look, if the guy has committed an act of terrorism, we shouldn't have to worry about him being able to buy a gun; he should be in jail!"

And, there is a DHS memo that warns against potential violence from "right-wing extremists," e.g., Americans who are concerned about illegal immigration, increasing federal power, restrictions on firearms, abortion, the loss of U.S. sovereignty, and the criminal behavior of professional politicians.

"Rightwing extremism," is defined as those "who can be broadly divided into primarily hate-oriented, and those who are mainly antigovernment and reject federal authority in favor of state or local authority. This term also may refer to rightwing extremist movements that are dedicated to a single issue, such as opposition to abortion, animal rights, or illegal alien welfare and amnesty, or gun rights, or medical marijuana legalization, GMO protestors, war protestors, etc etc.

A spokesperson for DHS told said the memo was recalled "within minutes" of being issued but declined to offer any details on the reasons, but Larry Pratt of Gun Owners of America said "This bill would enable the attorney general to put all of the people who voted against Obama on no-gun lists, because according to the DHS, they're all potential terrorists."

Pratt's biggest concern, however, is the sidestepping of the Constitution and due process that the nebulous language of this bill could permit. "Unbeknownst to us, some bureaucrat in the bowels of democracy can put your name on a list, and your Second Amendment rights are toast," Pratt told WND. "This is such an anti-American bill, this is something King George III would have done before he lost the American Revolution of 1776 that established American Citizens as the Sovereign Entity instead of the king."

And, Tax Protesters "have been known to advocate or engage in criminal activity and plot acts of violence and terrorism in an attempt to advance their extremist goals." The DHS memos were meant for distribution to law enforcement officials around the country, prompting some to worry the definitions might be used to classify Americans who simply disagree with government policies as being dangerous.

Please take action to stop H.R. 2159, the Denying Firearms and Explosives to Dangerous Terrorists Act of 2009, for the sake of safety, good policing, basic fairness, and most importantly the protection of Life, Liberty, Freedoms guaranteed by the Constitution for the united States of America and Bill of Rights.

Student Shot in Chest in SWAT Drug Raid

Derek Copp, the 20-year-old Grand Valley State University student who was shot in the chest during a March 11 swat drug raid on his apartment, will be charged with an unspecified drug possession offense.

Copp was not armed. He was shot once by Ottawa County Sheriff's Deputy Ryan Huizenga, a member of the SWAT team, as Huizenga came through a glass door into the apartment and encountered Copp. Huizenga has now been charged with a misdemeanor -- careless discharge of a firearm -- and was arraigned Monday. He was returned to the job to perform administrative duties by the sheriff's office, which said he was reinstated because it would take a long time for the case to be heard.

The shooting of Copp led to angry protests by college students and others in the area, as well as calls for an investigation by university officials and local newspaper editorial pages. An investigation is being done, but it is being conducted by the Michigan State Police. [But, of course! We already know the result of that!]

Hawaii's 2010 elections enjoined by Maui judge

Judge Joseph E. Cardoza granted an injunction against Hawaii's illegal use of electronic voting machines and the illegal transmission of vote results over the Internet. A written decision will be issued in the coming weeks, he said.

The suit (Babson v. Cronin, Civ No. 08-1-0115(3)) was brought by attorney Lance Collins on behalf of five citizens of Maui against Hawaii's Chief Elections Officer (see background on Disappeared News in these articles). The suit challenged three aspects of the voting process, according to attorney Collins:

1. The use of electronic voting machines was not adopted through lawful rulemaking in accordance with the Hawai'i Administrative Procedure Act (HAPA).
2. The use of the Internet and/or telephone lines to transmit vote counts was not adopted through lawful rulemaking (HAPA).
3. The use of the Internet and/or telephone lines to transmit vote counts is not allowed under current state law.

As I wrote earlier, one of the plaintiffs, Bob Babson, has been particularly concerned that electronic transmission of vote counts can compromise the integrity of the entire election system. He emailed:

The Hart tabulators at the four county count centers are connected to telephone lines so they can transmit votes to the Hart tabulator at the state count center which is also connected to telephone lines.

However, since they are connected to open telephone lines, they could easily be programmed (secretly) to dial ... a secret website controlled by Hart where the vote files could be opened and votes flipped and then immediately sent onto the state count center.

Bob correctly points out that we would never know if that has been done.

An administrative hearing officer last year, in a ruling that was "extremely critical of Kevin Cronin, the state's chief elections officer" (Honolulu Advertiser, Voting-machine deal in jeopardy ,8/10/2008), found that the Office of Elections acted in bad faith in awarding the contract for voting computers to Hart. The contract was to be cancelled at the end of the year. This new ruling by Judge Cardoza adds that the machines were used in a way that is contrary to Hawaii law.

It would be timely to review the actions of the Office of Elections and see what adjustments need to be made in its management. As attorney Collins said in his statement today after the judge's ruling:

"Voting is the bedrock of a democratic society. The desire to use the latest technologies cannot override requirements for orderly and secure vote counting procedures."
