### TAAC Recognition Ceremony

The Recognition Ceremony was held at Kulana O'iwi Halau 5-24. Originated by the Molokai Rural Development Project and designed by MCC- Molokai, Therapeutic Activity Aide Certification Program completed its first ever program. The program was developed to meet the needs of rural communities and to create an entry level position to encourage future careers in HealthCare. Upon completion, students will be prepared to work as aides under the supervision of licensed professionals in the community.

The fourteen students who completed the two-year program went through 20 credit hours of college instruction in supervised activities in Occupational, Physical and Speech Therapy. The Pilot Program subjects and Instructors included: Interpersonal Communication (Dr. Richard Rodriguez, PhD); (Human Development (Nita Bogart, PhD); Therapeutic Activities (Susan Peabody, OTR) Therapeutic Activities Practicum (Frances Nishioka, OTR; Anatomy & Physiology (Kat Suzuki Reith); Physical Therapy Support (Kirsten Hirsch, PT); Physical Therapy Support Practicum (Mary Anne Hill, PT); Elaine Slavinsky (Medical Terminology); Speech Pathology Support (Janie Bryan, SLP); Speech Pathology Practicum (Jodie Diener, SP Practicum); Capstone (Arlene DeRouin, LCSW).

With the idea from Molokai Rural Health Association Wai Ola O Hina Project Director Jodie Diener, UH MCC-Molokai Education Center Coordinator Donna Haytko-Paoa and Dr. Caryl Hitchcock did the research, wrote up the program, got the program implemented in Spring 2010 for the community.

Although there is no specific job position for the Therapeutic Activity Aides, most are Certified Nurse Aides and are better informed and aware of a the variety of therapeutic approaches, especially for long term care patients.



## Senate Votes Against Obama's Anti-gun Judicial Appointment: Goodwin Liu.

On Thursday, the U.S. Senate rejected Obama's anti-gun rights attorney Goodwin Liu for a seat on the 9th Circuit Court of Appeals. In a procedural motion that required 60 votes, Goodwin Liu's nomination was defeated in a near-party line vote of 52-43.

Liu was perhaps the most radical of Obama's judicial nominees. The UC Berkeley law professor supported the notion that the language of the Constitution is sufficiently ambiguous to bend with the times.

"It becomes pretty clear why 'originalism' and 'strict construction' don't make a lot of sense," Liu said in an interview promoting his book. "The Framers deliberately chose... broad words so they would be adaptable to new challenges over time."

In Liu's view, the right to keep and bear arms may have been necessary in the 18th century, but no longer needed.

For these reasons, the Senate was flooded with emails from gun owners insisting that Liu be voted down.

While Liu's defeat is a victory for Second Amendment supporters, it is also indicative that Obama is pursuing a course to pull the federal judiciary as far to the left as possible. Gun Owners of America will continue to expose the disdain with which Obama's nominees hold the Second Amendment.

Virtually every day there are reports of CEOs and directors of major corporations who are charged with fraud and tax evasion -- on a grand scale.

More often than not, those charged with such offenses end up making a settlement or plea agreement. Usually, those agreements result in fines and/or monetary settlement of lawsuits that don't even begin to compensate victims of the crimes. Moreover, having agreed to huge multi-million-dollar settlements, there is usually a denial that there was any wrongdoing. To add further insult to injury, few are ever incarcerated.

If you hold up a convenience store, and you're caught, you'll have the cuffs snapped on your wrists, get thrown into the slammer, and almost surely will do time. If you are one of those pillars of society, who unlawfully drains hundreds of millions from their companies and stockholders, cause job losses in the thousands and financially ruins many lives, you're more apt to first die from natural causes than you are to spend any time in prison.

There seems to be a dual standard of justice in this country when it comes to theft: one for the landed gentry, one for the 'common criminal'. Punishment should be meted out according to the gravity of the crime.

Cameras have been installed, one per lane, on the H-1 freeway. The system to which they are connected is capable of reading, recognizing, and storing the license plates of cars passing by.

According to this newspaper article, we are not supposed to be concerned about this surveillance:

"Rear license plate images will be taken, truncated, encrypted, and travel times between the camera locations will be calculated," the spokesman said.


The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

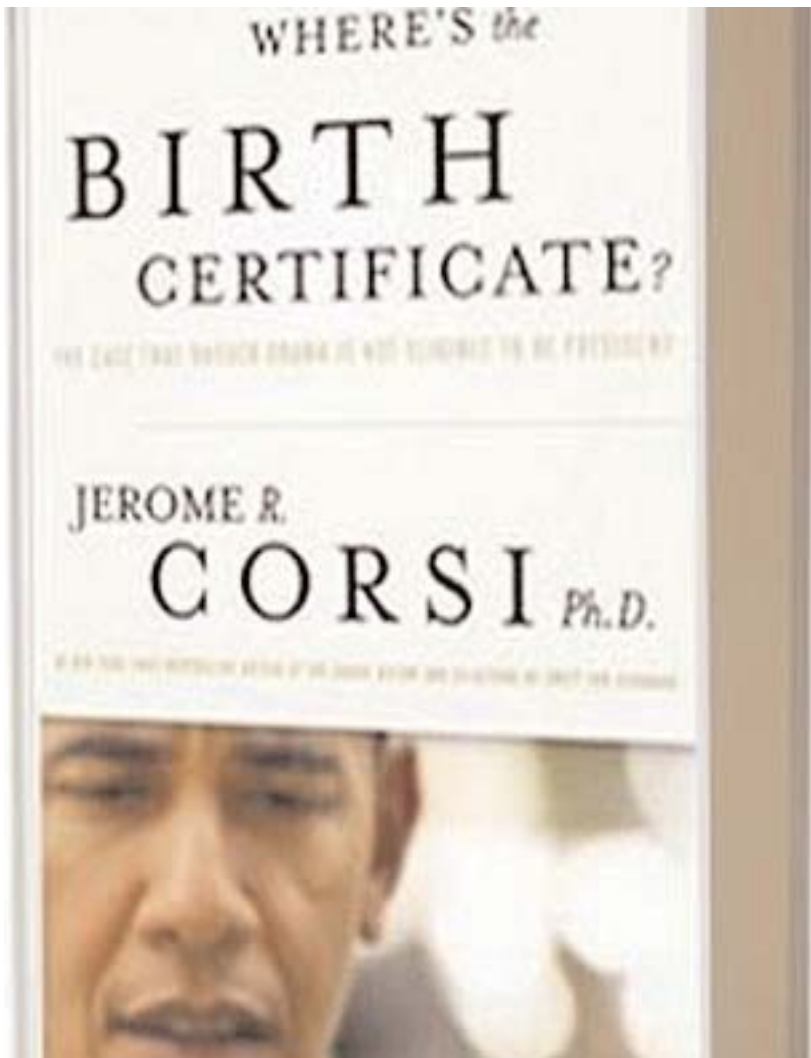

## Obama's New BC Is A Computer-generated FRAUD.

That opinion has been repeated many times, and WND has reported on a few of the objections that have been raised by various experts:

Ivan Zatkovich, of Tampa-based eComp Consultants, analyzed the various layers in the PDF file released by the White House, and concluded: "The content clearly indicates that the document was knowingly and explicitly edited and modified before it was placed on the web."

"It is possible to take a single layer PDF and inadvertently create multiple layers, without changing the image in any fashion. But that does not appear to be the case here. The multiple layers in the PDF document are a result of changes made to the image," his report said.

Among the various items that were separated into different layers include the main text, the mother's occupation, the dates accepted for DOH recording, the stamp and signature of the state registrar and the time stamp of the state registrar.

Furthermore, the presence of "kerning" in the text confirms manipulation. The type on the birth document show evidence of "kerning," the squeezing of letters into a line so that they intrude into adjacent letter spaces. Kerning is routine since the advent of word processors and computers, but impossible with a typewriter in 1961. This document has been assembled by somebody on a computer.

Perhaps most significant unresolved issues that point to conspiracy and fraud is that two weeks before Obama finally released his "long-form birth certificate," Hawaii's former Health Department chief Chiyome Fukino – the one official who claimed to have examined Obama's original birth document – was interviewed by NBC News' national investigative correspondent Michael Isikoff, who reported that Fukino told him she had seen the original birth certificate and that it was "half typed and half handwritten."

However, the document released by the White House was entirely typed. Only the signatures and two dates at the very bottom were "handwritten." What Fukino described is apparently a different document from what Obama released to the public.

Among other questions that remain about the document:

The objectivity of "experts" cited by the mainstream media to verify the birth certificate is suspect, including that of Fox News Channel's Jean-Claude Tremblay, who assured America they "should not be suspicious" of the document, but who is also an unabashed Obama supporter.

Obama's posted birth certificate contains the same anomalies as a well-known forgery reportedly created by employees of the Hawaii DOH that claimed he was born in Kenya, suggesting the anomalous markings came from the same source. How could Obama's 'real' birth certificate share these unique characteristics with an obvious forgery? Joe Farah of WND commented: "For the life of me, I can't figure out an answer other than they were created by the same person or persons."

The birth certificate's reported delivering physician, Dr. David Sinclair, differs from previously published reports and even the myth-busting Snopes.com's original entry, which named Dr. Rodney T. West as the doctor of record.

Obama's purported birth certificate contains over a dozen differences in type styles and formatting from the verified, Hawaii copy of the birth certificate issued to the Nordyke twins, born the next day at the same reported hospital.

And, the local registrar listed in the Nordyke twins' birth certificate is different than the local registrar on the Obama birth certificate.

Though Obama was born before the Nordyke twins, and though his birth was filed with the registrar three days before the twins' birth, Obama's purported birth certificate has a higher registration number. Obviously the forgers of Obama's BC conspiring with Hawaii DOH and governor Neil Abernethy picked the wrong number to assign, maybe belongs to a dead infant from Wahiawa?

Remember, Obama's grandmother says she witnessed his birth in Kenya!

Texas legislators made a valiant stand to outlaw the invasive patdowns that the Transportation Security Administration adopted to punish as a second option for people who didn't want to go through whole-body-imaging scanners (aka nude scans). Texas state representative David Simpon authored a bill that would make any patdown that involved touching private parts a misdemeanor that would mean a \$4,000 fine and possible jail time for TSA officials who are just following orders like good Nazi soliders.

The bill passed in the House, but floundered in the Senate after the feds threatened to cancel all flights out of Texas if it passed. Texas U.S. attorney told senators in a letter that Texas didn't have the right to pass a statute that would conflict with federal law, per the U.S. Constitution. In this case of Texas Hold'em, the legislators weren't willing to call the feds bluff; they folded without any questions whether the TSA itself was un-Constitutional and violate Bill of Rights of passengers without probable cause.

After the threat from TSA, there weren't the votes to support it being voted on. The bill cannot be reintroduced this term.

Texas, though, isn't the only state voicing its opposition to pat-downs. TSA-opposing state politicians are banding together to create "United States for Travel Freedom" — a bipartisan caucus of legislators from nine states (Alaska, Hawaii, Michigan, Montana, New Hampshire, New Jersey, Pennsylvania, Texas and Washington).

"We urge the federal government to reconsider its policies," said caucus co-chair, state Rep. Sharon Cissna, D-Alaska, in a written statement. "Law-abiding citizens are experiencing severe emotional and physical harm every day in our airports in the name of 'security.' It's not only wrong; it threatens the core values that America and the constitution stand for."

The people elect a president to do a constitutional job. ... If the president is guilty of acts justifying impeachment, then he, not the Congress, will have overturned the election. He will have acted in ways that betray the purpose of his election. He will have acted not as a constitutional representative, but as a monarch, subversive of, or above, the law."

Rogan's "lost" argument is now published in his new book, *Catching-Our-Flag-Behind-the-Scenes-of-a-Presidential-Impeachment-is* a volume of his comments and detailed diary notes as a member of the 13 House managers who prosecuted President William J. Clinton's Impeachment trial before the Senate.

"In my prepared closing argument before the Senate, I had tried to summarize for my children and my grandchildren what the trial was about," Rogan told Hillsdale.

Many of Rogan's other arguments also reflect a parallel between what Clinton was accused of doing and what some will accuse Obama of doing, when Obama is finally demonstrated to be ineligible to Office of POTUS.

For example, Rogan had "jettisoned" the following prepared comments from what he actually said before the Senate:

"[The president's] defenders now plead for no constitutional accountability for the one American uniquely able to defend – or debase – our Constitution and the rule of law," Rogan wrote in his "lost" argument. "They seek to save him who cares only about saving himself. And they call for this remedy at the cost of weakening Jefferson's revolutionary pledge, made only a few paces from this spot almost two centuries ago, of 'equal and exact justice to all.'"

"The youth of my generation were moved by the words of another who reminded us that the rule of law must apply to all, or it would apply to none," Rogan had prepared to say in his "lost" argument. "Shortly before his tragic death, President John F. Kennedy echoed Jefferson's sentiment. He said, 'For one man to defy a law or court order he does not like is to invite others to do the same. This leads to a breakdown of all justice. Some societies respect the rule of force; America respect the rule of law.' His words are important, because President Kennedy, like Jefferson before him, recognized no exception for those who happened to share his party affiliation or political agenda."

"Should this issue be decided by reviewing the latest polling data?" Rogan had planned to ask, but didn't. "If your answer is 'no' to his question in the abstract, but you are inclined to vote for acquittal, take this self-test. Simply ask yourself if your vote on the Articles of Impeachment would be the same if the president stood at a 6-percent job approval rating instead of a 60-percent job approval rating. ... But if that difference governs – if polls matter more than the oath to uphold the law – then..." the rule of law is lost, freedom lost, USA lost.

Not all of Rogan's prepared remarks were jettisoned, however, as he carried much of his closing argument into the Senate, including comments that will be eerily poignant when Obama is proven to be a usurper and ineligible:

"The mere fact that a person is elected president does not give him the right to become president, no matter how overwhelming his vote margin," Rogan told the Senate. "Votes alone do not make a person president of the United States. There is a requirement that precedes obtaining the power and authority of obtaining the presidency. It is the oath of office. It is swearing to preserve, protect and defend the Constitution. It is accepting the obligation that the laws are to be faithfully executed.

"No oath, no presidency," he continued. "It is the oath of office, and not public opinion polls, that gives life and legitimacy to a presidency. This is true no matter how popular an elected president may be, or how broad his margin of victory." AMEN! Impeach Obama !

## No fishing of moi during summer ? Is Molokai exempted Hawaiian-style regs?

In an effort to protect one of Hawaii's most significant fish species, the Department of Land and Natural Resources has closed the moi fishing season during the summer starting June 2011.

The department said in a release Wednesday state regulations make it unlawful to take, possess or sell any moi during June, July and August.

DLNR chair William Aila Jr. says moi at one time was reserved only for royalty. The early Hawaiians placed a kapu or prohibition on certain fish during their spawning season as a conservation measure.

During the open season of September through May the minimum size for moi is 11 inches, and the bag limit for possession or sale is 15. Commercial marine dealers may possess and sell more than 15 with receipts for sales.

If Molokai is exempted to allow Hawaiian-style conservation of moi, etc., is it ok to wipe out a whole spawning school of moi [700 lbs] if you give a lot away to neighbors before selling it to markets? What about reproduction? How about video records of such greed? Where are the reports, names, dates?
