



Heroism in Past Wars Remembered



In his Memorial Day message, guest speaker Michael Inouye, Navy veteran remembered the sight at Pearl Harbor of the US Navy ship Herbert K. Pililaau, named for Medal of Honor recipient, a US Army PFC, mortally wounded defending his unit at Heartbreak Ridge in Korea. He spoke of the parable of David and Goliath and Father Vince Cap O'Donnel, a Navy Chaplain killed protecting the unit's medic in a Viet Nam battle.

Kahu Inouye's message was to Honor folks who do the right thing; All vets who served in the military; All who have fallen in battle. He concluded that soldiers who have served have served our country and asked that we pray for our country and pray for leaders.

Memorial Day is a weekend to remember as David Nanod read the Moloka'i Roll Call of names of men in World War II, Korea and Viet Nam killed in battle and Albert Pu rang the bell. Parade of flags and lei and taps is a part of Memorial Day at the Kaunakakai Memorial Park. Postmaster Bo Mahoe's introduction and leading of Lorenzo Lyons "Hawai'i Aloha" was a fitting conclusion to the annual event.

According to VFW Commander George Harada, the members had placed flags on the graves of Veterans at the Cemetery in Hoolehua it is "Decoration Day," recalled many in the audience.



Ex-Queen Liliuokalani negotiated with President Dole for a Pension of \$25,000 in return for her abdication

Historical records show that deposed queen Liliuokalani attempted to profit with a \$25,000 pension from her recent position as Queen of Hawaii after her regime was dumped and replaced with the regime of Hawaiians who opposed her corrupted government.

Two journalists, one from New York City and the other from Troy N.Y., independently corroborate each other's testimony that ex-queen Liliuokalani was offering to abdicate all claims to the throne in return for an annuity of \$25,000. Her attorney Paul Neumann was actively engaged in secret negotiations with President Dole on this matter. President Cleveland's minister plenipotentiary with paramount powers, James Blount, heard about the negotiations and intervened to scuttle them, thereby blocking a "settlement" that would have facilitated annexation and would have avoided more than a century of strife over the ceded lands and claims to reparations.

The shorter testimony on this topic is by Mr. Charles MacArthur, and is presented first. It is fairly straightforward and simple, referring only to negotiations for abdication in return for an annuity, and does not refer to Minister Blount.

The second testimony on this topic is by Dr. William S. Bowen. It is quite lengthy, involving several layers of conspiracy. This testimony specifically describes Blount's intervention to scuttle the negotiations (thus blocking an easy path to annexation) and also some lies told by Blount about Dr. Bowen and his traveling companion, Mr. Sewall, who had been U.S. consul to Samoa.

WE THE PEOPLE ARE SOVEREIGN

U.S. Supreme Court rulings on the matter:

"Sovereignty, itself, is, of course, not subject to law, for it is the author and source of law; but in our system, while sovereign powers are delegated to the agencies of government, sovereignty itself remains with the people, by whom and for whom all government exists and acts."

Yick Wo v Hopkins and Woo Loo v Hopkins, 188 US 356 [1886]

"All codes, rules and regulations are applicable to the government authorities only, not human/Creators in accordance with God's laws. All codes, rules and regulations are unconstitutional and lacking in due process ..."

Rodrigues v Ray Donovan [U.S. Department of Labor,] 769 F. 2d 1344, 1348 [1985]

Thus, the sovereign people reign sovereign over the government of states and the United States, while states retain sovereignty and independence relative to all other states and the United States. That the County Clerk, and most other public servants, do not understand who or what is the sovereign does not take away from the fact that - in this country - the people are the sovereign.

Memorial Day Thoughts: Life & Liberty by Defending the Constitution

The care of human life and happiness, and not their destruction, is the first and only legitimate object of good government. — Thomas Jefferson

The bedrock of our nation is the Unanimous Declaration of the thirteen united States of America which declared the colonies to be free and independent STATES. Sovereignty is the right to govern; a nation or State-sovereign is the person or persons in whom that right resides. Kings have personal powers, dignities, and pre-eminences, but our representatives have none but official, nor do they partake in the sovereignty otherwise, or in any other capacity, than as private citizens." see CHISHOLM v. STATE OF GEORGIA, 2 U.S. 419 (1793)

Unfortunately, the People returned to business and left the tribunals in the tentacles of the attorneys who modeled them upon the crown magistracies complete with divine impunity. Where a cult priest is able to damn you is a temple of his cabal. Learn to take your case to constitutional court. You won't defeat them easily but you may keep them from disposing of you as an incompetent.

In this day 2007, do we accept that the Justices of the US Supreme Court have the power to decide for us what the Constitution means, and that their decisions determine, finally, what constitutional law is? I say emphatically No way!

Constitutionalism in the Founding era was the power of the People to interpret (not just the power to make) constitutional law that resides with the people in perpetuity as long as we remain a government in republican form. And not theoretically or in the abstract, but in an active, ongoing sense. It was the community at large~ not the judiciary, not any branch of the government~that controlled the meaning of the Constitution and was responsible for ensuring its proper implementation in the day-to-day process of governing. This is "popular constitutionalism" to distinguish it from "legal constitutionalism" where attorney/judges claim that constitutional interpretation has been turned over to the judiciary and, in particular, to the Supreme Court, and that they have immunity for their actions.

It stands to reason that the People (the community at large) would "control" the meaning of the Constitution and be responsible for ensuring its proper implementation in the day-to-day process of "governing" since the Constitution itself is the "consent of the governed" from which government, which includes the judiciary, derives its just powers and is prohibited from exceeding those just powers. "Constitutionalism in the Founding era" remains the same today, despite developments since then that have eroded the consent of the governed and turned constitutional authority over to the judiciary, "and, in particular, to the Supreme Court" creating the doctrine of "Judicial Supremacy."

We The People are Sovereign, and where the crown power exists to be exercised as a "supreme will", we must invoke it in one supreme COURT.

Each of us was born with Sovereignty as American citizens. The crown comes from "corona" approximating a halo and meaning the grace of God which the monarch claimed for himself when holding the power of life and death over his subjects. "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness."—Unanimous Declaration

"And for the support of this Declaration, with a firm reliance on the protection of divine Providence, we mutually pledge to each other our Lives, our Fortunes, and our sacred Honor." —Unanimous Declaration

Prior to the Unanimous Declaration of Freedom and Independence divine right was exclusive to the king. Our ancestors said NEVER AGAIN, but had to fight for it. God Blessed America, and we continue to fight for our Sovereignty.

Have a safe and dignified Memorial Day: Remember those who lived before us and created our Great Republic; and we today must live to honor their memories that those who live after us will respect all our lives because we enforce our sovereignty against violations of the limited enumerated powers we granted and defined in our Constitution for the United States of America. PEOPLE have the Police Power of Citizens. Never forget it; Never give it up; Question Authority!

Coed Snitching for Drug War Murdered

The death last week of a Florida State University student who was killed while acting as an informant for the Tallahassee Police Department after being arrested on marijuana and ecstasy charges has sparked intense criticism of the police. On Wednesday, around 100 people gathered at the Old Capitol to call for police accountability in the murder of Rachel Hoffman, 23, who was shot and killed by two men she was trying to set up for the police.

Tallahassee police have attempted to blame Hoffman for her death by arguing she didn't follow proper informant procedures.

But the protestors at the capitol weren't buying it. They criticized both Tallahassee police behavior in sending Hoffman out to buy cocaine and a gun, but they also leveled strong criticisms at the informant system in general.

"I just think it was stupid that this all happened over drugs," said McKenzie Smith. "TPD had Rachel Hoffman going into a situation she had no place being in, just because she was associated with marijuana," said Rachel Lillibridge.

Two men have been arrested in Hoffman's death. But for many in Tallahassee, the shooters aren't the only guilty parties.

The police force has become nothing but a legal gang, supported by our own government. I know I do not feel safe when I see a police officer. It is no longer about public safety but about FUNDING. I hope those in Tallahassee wake up and make those police accountable!!


