The 4th annual Molokai Senior Fair was complete with music, entertainment, free healthy snacks and lots of agencies offering seniors information. A mini-health fair with Na Pu'uwai nurses Judy Mikami, Josephine Manaba, and Donna Carvalho, testing for blood glucose; cardiac risk screening with Jane Woolsey and Dr. Nichols from the Molokai Community Health Center. Molokai General Hospital, Physical Therapist Mary Anne Hill, Dept. of Health Senior Companion Program, and massage therapists offered "hands on" activities. Agencies offering homebound seniors nursing, chore and support services were represented by Child & Family Service (Rochelle Ing Kuapu), Care Resources (Lana Apuna), Nursing Home without Walls (Marion Healy), Alzheimer's Association, American Cancer Society, Legal Aide Society, and Molokai Occupational Center and others offered lots of information.

Claire Iveson (and Rietta Tollefsen of Molokai Family Support Center co-chaired the event) and John Tomoso, County Executive on Aging introduced the many agencies who participated in the 4th annual Senior Fair.

Talented including Kaunoha Tap Dancer, Auntie Kauila's Halau and Tyra Dudoit and Kaunoha Seniors were others scheduled to provide musical entertainment.

Wounded man shoots back at robbers

A 69-year-old Florida man was grazed by a bullet on his cheek during an attempted robbery in the driveway of his home Sunday, but escaped with his life when he pulled out his gun and fired back.

Francesco "Franco" D'Arpino pulled into his garage at about 5:10 a.m. after working the night shift at his North Miami Beach restaurant, Franco's Pizza, when police say a white car rammed into the back of his car and someone opened fire. A bullet grazed D'Arpino's cheek. He grabbed his gun, which he keeps on him, and shot back, driving off the attackers.

Authorities suspect the gunmen targeted D'Arpino and may have followed him from his pizzeria. "It's safe to assume this was not a random act of violence," said Hollywood Police Capt. Tony Rode. "They were probably thinking, 'Hey, the business owner comes home late ... he probably has the safe deposit box with him.'"

D'Arpino was taken to Memorial Regional Hospital where he was treated and listed in stable condition Sunday at about 11 a.m. Records show he has a concealed weapons permit as does another, younger family member listed as living in the home.

"I'd like to thank him for standing up for the rest of the neighbors," said Eric Jostad, who lives a few doors down. "We didn't know what it was. You say, 'Nah, it can't be gunshots.' I figured someone was banging on some trash cans."

"He's such a nice guy, and the hurricane wiped [his restaurant] out. He lost power and all his food and then his insurance didn't help," she said, adding that recently, someone had been shooting the store windows with BB guns. "They were just getting on their feet again." He said D'Arpino worked the night shift nearly every night despite his age and his daughter worked the day shift.

Police said they had no suspects in the attempted robbery and shooting. Rode said D'Arpino was not able to give a description of the men in the four-door, white car.

Airline Passengers and NORAD Fighter Jets Handle Bomb Scare Effectively

April 22, a passenger who claimed to have a bomb aboard a United Airlines flight was subdued by other passengers as the California-bound plane was diverted to Denver International Airport, airport officials said.

Two F-16 fighter jets from Buckley Air Force Base scrambled to escort the plane as it flew into Denver Friday, according to Lt. Co. Sean Kelly, a spokesman for NORAD.

Jose Manuel Pelayo-Ortega was arrested after the plane landed around 4:30 p.m., FBI spokeswoman Monique Kelso said.

After the A-320 Airbus landed, it taxied to a remote part of the airport where the passengers got off and were bused to the terminal.

None of the 138 passengers or six crew members was injured, airport spokesman Chuck Cannon said. The flight was headed to Sacramento, Calif., from Chicago.

Authorities searched the aircraft for explosives and re-screened luggage and passengers before they reboarded the plane, which took off for its original destination around 7:30 p.m., Kelso said.

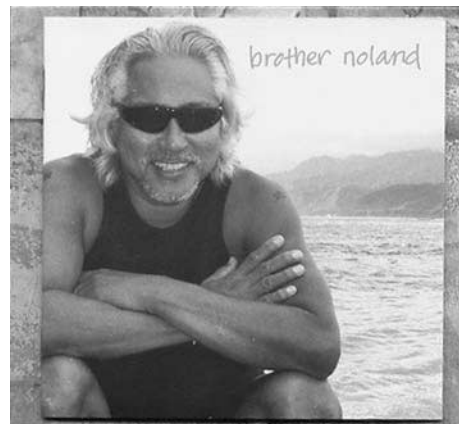

No FREE SPEECH in USA

Woman arrested for speaking freely right after Bush calls for "freedom...to speak freely" -- and CNN calls it "a blemish" on Chinese President Hu's visit to USA.

At an outdoor ceremony, Bush told Hu that China has become successful because the Chinese people now experience the freedom to buy, and to sell, and to produce -- and China can grow even more successful by allowing the Chinese people the freedom to assemble, to speak freely, and to worship.

Seconds later, one of the people assembled on the White House south lawn actually tried to speak freely right here in America

-- about the lack of free speech, human rights violations, and religion freedom in China. She shouted "President Bush: Stop him from killing" and, "President Bush, stop him from persecuting the Falun Gong," as she waved a banner with the red and yellow colors used by Falun Gong, a banned religious movement in China.

That free-speaking woman was promptly hauled off and arrested by US secret service agents who dragged her off the media camera stand.

Bush, standing next to Hu, leaned over and whispered a comment to the Chinese leader, who paused briefly and then resumed his speech of platitudes and praises.

Watching the scene unfold, we felt like we were living on a different planet from the folks at CNN. Any enemy of free speech is an enemy of ours, and we have long loathed the totalitarian regime in Beijing. Like millions of other, we still see the picture of the lone man standing up to a column of tanks in Tiananmen Square as the iconic picture of our times, with freedom of speech considered now as a security breach. The MAN would love to know just what exactly Bush -- the man who, you'll remember, did not utter a word when told the United States was under attack on 9/11 -- whispered to Hu as that poor woman was dragged off. Wonder who pulled the plug there -- the Chinese authorities, or someone at CNN?

China's authoritarian leadership said the Chinese students do not hunger for democracy. "People are actually quite free to talk about the subject," meaning democracy and human rights in China. "I don't think they care that much. I think people would say: 'Hey, U.S. democracy, that's a good form of government. Chinese government, good and stable, that's a good form of government. Whatever, as long as I get to go to my favorite Web site, see my friends, live happily!'"

Meanwhile, free speech continues to slide here at home, USA.

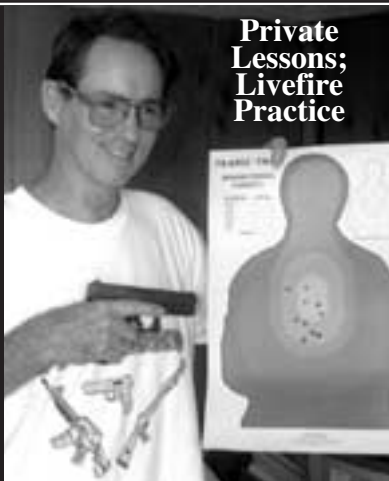
The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

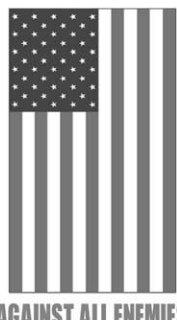
