


## Local Youth Face a Future of Continued Wars.....Are they prepared?

Thousands marched angrily through Kabul on Monday after at least seven people were killed and 40 were wounded following a riot sparked by a fatal traffic accident involving a U.S. military truck... Soon after, thousands of protesters gathered in central Kabul, some marching on parliament and some on the presidential palace. Several hundred congregated at an intersection leading to the heavily fortified U.S. embassy chanting slogans of "Death to America" and burning American flags.

### The Long War"

This little piece of clumsy marketing died off quickly, but it gave away what many already suspected: the War on Terror will never end, nor is it meant to end. It is designed to be perpetual. As with the War on Drugs, it outlines a goal that can never be fully attained—as long as there are pissed off people and explosives. ## There's more to Pasta than just "Spaghetti"

Culinary Arts (cooking) is just one of the enrichment classes offered during the Molokai Intermediate School's UPLINK program. Last Thursday, three students learned about pasta -- fettuccini, linguine, and penne. Personal Chef Don Hill, their instructor in the afternoon class, 3:30-4:30 has a well-planned and organized menu of learning about the tools, ingredients and cooking methods in his "hands on" class using "commercial cooking" techniques.

The aroma of garlic, the heat of cooking pasta, and jovial Chef Don greeted the students who had completed their day's homework in study hall and were eager for a different subject. Donning aprons, washing their hands, they listened to preliminary instructions for the hour -- Four different sauces -- Marinara, Bolognese, Alfredo and breadcrumbs & garlic. With limited time, Chef Don this day, had prepared chopped vegetables and garlic cloves and pre-cooked the pastas. Cheerfully and confidently, students each began preparations, asking Chef Don for advice when needed, for their assigned pasta dishes.

Jaime Duvauchelle was the first to complete the Garlic and breadcrumbs with Penne. She prepared the garlic bits to a golden brown in olive oil, added the al dente cooked penne and a half package of panko -- and voila! Flavorful and simple.



Meanwhile, Nainoa Macadangang stirred the mix of chopped onions, celery and garlic, with ground meat, added a can of crushed tomatoes and simmered it all with a dash or two of Italian Seasoning. His Bolognese sauce was the familiar red meat spaghetti dish enjoyed this day with a lesson on plating pasta with a twist and flourish.

Lulu Umi's Marinara was savory with shredded carrots, celery, onions and flavored with garlic, Italian Seasoning, and tomato sauce served with Linguine. Because of the vegetables, students approached tasting this dish cautiously, gamely sampled the dish, and were thoughtful and reserved in their comments.



Since there were only three students (some days as many as eight), Chef Don prepared the fourth dish, Fettuccini Alfredo, enlisting students to assemble a rich Parmesan and cream flavored sauce.

Following some discussion and reactions about the four sauces, students quickly and efficiently washed dishes, cleaned and were done for the day!

These three students and others who continue to be guided by Master Chef Don Hill, have prepared refreshments for MIS staff & Teachers Appreciation Day, and will be preparing a five course meal for Family Night on June 1st, 5:30 pm. There will be exhibits of student art work and dance performances, too.

At the Molokai Intermediate after school UPLINK program, students are offered academic support through study hall and remedial assistance program to complete homework, work on class projects or build reading and math skills. "UPLINK also offers enrichment classes, character building, and critical thinking skills that promote making healthy choices through a 'hands on' experience that is fun," according to Principal Gary Zukeran.

UPLINK focus on the 5 Cs: Character, Confidence, Connection, Competence, and Contribution. The students and Chef Don are great examples of what is accomplished in the after school program. Spontaneous, resourceful, positive, working as a team and individually, the students serve as models of making healthy choices.

Other enrichment classes have included art, video production, Polynesian music & dance, volleyball, sewing, ukulele and newswriting.

Lynn Bonk is Coordinator for UPLINK. Claudene "Hulu" Joao is the Academic Core Instructor for UPLINK's 7th and 8th grade students.

Though the school year ends June 5th, 7th and 8th grade students are encouraged to explore the opportunities available through UPLINK for a wide variety of classes, field trips and events.

### Long-distance Telephone tax refund ?

Treasury Dept. concedes a Spanish-American War tax on long-distance service is antiquated and consumers are entitled to a refund.

May 25, 2006 - After losing several court battles, the U.S. Treasury on Thursday said it would provide refunds to consumers for a federal excise "luxury" tax on long-distance service, the origins of which date back to 1898 to help pay for the Spanish-American War.

The refund will apply to the 3 percent excise tax billed to them on long-distance service since Feb. 28, 2003 and will include interest. Consumers will be able to claim it on their 2006 tax returns, which they will file in 2007.

"Today is a good day for American taxpayers; it marks the beginning of the end of an outdated, antiquated tax that has survived a century beyond its original purpose, and by now should have been ancient history," said Treasury Secretary John Snow in a statement.

"The Federal Appeals courts have spoken across the board. It's time to 'disconnect' this tax and put it on the permanent 'do not call' list," Snow added.

The tax was passed in 1898, when there was no federal income tax and telephone service was something that only the rich had access to. It was designed as a luxury tax to help the government during a time of high military spending.


Since then, it has become a good revenue generator for the Treasury, raising \$5.9 billion in 2005.

An excise tax is also levied on local service, but that will not be refunded. However, both Snow and Senate Finance Committee Chairman Charles Grassley (R-Iowa) said Thursday they would like lawmakers to abolish the excise tax in its entirety.



"We have staked the whole of all our political institutions upon the capacity of mankind for self-government, upon the capacity of each and all of us to govern ourselves, to control ourselves, to sustain ourselves according to the Ten Commandments of God." —James Madison

### Bill of Rights 2nd Amendment:

**"A well regulated militia being necessary to the security of a free State, the right of the people to keep and bear arms shall not be infringed."**

**Wake up militia! Use it , or lose it ! Got your gun, yet?**

Dr. Carter's translation of the **Bill of Rights** into Hawaiian language is supported by his extraordinary gift for the language, and his dedication to authentication and accuracy. "In order to acquire the style of "legal-speak" in Hawaiian, I studied the available copies of the Hawaiian constitutions of the 19th century (the ones published in 1839, 1840, 1852, 1864, and 1887). All five of those constitutions were published in both Hawaiian and English," explained Dr. Carter, who added "It's no surprise, for obvious reasons, that the U.S. constitution served as a model for the Hawaiian constitutions."

People who are fluent in Hawaiian will enjoy reading this historic document also because of Dr. Carter's effort to reproduce accurately the older style Hawaiian language. "I used some of the older vocabulary, spellings, and expressions, where possible, in order to capture some of that older "feel" in the Hawaiian translation that I wrote," wrote Dr. Carter who has a copyright on this unique document.

## Local Farmers Join Decontamination of Hawaii Island Organic Papaya Farm of GMO pollutants

University of Hawaii Sells GMO Contaminated Papaya Seed to the Public Locally and Internationally

Hilo, Hawaii –Thursday, May 25th, local papaya farmers and native Hawaiian activists concerned about genetically engineered papaya joined Greenpeace experts in decontaminating an organic farm in the Puna district of Hawaii Island that has been tainted with genetically engineered (GE) papaya from nearby commercial farms. The farm will be sealed off with signs reading, “GE Papaya Restricted Area” as volunteers in hazmat suits remove trees, fruits and seeds from the scene.

GE papaya profits have dwindled significantly as a growing number of global markets reject the crop. Organic farmers in Hawaii are especially alarmed, as the state is considered a contamination hot spot with the most GE field trials per square mile in the world and the only place where GE papaya is grown commercially.

Greenpeace has been at the forefront of decontamination efforts around the world, assisting farmers concerned about genetic engineering tainting and stopping illegal distribution of GE papaya in countries such as Japan and Thailand that have put a ban on these crops.

Organic and conventional farmers have suffered losses, as it is difficult to guarantee the GE-free status of their crops due to contamination from neighboring commercial GE farms. Greenpeace is calling on governments and industry to protect its farmers and consumers from the food safety and environmental risks posed by genetically engineered foods.

ALSO: Independent laboratory testing results released last week reveal that the University of Hawaii’s non-GMO papaya seeds are GMO contaminated. Hawaii SEED purchased seed packets of Waimanalo Solo, Sunset Solo, and Sunrise solo directly from the University. These 10,000 seed samples were sent to Genetic ID for PCR testing. The Waimanalo Solo variety tested positive for the GMO contamination. Two years ago Hawaii SEED (then GMO Free Hawaii) informed the University of Hawaii that its seed supply was GMO contaminated. The University denied contamination. These recent tests confirm that the University continues to sell GMO contaminated seeds.

A new report titled, “Hawaiian Papaya: GMO Contaminated,” is available on Hawaii SEED’s website <http://www.gmofreemaui.com/content.php?article.24>. The report describes breaking news on current test results of UH’s non-GMO seed supply plus the GMOPapaya Contamination Study that the group released data from in 2004. Shocking results included Hawaii Island had 50% GMO Contaminated, Oahu had >5% GMO Contamination, and Kauai had 0% GMO Contamination. The two organic farms tested had non-GMO trees, but GMO air contamination of the seeds in the fruit. The University of Hawaii’s non-GMO papaya seed stock showed contamination greater than 0.01% but less than 0.1% in the Waimanalo Solo variety.

“The University of Hawaii even sells non-GMO papaya seeds with a claim that they are not grown near GMO fields, but now we find that it is still GMO contaminated. The contamination levels we found mean one to ten GMO seeds per packet. This means one to ten GMO trees on an organic farm or on a farm in a country where it is illegal to grow GMO Papaya. UH sells some of this seed to growers around the world.” -Melanie Bondera, Hawaii SEED Spokesperson

“I am concerned that the traditional non-GMO papaya varieties continue to show GMO contamination. This proves how difficult is to contain GMO plants from polluting non-GMO plants. It’s amazing how long ago we brought this up, and the University of Hawaii still hasn’t responded.” –Dr. Hector Valenzuela, Vegetable Crops Extension Specialist, University of Hawaii, Manoa.

## Secret FEMA Plan To Use Pastors as Pacifiers in Preparation For Martial Law

Nationwide initiative trains volunteers to teach congregations to "obey the government" during seizure of guns, property, forced inoculations and forced relocation

A Pastor has come forward to blow the whistle on a nationwide FEMA program which is training Pastors and other religious representatives to become secret police enforcers who teach their congregations to "obey the government" in preparation for a declaration of martial law, property and firearm seizures, and forced relocation.

The Pastor was invited to attend a meeting of his local FEMA chapter which circulated information about preparedness for a potential bio-terrorist attack, any natural disaster or a nationally declared emergency.

The FEMA directors told the Pastors that attended that it was their job to help implement FEMA and Homeland Security directives in anticipation of any of these eventualities. The first directive was for Pastors to preach to their congregations Romans 13, the often taken out of context bible passage that was used by Hitler to hoodwink Christians into supporting him, in order to teach them to "obey the government" when martial law is declared.

It was related to the Pastors that quarantines, martial law and forced relocation were a problem for state authorities when enforcing federal mandates due to the "cowboy mentality" of citizens standing up for their property and second amendment rights as well as farmers defending their crops and livestock from seizure. It was stressed that the Pastors needed to preach subservience to the authorities ahead of time in preparation for the round-ups and to make it clear to the congregation that "this is for their own good."

We have received confirmation from other preachers and Pastors that this program is a nationwide initiative and a literal Soviet model whereby the churches are being systematically infiltrated by government volunteers and used as conduits for martial law training and conditioning. The Pastor was told that over 13,000 counties were already on board. It part of the umbrella of the NVOAD program which is training volunteers in a "Peer to Peer" program in a neighborhood setting.

Pastors were told that they would be backed up by law enforcement in controlling uncooperative individuals and that they would even lead SWAT teams in attempting to quell resistance. Police provided cover for a FEMA house-by-house search in New Orleans. "We get the the picture that we're going to be standing at the end of some farmer's lane while he's standing there with his double barrel, saying we have to confiscate your cows, your chickens, your firearms," said Pastor Revere.

The Pastor elaborated on how the directives were being smoke screened by an Orwellian alteration of their names. "They're not using the term 'quarantine' - this is the term they're going to be using - it's called 'social distancing' don't you like that one" ?

Pastor Revere said that many attendees believed in the necessity of the program and were completely unaware to the motivations behind its true purpose and were offered incentives to become volunteers such as preferential treatment and first access for themselves and their families to vaccines and food shipments in times of emergency.

The precedent for mass gun confiscation in times of real or manufactured emergency was set during Hurricane Katrina when police and national guard patrols forced homeowners even in areas unaffected by the hurricane to hand over their legally owned firearms at gunpoint.

Shortly after 9/11 a Phoenix FBI manual that was disseminated amongst federal employees that potential terrorists included, "defenders of the US Constitution against federal government and the UN," and individuals who "make numerous references to the US Constitution."

In another twilight zone Nazi-like spectacle, Pastors were asked to make a pledge or an affirmation during the meeting to fulfil the roles ascribed to them by FEMA. They were given assurances that they would be covered by full compensation in the event of resisters injuring them during property seizures and round-ups.

The Pastor said that his county had already succumbed to a tattle-tale like mentality where neighbors were reporting neighbors to the authorities for things like having chickens in their back yard. The brown shirt precedent has been set whereby people immediately turn to the authorities in fealty whenever their paranoid suspicions, fueled by zealous government and media fearmongering, are heightened.
