

Josephine Adolpho, Salutatorian spoke to the Dr. Seuss theme O the Places You Will Go.







New Book Reless: **WESTLAKE**Poems by Wayne Kaumualii Westlake (1947-84) Edited by Mei-Li M. Siy and Richard Hamasaki

Born on Maui and raised on O'ahu, poet Wayne Kaumualii Westlake was a prolific writer whose too brief life and career. He broke new ground as a poet, translated Taoist classical literature ad Japanese haiku, interwove perspectives from his Hawaiian heritage into his writing and art, and published his work locally, regionally and internationally. At the time of his death in 1984, only a 32-page limited edition chapbook independently published by a small press was available.

In this recent 275-page book published by the University of Hawai'i Press, Westlake's friend and colleague, Richard Hamasaki, introduces the writings by describing the "all too brief life and literary career." Educated at Punahou with an athletic scholarship, he is described as a good student who dis-



played hints of creativity that emerged in his poems. Westlake's work reflects his native Hawaiian lineage, his interest in Asia and Oceania, and his intense research into geothermal energy as well as Kahoolawe history, particularly petroglyphics. Westlake and Hamasaki taught in the Poets in the Schools Program, ad with others began collaborating on a literary magazine, *Seaweeds and Contructions*.

In 2001, seventeen years after his death, Westlake's former partner and present literary executor, Mei-Li M. Siy opened boxes stored in a shed near her family's home. That began a journey for Siy and Hamasaki to organize and select published and unpublished work written by Westlake from the late 1960s to 1984. Westlake's poetry, sketches, teachings and thoughts of sovereignty are in his unique style{Westlake, ISBN 978-0-8248-3067-0University of Hawai'i Press, 2009, 275 pp]. Deeply affected in the Kahoolawe after the disappearance of George Helm and Kimo Mitchell as they searched for Walter Ritte, Jr. and Richard Sawyer and the arrest and incararceration, he compiled and self-published a collection of poems, "Kahoolawe-- Chants, Legends, Poems, Stories by the Children of Maui," written by students in his Poets in the Schools program. His discovery of fragile petroglyphys after a 10-day volunteer archaeological study, and his interview of Ritte and Sawyer published in the Hawaii Observer "introduced beyond mere tokenism, a significant body of Hawaii's literature beyond the class-WESTLAKE may be a small sample of his writings, a collection of thoughtful, insigntful, artful -- a volume to be picked up, read, and re-read.




Judges are impeachable. Furthermore, judges may be removed immediately for violating oaths of office, involvement in conspiracies, extortion, and failing to uphold their duty

Obama's Wars Increase in Iraq and Afghanistan Using Contractors

According to new statistics released by the Pentagon, with Barack Obama as commander in chief, there has been a 23% increase in the number of "Private Security Contractors" working for the Department of Defense in Iraq in the second quarter of 2009 and a 29% increase in Afghanistan, which "correlates to the build up of forces" in the country.

These numbers relate explicitly to DoD security contractors. But the number of individual "security" contractors could be quite higher, as could the scope of their expansion. Overall, contractors (armed and unarmed) now make up approximately 50% of the "total force in Area of Responsibility."

This means there are a whopping 242,657 contractors working on these two US wars. These statistics come from two reports just released by Gary J. Motsek, the Assistant Deputy Under Secretary of Defense.

At present there are 132,610 in Iraq and 68,197 in Afghanistan.

Obama Breaks Promise to delay bill signings

It seemed among the easiest of his transparency pledges and is entirely under his control, but President Obama is finagling his promise to post bills on the White House Web site for comment for five days before he signs them.

Mr. Obama last week signed four bills, each just a day or two after Congress passed and sent it over to him.

The White House said it posted links from its Web site to Congress' legislative Web site about a week before Mr. Obama signed the measures, but transparency advocates say that doesn't match the president's pledge to give Americans time to comment on the final version he is about to sign.

"He didn't say, 'When there's a bill heading to my desk,' or 'When we're pretty sure a bill will soon be passed.' He said when a bill ends up on his desk - a strong implication that public review would follow the bill arriving at his desk," said Jim Harper, director of information policy studies at the Cato Institute.

"When there's a bill that ends up on my desk as president, you the public will have five days to look online and find out what's in it before I sign it, so that you know what your government's doing," Mr. Obama said in a major campaign speech laying out his goals for transparency.

Mr. Harper said that to him, the pledge means putting a copy of the bill on www.whitehouse.gov and then waiting five days to allow comments to roll in.

"That's the only interpretation of this promise that delivers solid transparency," he said. "Posting a bill late in the process doesn't give the public a chance to review the final legislation - especially last-minute amendments, which are where a lot of congressional hijinks happen."

Hawai'i's REAL program was represented by Brandon Antonius and Alex Halley of Maui, Michelle Magdirila of Molokai, and Courtney Viernes-Silva of Oahu, accompanied by Nicole Sutton, REAL project coordinator. They received the award in May at the Campaign for Tobacco-Free Kid's 13th Annual Youth Advocates of the Year Awards Gala

Michelle Magdirila is a senior at Molokai High School. She has been involved with REAL since 2006 and has served on REAL's statewide leadership team. Currently she is a statewide leader with the Tobacco and Alcohol Advertising Survey.

REAL is a youth-driven peer-to-peer education anti-tobacco group under the guidance of Dr. Cheryl Albright of the Cancer Research Center. REAL was one of the nation's first statewide, youth-led tobacco control movements founded after the 1998 state tobacco settlement. REAL advocates have worked to pass and defend a statewide smoke-free workplace law and advocated for a tobacco tax increase that passed on the first try. REAL has also worked on issues that reach beyond Hawai'i, such as supporting FDA regulation of tobacco products and the Framework Convention on Tobacco Control.

With no paid media support, REAL works through peer-to-peer marketing and grassroots mobilization. The youths' proudest achievements include a "Girl Talk" campaign in response to R.J. Reynolds' marketing of Camel #9 cigarettes, and "Youth Unite for Kick Butts Day," an all-day event at the state Capitol.
