

# Illegal Trash Fire Smoke Chokes Waialua Valley June 9



This year's brush fire season is under way as expected, according to Maui Fire Chief Jeff Murray. The choking billowing smoke from this out of control trash fire that originated at Theo Wainwright's residence in Waialua Valley in the afternoon of June 9 was an example of how easily dangers posed by illegal trash fires can become a real life problem, and expensive for Taxpayers who pay for the MFD helicopter that was called in to dump ocean water on the blaze that was inaccessible to MPD pumper trucks. "People need to be more responsible, whether it's cigarettes or open fires, campfires or cooking fires. They just need to be aware. With the dry conditions, if something gets started, it's going to go quickly," noted Murry.

Murray said residents also can help by calling 911 as soon as they see something suspicious. "We would rather be there early," he said. "In three to five minutes, that brush fire will be a lot bigger and a lot harder to control."

The importance of trimming overgrowth and clearing debris, especially near residents living on the edge of wildland areas are precautions of vital importance, and law. A minimum brush clearance of 30 feet is required around houses and other structures, although a larger area is called for in some situations. "If you are downwind or uphill of an area, the distances could be increased up to 100 feet," he said.

Nineteen citations have been issued so far this year for fire hazard violations. If a lot hasn't been cleared by the time of a follow-up inspection, a second letter is sent notifying the owner of the violation carrying fines of up to \$1,000 a day.

Murray said Fire Department commanders have been working to respond quickly to brush fires, calling on the Fire Department's Air One helicopter, county bulldozers and other resources to stop the fires from spreading.

In the public interest, the people who are responsible for illegal fires should be required to pay for the expense of extinguishment.



#### Kamehameha Day Holiday June 11, 2008

The first Great Anexator of the Hawaiian Islands was King Kamehameha I (1740-1819). With the aid of two American sailors, John Young and Issac Davis, and the military methods and musket and cannon, mounted on the bow of his ocean going war canoes, Kamehameha I was able to spill the blood of thousands of Hawaiian warriors resisting on each island, and thus annexed each island into his Kingdom of Hawaii by the 1795. Only Kauai was not yet conquered.

Before Kamehameha, the eight major Hawaiian Islands of the mid 1700's, isolated by thousands of miles of open ocean, was home to approximately 1,000,000 Kanaka Maoli,the descendants of native Americans and Inca's adrift at sea, ancient seafarers from the southwest whose migrations eventually settle most of Polynesia, and an occasional shirwrecked European or Asian sailor. Each island a system of feudal states ruled by Ali'i(chiefs) and Kahuna (priests) bonded by blood thru polygamy, constantly battling for control. The bountiful 'aina (land) and wai (water) worked by maka'ainana (commoners) and kauwa (slaves) captured in war, farmed taro loi (fields) and loko i'a (fishponds). Athe harvest time, the Makahiki, a celebration of games lasting from October to January mandated a cecession of all work and war. Human sacrifice was offered to the Gods, insuring success in war, good harvest and spiritual favor. Cannibalistic rites passed the mana (wisdom and power) from chiefs to chief.

Kamehameha I also tried to unite all of Polynesia via Tahiti though marriage, but that attempt failed. The end of his rule came on May 8, 1819.

Chief Kalaimoku expressed the feeling of those present that on this exceptional occasion in honor of our Great Chief. Kamehameha's bones were hidden in a cave in the hills behind Kona, inviolate to this day, having been gleaned and flesh consumed to insure mana as was the custom.



#### **COMMON LAWS**

<u>Hawaii Revised Statutes section 1-1:</u>

The common law of England, as ascertained by English and American decisions, is declared to be the common law of the State of Hawaii, in all cases, except as established by Hawaiian usage; provided that no person shall be subject to criminal proceedings except as provided by the written laws of the United States or the State of Hawaii.

The vast government bureaucracy consists of employees whose job duties can never be confused with legal duties. Since the United States district court judges obtain whatever authority they have pursuant to Article IV of the Constitution, they are accurately employees rather than officers of the United States. #### Crimes of Politicians Must Be Stopped by The People (You are The Militia)




Judges are impeachable. Furthermore, judges may be removed immediately for violating oaths of office, involvement in conspiracies, extortion, and failing to uphold their duty
