## Racist Akaka Bill is DEAD

*He maka'ala mau loa i ke kumu ku'oko'a* Eternal vigilance is the price of freedom.

**No people who have to ask to be Sovereign, will ever be.**

The US Senate voted 56-41 in Washington, D.C. last week to reject Hawaii senator Dan Akaka's efforts to bring the Akaka bill to the floor for debate and a vote.

While people in Hawaii are divided over the bill, it had the solid support of Hawaii's Democrat congressional delegation, OHA, and the Republican Administration of Lingle/Aiona. She and Hawaii A. G. Mark Bennett wasted taxpayers' dollars in D.C. before the vote to lobby Republican senators to support the ill-advised bill.

The Akaka bill, originally introduced in 2000, would create a process for a Native Hawaiian government to be recognized by the federal government, similar to the political status given to American Indian tribes. But, thousands of Native Hawaiians protested against the bill itself, as well as the lack of public hearings or local vote.

Opponents said it would create an unconstitutional, race-based government. Sen. McConnell said the bill "violates the letter and spirit" of the Constitution. "The way this bill tries to maneuver around this unconstitutionality is by ... creating a new tribe of Native Hawaiians," he said. "But this new tribe is a shell game. As recently as 1998, the state of Hawai'i itself acknowledged that the tribal concept has no historical basis in Hawai'i." Sen. John Cornyn concurred, adding that Congress couldn't "simply and arbitrarily" create an Indian tribe where none existed before.

U.S. Civil Rights Commission objected, this bill risks "further subdividing the American people into discrete subgroups accorded varying degrees of privilege." The Akaka Bill raises the serious threshold constitutional issues that arise anytime legislation seeks to separate American citizens into race-related classifications rather than "according to their own merits and essential qualities." Indeed, in the particular context of native Hawaiians, the Supreme Court and lower Federal courts have invalidated state legislation containing similar race-based qualifications for participation in government entities and programs."

Senate Republican Majority Leader Bill Frist reported that Senator Akaka recently made clear that this race-based Native Hawaiian government would have been under no obligation to remain within the United States or to adhere to the most basic of our political principles: "[T]he governing entity will make a decision as to what happens to independence or returning to the monarchy."

Many local people want those responsible to be held accountable. Ken Conklin gave this litney: "Shame on Governor Linda Lingle for squandering her political capital in Washington on the Akaka bill when there are so many productive things she might have used it for. Shame on Attorney General Bennett whose title tells us he surely knew (or should have known) all along that this bill is bad policy and worse law. Shame on our Legislators for repeatedly voting in favor of resolutions supporting the Akaka bill even when some of them privately said they think it's disgusting. They are cowards, and they also refused to place the issue on the ballot for Hawai'i's people to vote. Shame on them all, plus the OHA trustees, for spending many millions of dollars of our government money on lobbying, advertising, consultants' fees, postage, first-class travel, etc. Shame on them all for putting us through this wringer for so many years, causing divisiveness in this land of Aloha. It's time for the people of Hawai'i to stand up and be counted. *E ku'e kakou i ka palapala a Akaka, a me na po'e kako'o ana kela.* (Let's all stand opposed to the Akaka bill and to the people supporting it).

**George Peabody**, who is challenging Lingle for the GOP nomination for Governor in the Primary, said he is happy the Akaka bill is dead. "The record shows I have opposed this racist bill from its inception, and that is a very significant contrast to Lingle's history of racial bias," he said. "There is no reason why Hawaiians or any other ethnic, racial, political or religious group in the world may not exercise their own degree of local sovereignty without requesting federal recognition, and still be part of the whole of society. The fact that the republican FORM of government is not allowed to function as mandated by our Constitution

for the United States of America is the root of all political chaos. Read the Constitution for the United States of America and the Bill of Rights, then you may understand the advantage of republic government that vests the crown upon every man in his own right. The problem is caused by people who don't recognize their own God-given sovereignty — they demand socialism and "Give us a King, a Queen!" instead of "give me liberty or give me death! Time to vote out of office all the incumbent Democrats and Republicans! Enforce the Bill of Rights, and let this defeat of the racist Akaka bill be the start of a Revolution for equality under law, and sovereignty of The People."

## Alu Like - Moloka'i Celebrates a Special Time and Special Kupuna

A 30th Anniversary Celebration, Founders' Day Special Tribute to Aunty Anita Arce and Honors for Na Lei Hulu Mamo (Our Precious Kupuna) was observed on Wednesday, June 7th at Kulana 'Oiwī Halau.

It was an occasion for special Oli Aloha by the Moloka'i Alu Like staff, with interpretation by Vanda Hanakahi, who wrote the Oli at the request, many years ago by Aunty Anita Arce and help from Kumu Hula John Kaimikaua. The Oli Aloha describes the Island of Moloka'i, its significant landmarks and historically important architects/engineer who symbolize the work of Alu Like with Native Hawaiians from infancy to kupuna. In these thirty years, Alu Like's greatness of work followed the path to all areas of Moloka'i.

Kupuna Anita Arce, was honored for her contributions to the lives of opio, makua and kupuna as Alu Like's Outreach Facilitator since 1991. Aunty Anita is recognized as a practitioner of Ho'oponopono, La'au Lapa'au, Lomi lomi and Ai Pono.

Aunty Anita Naeole Arce received the 2005 Kaonohi Award by Papa Ola Lokahi for her significant contributions towards improving health of Native Hawaiians and Hawaiian families. Her work with the Alu Like Offender/Ex-offenders Program back in the 1990s, and as a founder of Kahua Ola Hou are just two of the projects she has been the kumu for so many. In his tribute, Wayde Lee describes Aunty Anita, "She taught me many things, to be humble, God comes first, give freely, take care of your kuleana." She gave the name Kahua Ola Hou-- The Foundation for a new beginning, for the 21-day, 24/7 wellness center that provides pu'uhoonua for youth between ages 14-21 who are affected by substance abuse within their families. Wayde Lee describes Aunty Anita's wisdom for the center's participants, "Make them healers...of themselves."

Married to Stephen Arce, Sr. since 1943, Aunty Anita and her husband had seven children -- "uku pile a kids" as Wayde Lee told of Aunty Anita's contributions to our community. Some of her 20 grandchildren and 21 great grandchildren were there to hear tributes to their kupuna. Aunty Anita continues to recover from a stroke, but she greeted her friends, family and co-workers at last week's celebration with undiminished warmth, grace and presence. As her daughter Lynn said, "Mom is a true believer in Alu Like's mission."

# IRS Begg to Dismiss Case!

On May 12, 2006 in Peoria, Illinois, the attorney for the U.S. Department of Justice (IRS/DOJ) begged the court to dismiss all charges against IRS victim Robert Lawrence in federal District Court. [IRS crimes are coming public!-The MAN]

Robert Lawrence knew his rights under the IRS laws, and IRS/DOJ attorneys knew that they would not prevail on their Motion designed to keep Lawrence from effectively arguing a defense regarding the fraud of the IRS 1040 form. The IRS/DOJ begged the judge to dismiss the indictment against Lawrence because a public trial would have opened a "Pandora's Box" of legal evidence and government testimony under oath that would establish the IRS 1040 form is both fraudulent and counterfeit.

The IRS/DOJ dismissed the indictment against Lawrence, with prejudice, by a dismissal motion that was filed at 2 p.m. on May 12, 2006, meaning they cannot renew the same false charges against him. Indicting and then permanently dismissing without any court action occurs so rarely as to require the IRS/DOJ to post a public explanation in order to satisfy the public's curiosity about this strange working of justice, but they won't because they do not want American Citizens to know they are not required to file the fraudulent unlawful IRS1040 forms, and the government controlled media will not tell you of this case. You read it in The MAN.

Section 3512 of the IRS/PRA law, titled "Public Protection" reads in part:

(a) Notwithstanding any other provision of law, no person shall be subject to any penalty for failing to comply with a collection of information [on 1040 form] if it does not display a valid control number assigned by the Director in accordance with this subchapter [44 USCS § § 3501 et seq.]; or (2) the agency fails to inform the person who is to respond to the collection of information that such person is not required to respond to the collection of information unless it displays a valid control number. (b) The protection provided by this section may be raised in the form of a complete defense, bar, or otherwise at any time during the agency administrative process or judicial action..."

The IRS never submitted a "supporting statement" as required to "identify any legal or administrative requirements that necessitate the collection of info on a 1040, nor did the IRS attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information." and did not include information regarding the "burden" imposed upon the public as a result of the "collection of information." because there is no law that requires American Citizens to file such unlawful 1040 IRS forms.

It is obvious that in accordance with the IRS laws and the circumstances of the dismissal of the Lawrence case that Americans have no obligation to file the unlawful IRS's1040 forms that bear no current, valid OMB control number. Countless other individuals maliciously prosecuted by the IRS/DOJ do not know their Rights or the IRS's and OMB's obligations to protect them from abuse by the IRS. As a result, the IRS and DOJ conspire at all levels, from senior executives to the lowliest agents and legal assistants, to prosecute, penalize, and victimize innocent Americans for failing to file a bootleg 1040, even though IRS victims have no legal obligation to file it.

The Lawrence case raises serious "abuse of federal power" concerns. Since 1981, the IRS/DOJ's enforcement actions appears to be unlawful, but also OMB employees appear to have willingly looked the other way rather than to require IRS to fully comply with the Law and to report the IRS's miscreant negligence to the U.S. Treasury Secretary and the President.

In addition, various federal judges and their law clerks who know the legal meaning of the phrase, "Notwithstanding any other provision of law," have blatantly ignored the clear and unambiguous meaning of the provisions of the PRA. Instead of heeding it and advancing its protections to the aid of IRS victims, they have waged complicit war against the People for willful failure to file a bootleg 1040 form under a variety of vague, confusing, circuitous, and questionable provisions of the Internal Revenue Code.

Under the facts and circumstances of the last 24 years of IRS abuses, and the 2006 Lawrence case, it is safe to say that IRS Form 1040 is a fraudulent, counterfeit, bootleg form. Government officials responsible for this fraud should be investigated and face indictment for willfully making and sponsoring false instruments, and the malicious prosecutions of American Citizens.

We the People of the United States of America orders your IRS/DOJ minions to immediately follow the law to the letter to protect the rights of American Citizens against further abuses by the IRS/DOJ, lest they face criminal prosecution for violating numerous laws and the Constitution of the United States of America, not the least of which are their oaths of office. Further we demand that you order IRS employees to immediately stop persecuting and maliciously prosecuting those who do not file the fraudulent, counterfeit IRS 1040 form.

Bank of America admits to forcing U.S. workers to train InfoSys/Tata replacements. Last week, further evidence surfaced that U.S. workers are being displaced by low wage foreign workers- this is happening under the radar across the country. This is the program that the Senate wants to expand.

Shirley Norton, a Bank of America spokeswoman, confirmed that while workers aren't being explicitly told they have to train their replacements or risk losing severance pay, they are being instructed that severance pay is contingent on satisfactorily completing their jobs. Completing their jobs, in turn, can include training replacements from India, she said.

A senior engineer at BOA said "They're here to learn our jobs and then leave. Some go back to India, and some settle here, where the headquarters is." Why would BofA hire Indians to work in the United States? "Because they don't actually work for Bank of America," the engineer replied. "They work for Infosys Technologies and Tata Consultancy Services, which are both in India. They do the work at half the cost of what a U.S. worker gets paid.", and they are here on H-1B visas.

American citizens are being forced out of the labor market by imported cheap labor - both for the high end jobs and the low end jobs, laborers, teachers, nurses, farm workers, even the U.S. Army is taking foreigners. This is economic warfare on the American people - and it is being waged on us by the corporate owned puppets in Congress.

### Request of Young Brothers, Ltd, to discontinue its less than container load service for the transportation of cargo to and from Kahului Harbor [Maui] **DOCKET NO. 2006-0120**

NOTICE IS HEREBY GIVEN that the STATE OF HAWAII, PUBLIC UTILITIES COMMISSION ("Commission"), will hold public meetings relating to the Transmittal of YOUNG BROTHERS, LIMITED ("YB"), filed on April 13, 2006, for approval to discontinue its less than container load service for the transportation of cargo to and from Kahului Harbor, island of Maui.

YB is a water carrier authorized to transport property by barge between the islands of Oahu, Hawaii, Kauai, Maui, Molokai, and Lanai. YB's intrastate water carrier operations are subject to the Commission's regulation. YB currently consolidates and deconsolidates cargo at its ports of call for shippers that do not place their cargo in containers.

YB proposes to discontinue its less than container load service for the transportation of cargo to and from Kahului Harbor in order to address the critical shortage of available harbor space at that port of call. YB explains that its proposal, if approved by the Commission: (1) will mean that the consolidation and deconsolidation of less than container load cargo bound for or leaving Kahului Harbor will have to occur at off-harbor sites located away from Kahului Harbor; and (2) motor carriers of property are or will be available as consolidators/freight forwarders. YB seeks to implement its proposal effective from January 1, 2007.

### DEAR EDITOR: DRUG WAR Worse than Drugs!
