Details about his adolescent years at Iolani and Punahou schools in Honolulu (1879 - 1883), factors in the formation of his character, and his five additional extended visits to Hawaii to found revolutionary societies, raise money, and recruit followers, ending in 1910. In 1911 the revolution he led was successful in toppling the 2000 year monarchy in China. Sun became President of the Provisional Government and then the first President of the Republic of China.

In doing so he followed the same revolutionary career path as another Punahou student had followed 18 years previously. Sanford B. Dole, a native-born subject of the Hawaiian Kingdom, was a member of the Kingdom legislature and a Justice of the Kingdom's Supreme Court, but resigned before the Hawaiian revolution in order to become President of the Provisional Government and of the Republic of Hawaii. Sun was present in Hawaii, founding revolutionary societies, raising money, and gathering recruits, at the same time Dole was leading the Hawaiian revolution. It seems reasonable to guess that Sun was inspired by Dole.

Ex-CIA says Obama Birth Certificate FORGED by Hawaii DOH w/FBI coverup



Legislature Approves Committee to investigate "Executive Agreements" between USA and Hawaiian Kingdom in 1893

After Queen Liliuokalani was deposed in 1893, two agreements were made between then US President Grover Cleveland and Liliuokalani, and the 2011 Legislature House is calling for an investigation of the validity of those two agreements and whether they are enforceable today, 118 years later.

HCR 107 introduced by Rep. Mele Carroll was approved to set up hearings to gather information about the two agreements, identified as the Liliuokalani Assignment issued January 17, 1893 that tells the US President to administer Hawaiian Kingdom law. The 2nd, Agreement of Restoration Dec. 1893, tells the US President to restore the Hawaiian Kingdom government with Liliuokalani as Queen as it was prior to the overthrow.

Questions posed: Were the agreements valid then, and now? Do they preempt Hawaii state laws as official treaties [between USA and a deposed Queen?] And, what affect do these agreements have on real property titles?

Rep. Mele Carroll also introduced a race based initiative to establish so called Kanaka villages for the homeless population of Native Hawaiians, estimated at 40% of all homeless in the state, to be located on DHHL properties.

Simply, it would establish places where native Hawaiians can camp in tents or other approved shelters and subsist on the land by traditional Hawaiian methods of sustainability, without fear of harassment and eviction.

The State recognition bill could allow the following:

1. Create a five member commission within six months to create a roll of qualified Native Hawaiians to participate in recognizing a Native Hawaiian government. Members, one from each county and one at large, will be appointed by the governor from a pool of candidates recommended by Hawaiian individuals and organizations.

2. Publish the names on the roll list to facilitate a convention to decide how the Native Hawaiian government will be organized. The mechanics of a convention are left up to the Native Hawaiian groups including OHA, and could require additional enabling legislation. One the roll is published, the commission is dissolved, and a report to the 2012 Legislature on progress.

Like the now dead AKAKA bill, the state recognition bill requires participants in the nation building process to show their genealogy connections back to prior to 1778 and/or were eligible for Hawaiian Homes Commission Act programs in 1921, and that they have maintained a significant cultural, social or civic connection to the Native Hawaiian community and want to participate in organizing a Native Hawaiian governing entity.

State senator Malama Soloman said the nation building convention might be similar to the way the Democratic Party is organized in Hawaii. [Organized Criminals for Obama?] with precinct level replaced by ahupuaa, then moku.

Clayton Hee and Soloman said this is a "move toward making right the wrong of the overthrow of the Hawaiian Kingdom", but they did not specify any particular wrongs they perceived nor refer to the facts of the overthrow from history by Hawaiian citizens, and members of the Hawaiian cabinet and legislature.

Governor Neil Abernethy is likely to support it by the July 12 signing deadline, his press secretary Donalyn Dela Cruz said. He has always supported Native Hawaiian recognition, including self-determination, she added.

Millions Suspect Obama Not A Natural Born Citizen, not Eligible to be President

The list is growing of those openly acknowledging the Obama long-form birth certificate released by the White House on April 27 is a **FORGERY**.

"That former CIA agents are beginning to weigh in on the White House forgery is important. It makes no sense — unless of course there is no long-form birth certificate in the Hawaii DOH vault." Hawaii governor Neil Abernethy reported he could not find it, sooooo.....?

When Obama released the purported long-form certificate, officials in the Hawaii Department of Health and governor's office refused to simply confirm to WND that the image being presented by Obama was an accurate representation of the records maintained by the state.

Vallely said the document should "thoroughly be analyzed by FBI officials and analysts to determine if in fact and validate whether it's forged or real."

"One of the apparent flaws in that document was they listed Kenya as the place of birth of Obama's father, but Kenya was not an established country by that name at that time," he noted.

"There's still a lot of controversy about it, and some of us would just like to have this thing clearly authenticated. Let the truth be know to Americans."

He also cited one of the many issues raised by document experts who have challenged the birth certificate's authenticity — the layering in the Adobe computer file Obama posted online purporting to be a copy of his real birth record.

"That's true, because they don't believe he is eligible. You have a fairly growing contingent out there."

Vallely also made similar statements in an online radio program in which he supported Lakin, the Army doctor who refused orders because neither the military nor the White House would document Obama's eligibility. He spent five months in Fort Leavenworth and only recently was released.

"Obama's birth certificate — I've had retired CIA agents and other investigators go over the birth certificate that was produced and by far, 10 out of 10 have said it's a forgery. So we still have that corruptness going on in the White House. There's a great number of organizations and people still trying to find out who Barack H. Obama is, where he was born, does he qualify as president of the United States. We know for sure that the Constitution has been violated in Article 2, particularly when you look at the natural-born status requirement."

LA Forced to Issue Concealed Carry

San Diego, CA On Thursday, June 9, 2011, Los Angeles Superior Court Judge Terry Green granted a motion against the City of Los Angeles to force LAPD to comply with a 16-year-old Consent Judgment to issue CCW permits.

LAPD has repeatedly sought to avoid its obligations under the judgment and to keep people in the dark about what it takes to get a CCW in the City of L.A.

Does this sound like MPD and HPD and KPD ? You bet! They violate the law and the 2nd Amendment all the time. Wake up Hawaii !

Under Penal Code § 12050, the LAPD has an obligation to process applications for CCWs, and to issue CCWs if the applicant has "good cause." For many years, the City and the LAPD had a policy of not making CCW applications available, never finding good cause to exist, and effectively prohibiting the issuance of any CCWs. The City's unlawful refusal to properly process CCW applications and issue CCWs was challenged in two lawsuits in 1992 and 1994.

To settle the suits the LAPD agreed to be bound by a Judgment requiring that all citizens who request a CCW permit application could get one at any LAPD station house, that the application would be accompanied by a written copy of the LAPD's procedure for handling the application, including the factors used to determine whether an applicant has "good cause" for the CCW, and that applicants would be informed of the procedures for appealing the denial of a CCW application. The settlement also established a Citizens Advisory Review Panel, made up of appointed citizens who would review CCW applications denied by the LAPD and make recommendations regarding whether the LAPD should reverse its denial of the CCW application.

BUT, THEN, The LAPD has repeatedly failed to honor its legal obligations under the Judgment. The LAPD stopped making CCW applications and a written copy of the CCW policy and appeal process available at all station houses. And the LAPD is ignoring the recommendations of the Citizens Advisory Review Panel and has instead enacted a de facto policy of again issuing no CCWs, despite whatever showing of good cause the applicants might make. Just like MPD !

To support the motion, NRA grassroots activists were recruited to investigate the LAPD's CCW practices. They were frustrated by uncooperative officers at individual LAPD station houses. The officers had no understanding of the LAPD's application process and, in almost all instances, could not provide a CCW application to the requesting citizen, much less a copy of the LAPD's written court ordered policy. LAPD officers bluntly told citizens that unless they were celebrities, they shouldn't even bother filling out the CCW application because they would be denied a CCW as a matter of LAPD policy. These NRA activist witnesses signed declarations about their frustrated attempts to get CCW applications, which were submitted with the motion to force LAPD to comply with the 16-year-old Judgment.

In granting the motion and ruling against the city, the Court ordered the City to prominently post a CCW link on the LAPD website so the public can easily access both the CCW application and the LAPD CCW policy. LAPD must comply with this Order by Wednesday, September 7, 2011.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





GardenNews: Reading Tea Leaves

There's been a lot of articles touting the health benefits of green tea, and most of the focus has been on the tea of commerce, *Camellia sinensis*. There are two subspecies of tea, *assamica* and *sinensis*. *Assamica* is native to East India, Burma, Vietnam, and South China, and most of the tea comes from this variety. *Sinensis* is native to South China and is processed into green and black tea. Processing is by drying, steaming, and oxidation or fermentation, the best teas are grown in areas with a warm season for optimal growth and misty rain and cool overcast weather during autumn and spring harvest to minimize bitterness. The highest quality Japanese teas are even shaded just before harvest, to create a taste they call 'umame' which is unique to the green teas. Plantings of tea can even be found in high elevation areas of the Big Island, where it's an up and coming crop there..

But there are also an even wider variety of herbal teas, infusions made from everything other than the tea of commerce. Some of the most popular include Chamomile, Peppermint, and Hibiscus, while local counterparts include Mamake and Koko'olau. According to folklore, many of the herbal teas provide health benefits but there's been little if any clinical evidence to prove this. Two researchers at the Jean Mayer USDA Human Nutrition Research Center at Tufts University in Boston, Diane McKay and Jeffrey Blumberg, have set out to change that.

They found that Chamomile has moderate antioxidant and antimicrobial activities, and also significant anti-platelet-clumping activities preventing blood clotting. Animal feeding studies have also shown that it prevents inflammation and has cholesterol-lowering activity.

Peppermint was found to have significant antimicrobial and antiviral activity, strong antioxidant and antitumor activities, and some anti-allergic activities. When animals were fed peppermint leaves, they experienced a relaxing of gastrointestinal tissue and also the nervous system.

Hibiscus tea is made from the buds of *Hibiscus sabdariffa*, also known as Roselle. This herbal tea affects blood pressure and has shown to drop the systolic pressure by 7 points after drinking it three times daily for six weeks. For those with high systolic pressure, the results were even more dramatic. Systolic pressure dropped by 13.2 points, diastolic pressure dropped by 6.4 points, and mean arterial pressure dropped by 8.7.

By heating dried leaves of plants, you can actually draw out important compounds that are beneficial to your health. A good example is *Uhaloa* or *Waltheria americana*, used as a Hawaiian herbal tea to breakdown phlegm, and is high in tannic acids.

The take home message here is that herbal teas can be a relaxing and healthy alternative to caffeine-containing teas, and can help lower your blood pressure as well. This is the reason Peter Rabbit's mother gave him chamomile tea, to calm his nerves after he almost got caught in Mr. MacGregor's garden eating some of his vegetables.

Health News: Don't use newly "FDA approved" drugs.

In a surprise announcement, FDA officials recently advised consumers to avoid taking any new drugs approved by the agency.

An FDA spokesman explained to reporters that drug approvals are often "fast tracked" so pharmaceutical companies can get valuable new drugs to market as soon as possible. In exchange, the companies promise to conduct trials to ensure drug safety.

The spokesman said: "This system obviously creates a giant black hole of safety hazards. That's why we're always a little concerned that a newly approved drug might cause serious, irreversible, or fatal side effects.

"So to be on the safe side, we're now encouraging consumers not to use those drugs. Just hold off a couple of years – possibly three or four years, maybe five. By then the drug companies might have more studies finished up with a better look at safety issues."

Examples "Victoza," said the FDA spokesperson.

"Last month the agency approved the use of Victoza, a drug that treats type 2 diabetes. The drug appears to help control blood sugar, but safety is a huge question mark. "In animal studies, Victoza caused thyroid tumors, and some were cancerous. In human studies patients who took Victoza developed pancreatitis (inflamed pancreas) more often than patients who took other diabetes drugs.

"So you've got a couple of serious red flags there. In fact, half the experts on our review panel recommended we not approve the drug. But the maker of Victoza, Novo Nordisk, they really had their hearts set on FDA approval, so we said, 'Oh, okay, whatever.' But we hit them with some pretty stiff requirements.

"First, they have to conduct an additional study to test safety in patients at high risk of heart problems.

"Second, they have to establish a cancer registry to monitor the rate of a specific type of thyroid cancer over the next 15 years.

"Third, they have to conduct a five-year study to test risk of thyroid cancer and other cancers, as well as pancreatitis and allergic reactions.

"In other words, anyone who takes this drug within the next five years is out of his mind. But hey, that's between you and your doctor."


FDA spokesman: "Looks like our time is up! Thanks for coming by!"

You don't mind being a drug company guinea pig, do you?




Book Reviews: Good Management Is NOT Firefighting How to Manage Using What You Already Know

COPS Hate VIDEO of their crimes!

An eyewitness to a fatal police shooting in Miami Beach last week claims police officers attempted to confiscate the video he filmed of the incident, and even crushed his phone underfoot in an attempt to destroy the recording.

Narces Benoit says he just happened to be in the area driving with his girlfriend when police fatally shot an erratic driver early Memorial Day morning.

He said after the disturbance started, he pulled over his truck, and started recording with his cell phone camera capturing the shooting.

"When he noticed me recording, one of the officers jumped in the truck, put a pistol to my head," he said. "My phone was smashed - he stepped on it, handcuffed me."

Juan Sanchez a detective with Miami Beach Police Department said he could not comment on how officers that night handled eyewitnesses who may have filmed the incident, because the matter could become the subject of an internal investigation or a civil lawsuit.

But Sanchez added that after the shooting, the site was an active crime scene and the police were looking for additional suspects.

Benoit's girlfriend, Ericka Davis, was also in the truck at the time.

"They handled us like we were criminals," she said. "The officer came over to the driver's side, on my left, and just put the gun to my head."

"They took everyone's phones and smashed them," she said.

Benoit says the only reason he still has the footage is because it was saved on a tiny memory card, which he removed and hid from the officers, despite being told to hand over his video.

"I took the chip out and put it in my mouth," he said, and kept it there the whole time he was interviewed by police at a nearby mobile command post.

His video shows an officer on a bike approaching his truck and pointing a gun directly into the camera; giving an indecipherable command; and then backing away. Another officer orders them to stop filming and get out of the truck, and then the video ends.

He has since given police a copy, he said, but is considering suing them over his treatment.

Miami Beach police say they are still investigating the fatal shooting of the driver, that Benoit captured on tape. Police say at 4 a.m. on Memorial Day, officers stopped Raymond Herisse in his car, but after an altercation, he sped off.

Miami Beach Police Chief Carlos Noriega said that Herisse drove recklessly, striking other cars, "driving on sidewalks, and you name it."

"One of the officers was struck," he told reporters, and the suspect posed a threat to the officers and the public, "as a situation involving deadly force."

A video posted on YouTube, which CNN cannot independently confirm, shows a commotion on a wide boulevard, as an erratically driven car comes to a stop at an intersection. Bystanders scatter as officers surround the car, with guns drawn. Then gunfire breaks out. In Benoit's video, it looks like there are muzzle flashes from the pistols of as many as a dozen officers.

Herisse was killed, and four bystanders were injured by gunfire, according to Noriega. Benoit and Davis criticized the police for the number of shots they fired, in the presence of numerous bystanders.

"We could have been killed," said Davis. "They were shooting so long, you could hear their guns clicking on empty, but they kept pulling the trigger," she said. "I think that's excessive."

Noriega said it was unclear whether the suspect shot at the officers, but police later recovered a gun from his car.


Phobiatopia and *Sword to Words* written by TamiSu

Learning From History The Sedition Act by Debbie Lewis

Northbrook, IL June 6, 2011 - A hero to many, Federalist John Adams was considered a significant Founding Father and was also the new country's second President. 

The Jeffersonians saw the Sedition Act was an attempt to keep people from opposing the government. The "Act for the punishment of certain crimes against the United States," prohibited speaking out, in any form, "with intent to defame," to bring the US government, the President and/or either house of Congress "into contempt or disrepute" OR to cause the population to hate or to "stir up sedition" for opposing or resisting any law of the United States...any act of the President...or to resist, oppose or defeat any such law or act..." It seems hardly possible after the debates surrounding the vital role of our freedom of speech and press.

Thomas Jefferson, who defeated the one-term Adams for the presidency in 1800, said the Sedition Act violated not only the 1st Amendment, but the 10th Amendment, as well, making the Sedition Act, "altogether void." The laws prompted Jefferson to draft the Kentucky Resolution and aided James Madison in the writing of the Virginia Resolution. Simply put, Jefferson's Kentucky Resolution states that "the several states...are not united on the principle of unlimited submission to their general government" and that the states had every right, as individual governing bodies, to abstain from following "undelegated powers" by the central government if they were not found in the Constitution.

"Thomas Jefferson understood the Constitution and acted promptly to call out Adams on his deplorable behavior," says filmmaker William Lewis. This early example of the attempt to usurp protected freedoms of the new population and the determination of the men dedicated to preserving our liberties is a clear sign that We-the-People must stay vigilant to protect our rights and freedoms. *Blood of Patriots* concludes by re-asserts all the rights given to the population in the Bill of Rights.

THE CONSTITUTION IS Near DEAD

On October 26, 2001, President George W. Bush signed the USA PATRIOT Act into law. On May 26, 2011, President Barack Obama signed a 4-year extension of this law. USA PATRIOT is an acronym that stands for "Uniting and Strengthening America by Providing Appropriate Tools Required to Intercept and Obstruct Terrorism Act." This Patriot Act has been used to supersede the rights afforded citizens by the U.S. Constitution.

Even though the Patriot Act violates at least six of the ten original amendments known as the Bill of Rights—the First, Fourth, Fifth, Sixth, Seventh and Eighth Amendments—and possibly the Thirteenth and Fourteenth as well, our government continues to ignore these concerns by forcing new, similar-type legislation upon us.

The Fourth Amendment once stood as the ultimate protection between Americans privacy rights and government abuse of power. Now those rights are gone, law enforcement can break down your door, and as in http://www.huffingtonpost.com/2011/05/25/jose-guerena-arizona_n_867020.html the case of Jose Guerena, they can kill you; we no longer have the right to liberty nor the right to life.

Caught in the Middle of two Federal Bureaucracies

Hawaii resident Keith Unger of South Kona is struggling with the frustration of dealing with an Internal Revenue Service (IRS) audit involving a \$3.44-million donation linked to the sale of a piece of environmentally sensitive land to the U.S. Forest Service (FS).

His story appears in the current issue of RANGE magazine, an award-winning publication devoted to sustainable resource use. Often controversial, RANGE has been called "the voice of reason amidst a cacophony of madmen."

Unger, the general manager of the McCandless Land & Cattle Co., based in Honaunau, negotiated in good faith the terms of the sales agreement with the FS, which reviewed the land's appraisal and had the value approved by its "in-house" appraisers.

"We bent over backwards to follow every rule and protocol," says Unger. "We incurred additional expenses to cross every 't' and dot every 'i.' We did all the right things at the right time for the right reasons, yet now we are being persecuted by the IRS."

The agreement dealt with 3,000 acres on the slopes of Mauna Loa, the site of a uniquely Hawaiian subalpine ecosystem, which not only strategically connects the U.S. Fish & Wildlife South Kona Unit of the Hakalua Forest National Wildlife Refuge with Volcano National Park, but also hosts endemic and indigenous plants and birds.

The value of the property was determined to be \$5.64 million, but only \$2.2 million had been federally appropriated for the purchase. The cattle company agreed to a cash payment of the \$2.2 million and \$3.44 million as a donation. So far, the IRS has disqualified the entire amount of the gift.

"At the time, had we realized that our donation would be considered worthless by the IRS, we never would have agreed to the sale," says Unger.

While the situation is a huge setback for the ranch, says Unger, more importantly it is a huge setback for conservation in Hawaii and nationally. Conservation easements are a useful conservation tool because they offer a landowner one of the few alternatives to selling, developing or logging. The benefits to the public are timeless and priceless and include preserving open space, water collection and filtration, carbon sequestering, soil retention maintaining biodiversity and protecting wildlife habitat.

Unger says he still believes conservation easements create a win-win situation in Hawaii and elsewhere; however his company is actively out in the ranching and landowner community cautioning against such transactions.

"If you are contemplating a similar sale for your property...beware."


The vast majority of Molokaians are armed and prepared to use those arms in their own defense.


U.S. Constitution, Article II, Section 1, Clause 5 . . .
