Obama's War Against Truth

OBAMA ON DRUGS Let's assume that Obama was honest in his autobiography regarding his illicit drug using before the Presidential elections. On that basis, Obama has done FAR more illegal drugs than 99% of Americans, yet he is claiming to be President of USA, and will not be prosecuted for violating drugs laws. And, he is still addicted to Nicotine, and smokes cigarettes out of public sight. Medical marijuana legalization is opposed by Obama, and he is allowing the DEA raids and prosecutions of non-violent MM users demonstrates Obama is an arrogant pathological liar and hypocrite. This has become so obvious that The U.S. House Appropriations Committee Tuesday approved language seeking clarification of the Obama administration's stance on medical marijuana in states where it is legal. Attorney General Eric Holder has made several statements suggesting the administration would not seek prosecutions of people acting in line with state laws, but some DEA raids have occurred in California, medical marijuana providers continue to be sentenced to federal prison, and federal medical marijuana prosecutions. [Even on Molokai, a 61 year old State of Hawaii licensed MM patient is being evicted from Hale Home Pumehana, a HUD facility for senior citizens, because of her private use of her doctor approved medicine.

Rep. Maurice Hinchey sponsored the addition of the following language: " Within 60 days of enactment, the Department shall provide to the Committee clarification of the Department's policy regarding enforcement of federal laws and use of federal resources against individuals involved in medical marijuana activities." Federal defendants are still prohibited from providing any evidence during federal trial that their state licensed medical marijuana activities for which they stand accused by DEA are lawful by state law, so Hinchey declared that "It's imperative that the federal government respect states' rights and stay out of the way of patients with debilitating diseases such as cancer who are using medical marijuana in accordance with state law to alleviate their pain."

OBAMA BIRTH CERTIFICATE? Obama has refused to show proof that he was born in Hawaii, has spent reportedly \$1-million fighting lawsuits that make the simple reasonable demand for proof, obviously because if he was born in Kenya as his family has stated, then he is not a Constitutionally defined "Natural Born" American Citizen, and therefore he is NOT eligible for Office of President.

"I discovered this article, folded away among my birth certificate and old vaccination forms, when I was in high school...." This excerpt exists on page 26 of Obama's autobiography "Dreams from My Father." It is proof that Obama's birth certificate exists, that his Honolulu grandmother had a copy, and that he's seen it. So he knows what's on it, and whatever it is -- or isn't -- it's the reason he is fighting its release so ferociously. Undoubtedly, this knowledge provided the motivation for the ransacking of his grandmother Dunham's apartment within hours of her death. He was looking for this document before it fell into the "wrong" [public] hands.

Both hospitals that Obama has stated where he was born, have denied that both his mother and he were ever a patient. Obama supporters said that Rodney T. West, M.D. was the doctor who delivered Obama, but that story is false because Doctor West retired in 1956, and at age 97, died February 24, 2008. If Dr. West did in fact deliver Barack Obama on Aug 4th, 1961, why did he NOT confirm it when he was alive? Barack Obama was already campaigning and stating he was born there, and Dr. West could have been asked. Just like his grandmother's convenient passing at a time when questions were being asked. Hawaii can hold a foreign birth certificate and register the birth in the State of Hawaii. Section 7c on the Hawaii form is for this. Hawaii DOH has NOT stated that Obama has a Hawaiian Birth Certificate that they hold sealed, nor have they stated that they have one document or several documents that comprise Obama's birth record. The birth certificate on file in Hawaii can easily be Obama's Kenyan birth certificate.

WND Editor and Chief Executive Officer Joseph Farah to put up billboard's asking "Where's The Birth Certificate?" . 300-plus million citizens of the United States have a right to know this information, contrary to the judge Barclay Surrick's opinion that Berg or any other U.S. Citizen had no standing to demand such evidence to ensure that a presidential candidate actually meets the constitutional requirements of the office of president.

"When people are made aware of the Obama 'HOAX,' that Obama has not proven he is constitutionally 'qualified/eligible' to be president; that Obama has not produced his original Birth Certificate; that Obama has not produced legal documents to show he legally changed his name from his 'adopted' name of 'Barry Soetoro' from Indonesia; they will demand Obama be removed from the office of President of the United States," Berg said.

WND has reported on dozens of legal challenges to Obama's status as a "natural born citizen," as Obama continues to violate with impunity the Constitution for the united States of America, Article 2, Section 1: "No Person except a natural born Citizen....shall be eligible to the Office of President."

Some of the lawsuits have focused on Obama's citizenship through his father, a Kenyan subject to the jurisdiction of the United Kingdom at the time of his birth; and, his attendance in Indonesian schools during his childhood; and the Indonesian passport he used to travel to Pakistan when he was 21.

The ultimate questions remain unaddressed to date: Is Obama a natural born citizen, and, if so, why hasn't documentation been provided? The answer could take only minutes: authorization from Obama to Hawaiian officials to release his documentation.

White House spokesman Robert Gibbs laughed at efforts by American Citizens who are demanding Obama prove his birthplace, or resign.

OBAMA WARS Obama promised he would expedite ending the wars in Afghanistan and Iraq. He lied. It is clear that the Obama administration's Zionist and NeoCons recycled from the Clinton and Bush regimes is radically expanding the US war in Afghanistan deeply into Pakistan. Whether it is through US military trainers (that's what they were called in Vietnam too), drone attacks or commando raids inside the country, the US is militarily entrenched in Pakistan. It makes Obama's comment that "We have no intention of sending US troops into Pakistan" simply unbelievable.

Three days after his gala inauguration, on January 23, 2009, President Barack Obama ordered US predator drones to attack sites inside of Pakistan, reportedly killing 15 people. It was the first documented attack ordered by the new US Commander in Chief inside of Pakistan. Since that first Obama-authorized attack, the US has regularly bombed Pakistan, killing scores of civilians. The New York Times reported that the attacks were clear evidence Obama "is continuing, and in some cases extending, Bush administration policy." In the first 99 days of 2009, more than 150 people were reportedly killed in these drone attacks. The most recent documented attack was reportedly last Thursday in Waziristan. Since 2006, the US drone strikes have killed 687 people (as of April). That amounts to about 38 deaths a month just from drone attacks. This has the full support of Israel's Zionists who are supported by Obama and control the Pentagon, and own Congress as well.

Obama's big military plans include a \$1 billion massive US "embassy" in Islamabad, which is reportedly modeled after the imperial city they call a US embassy in Baghdad. As we know very clearly from Iraq, such a complex will result in an immediate surge in the deployment of US soldiers, mercenaries and other contractors. Do you think Obama is bringing our troops home anytime soon? And Congress gives \$\$: In a vote that should go down in recent histories as a day of shame for the Democrats, on Tuesday the House approve another \$106 billion dollars for the bloody wars in Iraq and Afghanistan (and increasingly Pakistan).

US Senate Passes War Photos Prohibition, aka the Graham-Lieberman bill, which seeks to make it illegal to make public any images of US prisoner abuse and torture of individuals captured or detained after September 11, 2001, by the Armed Forces of the United States. The Obama White House supports this outrageous legislation whose sole purpose is to make it illegal to reveal the truth about US torture. Before the Senate vote, Graham told his stated that Obama "would sign ... an executive order" classifying the photographs unless Congress acted to prevent their release." Graham also told a Judiciary Committee hearing that he had received assurance from White House Chief of Staff Rahm Emanuel "that the president will not let these photos see the light of day."


More Graduation News Kudos for Chris Blair



MUNICIPAL SERVICES BUREAU? COURT COLLECTIONS IS RACKETEERING !

Dear Municipal Services Bureau: RUDE, ARROGANT AND COLD BLOODED and violating federal Fair Debt Collections Act

Knock it off. Seriously. Six calls to one phone is a bit excessive, even if we did owe money on a ticket or fine - which we don't.

'Under the guidelines of the FDCPA, this is your official legal notice to cease all communications with our household over the phone and in writing.' If calls persist, file a lawsuit for blatant FDCPA violation of continuing communication after receiving your cease communications demand letter. ph. 1-800-218-1175

And given that we called three times and e-mailed twice asking for you to quit calling, even if we did owe money - which we don't - you'd have to stop calling. It's the law, and you broke it like, four times at least. And for the record, hanging up on someone when they call you back to ask that you quit calling is rude, but it also doesn't absolve you from having to follow the law and quit calling, either.

A little primer on the Fair Debt Collection Practices Act of 1977.

1. You can't call before 8 a.m. or after 9 p.m. unless the debtor agrees.
2. Within five days after first contact, you must send a debtor a written notice.
3. When the consumer knows he doesn't owe money, she has 30 days to respond to that notice after receiving it before you can contact again.
4. Debt collectors can't harass, oppress or abuse a debtor. They also can't repeatedly use the telephone to annoy someone.
5. And they can't lie. In other words, when someone calls you -three times - and says quit calling this number, you can't claim the number isn't even in your system. And then call again 15 minutes later.

So you've been reported to the FTC and the Better Business Bureau for your antics. And for you municipalities out there using this company - sure, they may get you results, and they may even be cheaper than another collections agency, but do you really want this particular bunch of nogoodniks representing you?

If you're an agency who has the job of upholding the law, and you hire a company that doesn't obey it, isn't it a little hypocritical?

So for all you readers out there, if you get harassment calls from this Municipal Services Bureau, owned by the Gila Corp of Texas, but hired by Hawaii Courts to do their dirty work racketeering tickets, they have a lengthy list of complaints for violating the Fair Debt Collections Law, and they can be sued for harassment, along with crooked judges, cops, clerks, bailiffs, sheriffgoons.

"American Idol" Finalist Michael Johns Releases Debut CD

We Are Sovereign! Now, The Crown Belongs to Every American Citizen

"Sovereignty is the right to govern; a nation or State-sovereign is the person or persons in whom that resides. In Europe the sovereignty is generally ascribed to the Prince; here it rests with the people; there, the sovereign actually administers the Government; here, never in a single instance; our Governors are the agents of the people, and at most stand in the same relation to their sovereign, in which regents in Europe stand to their sovereigns. Their Princes have personal powers, dignities, and pre-eminences, our rulers have none but official; nor do they partake in the sovereignty otherwise, or in any other capacity, than as private citizens." see CHISHOLM v. STATE OF GA., 2 U.S. 419 (1793)

Supreme Court rulings on the matter: "Sovereignty, itself, is, of course, not subject to law, for it is the author and source of law. In our republican form of government, sovereign powers are delegated to the agencies of government, sovereignty itself remains with the people, by whom and for whom all government exists and acts." Yick Wo v Hopkins and Woo Loo v Hopkins, 188 US 356 [1886]
