I.R.S. Attack on Ed Brown National Concern: Live Free from IRS, or Die

Ed and Elaine Brown, New Hampshire, have not paid the IRS claimed income tax for years because There Is No Law Requiring Them to Pay. But last month they were found guilty and sentenced to prison.

Calling the federal agents surrounding his home "guns for hire," Brown vowed that he and his wife would fight U.S. marshals to the death if they tried to capture them, warning "Do not under any circumstances make any attempt on this land. We will not accept any tomfoolery by any criminal element, be it federal, state or local," said Ed Brown in a press conference from his home. "We either walk out of here free or we die."

Brown and his wife, Elaine, were sentenced in absentia in April to serve 63 months in prison for failing to pay more than \$1 million in income tax. The couple, however, insists that there is no law that requires citizens to pay income tax.

Brown and his supporters, including Randy Weaver, leader of the 1992 standoff with ATF agents at Ruby Ridge, Idaho, told the press that the government has unlawfully tricked people into believing

they have to pay income tax, knowing full well that such a law would be unconstitutional. "This is 1776 all over again. You cannot tax someone's labor because that is slavery," Brown said. Carrying a pistol in his waistband, Brown also insisted that he could not receive a fair trial in a federal court.

Weaver, whose wife and son and dog were killed by federal agents in the Ruby Ridge federal sniper attack, said he was there to support the Browns. "I'd rather die on my feet right here than die on my knees under this de facto government," he said.

Despite months of surveillance and reports of agents hiding in the woods, U.S. marshals said this morning that the Brown's home was not surrounded by their officers. Monier told ABC News.com. "We have no intention of assaulting the house or engaging in a violent confrontation." "We know they have weapons and we do not want to see this escalate."

Last week agents cut off the home's telephone, Internet and power access.

Last week, Danny Riley a friend of the Browns was shot at, tasered and arrested near their home by

federal agents in bushes he discovered while walking the Brown's dog on their own property.

The Marshals claim they were engaged in routine surveillance of the property, but the Browns believe Riley thwarted a potential violent armed raid.

Ed Brown said "We've told them all along, just show us the law, and we'll give you the money. But this isn't about a bunch of Federal Reserve Notes, and they know it. They are here to kill us because they can't keep up the fraud any other way. And, they've just shown that they are ready to draw first blood."

Along with various support vehicles, four armored vehicles have taken positions on the perimeter, and Ed has counted twelve gunmen in camouflage and ghillie suits.

Supporters have appealed to all Americans to call the county sheriff at 603-863-4200 to rescue the Browns from the federal SWAT teams. The sheriff has the authority to eject the federal marshals from the county, as does the New Hampshire governor Lynch [(603)271-2121]. STOP the IRS criminals.

Moloka'i Land Trust- "Trust Who?"

Moloka'i Ranch has been selling the community on the idea that if we allow them to rezone and develop La'au that the community in turn will receive 51,000 acres of land. In fact this has been repeated so many times that most people have started to believe it. The truth however is that the community of Moloka'i will get nothing!

The aforementioned 51,000 acres will consist of two different venues of ownership and control.

24,950 acres of this land will remain under the ownership and operation of Molokai Ranch. Of this portion 10,560 acres will be zoned rural landscape and the other 14,390 acres will be zoned agricultural.

The only involvement of the Land Trust will be to oversee the enforcement to which these lands are dedicated. Although keeping this much land into agriculture sounds good, in truth the 14,390 acres of agricultural land could allow for the same kind of development that exists currently at Kaluako'i. "The Plan" states that only "farm dwellings" will be allowed. All of the large homes on the West end are legally considered "farm dwellings".

The remaining 26,200 acres is the land that will go directly into the Land Trust and will be owned and operated by the Land Trust.

It is important to recognize that neither "Moloka'i Ranch" or "The

Moloka'i Land Trust" are the Community.

Molokai Ranch is a subsidiary of a large offshore corporation based in Singapore and it's loyalty lies with it's shareholders.

The Moloka'i Land Trust is a private organization that requires no community input and offers no voting privileges outside of the trust itself. It is self perpetuating.

Although some of the key points of the purpose of the Land Trust are quite noble, it should be of grave concern to the people of Moloka'i that the key members of the initial board of directors are the same folks that have continuously denied voting privileges to the Molokai Community in regard to La'au. These are also the same folks that have given us the "one last project" slogan, when in reality, Molokai Ranch has many more projects on the burner.

This group has also ignored the volatile situation that exists with our water supply by choosing to ignore Project #7 of the Molokai EC, which requires that a water management plan be in place for our island.

"THE PLAN" will place large amounts of the land into the hands of a few, which in turn will only perpetuate an abuse of power. If it is a community plan then let it be so. We must create an acceptable model that will truly help us with self determination. We need a community plan that will be pono now and for future generations to come.

It is important to recognize that neither "Moloka'i Ranch" or "The Moloka'i Land Trust" are the Community.

No-Smoke Medical Marijuana Validated

Two new studies, one from the University of California, San Francisco, and the other from the University at Albany, State University of New York, provide strong evidence that technology now allows medical use of marijuana with the rapid action and easy dose adjustment of inhalation, but without the respiratory hazards associated with smoking.
