

Qualified Molokai Resident Denied Teacher License. Why?

David Layne has been a substitute teacher on Molokai since at least 2002. And he started teaching on Molokai with some high qualifications and experience as a musical instrument artist and teacher and physical education teacher. His documentation includes a Professional License from the California Commission on Teaching Credentials, Verification of full contracted employment, Fifth Year of Study documents from California State University Long Beach, Official letter from CSU, Dominguez Hills, Certification, Assignment and Waiver letters from Commission on Teacher Credentials for July and August 2010, and he passed the Hawaii DOE tests when he first applied for the Hawaii teaching license in 1995. His work history is clean, and he is well liked as a substitute teacher by teachers and students on Molokai.



Yes, David Layne has been denied qualified teacher status since 1995! Undaunted, he perseveres as a competent, popular substitute teacher on Molokai.

He hates to complain, but this is his story, VERY briefly.

I have been trying to receive the appropriate professional license from the Hawaii Teacher Standards Board since 1995, and they have not issued the Hawaii license that should be given by way of the Interstate Agreement on licensing.

My California qualifications documents are accepted throughout the entire United States of America, and by law it should be accepted by the State of Hawaii.

Hawaii Revised Statute Section 302A-602 states "No person shall serve as a teacher in the department without first having obtained a license from the Hawaii teacher standards board in such form as the Hawaii teacher standards board determines." Mr. Layne contends the Standards board is breaking that law in his case by not issuing a license to teach school.

The result is that I can not apply anywhere in the State of Hawaii to teach Physical Education or Instrumental Music if the Hawaii license is not issued to me. Furthermore, without the Hawaii license as proof, school Principals can not hire me. And, thirdly, my status with out a Hawaii license to teach will keep me as a Substitute Teacher without benefits, medical, or retirement.


Even after presenting my Professional Licenses from California to the Hawaii Teacher Standards board, I am still left without a license from the State of Hawaii. This breaks Hawaii's law, and Interstate Agreement, Layne concluded.

He says he cannot understand why the Board refused to honor his credentials and the national Interstate Agreement on teacher licensing. Maybe his persistence and continued good record as a Molokai substitute teacher will bear fruit with his next effort. He will re-apply yet again in hopes that the new state Administration DOE board will recognize his qualifications and his dedication to teaching by issuing to him a Hawaii State Teachers license in 2011.

Valley also made similar statements in an online radio program in which he supported Lakin, the Army doctor who refused orders because neither the military nor the White House would document Obama's eligibility. He spent five months in Fort Leavenworth and only recently was released.

"Obama's birth certificate — I've had retired CIA agents and other investigators go over the birth certificate that was produced and by far, 10 out of 10 have said it's a forgery. So we still have that corruptness going on in the White House. There's a great number of organizations and people still trying to find out who Barack H. Obama is, where he was born, does he qualify as president of the United States. We know for sure that the Constitution has been violated in Article 2, particularly when you look at the natural-born status requirement."

Baggage Security: fly with gun

If you want to keep your checked valuables from being stolen by TSA baggage handlers while you fly, just keep a gun in your suitcase.

Many airports won't let you effectively lock your suitcases when you fly, and that means it's open season for unscrupulous TSA employees and baggage handlers to help themselves to your valuables in checked bags.

But once you add a gun to your luggage, it gets extra-locked, gains new tracking privileges, and is subject to heightened scrutiny all the way to your destination. I have a starter pistol for all my suit cases. All I have to do upon check-in is tell the airline ticket agent that I have a weapon to declare. I'm given a little card to sign, the card is put in the case, the case is given to a TSA official who takes my key and locks the case, and gives my key back to me.

That's the procedure. The case is extra-tracked...TSA does not want to lose a weapons case. This reduces the chance of the case being lost to virtually zero.

AK47 Birthday for the "Liberty Gun"

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

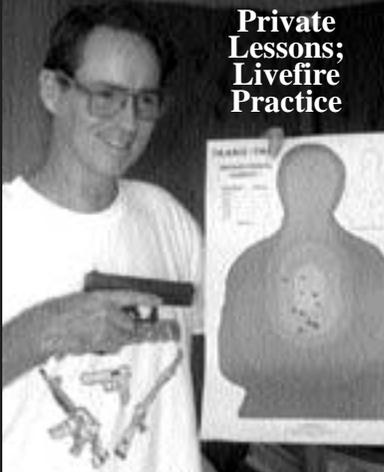

# Whats Wrong with Socialist Government?



## Obama's TSA Forces 95 year old to Remove her adult diaper for security?!!

Transportation Security Administration stood by its security officers Sunday after a Florida woman complained that her cancer-stricken, 95-year-old mother was forced to remove her adult diaper while going through airport TSA security.

The TSA released a statement Sunday defending its agents' actions at the Destin-Fort Walton Beach Airport. "We have reviewed the circumstances involving this screening and determined that our officers acted professionally and according to proper procedure."

Jean Weber told CNN's Fredricka Whitfield on Sunday that the security officers may have been procedurally correct, but she still does not believe they were justified, especially given her mother's frail condition. And she almost missed her flight because of the TSA delay and intense scrutiny.

Weber said the two were traveling June 18 from northwest Florida to Michigan, so her mother could move in with relatives before eventually going to an assisted living facility.

"My mother is very ill, she has a form of leukemia," Weber said. "She had a blood transfusion the week before, just to bolster up her strength for this travel."

The 95-year-old was taken by a TSA officer into a glassed-in area, where a pat-down was performed, Weber said. An agent told Weber "they felt something suspicious on (her mother's) leg and they couldn't determine what it was" -- leading them to take her into a private, closed room.

Soon after, Weber said, a TSA agent came out and told her that her mother's Depend undergarment was "wet and it was firm, and they couldn't check it thoroughly." The mother and daughter left to find a bathroom, at the TSA officer's request, to take off the adult diaper.

Weber said she burst into tears during the ordeal, forcing her own pat-down and other measures in accordance with TSA protocol. But she said her mother, a nurse for 65 years, "was very calm" despite being bothered by the fact that she had to go through the airport without underwear.

Eventually, Weber said she asked for her mother to be whisked away to the boarding gate without her, because their plane was scheduled to leave in two minutes and Weber was still going through security.

"My mother is a trouper," Weber said. "If this is your procedure... your procedure needs to be changed," she said.


## Book Reviews: Overtime


