TSA Is a Threat to Safety and Freedom

OBAMA perpetuates the treason and tyranny of the TSA/Homeland Security in Hawaii and Nationwide. Here is another victim speaking out with the authority of a veteran patriot and an educated American Citizen who supports the Constitution for the united States of America against the TSA tyranny, because the Constitution and the Bill of Rights have ceased to protect US citizens from tyranny. Following are excerpts from his letter to his local TSA

Dear Mr. Lou Traverzo [Homeland Security-TSA] :

My name is Jeffrey A. Dickstein. I am an eight time decorated veteran of the Viet Nam War, having enlisted in the United States Air Force in December,1965. For seven years and three months I did what I thought my patriotic duty required: I took an oath to support and defend the United States Constitution against all enemies, foreign and domestic, and did just that. I protected my country from the evils of North Vietnamese Communism.... the threat of that communism was vividly portrayed, during the time I grew up, by the East German check-points. Run by armed men in government uniforms, all were required to produce official, government issued ID and traveling papers. This activity was considered such a dangerous threat by the United States Government we entered into a cold war and armed with nuclear weapons pointed at the communist infringers of our American way of life.....

I took the same oath again when I was admitted to practice law.... My practice has been almost exclusively limited to representing political dissidents from attacks by their government. I can honestly, albeit heartbreakingly, say that the attacks have become worse over time, as evidenced by my experience in the hands of people for whom you [TSA] are responsible.

Your [TSA/Homeland Security] agents have set up an East German-like checkpoint at the airport. Run by men in government uniform, all are required to produce official, government issued ID and traveling papers if they are to proceed past the checkpoint. These are stops that violate the Supreme Court's decision set down in Terry v. Ohio [1968 that before anyone in the United States can be lawfully stopped by police there must be something suspicious about the person].

I was stopped by one of your agents. A TSA agent first asked for my government issued ID and my traveling papers. That stop violated my inalienable right to be left alone so long as I am not hurting someone else. That, sir, is the very definition of liberty.

Thereafter I was forced, if I were to be allowed to proceed, to open up part of my sealed property, partially undress, and to subject myself and my property to various searches by x-ray and other technologies. Further, I was again required to present the very same traveling papers that I had produced only moments before.

Immediately after that one of your agents physically seized my sealed computer bag and carried it off with him. He demanded to know [continued page 5]

COP Says STOP WAR ON DRUGS! Wins Back Job + \$800,000

A Washington state police sergeant who was fired after publicly criticizing the "war on drugs" has reached an \$812,500 settlement in a lawsuit he filed against the city and police department. Under the settlement, Sergeant Jonathan Wender has been reinstated on the force and is eligible to receive back pay and full retirement benefits.

"In an open society, people on the front lines of the criminal justice system have an ethical duty to speak out on controversial social and legal issues that affect the public we serve," said Sgt. Wender, a member of Law Enforcement Against Prohibition (LEAP), a 10,000-strong organization representing police, prosecutors, judges and others who fought on the front lines of the "war on drugs" and who now want to legalize and regulate drugs. "The public has a fundamental right to know which laws and policies are effective, and which ones aren't; and they should expect that their police officers will speak the truth even when it isn't popular or comfortable to do so. I hope that the outcome of this case will help reassure police and other public officials that they can speak freely on controversial topics such as the urgent need to seek better ways to deal with the crisis of drugs that plagues American society."

Sgt. Wender joined the police force in 1990 after graduating from college and was terminated in 2005. He holds a Pd.D. from Simon Fraser University and is currently a full-time sociology professor at the University of Washington. As part of the settlement, Sgt. Wender is back on the payroll at the Mountlake Terrace Police Department, where he will serve on administrative leave until he retires from the force on November 10, 2010 and can then qualify for his full pension.

"Jonathan Wender's fight and his victory is ours, as well" said Norm Stamper, the retired Seattle police chief and LEAP member. "Because of this fine man's courage and perseverance, and his willingness to tell the truth about the 'drug war,' we've all moved closer to putting an end to that failed and immoral war. I believe police officers across the country will be moved by Jonathan's example, and will raise their voices in support of LEAP's goal of ending drug prohibition."

MARIJUANA FREEDOM BILL INTRODUCED TO CONGRESS, BUT MPD CHIEF RAKES IN \$\$\$\$

Friday, June 19, Rep. Barney Frank introduced a bill that would decriminalize the possession and not-for-profit transfer of small amounts of marijuana. Marijuana freedom is on the near horizon, but Maui Police Department officers don't want the fun for them to end, because CRIME PAYS: MPD Chief Yabuta reports receipt of another huge pile of money in Drug Forfeiture Funds, \$34,146.50

Titled the Personal Use of Marijuana By Responsible Adults Act of 2009 (H.R. 2943), the bill would remove federal criminal penalties for the possession of less than 100 grams (about 3.5 ounces) and for the not-for-profit transfer of up to one ounce. The bill would not change marijuana's status as a Schedule I controlled substance, would not change federal laws banning the growing, sale, and import and export of marijuana, and would not undo state laws prohibiting marijuana.

Congressman Frank said, "It's a matter of personal liberty. Moreover, our courts are already stressed and our prisons are overcrowded. We don't need to spend our scarce resources prosecuting people who are doing no harm to others."

"Congressman Frank's bill represents a major step toward sanity in federal marijuana policy," said Marijuana Policy Project director of government relations Aaron Houston. "The decades-long federal war on marijuana protects no one and in fact has ruined countless lives. Most Americans do not believe that simple possession of a small amount of marijuana should be a criminal matter, and it's time Congress listened to the voters."

As of the middle of this week, the bill had five cosponsors: Reps. Tammy Baldwin (D-WI), Maurice Hinchey (D-NY), Ron Paul (R-TX), Jared Polis (D-CO), and Dana Rohrabacher (R-CA). The bill has been referred to the House Judiciary Committee and the House Energy and Commerce Committee. No word yet on any hearings.

Ten states have already decriminalized the possession of small amounts of marijuana. Those states are California, Colorado, Maine, Minnesota, Mississippi, Nebraska, Nevada, New York, North Carolina, and Oregon. In an eleventh, Alaska, the possession of up to an ounce in one's home is not just decriminalized, it's legal.

MAYOR FILES LAWSUIT re: SWAT Raid and killing dogs

Maryland, Sheriff's Department has finished its investigation into a drug raid last summer in which deputies charged into the home of the mayor of Berwyn Heights and killed two family dogs. Not surprisingly, the department cleared itself of any wrongdoing whatsoever, job well done.

Berwyn Heights Mayor Cheye Calvo, one of the victims of the raid, disagrees. He said he was would file a lawsuit in Circuit Court against officials in the sheriff's office and police department. Calvo said he will seek to force the county to change its policies for deploying SWAT teams for search warrants, murders animals, and detains and abuses people.

Sheriff Michael Jackson doesn't see it that way. The departmental review of the raid was "consistent with what I've felt all along: My deputies did their job to the fullest extent of their abilities," he said at a news conference last Friday as he announced the whitewash.

The raid drew national attention when SWAT team members tracking a package of marijuana delivered to the Calvo home without the residents' knowledge burst into the house, shot and killed the family's two Labrador retrievers, and detained Calvo and his mother-in-law for several hours. One dog was shot four times by the front door. The other was shot twice as it ran from officers. The sheriff's office later admitted that the Calvos had nothing to do with the drug delivery.

"I'm sorry for the loss of their family pets," Jackson said. "But this is the unfortunate result of the scourge of drugs in our community." [No you Nazi bastard, its the scourge of Police State treason and dictatorship mindset by cops who benefit with big bucks in drug forfeiture racketeering under color of law Drug War]

In a 1995 case, police allowed a commercially shipped package that contained marijuana allegedly sent from California, to be delivered to a woman at her ranch where her teenagers lived. Immediately after the woman signed for the package she opened the box. Inside the box she found a written phone number and a note stating, "call police." Before the woman could do anything police crashed into her home and arrested her. The woman was sent to prison because she "signed for the package" and police seized her \$600,000 ranch because that is where the package with illegal drugs was delivered. Of great concern, anyone with a grudge can easily cause police to raid a home, cause an innocent person's arrest or injury and their dogs murdered by police, simply by mailing a homeowner illegal-drugs in a manner, sure to be discovered by drug agents.

When the U.S. Supreme Court lowered the legal requirement for "no knock warrants" and reduced the time police must wait to smash down a door, it opened the door for SWAT TEAMS to arbitrarily attack U.S. Citizens. Historically, police-military styled raids when not brought under control to protect the public, have incrementally moved forward to target innocent Citizens not just or alleged crime but for their political speech, for attending an assembly or because a person wrote something that offended the police or a politician. It is imperative Americans NEVER accept SWAT TEAM misconduct.

TSA Is a Threat to Safety and Freedom

Dear Mr. Lou Traverzo [Homeland Security-TSA] :

whose property it was. I told him it was my property. He asked me for my permission to look inside. I asked him what his probable cause for the seizure was, as well as the probable cause for wanting to search. He responded: "I'm just checking." I told him that in the absence of probable cause, the seizure was illegal and he did not have my permission to search. I also told him that since I was being stopped without probable cause, I would be exercising my right to remain silent from then on out. He responded he didn't have a clue as to what I was talking about and called for his supervisor and his armed force, the local sheriff's department, complaining to them that I was being "unruly." Within moments I was surrounded by three or four of your agents, one of their supervisors, and at least five men armed with weapons.

My personal property was searched anyway, my government issued identification papers and traveling papers were confiscated, and one of your agents pointed his finger at me, pointed to the floor, and told me: "Stand there!" Despite having just gone through all of your security, designed to "keep me safe," I was detained for another ten minutes so your agents and squad of armed men could fill out reports.

A report of what? Your unconstitutional stop and search turned up nothing!

It is my opinion that with an armed and dangerous enemy foreign national in my country, whose presence constitutes an "elevated alert status," that I have a right to be armed to protect myself and my family. Our founding fathers thought the same thing as evidenced by the Second Amendment to the United States Constitution. You, apparently, believe differently. You believe it is your job to keep me safe, and it requires you to take away both my Second and Fourth Amendment rights to do so. The events of 9/11 leave no doubt in my mind that your ability to keep people safe is a

deadly myth.

I have to tell you, I fear you and your communist like agents much more than I fear any foreign national. So long as you and your agents and army are going to violate my inalienable rights and the prohibitions of the United States Constitution respecting your conduct, I am going to be exercising my First Amendment right to speak and petition for redress of this serious grievance. So too, I will verbally demand a statement of probable cause before my person or property is searched by the government in the total absence of anything other than my peaceful and lawful conduct.

I have several purposes in writing this letter to you:

First, I want to know the precise legal authority, be it statutory, regulatory, administrative, or other, for stopping everyone at your check point, forcing them to produce government ID and traveling papers, all without any discernable suspicious conduct, and for the seizing of closed personal property, and its warrantless search, in the complete absence of probable cause and over my stated objection.

Second, I'm a frequent traveler. My law practice is national in scope. I don't want to be harassed by your agents, or subjected to your even more intrusive supplemental security screening because of my protest against your illegal conduct and the report that was written. Since I have been searched and found not to contain any contraband, and you know who I am, you should have no reason to suspect me of anything. If I am now so suspect as to require further scrutiny, solely because of my protest, then I will be the subject of a bill of attainder like due process violation, which is also prohibited by the United States Constitution.

Third, I want a copy of each and every report made concerning me.

Fourth, I want to know the precise legal authority, be it statutory, regulatory, administrative, or other, for detaining me after the search and making a report when neither contraband nor explosives were found on my person or in my property.

Fifth, I want to complain about the attitude of your manager. If he wants me in a particular location, he can politely ask me to move to that location. He has no lawful authority to tell me where or where not to stand, and his attitude to the contrary was rude and obnoxious. Since he is a public servant, he needs to be taught how to act like one. Furthermore, the absolute ignorance of your people regarding the Fourth and Fifth Amendments to the Constitution is disgusting, at best, and dangerous, at worst.

Finally, in the spirit of asking what I can do for my country, I want to offer my services to teach your people about their illegal conduct. I certainly wouldn't want them to get into legal trouble out of their ignorance. And wouldn't they be better able to serve their country by upholding, rather than violating, the United States Constitution? I respectfully await your reply and specific response to all, and until then,

Obama's War in Afghanistan Has Become America's Drug War in Afghanistan

As 20,000 additional US troops are joining American and NATO forces on the ground, bringing foreign troop totals to nearly 90,000, the West is taking direct aim at the drug trafficking networks that deliver hundreds of millions of dollars a year to the insurgents.

Lt. Col. Stephen Cartwright, commanding officer of some of the British troops: "The link between the insurgents and the narcotics industry is proven as militants use the money derived from the drug trade as a principle source of funding to arm themselves with weapons.... By destroying this opium and the drug making facilities we are directly target their fighting capability...."

Admiral Michael Mullen, chairman of the US Joint Chiefs of Staff, laid out the new thinking in testimony to the Senate last month. The West is losing the battle against opium production, he said, so instead of merely going after Taliban militants it is time to "go after" the powerful drug lords who control the trafficking and smuggling networks in Afghanistan.

"The whole policy has changed," agreed Raheem Yaseer, assistant director of the Afghanistan Studies Center at the University of Nebraska-Omaha. "They were concentrating on the terrorists, but now they realize the opium traffic has actually been used to finance their activities," he explained.

Malou Innocent, a foreign policy analyst with the libertarian leaning Cato Institute. "The best policy would be legalization," she said, adding "I have a feeling this is going to be a very bloody summer. There will be more violence as this year is going to be a sort of counteroffensive to the Western surge."

US soldiers and NATO have no good reason to be remaining in Afghanistan. "We haven't found bin Laden in eight years, and most of the high-level Al Qaeda we've captured have been the result of police detective work, not military force. The foreign military presence in Afghanistan is perceived as a foreign occupation by many people in the region on both sides of the border," she said.

The US needs to be planning an exit strategy, said Malou. "When you look strategically and economically, the US just doesn't have a vital interest impelling us to stay in the region indefinitely," she said. "We need a timeframe for withdrawal. We need to narrow our objectives to training security forces. I don't see any reason why we need to stay in this region any longer."
