Obama Allows Torture and Gitmo! Senator Dan Inouye Stops Funding for Gitmo-Cuba Prison Closure

Above Obama hangs a "sword of Damocles" that will threaten his image as long as he hold back new torture photos that he promised to release, and as long as GITMO remains open, and as long as our government refuses to prosecute the real criminals who tortured and cost prisoners their lives—the story of the homicides has largely not even surfaced in the American press. The worst criminals are the ones at the top during the Bush administration, but Obama has become complicit and is obstructing justice with his coverup of evidence like these photos that were leaked, and worse. Obama is continuing to use a notorious military police unit at Guantanamo that regularly brutalizes unarmed prisoners, including gang-beating them, breaking their bones, gouging their eyes and dousing them with chemicals.



And Hawaii Senator Dan Inouye is also complicit, now his new crime is to block funding that was to be used to close GITMOCuba. Voting 90-6, the Senate stripped \$80 million from a supplemental military funding bill, \$50 million of which was designated to close the controversial prison and \$30 million for a Justice Department investigation into torture techniques used there.

GITMO's Immediate Reaction Force is a thug squad that is used to mercilessly punish prisoners who show the slightest bit of resistance or who do things that technically they're not supposed to do, infractions like having two Styrofoam cups in their cell instead of one.

GITMO Guards will call in this goon squad. They come in with their Darth Vader outfits, and they literally gang-beat prisoners. There are five men, generally, that are sent in. Each of them is assigned to one body part of the prisoner: the head, the left arm, the right arm, the left leg, the right leg. They go in, and they hogtie the prisoner, sometimes leaving them hogtied for hours on end. They douse them with chemical agents. They have put their heads in toilets and flushed the toilets repeatedly. They have urinated on the heads of prisoners. They've squeezed their testicles in the course of restraining them. They've taken the feces from one prisoner and smeared it in the face of another prisoner.

Barack Obama issued an executive order saying he was going to close down Guantanamo within a year and that he was going to respect the Geneva Convention while his administration reviewed Guantanamo, but this force has continued to operate and torture prisoners under the Obama administration.

In February of this year, about a month after Obama was inaugurated, there were sixteen prisoners on a hunger strike at Guantanamo. Immediate Reaction Force was used to go in and violently shove massive tubes down their noses into their stomachs. They would use no anesthetics or any painkillers, shove this massive tube by force down their nose into their stomach and then yank it out. Obviously this is torture, torture, torture. Many have passed out from the pain.

And, it does not speak well of Democrats like Hawaii Sen. Dan Inouye who have been briefed on the torture that they are working against resolution of the torture issues and of their own likely complicity in torture and the coverup.



Lingle Complicit in Superferry \$40-M Taxpayer Ripoff

So what's happening with the \$40 million harbor improvement money to be paid by Hawaii Superferry?

Hawaii Superferry is in the process of canceling its revocable leases with the state Department of Transportation for harbor space, according to Michael Formby, DOT deputy director of the Harbors Division. HSF has also filed papers for Bankruptcy to avoid paying creditors.

I hope a lot of Citizens will ask Lingle whether she will be recovering that \$40 million under authority of the 3rd Mortgage on the HSF held by this State. Why not sell off the barges, ramps and other equipment? The third mortgage that the state holds against non-payment appears to be a FRAUDULENT scam by Lingle, the largest known ripoff by an elected official in Hawaii's modern times.

The state has no plans at this point to lease the properties to anyone else or to sell off \$40 million worth of barges, ramps and other equipment purchased to load and unload vehicles from the HSF, Formby said.

Hey, we Hawaii Taxpayers and harbor users don't owe the Superferry a parting gift of that \$40-million.



The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





Obama Blocks Torture Photos, but General Taguba Says he saw them

"The decision to not release the photographs makes a mockery of President Obama's promise of transparency and accountability," said ACLU attorney Amrit Singh, who had argued and won the case before the 2nd U.S. Circuit Court of Appeals in New York. "It is essential that these photographs be released so that the public can examine for itself the full scale and scope of prisoner abuse that was conducted in its name."

General Taguba on the record said he SAW the PHOTOS:


London's Daily Telegraph quoted Maj. Gen. Antonio Taguba describing photos (that the Obama administration is fighting to keep secret), which allegedly depict US personnel raping prisoners, other sexual assaults on prisoners with objects including a truncheon, wire and a phosphorescent tube. "These pictures show torture, abuse, rape and every indecency," said Taguba. Taguba said he was referring to the hundreds of images he reviewed as an investigator of the abuse at Abu Ghraib prison in Iraq, and his report which led to losing his job.

The Telegraph reported: At least one picture shows an American soldier apparently raping a female prisoner while another is said to show a male translator raping a male detainee. Others depict sexual assaults on prisoners with objects including a truncheon, wire and a phosphorescent tube, while another shows a female prisoner having her clothing forcibly removed to expose her breasts.

Allegations of rape and abuse were included in Taguba's 2004 report on Abu Ghraib but the photographs was never revealed. He has now confirmed their existence in that interview with the Daily Telegraph, and said with 100% certainty that he has seen photos that "show torture, abuse, rape and every indecency."

Will the White House deny these exist? Obama Deception! Now, Obama's fiercest defenders are the Wall Street Journal, the neocons and hawkish Congressional Republicans.

Obama's Iraq policy and his Afghanistan escalation of those wars are blatant endorsements of Bush-Cheney policies. Obama-flips are now routine: for example, opposing the release of prisoner abuse photographs and support for indefinite detention for detainees, and that's just this week. More remarkable is Obama's White House P.R. creativity in portraying these violations of public trust as "epic change."
