Hawaii Judge Puts Man Behind Bars Over 'Thank You, Jesus'

HONOLULU, July 14, 2006 -- A state judge on Friday refused to apologize to a man he put behind bars for shouting "Thank you, Jesus" in his courtroom.

Junior Stowers awaited the verdict in his domestic abuse trial last week. A lot was at stake for Stowers. As an immigrant, if he was convicted he could be deported and could lose his position as a youth volunteer at his church.

The judge was Patrick Border. Gov. Linda Lingle appointed him two years ago.

Just before the verdict was read, the judge whispered a warning to the attorneys.

Dialogue from the trial:

"No displays of emotion one way or another by anyone in the case. You understand?" Border said in court.

Defense attorney Carmel Kwok said she didn't have time to warn her client. The verdict came four seconds after the judge's warning.

Dialogue from the trial:

"We, the jury, in the above entitled case find the defendant not guilty," the jury foreman said.

"Thank you, Jesus!" Stowers exclaimed.

"You be quiet. OK, we will be in conference after that," Border said.

"He wanted to apologize, and the judge cut him off and didn't let him apologize," Kwok told KITV on Friday.

Dialogue from the trial:

"May I approach the bench, your honor?" Stowers said.

"No, you may not," Border said.

"Your honor, he just wants to apologize," Kwok said.

"Well, I think I had earlier alerted counsel, and I had in previous cases," Border said. "This kind of behavior, outbursts are not permitted."

The supervising public defender, Ronnette Kawakami, said she was shocked to see the judge order Stowers locked up.

"He was placed in handcuffs in front of his family, in front of his family and taken down to the cellblock for nothing other than saying, 'Thank you, Jesus' in a loud voice," Kawakami said.

Six hours later, Border defended his action.

"It was observed within my presence. It was behavior that was more characteristic, more applicable for the swap meet or a major contest," Border said.

Stowers remained in custody for four to five hours.

A week later, Border dropped the contempt charge, agreeing that Kwok didn't have a chance to warn her client before the verdict. On Friday, Border refused to make any other comment or offer an apology.

Stowers told his lawyer he is not looking for an apology. He said he just wants to get on with his life.

As for Border, except for the reappointment process that comes around only every 10 years, there is really no mechanism in Hawaii for judging the behavior of judges, KITV reported.

Marijuana Legal in Alaska, again

July 11, 2006--A judge struck down part of the new Alaska law that had re-criminalized marijuana in the state, ruling that the new law conflicts with past state Supreme Court decisions that protect adults who have small amounts of marijuana in their homes.

Until last month when the new Alaska law took effect -- possession of up to four ounces of marijuana in the home had been legal in Alaska. Unfortunately, the new law attempted to make it a crime to possess any amount of marijuana in the privacy of the home, directly contradicting a September 2004 Alaska Supreme Court decision allowing adults aged 21 and older to use and possess up to four ounces of marijuana in the privacy of their homes. The MPP grants program funded this litigation.

You can read about the ruling in <http://www.mpp.org/AK/news/12361.mpp> this Associated Press article -- means that police will not be able to search someone's home for marijuana unless they have probable cause to believe that the home contains more than one ounce of marijuana. (The court limited its decision yesterday to amounts under one ounce -- not four ounces -- saying that the Alaska Civil Liberties Union, which brought the case, argued that the issue at hand was the state legislature's power to regulate "small amounts" of marijuana.)

The bad law enacted last month was the result of an aggressive lobbying campaign by Alaska Gov. Frank Murkowski (R), who went on a personal crusade to re-criminalize marijuana in the state. Political observers originally expected Murkowski's bill to pass within weeks of its introduction in early 2005, but many months of lobbying and grassroots organizing by MPP, the Alaska Civil Liberties Union, and Alaskans for Marijuana Regulation and Control succeeded in blocking the bill for one-and-a-half years. However, the governor and state attorney general's intense lobbying campaign, which included personal phone calls to waffling legislators, ultimately tilted the vote; the bill passed in May and was signed into law on June 2.

The court ruling is a clear and direct rejection of Gov. Murkowski's prohibitionist zealotry --and a victory for all Alaskans.

WAR: USA admits it used NAPALM bombs in IRAQ - 2003

American pilots dropped the controversial incendiary agent napalm on Iraqi troops during the advance on Baghdad. The attacks caused massive fireballs that obliterated several Iraqi positions.

The Pentagon denied using napalm at the time, but Marine pilots and their commanders have confirmed that they used an upgraded version of the weapon against dug-in positions. They said napalm, which has a distinctive smell, was used because of its psychological effect on an enemy.

A 1980 UN convention banned the use against civilian targets of napalm, a terrifying mixture of jet fuel and polystyrene that sticks to skin as it burns. The US, which did not sign the treaty, is one of the few countries that makes use of the weapon. It was employed notoriously against both civilian and military targets in the

Vietnam war. The upgraded weapon, which uses kerosene rather than petrol, was used in March and April, when dozens of napalm bombs were dropped near bridges over the Saddam Canal and the Tigris river, south of Baghdad.

"We napalmed both those [bridge] approaches," said Colonel James Alles, commander of Marine Air Group 11. "Unfortunately there were people there ... you could see them in the [cockpit] video. They were Iraqi soldiers. It's no great way to die. The generals love napalm. It has a big psychological effect."

A reporter from the Sydney Morning Herald who witnessed another napalm attack on 21 March on an Iraqi observation post at Safwan Hill, close to the Kuwaiti border, wrote the following day: "Safwan Hill went up in a huge fireball and the observation post was obliterated. 'I pity anyone who is in there,' a Marine sergeant said. 'We told them to surrender.'"

At the time, the Pentagon insisted the report was untrue. "We completed destruction of our last batch of napalm on 4 April, 2001," it said.

The revelation that napalm was used in the war against Iraq, while the Pentagon denied it, has outraged opponents of the war.

"Most of the world understands that napalm and incendiaries are a horrible, horrible weapon," said Robert Musil, director of the organisation Physicians for Social Responsibility. "It takes up an awful lot of medical resources. It creates horrible wounds." Mr Musil said denial of its use "fits a pattern of deception [by the US administration]".

The Pentagon said it had not tried to deceive. It drew a distinction between traditional napalm, first invented in 1942, and the weapons dropped in Iraq, which it calls Mark 77 firebombs. They weigh 510lbs, and consist of 44lbs of polystyrene-like gel and 63 gallons of jet fuel.

Officials said that if journalists had asked about the firebombs their use would have been confirmed. A spokesman admitted they were "remarkably similar" to napalm but said they caused less environmental damage.

But John Pike, director of the military studies group GlobalSecurity.Org, said: "You can call it something other than napalm but it is still napalm. It has been re-mulated in the sense that they now use a different petroleum distillate, but that is it. The US is the only country that has used napalm for a long time. I am not aware of any other country that uses it." Marines returning from Iraq chose to call the firebombs "napalm".

Mr Musil said the Pentagon's effort to draw a distinction between the weapons was outrageous. He said: "It's Orwellian. They do not want the public to know. It's a lie."

In an interview with the San Diego Union-Tribune, Marine Corps Maj-Gen Jim Amos confirmed that napalm was used on several occasions in the war.

US Troops, Iraqi Police Seize Marijuana Plants

7/14/06 -- US troops and Iraqi police seized and destroyed a bumper crop of marijuana plants last week, according to a report in Stars & Stripes. Based on a military press release, the report said soldiers from the 172nd Stryker Brigade Combat Team, which has responsibility for most of northern Iraq, discovered the field in an unnamed location.

According to the military press release, the field contained "juvenile marijuana plants grown in a series of furrows. The owner claimed he was growing sesame."

Police put the value of the field at \$2 million. The crop was cut down and destroyed, and the man arrested.

While drug use and trafficking was rare under the repressive regime of Saddam Hussein, the chaos and violence into which the country has descended since the US invasion in 2003, has both increased drug use and made the country more attractive to smugglers. That is to be expected, complained Hamid Ghodse, head of the International Narcotics Control Board, the United Nations body charged with monitoring compliance with UN anti-drug treaties.

"Whether it is due to war or disaster, weakening of border controls and security infrastructure make countries into convenient logistic and transit points, not only for international terrorists and militants, but also for traffickers," Ghodse told the BBC in referring to Iraq last year.

"You cannot have peace, security and development without attending to drug control," Ghodse added, staying on point. But in Iraq, maybe we'd all be better off if everyone just smoked some herb and chilled out.

U.S. Abandons Animals in Lebanon Chaos

Images of kittens sniffing amid rubble. Dogs seen running frantically down the streets. Distraught Americans told that they must leave their animal companions behind to starve and die in the destruction. These scenes-reminiscent of cruel and illegal decisions made in the wake of Hurricane Katrina-are reality once more. While the French government has made provisions for animal evacuations, the U.S. is doing the opposite. U.S. officials evacuating citizens from Lebanon have failed to heed the lesson of the Gulf Coast and are refusing Americans' attempts to evacuate with their animal companions.

PETA Calls On U.S. Commander, South African Embassy Official to Facilitate Evacuation of Animals PETA has sent an urgent letter to Brig. Gen. Carl Jensen-the military commander in charge of U.S. evacuation operations in Lebanon-begging him to instruct his officers to help evacuees take their animals with them to safety and bringing international attention to the government's failure to serve all Americans trapped in Lebanon.

PETA also dashed off a letter to Siyabonga Ponco, chargé d'affaires of the South African Embassy in Cairo, urging him to permit South African nationals who are being evacuated to take their companion animals with them rather than forcing them to abandon their animals in the rubble to starve. The plea stemmed from an e-mail message that Ponco sent to PETA in which he suggested that evacuees with animals should "not demand more than they could be given"-implying that a request to help South African citizens take their beloved cats, dogs, and birds with them would be asking too much.

Toxic Gas Weapons being used in Lebanon?

Beirut -- July 19, 2006 The attached pictures are hideously gruesome, but you have to look at them. Help me find out what kind of weapons cause this kind of dismemberment and mutation.

What kind of weapons cause this kind of damage? Do you know? Could you find out? None of this is confirmed, or could be here and now. However, there are growing doubts that Israel might be using internationally forbidden weapons in its current aggression against Lebanon. News from "Southern Medical Center", a hospital in Saida (in South Lebanon) are not good. Dr. Bashir Sham, member of "French Association of Cardiovascular Surgeons", explains that the way the corps look when they reach the hospital, especially those of the air strikes in Doueir and Rmayleih, is very abnormal."

One might think they were burnt, but their colour is dark, they're inflated, and they have a terrible smell" All this, and the hair is not burnt nor do the bodies bleed. Eight of the victims of an air strike on Rmayleih bridge, near Saida, on the 15th of July, were transferred to Sham's hospital. Sham says that only chemical poisonous substances "lead to instant death without bleeding".

And what indicates the power of these substances, is the high and unusual of number of dead victims, compared to the number of injuries. Sham thinks that whatever "abnormal" substance causing these features might penetrate through the skin, or another explanation would be that the missiles contained toxic gas that stopped the proper functioning of the nervous system, and led to blood clotting. These toxic materials cause immediate death, within two to thirty minutes, according to Sham, who admits that these doubts can't be proven, not even by an autopsy. The director of the same medical center, Ali Mansour, says that due to the strong smell of the corpse, he couldn't breathe properly for at least 12 hours after the corps were handled. He explains that the center received eight bodies from Rmeileh last Monday, and none of them was bleeding.






What Happened on 9-11-01?

IRS Threatens Churches on Political Expression

"The Internal Revenue Service has been warning churches and nonprofit organizations that improper campaigning in the upcoming political season could endanger their tax-exempt status. In notices to more than 15,000 tax-exempt organizations, numerous church denominations and tax preparers, the agency has detailed its new enforcement program, called the Political Activity Compliance Initiative, the Los Angeles Times reported Tuesday.

Under the initiative, the IRS plans to expedite investigations into claims of improper campaigning, no longer waiting for an annual tax return to be filed or the tax year to end before launching a probe. A three-member committee will make an initial review of complaints and then vote on whether to pursue the investigation in detail."
