If the National Debt Is not Paid Default will happen like this: Print. Lie. Borrow. Deceive. Deny. Federal Reserve Policy is Steal from You

Every day it becomes more and more obvious that the fiat financial system as we know it is breaking down. The United States and European monetary union, whose currencies comprise nearly the entirety of the world's fiat reserves, have both signed up to debase their currencies as rapidly as possible.

Slavery is alive and well. And not only do the Elite not have to feed and clothe the slaves, but the slaves pay them for the privilege, through inflation.

Inflation is theft in more ways than one: it also steals our liberty.

We know three things: 1) the official policy of the Federal Reserve is to engineer and maintain inflation and 2) inflation is theft, and 3) adjusted for inflation, income purchasing power has declined 40%, especially in Obama's 3- years.

The dollar has already lost 95% of its value in the past century, and most of that loss has been just during past 45 years. BLS inflation calculator (which very likely understates real inflation), it takes \$7 today to buy what \$1 bought in 1966.

The Federal Reserve robs savers every day of millions of dollars, which it then transfers to the "too big to fail" banks by paying interest on those banks' reserves. Savers earn .01% on their cash while banks are paid 2% interest. The difference is what is stolen from savers and funneled to the banks.

Inflation is theft not just of cash but of liberty, as demonstrated by the nexus of the criminal justice system and the financial system, specifically the inflationary nature of our system. The criminal laws with standards for the value of property and the relative level of crime with which a person would be charged, if one violated that law; and, a corresponding amount of fines and penalties for convictions for those crimes.

The trouble is that these statutes are not indexed for inflation, so what happens is people are charged with a higher level of crime than they otherwise would have in the past, for no other reason than inflation. Result is that a number of people being charged with felonies when they should only be charged with a misdemeanor if the statutes were indexed for inflation.

If the relative value of the dollar goes down over time due to government mismanagement, how is that statute a fair one? There was no debate in our legislature or discussion in our society to see if we want additional numbers of people prosecuted for felonies, rather than misdemeanors.

Are we preventing crime and catching more criminals because of inflation or are we making more criminals out of otherwise decent people? The same goes for fines. I have noticed that the government is much better at raising fines than raising the levels for felony prosecution.

What happens when the inflation rate starts to get exceedingly high in the coming years, as we get QE 3,4, 5, etc.? So, it appears some people are looking at this, but not enough, in my opinion. I doubt many law makers and law enforcers really understand how pernicious inflation actually is.

Long-term capital gains enables theft of purchasing power via unrecognized inflation, i.e., it taxes inflated gains, not real value.

Say I invest \$100 in stocks and then sell them 15 years later for \$200. I made a profit of \$100 right? Wrong! During that time inflation (caused by government policies) reduced the value of my money so that the purchasing power of my \$200 is about the same as the \$100 I invested, meaning I really made no money at all.

Too bad theft via inflation isn't a felony.

The Emergency Homeowners' Loan Program (EHLPP) was created to provide emergency mortgage assistance to homeowners who are temporarily and involuntarily unemployed or underemployed due to the economy or a medical condition and are at risk of foreclosure. The Dodd-Frank Wall Street Reform and Consumer Protection Act provided \$1 billion to the U.S. Department of Housing and Urban Development (HUD) to develop EHLPP.

The Emergency Homeowners' Loan Program (EHLPP) can provide eligible homeowners with a 0% interest, forgivable loan that pays past-due mortgage payments (principal, interest, taxes, insurance, attorney fees), as well as a portion of the homeowner's mortgage payment for up to 24 consecutive months, or up to \$50,000, whichever comes first, and provided that certain eligibility requirements are maintained.

Once your EHLPP emergency assistance has ended, no regular monthly payment is due on your EHLPP loan. Absent default under the terms of your EHLPP loan documents, your outstanding EHLPP loan balance will be reduced by 20% each year following the date your assistance ended, and until your outstanding balance reaches \$0 (approximately 5 years after your assistance ended).

Due to expected high demand, interested homeowners will complete a Pre-Applicant Screening Worksheet first. If there are more potentially eligible pre-applicants than funding available, the worksheets will be entered into a random selection process. Homeowners will be randomly selected and invited to apply for EHLPP. Unfortunately, some qualified homeowners will not be selected

How to apply for EHLPP assistance?

The first step is to get a copy of the Pre-Applicant Screening Worksheet. Worksheets are available online at <http://www.FindEHLPP.org> as well as from non-profit housing counseling agencies participating in the EHLPP program. You can submit the completed worksheet to an EHLPP counseling agency in person, via fax or email. The deadline for worksheet submission is July 22, 2011.

Foreclosure in the works? SORRY! Those with foreclosure sale dates less than 30 days away will not qualify.

Maui County Permit Process Made Easier

If you are building a new structure and think you need a lengthy special management area major permit, you may be happy to learn that the monetary trigger required for SMA requirements has been raised from \$125,000 to 500,000. If your project is less than \$500,000, then commercial or residential projects will not be burdened by the SMA major permit proceedings.

Mayor Alan Arakawa explained that he proposed and supported the change because state law needed to be upgraded for the sake of free enterprise.

Whether the Mayor new it or not, its about INFLATION, i.e., the devaluation of the dollar's purchasing power. The materials and labor you could buy with \$125,000 ten years ago, today cost about \$250,000. Therefore, most small projects today would become major SMA projects under the old standard.

Now, the Mayor says homeowners can remodel their kitchens and store owners can improve their shops without the expense and time of SMA Major permits.

The changes also include a limit of less than 7,500 sq ft and cost less than \$500,000 will be exempt. Larger homes or more expensive homes will be required to obtain an SMA major or minor permit before construction.

USDA Grants \$\$ for Farmers

The Value-Added Producer Grant program [VAPG] can award up to \$100-K for ag related planning, and up to \$300-K for working capital expenses for such agriculture projects where there is limited access to healthy foods.

Application deadline is August 29, 2011.

Value added products are created when a farmer increases the consumer value of an agriculture commodity in the production or processing stage.

The USDA VAPG dollars can be used for feasibility studies, business plans, marketing, and for farm based renewable energy projects.

Legislator Defends with gun, but vote against gun rights?

Rep. Leonard Boswell (D-Iowa) and his family were victims of a home invasion at their rural farm house as reported in MAN last week. But his voting record is evidence he is no friend of gun rights for other people even though he has first hand experience now that guns save lives, his and his family.

Congressman Boswell has voted multiple times to make it harder for law-abiding citizens to access weapons during a life or death confrontation with armed attackers.

Boswell is on the record as supporting the Davis Amendment to H.R. 2122, which mandated trigger locks on new firearms that are sold by FFL dealers. So now, if someone breaks into your home, you are expected to have the time to find your key, unlock your gun, load your gun and then defend yourself.

Not likely. Too late. You are dead, kidnapped, raped, robbed.

Congressman Boswell also voted against the Musgrave amendment to H.R. 5672. This amendment, brought forth by pro-gun champion Congresswoman Musgrave, would have defunded the enforcement of the trigger lock mandate, thereby defanging this anti-gun legislation. Boswell voted against this.

He supported rabidly anti-gun then-Congressman Charles Schumer's H.R. 424 which elevated the minimum sentence against citizens who are charged with using guns for self-defense!

Boswell voted against Congressman Goode's amendment to H.R. 2122, which would have lifted the DC gun ban. No comfort to the law abiding citizens of the District of Columbia.

Congressman Boswell even voted in favor of the McCollum Amendment to H.R. 2122, which makes it illegal for juveniles to have in their possession any magazine that is over 10 rounds, even when accompanied by an adult!

There's more, but Gun Owners of America recently gave Congressman Boswell a D- in their voter scorecard. That sums it up.

So, how does the NRA, give Congressman Boswell an "A" and endorsed him in his re-election bid last year?

There is one more thing we'll say about Congressman Boswell: he was lucky.

Again we are happy that he and his family were unhurt. We applaud him for confronting an attacker in his home at the age of 77 years old. We are pleased that his situation became yet another example of a law-abiding Iowan using a firearm to defend himself.

But it should be pointed out that the criminal in this case was armed with a mere BB gun. What if the intruder had brought a real gun. By the time Boswell's grandson ran to the gun case, unlocked it, found the shotgun, found the ammunition for it, loaded it, and then ran to assist his family it would have been too late.

It is for situations like this that Iowa Gun Owners strongly opposes any attempts to require Iowans to lock up their guns - useless in violent attacks.

As gun owners Iowa Gun Owners had HF7 "Stand-Your-Ground" legislation introduced into the Iowa House give important protections to law-abiding Iowans who are forced to defend themselves and their families.

During re-election campaigns all the candidates pledged to pass this bill out of the House this year. Yet they did not. The bill, having passed out of Committee, was never allowed to see the light of day on the House floor.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





# Jewish Military Navy & Coast Guard acting like Pirates taking over boats in international Waters. National Debt?

## Israeli commandos have intercepted and boarded a boat trying to breach Israel's blockade of Gaza Strip.

The boat Dignite-al Karama, the sole representative of an initial 10-vessel flotilla, had earlier been warned by Jewish Military to change course.

An anti-blockade protest group said the boat had been in international waters.

Maxime Guimberteau from A French Boat for Gaza said activists on board the Dignite-al Karama had told him they were 40 nautical miles off the coast of Gaza in international water out of the jurisdiction of Jewish Navy when the boat was surrounded by four Israeli navy ships. He said their conversation then cut off.

Responding to the news that Israeli commandos had boarded the boat, another French-based group, Platform Palestine, told the Associated Press news agency that Israel's action clearly showed "the military logic of Israeli politics, which only speaks the language of force".

The Israeli military said the boat had been boarded peacefully. It was later escorted into the Israeli port of Ashdod.

Upon expressing their unwillingness to arrive at the Ashdod port, it was unequivocally necessary to board the vessel and lead it there"

Hours later, the ship entered the port city of Ashdod flanked by three small Israeli naval vessels.

Israeli officials said those on board would be turned over to the Israel police, the immigration authority and the interior ministry at Ashdod.

The Dignite-al Karama is part of Freedom Flotilla II, which has been trying to deliver humanitarian aid to Gaza since the end of June. Flotilla organisers say despite the opening of Gaza's Egyptian border, the territory remains under "unlawful blockade" by the Israelis.

In 2010, nine Turkish activists and an American were killed when Israeli commandos boarded the lead ship of the first Freedom Flotilla, causing an international outcry.

Israel increased sanctions on the impoverished Palestinian territory in 2006 Although the Islamist group won Palestinian legislative elections, it refuses to recognise Israel since the Jewish State was carved out of Arab lands after WWI by the British in payment to Zionists who manipulated USA into to WWI.

## Jews Torture Arabs

The use of torture in Israeli prisons has been the subject of extensive inquiry. In 1977, the London Sunday Times conducted a five-month investigation. Corroboration was obtained for the evidence adduced. The torture documented occurred "through the ten years of Israeli occupation since 1967. The investigation resulted in concrete conclusions: Israeli interrogators routinely ill-treat and torture Arab prisoners. Prisoners are hooded or blindfolded and are hung by their wrists for long periods. Most are struck in the genitals or in other ways sexually abused. Many are sexually assaulted. Others are administered electric shocks to anus, genitals, ears, mouth, beatings, etc.

In February 1969, Rasmiya Odeh was arrested and brought to Jewish prison in Moscobiya. Her father, Joseph, and two sisters were also detained for interrogation. Joseph Odeh was kept in one room while his daughter Rasmiya was beaten by Jewish military. When they brought him to her she was lying on the floor in blood-stained clothes. Her face was blue, her eye black. In his presence, they held her down and shoved a stick into her vagina. One of the interrogators ordered Joseph Odeh "to fuck" his daughter. When he refused they began beating both him and Rasmiya. The Jews again spread her legs and shoved the stick into her. She was bleeding from the mouth, face and vagina when Joseph Odeh fell unconscious. <http://www.marxists.de/middleeast/schoenman/ch10.htm#n138>.

## Financial Reckoning Day Martial Law?

Today, our nation is sinking into bankruptcy, insolvency, and a serious financial reckoning day because our political class in Washington DC continues to load our posterity with perpetual debt and servitude.

This year-long Army exercise is studying the implication of a collapse of the US dollar and bond market, maintaining "domestic order amid civil unrest" and "ways to deal with fragmented global power and drastically lowered budgets."

Most Americans are distressed, perplexed, and confused because of their "downright ignorance" of sound money principles enshrined in our US Constitution and the evils of central banking.

In 1910, a secretive cabal of Wall Street and international bankers conspired to create the Federal Reserve System, which became our nation's central bank in 1913. Our Founding Fathers were well acquainted with the evils of central banking (beginning with the Bank of England in 1694), and they diligently sought to enshrine hard money principles into our Constitution. In 1913, our national debt was \$2.9 billion dollars and today it is \$14.5 trillion dollars--an incomprehensible 400,000% increase! And, our unfunded liabilities now exceed \$115 trillion and each taxpayer is on the hook for over \$1 million dollars!

Our present banking system was conceived in fraud and deceit by our modern money changers and corrupt politicians. Over 200 years ago James Madison wrote, "History shows that the money changers have used every form of abuse, intrigue, deceit and violent means possible to maintain control over governments by controlling the money and issuance of it." The Bible affirms that "the love of money is the root of all evil" (I Timothy 6:10), and we also read that when our Lord saw the "money changers" in the Temple, He drove them off with violence (John 2:13-15). America is facing a dangerous tipping point unless we enact some serious fiscal and monetary reform. Already 46 out of 50 states have failed to meet their balanced budget deadlines for June of this year, and many like Illinois, Minnesota, Florida, California, Wisconsin, and Arizona are laying off workers and suspending essential services. As Margaret Thatcher famously said, "The problem with socialism is that you eventually run out of other people's money." The states are broke! And, unlike the federal government, they cannot print money over at the Fed.

In response to these developments several states are asserting their state sovereignty by adopting sound money legislation to declare gold and silver as legal tender. The US Constitution says that no state "shall coin money; emit bills of credit; [or] make anything but gold and silver coin a tender in payment of debts" (Art. 1, Sec. 10). The wording here is clear. As George Washington said, "Paper money has had the effect in your state that it will ever have, to ruin commerce, oppress the honest, and open the door to every species of fraud and injustice." Utah has become the first state to fully adopt sound money legislation in May, and others that are in the process of adopting this legislation include Minnesota, Iowa, Colorado, Georgia, Virginia, Tennessee, South Carolina, Montana, Missouri, Indiana, Idaho, New Hampshire, and Washington. In addition to supporting these bills, we also need to support The Free Competition in Currency Act (HR1098) introduced by Ron Paul to repeal US legal tender laws and remove taxation on gold and silver. A similar bill has been introduced in the Senate (SB500) by Senators Rand Paul, James DeMint, and Mike Lee.

Sir Thomas Gresham's Law says that bad money drives out good money. Because we have allowed the Federal Reserve System to illegally and unconstitutionally act as the fiscal agent for the US government we are experiencing Gresham's Law.

Thomas Jefferson has warned us that banking institutions are more dangerous to our freedom and liberty than standing armies. This truth holds true to this day and probably even more so. America is facing a reckoning day and to "reckon" means to "settle" and we cannot settle our assets against our liabilities. This cannot go on forever.

Finally, Thomas Jefferson has challenged us that we must make our election between liberty or servitude. Our monetary system today is an abomination unto the Lord (Proverbs 11:1). ## Maui Charter Independence for Molokai ?

In a democratic republic, how we select our representatives is a fundamental concern. If your community is represented by someone your community did not elect, which frequently happens in Maui County, then you have a problem.

The Maui County Charter Commission will be reviewing this issue again over the next year.

The Maui County Council system today guarantees that residents of the smaller, isolated communities of Lanai, Molokai, and Hana serve on the nine-member council. But, if Lanai (pop:3135) or Hana (pop:3136) voters elect their own Council Member in equally proportioned districts with Maui, the Council would have to have 50 members to comply with the Constitutional mandate for equal representation. Some people who like centralized political systems say such a large Council is an obvious non-starter. But they ignore the advantage of better representation and the decentralization of political power of such a large Council, each councilmember representing fewer voters, more accountability.

The current at-large elective system requires that Council candidates come from certain defined residency districts but allows that all nine members are elected at-large, that is, by all of the voters. This reality is that Lanai and Molokai representatives are actually elected by the huge number of Maui voters.

What needs to happen is to bring governance to the local level: Lanai, Molokai, and perhaps Hana should have their own governments, elected at the local level by their own residents.

The goal is to give these communities responsibility for their own destinies by electing their own leadership. To achieve that end, Charter Commissioner Dave DeLeon has proposed that the County Charter allows for the creation of Lanai and Molokai Island Boards elected by the residents of their communities.

DeLeon proposes these boards would replace the Lanai and Molokai Planning Commissions and be responsible for all land use on the island, including permits, zoning and variances. The Molokai boardmembers would be the true representatives of their communities, serving as the official voice of their communities, at all three levels of government to represent their communities interests. Molokai residents would have their own voice on issues affecting their communities and would be responsible for their own futures, he suggested.

50 Councilmembers is a good thing for decentralization of political power. But Molokai should be independent from Maui, with our own all local elected government in republican form, that is, self governance by Sovereign Individuals of good character and aloha for neighbors. Self governance and quality of life can be enhanced with assistance from our locally elected and hired government agents [ Sheriff and Peace Officers not MPD] who would be commissioned under Oath and Penalty to support and protect our rights to Life, Liberty, Property, Freedom from taxation slavery, and to assist us enforcing our laws against the tyranny from Organized Crime aka Maui County, Hawaii State, Obama-racketeers, United Nations, AIPAC, Fed, IRS, BATF, DEA, etc. No RPT taxes on homes!

## Ron Paul, Candidate for President says Cut Cap Balance Act is a SCAM

HR 2560, the Cut, Cap, and Balance Act only serves to sanction the status quo [Obama-racketeering] by putting forth a \$1 trillion budget deficit and authorizing a \$2.4 trillion increase in the debt limit.

First, it purports to eventually balance the budget without cutting military spending, Social Security, or Medicare. This is impossible. These three budget items already cost nearly \$1 trillion apiece annually. This means we can cut every other area of federal spending to zero and still have a \$3 trillion budget, with annual federal tax revenues of only \$2.5 trillion.

Second, it further entrenches the ludicrous beltway concept of discretionary vs. nondiscretionary spending. America faces a fiscal crisis, and we must seize the opportunity once and for all to slay Washington's sacred cows-- including defense contractors and entitlements. All spending must be deemed discretionary and reexamined by Congress each year. To allow otherwise is pure cowardice.

Third, the Act applies the nonsensical narrative about a "Global War on Terror" to justify exceptions to its spending caps. Since this war is undeclared, has no definite enemies, no clear objectives, and no metric to determine victory, it is by definition endless. Congress will never balance the budget until we reject the concept of endless wars.

Finally, this Act ignores the real issue: total spending by government. What we need is a dramatically smaller federal government [ no TSA, BATE, IRS, cut Congress wages]; if we achieve this a balanced budget will take care of itself.

We do need to cut spending, and by a significant amount. Why has our budget doubled in 10 years? This country doesn't have double the population, or double the land area, or double anything that would require the federal government to grow by such an obscene amount.

We need to cap spending, and then continue decreasing that cap so that the federal government grows smaller and smaller. In recent history the government has way overstepped its constitutional mandates. All we need to know about spending caps is that they need to decrease year after year.

What we have been asked to do here is support a budget that only cuts relative to the President's proposed budget. It still maintains a \$1 trillion budget deficit for FY 2012.

By capping spending at a certain constant percentage of GDP, it allows for federal spending to continue to grow. Tying spending to GDP creates an incentive to manipulate the GDP figure, especially since the bill delegates the calculation of this figure to the Office of Management and Budget, an agency which is responsible to the President and not to Congress. In the worst case, it would even reward further inflation of the money supply, as increases in nominal GDP through pure inflation would allow for larger federal budgets.

Finally, this bill authorizes a \$2.4 trillion rise in the debt limit. I have never voted for a debt ceiling increase and I never will. Increasing the debt ceiling is an endorsement of business as usual in Washington. It delays the inevitable, the day will come when we cannot continue to run up enormous deficits and will be forced to pay our bills.

In conclusion, Mr. Speaker, I must vote against HR 2560.

## About Your Garden: Hot Potatoes

Recent studies on Food Security in Hawaii indicate that we don't grow enough starches to feed ourselves, and carbohydrates are critical to our survival living in the middle of the Pacific. One overlooked crop is irish potato. Not new to Hawaii, irish potato was grown on Molokai during World War II, in the mid-1970s by Marvin Berry in the Ag Park, and more recently by Duane Craney in the old alfalfa field. And Molokai can surely grow them big. Some of Duane's lunkers were almost a foot long and looked like clubs. The potatoes were so large, they couldn't fit into the chipping machines and he lost the Frito-Lay contract.

Irish potato is like finding hidden treasure and the kids love to dig them out, even when they're not mature. A native of South America, and a member of the tomato family, growing potatoes takes seeds and timing. Buying seed potatoes can be costly if buying in small amounts, but there are many internet sources, and most are certified to be disease-free or even organic. I sometimes buy bags of potatoes and plant them, making sure they look healthy with no blemishes in and out, but I don't recommend it. There are many diseases that can be carried in the potato, including viruses, bacteria, and fungus, and can be introduced to your ground.

There are times of the year when minimal water is required to grow them, and they can also handle poor and acid soil, which makes them so versatile. Cold and wet weather over extended periods are ideal conditions for potato late blight, a devastating fungus that can melt the plant away and spoil the tubers as well. This disease caused the great potato famine in Ireland in the late 1840s, killing over 1 million and forcing many to emigrate to America and elsewhere. Ideal conditions for this disease occur from November to February. Two good times to start planting would be March and later, and also late summer in August so you can harvest before the bad weather.

Each seed piece should have at least one eye, but I like to go with two. These are planted in a furrow about 1 foot apart. One pound of seed is sufficient for about 10 feet of row. Fertilizing at planting or when the eyes start to sprout with fertilizers such as 10-30-10 or 10-20-20 seems to work well, and I also fertilize a little when I hill them, but if you're serious about planting potatoes, do a soil sample. The plant needs to be hilled when they start to send out little spears from the main stem. These are stolons where the potatoes will form on the tips, and will need to be covered in order to form potatoes.

Potatoes are classified as early, mid-, and late season. I usually grow the early and mid-season ones because I don't like to wait that long, but the later the variety, the greater the potential yield. There are many good varieties to grow, including whites, reds, russets, and yellows or even novelties such as purple, pink, red and two-tones. Some of my favorites include Red LaSoda, Dark Red Norland, Yukon Gold, Red Dale, and Chieftain, but it really comes down to what seed you can get your hands on. Keeping the small ones for seed next season is a good idea. To avoid build-up of soil-borne diseases, don't plant in the same area for a year. Eat them fast or store them in a cool place, otherwise they'll start to sprout from the heat. And nothing beats freshly grated Yukon Gold hash browns for breakfast.
