Obama's Retaliation Against Maj. Stefan Cook who Challenges Obama's birthplace: You are fired!

Major Cook's attorney Orly Taitz is forced to amend their complaint to include charges of retaliation against a whistleblower.

Retaliation has occurred against Plaintiff Stefan Frederick Cook for the exercise of his First Amendment right to petition for redress of grievances and Plaintiff Cook accordingly here seeks an injunction against the continuance or full implementation of this official governmental retaliation or in the alternative for a writ of mandamus, order to show cause, or rule nisi be issued to the Department of Defense commanding it to cease, cure, or remedy all retaliation against Plaintiff Cook. The circumstances are as follows:

Late on Tuesday afternoon, July 14, 2009, at around about 4:30 pm, Plaintiff Stefan Frederick Cook was told that his services were no longer required in Afghanistan and that he need not report for duty; and, a followup e-mail with the revocation order attached from Master Sargent Miguel Matos. Upon receipt of the revocation, Plaintiff Major Cook called his civilian boss, the CEO of Simtech, Inc., a corporation that does DOD contracting in the general field of information technology/systems integration, at which Plaintiff Major was employed until taking a Military Leave of Absence on Friday July 10, 2009, in preparation for his deployment to Afghanistan.

The CEO of Simtech, Inc., Larry Grice, explained to Major Cook that he had been terminated. Grice told the Plaintiff that he would no longer be welcome in his former position at SOCOM. Grice told Plaintiff, that the situation had become "nutty and crazy", and that Plaintiff would no longer be able to work at his old position because the Defense Security Services of Obama's DOD had compelled Cook's termination. Grice then discussed Plaintiff's expectation of receiving final paychecks (including accrued leave pay) already owed, without any severance pay, and wished the Plaintiff well.

A federal agency clearly violates the Whistleblower Protection Act if it takes a personnel action with respect to any employee because of any disclosure of information by the employee that he reasonably believes evidences a violation of a law, rule or regulation; gross mismanagement; gross waste of funds; an abuse of authority; or a substantial and specific danger to public health or safety. What has happened in the present case of Stefan Frederick Cook is that a federal agency appears to have retaliated against Stefan Frederick Cook's private employer, Simtech, Inc., is as much a victim of the Department of Defense' heavy-handed interference with Plaintiff Cook's private-sector employment as is Plaintiff Cook himself because Simtech was forced to layoff a skilled and valuable employee in order to continue their contracts with Obama's DOD.

Molokai Water Failure 7-17

KAUNAKAKAI, Molokai — A mechanical breakdown affecting a water pump will severely affect residents and businesses in Kaunakakai and Kalae on Molokai. Until repairs can be completed, residents and businesses in the areas of Kaunakakai and Kalae should make every effort to immediately conserve water and limit usage to minimum requirements needed for health, safety and hygiene.

Water customers will experience low water pressure or no water as water tank storage levels diminish. The county is working with the Department of Hawaiian Home Lands to utilize a second well that DHHL has.

The County of Maui has mobilized a 5,000-gallon water tanker, which is at the intersection of Ala Malama Avenue and Kukui Place near the post office in Kaunakakai. It will be available in the evening and day time until repairs are completed. Residents are encouraged to fill personal containers at this location should water service diminish.

An estimated 1,275 water meters serving households, businesses and agencies in the Kaunakakai and Kalae areas are affected.

U.S. Attorney General Eric Holder Refuses to Prosecute His Boss Obama

Under False Claims Act whereby Obama was accused of Defrauding the U.S. Treasury by Illegally being a U.S. Senator from Illinois as Obama is an Illegal Alien, not a U.S. Citizen

At a closed door hearing on June 9, 2009 because of the status of the "sealed case," sealed because of the nature of the case, that being a "Qui Tam" or FCA [False Claims Action] case, the Attorney General through his representatives refused to proceed with the prosecution of Obama for fraudulently serving as a U.S. Senator from Illinois for 3 years."

Berg continued, "I presented overwhelming evidence that Obama was ineligible to be a U.S. Senator and therefore, Obama fraudulently received a salary and benefits of nearly \$1 Million Dollars.

Since the case was 'Dismissed with Prejudice' it is now 'Unsealed' and the record is open for review. The case, Berg vs. Obama, U.S. District Court for the District of Columbia, No. 08-cv-1933 and is available on Pacer or our website, obamacrimes.com. Berg, will be Appealing.

Berg said that during oral argument, I raised the issue of a 'Conflict of Interest' as Attorney General Holder's boss is the Barack H. Obama, so how could they properly review this case? I suggested the appointment of a Special Prosecutor. I also raised the issue that any Discovery used in the Government's decision to have the case dismissed should be turned over to me as the Relator, however, no Discovery was turned over.

Article II, Section 3 of the U.S. Constitution entrusts the Executive, which includes the United States Attorney General, with duty to take Care that the Laws be faithfully executed. Berg stated, "I am very disappointed that U.S. Attorney General Eric Holder through his Staff has failed to uphold his duties."

Notice of Proposed Endangered Status for Flying Earwig Hawaiian Damselfly (*Megalagrion nesiotes*) and Pacific Hawaiian Damselfly (*M. pacificum*) Throughout Their Ranges on the Islands of Hawaii, Maui, and Molokai

On July 8, 2009, the U.S. Fish and Wildlife Service published a proposed rule in the Federal Register (74 FR 32490) to list the flying earwig Hawaiian damselfly (*Megalagrion nesiotes*) and the Pacific Hawaiian damselfly (*M. pacificum*), as endangered under the Endangered Species Act of 1973, as amended (Act). If we finalize this rule as proposed, it would extend the Act's protections to these species. We have determined that critical habitat for these two Hawaiian damselflies is prudent, but not determinable at this time. Comments and materials related to this proposal are solicited.

The flying earwig Hawaiian damselfly is currently known only on Maui though historically it was also found on the Big Island. The Pacific Hawaiian damselfly is currently found on Maui, Molokai, and the Big Island. This species no longer occurs on Kauai, Oahu, and Lanai.

Obama Loves Israel? Why?

These Jews "more than hate" non-Jews.

One of the reasons I continue to educate myself about this group, is the shock I continually get, the more I learn: Christians in Jerusalem want Jews to stop spitting on them report By Amiram Barkat Haaretz July 13, 2009

A few weeks ago, a senior Greek Orthodox clergyman in Israel attended a meeting at a government office in Jerusalem's Givat Shaul quarter. When he returned to his car, an elderly man wearing a skullcap came and knocked on the window. When the clergyman let the window down, the passerby spat in his face.

The clergyman preferred not to lodge a complaint with the police and told an acquaintance that he was used to being spat at by Jews. Many Jerusalem clergy have been subjected to abuse of this kind. For the most part, they ignore it but sometimes they cannot.

On Sunday, a fracas developed when a yeshiva student spat at the cross being carried by the Armenian Archbishop during a procession near the Holy Sepulchre in the Old City. The archbishop's 17th-century cross was broken during the brawl and he slapped the yeshiva student.

Both were questioned by police and the yeshiva student will be brought to trial. The Jerusalem District Court has meanwhile banned the student from approaching the Old City for 75 days.

But the Armenians are far from satisfied by the police action and say this sort of thing has been going on for years. Archbishop Nourhan Manougian says he expects the education minister to say something.

"When there is an attack against Jews anywhere in the world, the Israeli government is incensed, so why when our religion and pride are hurt, don't they take harsher measures?" he asks.

According to Daniel Rossing, former adviser to the Religious Affairs Ministry on Christian affairs and director of a Jerusalem center for Christian-Jewish dialogue, there has been an increase in the number of such incidents recently, "as part of a general atmosphere of lack of tolerance in the country."

Rossing says there are certain common characteristics from the point of view of time and location to the incidents. He points to the fact that there are more incidents in areas where Jews and Christians mingle, such as the Jewish and Armenian quarters of the Old City and the Jaffa Gate.

There are an increased number at certain times of year, such as during the Purim holiday. "I know Christians who lock themselves indoors during the entire Purim holiday," he says.

Former adviser to the mayor on Christian affairs, Shmuel Evyatar, describes the situation as "a huge disgrace." He says most of the instigators are yeshiva students studying in the Old City who view the Christian religion with disdain.

"I'm sure the phenomenon would end as soon as rabbis and well-known educators denounce it. In practice, rabbis of yeshivas ignore or even encourage it," he says. Evyatar says he himself was spat at while walking with a Serbian bishop in the Jewish quarter, near his home. "A group of yeshiva students spat at us and their teacher just stood by and watched."

Obama's Economic Catastrophy

The fiscally disastrous consequences of Obama's federal spending binge that is taking place under Obama and the new Congress, according to Independent Institute Senior Fellow Ivan Eland.

"Obama's budget would double the projected deficit over the next 10 years," Eland writes in his latest op-ed. "By 2019, federal spending is projected to be an eye-popping quarter of the nation's GDP." Unless the government gets its fiscal house in order, Eland continues, the consequences could be high inflation and economic stagnation to a degree that would make the stagflation of the 1970s "look like an economic picnic."

Lawmakers must cut both entitlements and non-entitlements, the largest component of which is defense spending. That will require overcoming the vested interests that support wasteful weapons systems and the foreign-policy elites who push for grandiose interventionist goals across the globe. Scrapping outmoded weapons systems and excising total payroll are essential. "Thus, instead of expanding the Army," Eland writes, "the nation needs to dismantle all forces stationed abroad on land and sea and some of those based at home."

By 2007, the wealthiest countries had given the world's worst dictators \$105 billion in development aid, but that "investment" had yielded zero return in terms of meaningful economic, social, or political progress. Worse, development assistance has solidified dictators in their position of power, according to Christopher J. Coyne and Matt E. Ryan, authors of "With Friends Like These, Who Needs Enemies? Aiding the World's Worst Dictators".

Take the case of Sudan. Its government, ruled by dictator Omar al-Bashir, is infamous for its corruption, violence, and violations of basic rights, especially in Darfur. Nevertheless, the developed countries gave al-Bashir nearly \$7 billion in development assistance from 1989 to 2006, including about \$2.7 billion from the U.S. government, according to Coyne and Ryan. Moreover, although Sudan remains on the U.S. State Department's list of countries that sponsor international terrorism, donor governments have pledged an additional \$7 billion.

"It is difficult to argue that the significant aid provided to the Sudanese government has had any positive impact," write Coyne and Ryan. "The country is still ruled by a brutal dictator, and its political institutions remain unreformed.... The bottom line is that if developed countries' goal is to foster liberal economic, political and social institutions abroad, they should stop providing aid to the world's worst dictators."

Two Shot in South Richmond Store

A gunman who had wounded a shopkeeper and opened fire on several customers was stopped yesterday when another man shot him at the store in South Richmond, authorities said.

The violent attempted robbery took place shortly after 1 p.m. at the Golden Food Market at 2701 Jefferson Davis Highway, the same store where another man was shot last month—and only three blocks from the scene of another robbery in June that left a shopkeeper dead.

Trammell, who arrived outside the store shortly after yesterday's shootings, described a frenzied scene. One man told Trammell that the man who had shot the robber was a guardian angel. "Whoever did it probably saved their lives in there," Trammell said of the shooter. Police did not identify the hero.

The man who shot the robber is a friend of the store owner, and he was wearing openly a holster with a Western-style revolver, said Managing Deputy Commonwealth's Attorney Tracy Thorne-Begland.

After the suspect shot the store owner and opened fire on patrons, the owner's friend shot the suspect once in the torso, took his gun and called police.

Police said it appeared that the shooting of the suspect was justified, and that they expect to file charges against the injured suspect.

Police Cmdr. Steve Drew said it was unusual for a commercial robbery to happen so early in the day.

The previous shooting at Golden Food took place late the night of June 12. And three nights earlier, a co-owner of the Come and Go Food Market, which is about three blocks north of Golden Food on Jefferson Davis, was shot and killed in a robbery.

A few hours after yesterday's attempted robbery and shootings, "Sam" Messaf, the man who was shot June 12 at Golden Food, was at the store to help another man shut down the market.

He had been helping out at the store June 12 when two robbers came inside. One man opened fire, reaching over the counter and shooting as Messaf cowered behind it, he said. Messaf was shot six times in his legs. He said he suffered nerve damage in his left leg and has trouble sleeping.

Krazy for Kolea Kontest

The fall migration of the kolea, the Pacific Golden Plover (*Pluvialis fulva*), has begun, with the July 13th observation of the first kolea to return from breeding grounds in the Alaskan tundra. The earliest observed birds are typically females that may have experienced a failed nesting attempt or perhaps did not bond with a mate for the breeding season. Adult males normally appear by the end of August, followed by juveniles in October. The kolea is easily recognized by its bold black & white breeding feathers called 'alternate' plumage, however this is lost by winter and the bird molts back to 'basic' plumage. Kolea are long-lived (20-plus years), territorial and annually return to the same grounds: Many Molokai residents have named their distinguished winter guests and note arrival and departure dates on calendars. Sightings are collected at Nene O Molokai and emailed to Mr. Peter Pyle, ornithologist, who then compiles this information for the Bishop Museum.

The kolea is a swift flyer, performing an incredible non-stop transpacific migration to Hawaii in about 40 hours at speeds averaging 56 - 60 miles per hour. Some birds continue on to points as far south as Australia or as far away as Madagascar. In Hawaii the winter range of the kolea can include pastures and cultivated fields, coastal salt marshes and mudflats, the grassy borders of airport runways, athletic fields, golf courses, and residential lawns. The kolea spends most of its daylight hours foraging and can be recognized from a distance by its peculiar feeding behavior of run-stop-run. Nighttime roosting sites are Molokai's coastal fishpond walls or rocky points, parking lots, roof tops or other areas where distance visibility is good and predators can be easily sighted.

Kolea on their northern migration may have aided ancient navigators with the discovery of the Hawaiian Islands, and the bird figured prominently in Hawaiian folklore: it was considered to be the embodiment of the god of healing, Koleamoku, and a messenger of high chiefs.

Report the return of your kolea and win a prize. Include date, time, and location. The observer of the first CONFIRMED sighting will win a Kolea Research T-shirt from the Hawaii Audubon Society. The first ten confirmed observations will receive a gift certificate for a scoop of ice cream at Kamoi Snack 'N Go. In addition, any individual reporting a banded kolea will receive \$20. The sighting and location of each banded bird WILL BE CONFIRMED for this prize.

Kolea banded on Molokai have a green or yellow band over a silver metal band. Also be on the lookout for birds banded with a combination of three color and one metal band. These birds were banded by Dr. Oscar "Wally" Johnson on Montana State University for a long-term life history study. Bird bands are read as if reading a book, that is, left leg top to bottom, then right leg top to bottom. Call Arleone 553-5992 or email researchbirds@yahoo.com. The director of the Central Intelligence Agency, Leon E. Panetta, has told the House Intelligence Committee in closed-door testimony that the C.I.A. concealed "significant actions" from Congress from 2001 until late last month. In fact, Blackwater's owner, Erik Prince, discussed this practice when he testified in front of Congress in October 2007 and admitted to paying \$20,000 to a Blackwater victim's family and \$5,000 to another.

Now, under defacto President Barack H. Obama, Blackwater (which recently renamed itself "Xe") is attempting to use other means to silence its victims. On July 20, the company's high-powered lawyers from Mayer Brown, which boasts that it represents eighty-nine of the Fortune 100 companies and thirty-five of the fifty largest US banks, filed a motion in the US District Court for the Eastern District of Virginia to impose a gag order on Iraqi civilians suing the company. The motion also seeks to silence the lawyers representing the families of Iraqis allegedly killed or injured by Blackwater in a series of violent incidents spanning several years.
