**Moon attacks J.A.I.L. for Judges**

Joining in the list of Chief Justices around the nation condemning J.A.I.L. for Judges movement, is Hawaii Chief Justice Ronald Moon in his 2007 State of the Judiciary Address to the State Legislature.

JAIL for Judges, is about criminal behavior by judges, and the lack of an effective procedure to arrest criminal behavior by judges in Hawaii. George Peabody of Molokai is a leading advocate of JAIL for Judges, and a critic of the corrupted judicial system in Hawaii.

**Peak Season for Barn Owl Sightings**

The Barn Owl (Tyto alba) was introduced to Hawaii in April, June and October 1958. A total of 15 birds were imported from California by the State Department of Agriculture and released at Kukuihaele on the Big Island. Over the next five years an additional 71 owls were introduced on Kauai, Oahu, and Molokai on Molokai Ranch lands. The Barn Owl is often mistaken for the Hawaiian pueo, or Hawaiian Short-Eared Owl (Asio flammeus sandwicensis). A



few differences are easily perceivable, however: The Barn Owl is golden-buff in color, while the pueo is dark brown and about half the size of the Barn Owl. The pueo is largely diurnal, hunting during daylight hours, while Barn Owls are nocturnal. Both species are ground nesters.

Over the past several weeks I ve received numerous phone calls reporting sick or injured Barn Owls or regarding the number of Barn Owls observed on the highway see photo. A few individuals were concerned that the sickness might be caused from poisoned rodents. Sightings such as these are seasonally typical, have a peak period, and correlate to optimal nesting conditions and a seasonal increase in rodent population. Pathology and toxicology results indicate that the deaths are not related to environmental events such as a brush fire (smoke inhalation), contact with a causative agent, or by eating poisoned rodents.

From 1992 to 1994, a monitoring program was initiated to identify the cause of the then undiagnosed owl disease now known as Sick Owl Syndrome. Dozens of owl mortalities were recorded and suitable specimens were sent for necropsy and analysis. Results identified impact injury (apparently vehicular collision) as the most common cause of death (50%), followed by infectious disease (trichomoniasis, pasteurellosis, aspergillosis) (28%) and emaciation (22%). No predisposing cause of emaciation was detected. Pesticide use was addressed in the study, and no evidence was found of organochlorine, organophosphorus, or carbamate pesticides as causes of death in Barn Owls or pueo. Wildlife biologists in Hawaii use Diphacinone (an anticoagulant specifically affecting mammals) to control rodents in endangered species bird habitat because it is not very toxic to birds.

As part of the study, Barn Owls were also fitted with transmitters to determine their movement patterns and home ranges. The owls were quite habitual, and maintained fairly small short-term home ranges, suggesting that the owls moved into new areas and re-settled due to food availability. Barn Owls are very efficient hunters, and have the ability to locate prey by sound alone. But even with this ability, intensive studies conducted in Hawaii indicate that this species has done no more in controlling rodents than mongooses. During the Sick Owl Syndrome study, pathologists analyzed the stomach contents of 28 Barn Owls and found mainly insects (64%), and rodents (18%); the remainder had mixtures of rodents and insects or grass.

The Barn Owl is the most widespread owl species in the world and occurs on every continent except Antarctica. They are short-lived, with a life expectancy of one to two years, although the oldest known Barn Owl in North America lived to be 11 years, 6 months. Barn owls are protected under the U.S. Migratory Bird Treaty Act and under CITES Appendix II. They are not federally threatened or endangered in the United States, but they are protected in some individual U.S. states where they are considered endangered due to habitat loss.

# New 9/11 Study: No 757 Plane Hit the Pentagon

A study of the black box data provided by the government to Pilots for 9/11 Truth has confirmed the previous findings of Scholars for 9/11 Truth that no Boeing 757 hit the Pentagon on 9/11. This new study by Pilots of the NTSB data, drives another nail into a coffin of lies told the American people by government that American Airlines Flight 77, a Boeing 757, hit the ground floor of the Pentagon after it skimmed over the lawn at 500 mph. The truth is that the Pilot's study shows that a large aircraft did head toward the Pentagon but did not impact with it. It swerved off and flew above the Pentagon.

The study was signed by fifteen professional pilots with extensive military and commercial carrier experience.

Four other facts also prove that no Boeing 757 hit the Pentagon:

(1) The hit point at the Pentagon was too small to accommodate a 100-ton airliner with a 125-foot wingspan and a tail that stands 44 feet above the ground; the kind and quantity of debris was wrong for a Boeing 757: there were no wings, no fuselage, no seats, no bodies, no luggage, no tail! Not even the engines were recovered, and they are practically indestructible.

(2) Of an estimate 84 videotapes of the crash, the three that have been released by the Pentagon do not show a Boeing 757 hitting the building. There are indications of a much smaller plane, but not a Boeing 757.

(3) Indeed, the aerodynamics of flight would have made the official trajectory--flying more than 500 mph barely above ground level--physically impossible, because of the accumulation of a massive pocket of compressed air beneath the fuselage; and if it had come it at an angle instead, it would have created a massive crater; but there is no crater and the official trajectory is impossible.

(4) Flying low enough to impact with the ground floor would have meant that the enormous engines were plowing the ground and creating massive furrows; but there are no massive furrows. The smooth, unblemished surface of the Pentagon lawn thus stands as a "smoking gun" proving the official trajectory cannot be sustained.

The government's report that 19 Islamic fundamentalists hijacked four commercial airliners, outfoxed the most sophisticated air-defense system in the world, and committed these 911 atrocities under the control of a man in a cave in Afghanistan. is the big lie: THE 9/11 CONSPIRACY. Clearly, evidence shows government agency involvement in the 9/11 attacks on the Pentagon and Twin Towers.

"Don't be taken in by photos showing damage to the second floor or those taken after the upper floors collapsed, which happened 20-30 minutes later," Fetzer said. "In fact, debris begins to show up on the completely clean lawn in short order, which might have been dropped from a C-130 that was circling above the Pentagon or placed there by men in suits who were photographed carrying debris with them." The most striking is a piece from the fuselage of a commercial airliner, which James Hanson, a newspaper reporter, has traced to an American Airlines 757 that crashed in a rain forest above Cali, Columbia in 1995. This crash debris is not from 9/11.

"The Pentagon has become a kind of litmus test for rationality in the study of 9/11," Fetzer said. "Those who persist in maintaining that a Boeing 757 hit the building are either unfamiliar with the evidence or cognitively impaired. Unless," he added, "they want to mislead the American people. The evidence is beyond clear and compelling. It places this issue 'beyond a reasonable doubt'."


The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!




