Hawaii Inmates Abused in Mainland Commercial Prisons

The Courthouse News Service reported this morning that new complaints have been filed against the Hawaii Department of Public Safety and Corrections Corporation of America (CCA) alleging that abuses continue at Saguaro Prison in Arizona. The plaintiffs [Prisoners] are seeking injunctive relief.

The Hawaii inmates at CCA report guards "deliberately destroyed and failed to preserve evidence of their wrongdoing, including videotapes ... intercepted mail, delayed mail, denied mail and interfered with phone calls to family and attorneys" and "deliberately falsified reports."

They say that Saguaro's Warden Todd Thomas participated in the abuses, and Hawaii's on-site Public Safety monitor, John Ioane, did nothing to stop it.

Is this Torture in Prison Camp USA, like Jews torturing Palestinians? How much State of Hawaii taxes are invested in Corporation of America is a question that should be answered by governor Aberblabbercommie who just signed a new \$45.5 million contract with CCA to keep Hawaii inmates on the Mainland.

According to the new complaint, they are TORTURED by CCA guards:

"Plaintiffs were stripped of nearly all of their clothing while being beaten, questioned, and humiliated.

"Plaintiffs were threatened with harm to themselves and their families, including through such statements as:

"a. 'We have your emergency contact information;'

"b. 'We know who your family is and we are going to harm them;'

"c. 'We are going to kill you;'

"d. 'We will continue to beat you and until you commit suicide;'

"e. 'We will send you to hell;'

"f. 'We will stick something up your ass.'

"g. 'We will smash all the bones in your face.'"

"h. If you tell anyone, you will be beaten or killed."

To conceal the abuses, CCA violated its own policy by refusing to videotape the acts, the complaint states.

Although the report does not use the word, the alleged treatment of Hawaii prisoners probably amounts to torture under the international conventions that the US has signed onto and which then became law of the land.

Hawaii Governor Neil Abercrombie recently signed a new contract with CCA worth \$45.5 million a year to keep prisoners at Saguaro and at the Red Rock Correctional Center until 2014.

Obama's FAA Out of Money! Flight Tax is Off: Fly Hawaiian Airwithout the \$44 FAA tax!

The budget crisis stalemate in Congress is proving to be a boon for travelers. Since Sunday, the Federal Aviation Administration has had to stop collecting the federal taxes on airline tickets because of a political fight on Capitol Hill over the agency's funding. That means airline tickets are a little cheaper for now.

Alaska and Hawaiian airlines are among the few right not raising ticket prices to fill the tax hole.

So, for Hawaiian Air passengers, that amounts to a savings of about \$15 on interisland airfares and about \$30 on mainland airfares.

"We haven't done anything with our fares, so that means there's a discount on the board right now for customers," Hawaiian Airlines spokesman Keoni Wagner said. On Alaska Airlines from Hawaii or Alaska to the mainland, passengers will save about \$44 in taxes.

The tax holiday is only good until Congress reauthorizes the funding.

Real Property Tax Bills Deadline to pay first half taxes is August 22, 2011

The County of Maui, Real Property Tax Division announced today that real property taxes are due on Monday August 22, 2011 for the first installment of fiscal year 2011-2012. The deadline set by the Maui County Code of August 20 falls on a Saturday, thereby making this year's deadline the following business day, Monday the 22nd.

Real Property tax bills from the County of Maui have been mailed to property owners or the agents servicing their accounts. Property owners who pay their real property taxes directly and who have not received a real property tax bill should check on their taxes by contacting the County of Maui Real Property Tax Division by phone at (808) 270-7697, in person at the Maui Mall Service Center (Mon-Fri 8am - 4pm), or online at www.mauipropertytax.com.

The Real Property Tax Division is offering electronic payment options for Real Property Taxes. Electronic payments are accepted via the internet or phone. This service is being offered through a private vendor Link2Gov. The service provider will be charging a convenience fee. These fees are not being collected by the County of Maui. To make an electronic payment it is a good idea to have your tax bill on hand because you will need your 13 digit tax map key number.

To find out more about electronic payment options visit <http://www.maui-county.gov/departments/Finance/rptpayment.htm>. To make an online payment go to <https://gate.link2gov.com/MauiRPT/>. You must have an email address to use the online payment service. To make a payment by phone call 1-877-729-4775 and follow the voice instructions.

Property owners are reminded that failure to pay their taxes on time because of non-receipt of a tax bill will not excuse them from being assessed a 10 percent penalty plus interest at the rate of 12 percent per year. Unless hand delivered on time, the United States Postal Service cancellation mark is the date of receipt by the County of Maui. It is the taxpayer's responsibility when sending via postal mail to assure that all envelopes are timely postmarked by the USPS on or before August 22, 2011.

What do these shootings have in common?

The answer is they all occurred in government facilities where the private possession of firearms was prohibited.

In Washington, unconstitutional legislation is commonplace. But sometimes unconstitutional laws can have deadly consequences. The so-called "gun free school zones act," written by radical anti-gun Senator Heb Kohl, is one such law.

Slammed through in 1996 as an amendment to a giant last-minute must-pass appropriations bill, the legislation disarmed school staff and other adults – leaving elementary and secondary school children defenseless to serial killers.

It also made it virtually impossible to drive your car down the street with your gun inside without violating the law by creating a 1000-foot so-called "gun-free zone" around every public and private school in the country.

"Gun free," that is, except for the criminals.

No one – including politicians, the police, or the individual citizen – can predict where the next deranged serial killer will attack. And yet politicians continue to create "criminal safe zones" such as schools, churches, parks, restaurants that serve alcohol, etc., where the law-abiding are disarmed.

The net impact of turning schools, in particular, into defenseless targets for serial killers has been dramatic.

When many people over the age of 40 were growing up, ROTC students would march up-and-down high school campuses with their semi-automatic M1's – and no one would think anything of it. Shooting clubs on school grounds were also not uncommon.

But within a couple a years of the enactment of the Kohl amendment, two disaffected teenagers walked into Columbine High School secure in the knowledge that they would be the only ones in the school who were armed.

And, of course, Columbine triggered a slew of copycat episodes – laying a mounting string of innocent casualties at the feet of Herb Kohl and his misbegotten legislation.

It's time to say NO to criminal safe zones. And a great place to start is the blatantly unconstitutional gun free school zones act.

Thankfully, Congressman Ron Paul (R-TX) agrees and has introduced legislation to do just that.

Rep. Paul recently introduced the "Citizens Protection Act of 2011" (H.R. 2613), which will repeal the Kohl amendment and thus remove the federally created criminal safety zones.

Rep. Paul is one of the few members of Congress who respects the Constitution and who actually introduces legislation to restore federalism. And, unlike some legislators, Paul has a history of forcing the House to vote on his pro-gun proposals, thus putting other congressmen on record.

GOA is proud to stand with Rep. Paul in the effort to repeal the unconstitutional gun free zones law. For anyone who cares about liberty, now is the time to work on getting the 218 votes we need to pass this important piece of legislation.

ACTION: Contact Congress. Urge your Rep. to cosponsor Ron Paul's Citizens Protection Act of 2011, H.R. 2613.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

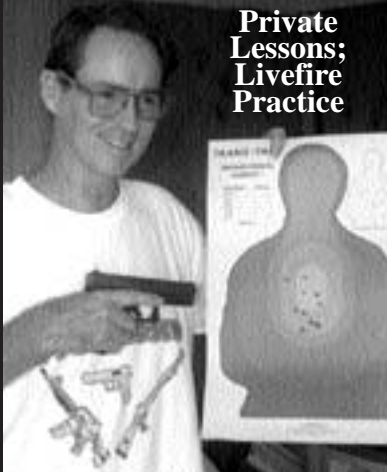

"A well regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms shall not be infringed." Exercise the 2nd Amendment.

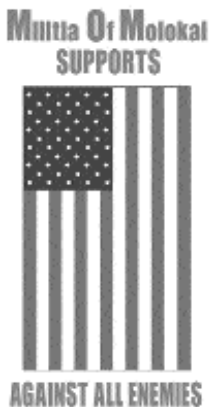

Social Security Ponzi Scheme

Ponzi scheme are about bringing in lots of new money to pay small amounts out to suckers, and keeping the bulk for other purposes. Its Social Security.

"The balance is comprised of federal debt, or more precisely, special issue non-marketable U.S. government debt securities. When payroll taxes exceed benefits, Social Security is said to 'invest' its surplus in these securities and the balance goes up. Conversely, when benefits exceed payroll taxes, Social Security is said to 'redeem' its investments in these securities to cover the deficit and the balance goes down."

Commentator Charles Krauthammer wrote in the Washington Post that the reality is the Social Security trust fund contains nothing.

"Here's why. When your FICA tax is taken out of your paycheck, it does not get squirreled away in some lockbox in West Virginia where it's kept until you and your contemporaries retire. Most goes out immediately to pay current retirees, and the rest (say, \$100) goes to the U.S. Treasury – and is spent. On roads, bridges, national defense, public television, whatever – spent, gone."

Obama warned that the debt ceiling must be raised after House members passed a plan called Cut, Cap and Balance Act of 2011, which would cut \$6 trillion from the proposed budget but failed in the Senate. Since then, several ideas have been proposed.

A spokesman for Posey, George Cecala, said seniors should not feel threatened. "You can't not pay Social Security benefits with Social Security money and pay something else with that money. "That money belongs to the seniors. It's their money." —60 million people are receiving benefits from Social Security.

The Joint Economic Committee report also confirmed the "arcane" budgetary treatment of Social Security simply includes fallacies.

"Social Security has its own 'trust fund,' Social Security receipts and outlays are labeled 'off-budget,' and the Social Security Administration is an 'Independent Agency.' When Social Security has a cash-flow surplus, Social Security taxes are available to pay for other programs. When Social Security has a cash-flow deficit, the government must collect other non-Social Security taxes or borrow from the public to pay for Social Security benefits," the report said.

"When people talk about the 'trillions' in the trust fund, they are knowingly or unknowingly referring to the balance of unredeemed non-marketable U.S. government debt securities, not a pile of unspent cash."

"The only reason to raise the debt limit is to continue business as usual in Washington," said Joe Farah. "There is no necessity to do it. The prudent and responsible move would be to run the government with the trillions in revenues it takes in. No individual, no business and no state or local government can just keep borrowing to justify uncontrolled spending. It's time the federal government starts operating like the rest of us do."

In recent weeks, a number of high-profile commentators also have come out in favor of calling a halt to the borrowing – estimated at some \$5 trillion since Obama took office.

"If a family is broke and dependent on loans," Savage continued, "what bank would extend a new credit line until the family 1) sold assets; 2) worked out a repayment plan for existing loans? We will become a bigger 'banana republic,' like Argentina 20 years ago, if we increase our national debt."

Thomas Jefferson stated: "All tyranny needs to gain a foothold is for people of good conscience to remain silent. Timid men prefer the calm of despotism to the tempestuous sea of liberty. The strongest reason for the people to retain the right to keep and bear arms is, as a last resort, to protect themselves against tyranny in government."

Alexis de Tocqueville visited the United States in 1831 and marveled at the social dynamism he saw, a by-product of the young republic's protection of the "law of equal liberty." He also warned that democratic politics runs the risk of creating a "tyranny of the majority," as voters use the electoral system to overrule their neighbors' property rights. In a symposium sponsored by the Center of the American Experiment, Independent Institute President <http://www.independent.org/aboutus/person_detail.asp?id=531>David J. Theroux offered his top recommendation to help restore civil society to the full glory that Tocqueville had witnessed: he called for an end to U.S. wars in Iraq, Afghanistan, Libya, Pakistan, and elsewhere.

Ending these military interventions, Theroux writes, "could be a much-needed step to reduce the U.S. annual deficit, save countless lives and injuries, and restore America as a beacon of liberty and justice."

War crises, Theroux continues, "have always been the most efficient engine to generate big government in every area, including entitlements, regulation, taxes, and so on." War crises have given birth to virtually every single program of federal spending and power, he argues. "As a result, it is a fool's errand to seek to reduce the welfare state or eliminate farm subsidies as long as invasive wars are pursued unchecked.... The vibrant blessings of liberty in America that Tocqueville discovered and chronicled so well can be restored only when America's invasive wars are ended."

Obama and the tyrants in Congress will destroy our republic if we let them. We must not be timid. Let's roll!



Obama's F.D.A. Is Bad for Food Nullify FDA Law by Washing State Is the example Hawaii needs to follow!

A county assembly in Washington State has just passed a food freedom ordinance which would punish federal agents with up to ten years in prison and \$20,000 fines.

On July 20th, the Stevens County Assembly finalized the ordinance. They are now in the process of collecting signatures from the residents of Stevens County – urging them to claim his/her natural right to grow, produce, purchase, and consume the foods of their choice. WHEREAS, We find the history of government regulators, even with hundreds of food regulations on the books, shows they are incapable of protecting citizens from exposure to food poisoning events from foods produced by corporate farming

Beyond that, the passed ordinance would make it unlawful for agents of either the State or Federal government to execute to interfere with the ordinance.

Four towns in Maine have passed similar measures, and Hawaii should, too. WHY, you ask?

Last year, Congress introduced the Food Safety Modernization Act (S. 510) which opponents say will lead to crushing regulations on local food production – at the benefit of the big corporate farming interests that backed passage of the law. Local food ordinances appear to be a direct response to the new regulations.

What exactly have the FDA regulations enforcement done? For example:

The year-long raw milk sting operation that resulted in a raid consisting of two US Marshals, two State Troopers and two FDA officials on a SWAT like assault on an Amish farm in Pennsylvania at 5 a.m. see <<http://www.tenthamentcenter.com/2011/07/22/push-back-against-fda-growing/>>

–In the first half of 2008, there was an epidemic of human salmonella poisoning that afflicted 1,294 people in 43 states, the District of Columbia and Canada. The FDA immediately sprang into action and after a hasty investigation they proclaimed that tainted tomatoes may be the source of the epidemic. Several varieties of tomatoes were withdrawn from markets and restaurants across the country. Several weeks later, the FDA proclaimed that it may indeed be jalapeno peppers and cilantro that could be contributing to the outbreak. All of these ingredients are commonly used to make salsa which is a staple when eating Mexican food. Surprise! Finally the FDA pinpointed the peppers and cilantro that were imported from Mexico because it had traced contaminated irrigation water. The American tomato industry lost millions of dollars because of these errant recalls.

–Last year, FDA “Investigators” entered an organic grocery store in Venice, California – warrant and guns in hand. As reported by the LA Times, they “ordered the hemp-clad workers to put down their buckets of mashed coconut cream and to step away from the nuts. Then, guns drawn, four officers fanned out across Rawesome Foods in Venice. Skirting past the arugula and peering under crates of zucchini, they found the raid’s target inside a walk-in refrigerator: unmarked jugs of raw milk.

These are but a few of the seemingly endless examples of how the FDA and its increasing regulatory and police power have been keeping you “safe.” Some people, as shown by the five towns taking matters into their own hands, have decided that “enough is enough.”

Sedgwick, Maine resident Mia Strong told Natural News: “Tears of joy welled in my eyes as my town voted to adopt this ordinance. I am so proud of my community. COMMUNITY FARMING, ORGANIC FOODS: Nullification 101

While the media would like to portray any and all actions that assert the Tenth Amendment as a “tea party” or “right wing” movement, support for food sovereignty ordinances, along with fifteen states passing medical marijuana laws, certainly proves that stereotype to be little more than media hype.

The ordinance from Stevens County makes this clear:

WHEREAS, We, the people of the State of Washington domiciled on Stevens county, declare:

1. The Tenth Amendment to the Constitution for the United States, states, “The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people”; and

2. That pursuant to Article 1, Section 8, of the Constitution for the United States, there is no power granted to the federal government to regulate local foods on Stevens county; and

3. The Ninth Amendment to the Constitution for the United States, states, “The enumeration in the Constitution of certain rights shall not be construed to deny or disparage others retained by the people.”; and

4. That pursuant to the Ninth and Tenth Amendments to the Constitution for the United States, the power to regulate local foods on Stevens county is reserved to the State of Washington or the people of the State of Washington.



WARNING TO Obama FEDS

Like the four towns in Maine that have passed similar ordinances, Stevens County means business. They’ve also included an enforcement clause – telling the feds, in essence, to butt out.

ENFORCEMENT CLAUSE;

(A)(1) The people of the State of Washington domiciled on Stevens county, declare that any law enacted by the congress of the United States; any federal regulation, rule, or policy promulgated; any executive order issued by the president of the United States; and any court decision; that seeks, purports, or is otherwise intended to regulate, in any way, the unalienable and fundamental rights of the people on Stevens county to choose the local foods they produce; process or prepare; sell, purchase, or distribute; preserve and store for extended periods of time; and consume, for food or drink, for people or other life forms, is not authorized by the Constitution for the United States of America; and

(2) The people of the State of Washington domiciled on Stevens county, declare the federal laws, etc., referred to in subsection (A)(1):

- (a) Are invalid on Stevens county; and
- (b) Will not be recognized by Stevens county; and
- (c) Are specifically rejected by Stevens county; and
- (d) Are null and void, having no effect on Stevens county.

The ordinance continues

(D)(1) Public employees employed at the federal, state, or local levels, including, but not limited to, agents of the Federal Bureau of Investigation, Department of Homeland Security, Food and Drug Administration, Washington state Patrol, sheriff’s departments, and municipal and county police will not enforce or attempt to enforce the federal laws, etc., referred to in (A) subsections (1) and (2); or treaties referred in (B) subsections (1) and (2); or Washington state laws, etc., referred in (C) subsections (1) and (2);

and

(2) A violation of subsection (D)(1) is a class B felony (as defined at RCW 9A.20.021(1)(b)) and is punishable by confinement in a state correctional institution for a term fixed by the court not to exceed ten (10) years, or by a fine in an amount fixed by the court not to exceed twenty thousand dollars (\$20,000), or by both such confinement and fine; and

While the FDA has been getting increasingly aggressive – raiding raw milk activists, threatening walnut producers, and the like – these activists believe that they can push back and win by doing the same to DC. Will a local government ever attempt to arrest an FDA official? Only time will tell, and maybe they’ll never have to. With five local ordinances now passed, the “food sovereignty” movement is just in its infancy. But, if they learn from the efforts of those who defied DC on issues like medical marijuana and the real ID act, they’ll recognize that when enough people, towns, and even states – say NO to Washington DC, there’s not much the feds can do to stop them. Feds are NULLIFIED !
