

Freight Rate Increased

HONOLULU-Young Brothers, Limited on July 28, 2009 received approval from the Public Utilities Commission (PUC) for an increase in rates for its regulated inter-island (intrastate) cargo services. The average over-all increase will be 13.46 percent, with the newly approved rates including a 9.66 percent increase for containerized cargo, a 9.22 percent increase for automobiles and "roll-on/roll-off" cargo, and a 21.26 percent increase for LCL or less-than-container-load cargo (except for Molokai and Lanai, for which the LCL increase is 12 percent). Young Brothers originally submitted to the PUC in December 2008 a request for an average rate increase of 17.9 percent, including a 15 percent increase for containerized cargo, a 10 percent increase for automobiles and "roll-on/roll-off" cargo, and a 25 percent increase for LCL or less-than-container-load cargo. In June 2009, Young Brothers and the Consumer Advocate entered into a settlement agreement, agreeing upon an average over-all increase of 14.61 percent, with a 10.5 percent increase for containerized cargo, a 10 percent increase for automobiles and "roll-on/roll-off" cargo, and a 23 percent increase for LCL or less-than-containerload cargo (except for Molokai and Lanai, which was set at 12 percent for LCL cargo). The PUC further reduced these percentages in its July 28, 2009 decision as noted above.

"We recognize that our Neighbor Island customers depend upon reliable and frequent service, and we have taken the steps to ensure such service. We also recognize that customers share the same burdens with the economic recession. To respond to current economic conditions, we have taken measures to control and reduce costs, with all of the savings being passed on to our customers," said Glenn Hong, President of Young Brothers.

'The revenue from this rate case is needed to finance new investments in vessels and other cargo equipment and to pay for costs associated with maintaining reliability of service and the same number of sailings despite falling cargo volumes," added Roy Catalani, Young Brothers' Vice President of Strategic Planning and Government Affairs.

Young Brothers has been replacing older vessels "to meet both current and its next generation of water transportation equipment and infrastructure, and developing a more efficient system to meet future demand," Catalani continued. He said that since 2006, Young Brothers made capital expenditures of over \$95 million to deliver four new, large flat-deck barges (with the fourth and last new barge arriving in 2009), a roll-on/roll-off barge, new cargo-handling equipment, a new computer system, and a statewide telephone system.

With respect to cargo volumes, Young Brothers experienced a 9.6 percent quent service, driven largely by the lack of Neighbor Island storage capacity and the "just-in-time" manner of inventory management, Young Brothers has maintained twelve regularly scheduled weekly sailings to the Neighbor Islands.

As an example of measures to control and reduce costs, Young Brothers schedule changes earlier this year. Young Brothers was able to reduce its intrastate costs by over \$900,000, with all of the savings passed on to its customers in three specific ways:

-Reduce the rate increase for all categories.

-Limit the LCL rate increase for Molokai and Lanai to 12 percent. These

-Increase the "island product" discount for local agricultural products from 30 percent to 35 percent for containerized cargo (not for LCL). ranchers, these savings allow Young Brothers to increase the discount it currently provides on cargo rates for containerized local agricultural products.

Young Brothers has also taken other measures to reduce costs. For example, the design and size of its new barges, as well as upgrades to its tugs, allow Young Brothers to deliver cargo more efficiently in fewer barge sailings, resulting in fuel and other operational cost savings. Increased fuel efficiency, along with decreased average fuel costs over the March 2009 to April 2009 period, allowed Young Brothers to provide its customers 1.01 percent fuel price adjustment (FPA) credit on freight charges in June and July. The FPA will return to zero on August 1, 2009, as part of the recently concluded rate case. The successful performance of Young Brothers' new barges has also resulted in Young Brothers taking older vessels out of service, thereby reducing the high maintenance costs of older vessels.

The 21.26 percent increase in LCL rates will add about 8 to 9 cents to the cost of shipping a 24-package case of saimin (shipped on a pallet of 90 cases) or a case of 24 cans of juice or soda (shipped on a pallet of 110 cases). For Molokai and Lanai, the increases will be about half of these amounts. Alternatively, shipments made in a 20-foot container load (9.66 percent rate increase) would add about 2 cents per case.

Hawaii Answers Need for more Primary Care Health Professionals State Lawmakers Expand Scope of Practice for Naturopathic Physicians The Hawaii Legislature overrode Governor Linda Lingle's veto of SB 420, which expands the scope of practice for naturopathic physicians in Hawaii. The bill ensures that people in Hawaii can use a range of health care options and receive the right care at the right time.

Effective January 2010, the bill allows the naturopathic licensing board to establish a formulary and to adopt administrative rules establishing requirements for parenteral therapy (administering injections), minor surgical procedures, standards of practice, care and ethics. The new law also clarifies that naturopathic physicians in Hawaii have equal rights with other physicians in all matters of public health. This legislation brings the scope of practice for naturopathic physicians in Hawaii up to the standards in which it is taught in naturopathic medical schools, as well as to the standards of other state laws, while providing adequate protections for consumer health and safety.



Carry a BIG Gun for Protection, and be able and ready to deliver a cranio-ocular shot to save your life What is the best handgun cartridge and bullet design for self defense?

My standard response to this question is to carry the largest caliber, with the heaviest bullet, loaded as hot as you can handle it in order to deliver two, quick center of mass shots... and have the skills to be able to follow up with a precise shot to the cranio-ocular cavity (between the eyebrows and mouth) when the first two thoracic cavity hits don't stop an extremely dedicated opponent.

The terminal ballistics of various handgun cartridges are demonstrated when shot into ballistic gelatin. Note that every cartridge tested penetrates over 12 inches, but the wound channels are much larger for bigger bullets.

The bigger the wound channel, the more damage and the more likely you are to adversely affect bones, joints, the nervous system and circulatory hydraulics – all of which lead to incapacitating your opponent so he stops fighting. Clearly the larger calibers perform best.

Who would chose a 9mm over the larger, more powerful calibers? Our military servicemen have been asking that question every since the government switched from the proven, battle tested 1911 in .45ACP to the Beretta 9mm.

However, in a real gunfight, you can throw all of the theory and ballistic gelatin testing out the window, because MINDSET and TRAINING trumps equipment every time. And I'm referring to the mindset and training of both YOU and YOUR OPPONENT.

On the street, he who hits first with the most, wins. Shot placement is EVERY-THING. A disciplined and dedicated fighter with any weapon is superior to Joe Average Citizen who does not have the mindset or ability to finish the fight.

A case in point, police confronted a man with a 45 ACP handgun at a range of 20 feet. Officers used M4s with 55 grain and 75 grain .223 ammunition and Glock 22's with Speer 180 grain Gold Dot ammunition to shoot at him 107 times. But no head shots were delivered to the gunman who fired 26 shots and reloaded, then fought with officers before being subdued.

Lesson Learned: When you do not inflict immediate, incapacitating damage to your adversary, you often create a "Superman Effect" in your adversary from the normal physiologic response to significant, but non-life threatening injury.

The answer to such a dangerous opponent is the cranio-ocular shot. You must have the mindset and ability to slow down your response and deliver a dedicated shot to the area between your opponent's eyebrows and mouth to end the fight.




Judges are impeachable. Furthermore, judges may be removed immediately for violating oaths of office, involvement in conspiracies, extortion, and failing to uphold their duty






