## Independence Day July 4: Reflecting on 1776 and 2011

The United States of America was founded upon a Unanimous Declaration and indictment against the King of England's violations of terms of contract with the British Citizens laboring in the American colonies who thereby decided they were no longer bound by contract, and thereafter Declared Independence.

After the Revolution, the USA Republic was organized by way of the Constitution for the United States of America to form a more perfect union of the individual States to defend against foreign enemies, protect Life, Liberty, and Property of American Citizens. But the functions have been corrupted.

I think it's worth pointing out that the Declaration's language basically guaranteed the right of the states to withdraw from the union. Most of what the colonists complained the king was doing is now being done by the Obama regime. If Obama not removed soon, we will look back at July 4, 2011 as good old days.

States thought of themselves as independent countries that had a right - guaranteed in the founding documents of the union - to leave that union when they no longer saw it to be to their benefit. I think it's worth reiterating that when the cost of participating in any society exceeds the benefits of belonging to that society, people have the right to remove themselves.

The Declaration of Independence is a good read, and many, if not most of Jefferson's grievances against the King are just as applicable to the U.S. government today. Jefferson's writings show that he expected tyranny to grow back and will have to be overthrown frequently. Let's talk specifics.

It's striking how applicable they are again today, if you update them for modern times. It has made U.S. Judges dependent on Obama's Will alone, for the tenure of their offices, and the amount and payment of their salaries.

The federal judiciary system today is thoroughly corrupt - perhaps even more so than the King's judges were in 1776. The U.S. government employs both judges and prosecutors - that's a clear conflict of interest right there.

Federal judges, including those on the Supreme Court, are appointed, not elected. That makes it almost impossible to hold them accountable for their decisions. And they're all employees of the state - even the elected ones.

Prosecutors are also state employees; they get promoted and further their political careers by securing convictions. The incentive in this system is not to secure justice, but to secure convictions. And the police are also state employees, of course. When the government is the plaintiff, prosecutor, and judge, defendants are at a huge disadvantage, just as they were when the King's men had the power of the Sovereign and the force of arms against the people.

Only a conspiracy of modern government agents could result in the current 90% conviction rate by federal prosecutors. It is very, very dangerous that the government - not private citizens against one another - now brings the majority of the cases in federal courts. Especially since, **the only two crimes enumerated in the Constitution are treason and counterfeiting.**

Another example is "He has erected a multitude of New Offices, and sent hither swarms of Officers to harass our people, and eat out their substance."

We have similar problem 2011. We have a largely unauthorized and unaccountable fourth branch of government in all the alphabet soup agencies and paramilitary police officers: ATF, FBI, DEA - now DHS - DOL, DOA, DOE, DOC, IRS, FDA, SEC, MPD, and on and on. These parasites literally swarm over the countryside, making it all but impossible for an honest man to earn a living.

While generations of propaganda and government schooling have nearly destroyed the average U.S. citizen's ability to engage in real, critical thinking and inculcated a culture of dependence and entitlement that Obama socialists Marxists need to destroy American freedom, slowly about half of the voters are realizing that they made a mistake to allow Obama to be elected. But this is not a problem that can be fixed in a day, nor with the simple turning of a new page.

It would take a lot of re-education, de-programming, or maybe just generations of facing harsh economic realities to really regain the independent American spirit that made America great. And I think American society will suffer much

more before our Republic is restored though political channels or the threat of use of force per the 2nd Amendment Right to Keep and Bear Arms against Tyranny.

Obama/Clinton regime has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation ... Sounds to me just like the UN and all the U.S. treaties that subject U.S. citizens to foreign powers and interests.

In the past it was understood that they had not only the right but the duty to seek justice - not just to enforce laws as instructed by some judge. I consider this an unconscionable usurpation. Need fully informed juries.

The current government of these forcibly united states is much more dangerous and capricious than the monarchy in 1776.

But there's one more thing in the closing thoughts of the Unanimous Declaration Of Independence that is particularly worth noting: A Prince whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people.

That certainly describes the Obama Regime today. Obama-government is not the friend of the people, nor their protector, nor their benefactor. The government is the single greatest threat to an individual's life, liberty, property, and even his pursuit of happiness. It's unworthy of the support people give it. It's an entity with a life of its own. Instead of our former great Republic defined and limited by Constitution, we have a so-called democracy through which people may actually get the government they deserve as an unintended consequence. Reality is going to reward them with a lower standard of living, and a lot less respect from other people. The universe isn't malevolent, but it is disinterested. Residents of the U.S. will find that they've forfeited the right to be free and sovereign.

Instead of wearing red, white and blue, people should wear black on the fourth of July, to mourn the passing of the spirit of independence that was once America's greatest virtue and driving force.

I find myself irritated around this time of year, as person after person wishes me a happy "4th of July" - as though the passage of the fourth day of this or any month had any significance whatsoever. **It's Independence Day.** Successful rebellion against tyranny is what all the fireworks are about, not just some random long weekend that gives people more time to drink beer and distract themselves from maxed-out credit cards with fireworks.

We are supposed to be celebrating the fact that individual farmers, trappers, and carpenters, everybody, had the firepower to throw off their corrupted government that now prohibits the average individual to own more than sparklers.



## Support the Troops Bring Them Home

Reversing long-standing policy, Obama will now send condolence letters to the families of U.S. military personnel who commit suicide in combat zones.

That's nice. But he could prevent future suicides by bringing all the troops home and ending America's interventionist foreign policy. That would also save hundreds of thousands of lives and millions of people from war violence, not to mention the US economy and the Obama Not Eligibility Constitutional Crisis.

The help troops really needed was not to be sent to invade foreign countries in the first place and to fight senseless wars, like the ones in Iraq and Afghanistan. Repeated combat tours in behalf of imperial policies are intolerable. But even one tour is one too many. For the last 10 years the U.S government has fought aggressive wars by choice. They were not defensive but rather a continuation by other means of American intervention in the Arab and Muslim worlds for oil. The criminal attacks on 9/11 by criminals in Bush Administration were not the cause of that intervention but the excuse Bush used to attack for oil and power. All these wars have been contrary to the Founders' intentions for America's peace and security.

Wars of aggression such as the U.S. government has pursued since 2001 have many costs. First are the lives lost and ruined among the foreign population. Presidents Bush and Obama undoubtedly are responsible for more than a million deaths, many civilians among them, including those in Pakistan and now Libya. The U.S. government calls many of its victims "insurgents" and "militants," but that may mean only that they objected to occupation by US military. The cost also includes destruction of water and sanitation facilities and power generation, jeopardizing the health and lives of people, especially children and the elderly.

Another obvious cost is the money: Afghanistan costs \$10 billion a month. The Iraq and Afghanistan wars have now cost more than \$1 trillion, and these money pits are still in operation.

Politicians love nothing better than to pay tribute to "our troops," especially those who have made "the ultimate sacrifice." Yet those words stink of hypocrisy when one realizes that the same politicians create the conditions that are used to justify invasions, occupations, and war in foreign countries. Despite all the nonsense about valor on the battlefield and sacrifice for one's country, war wreaks havoc with the lives of those who physically survive it. Some are wrecked bodily, others psychologically. Their marriages and families are disrupted if not destroyed. Some will return home permanently scarred, perhaps to live on the streets as beggars. Others will take their own lives.

Suicide by some of our military is a chosen act, of course, but the politicians and war planners share in the responsibility because of the horrors to which they callously subject young people. Apologists for the empire will laud American military personnel for "serving their country" and for "fighting for our freedom."

Nonsense. They, like the public, were duped into believing that. In fact, their lives were destroyed serving the political and economic interests of empire-builders and contractors. There was nothing noble or patriotic in what the troops were ordered to do. The mistake our troops made was in trusting the people like Obama and Bush and Clinton who claim to be "leaders."

Support the troops, we're told. Here's a better idea: Don't "support" them. Bring them home now.

## 2nd Am Rights Are Absolute

The second amendment is **ABSOLUTE** because it must be if it is to operate at all. The second amendment is the lethal force which backs our sovereignty, and any challenge to it is a challenge to our sovereignty. All gun laws over time are illegal and a challenge to our sovereignty. These need to be repealed in recognition of who is the Sovereign.

Private property rights have their exceptions where the second amendment has no exceptions. A property owner can refuse access to some people as the owner may wish, but property owners cannot commit crimes on private property. A duly issued search warrant can gain access to property against the wishes of the property owner, and trespasses have affirmative defenses which acquit a person for illegal entry without consent.

Technically and in all practicality, the second amendment shall not be infringed, which is a technical term for interference. Shall not is a term of art and its language gives the right its absolute nature. Just because this is defied does not change custom and usage in our societal mores and norms: gun control is still a fraud.

Gun control is not a differing opinion; it is not a wrong without damage, it is in fact most damaging to millions of persons. Millions have died because they believed it was wrong to be armed. It is so likely that they were sufficiently intimidated by gun control that they took their chances with thuggery rather than battle the system.

Americans need to grasp why the second amendment is absolute as a means of realizing their own sovereignty and powers to resist centralization. This translates into something for smaller government: refusing to be a victim of both the thugs and the system. A two-fer.

This is why Americans need to be free from the dilemma of choosing felony or funeral. I'll even add a third: Financing. Financing bureaucracy. This is why I believe that the repeal of all gun laws must be the first step to reducing the size of government.

Incremental infringements on the second amendment have been relatively small and ever so subtle over the generations. They have been framed to sound reasonable under current conditions, such as the thirties when machine guns were used by crime gangs. Machine gun bans were the response of the government. The giveaway to the stupidity or hostility of public servants is in how they made it illegal to own a machine gun when the crimes of the gangs ought to have been - to the mind of a reasonable person - sufficient; murder was already illegal. The proof of hostility and stupidity was in making laws which applied only to the law-abiding who never did the gangland shootings. Of course, as we all know, gun laws do not apply to criminals.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





## Cancer Surges In Body Scanner Operators; TSA Launches Cover-Up

Fearful of provoking further public resistance to naked airport body scanners, the TSA has been caught covering up a surge in cases of TSA workers developing cancer as a result of their close proximity to radiation-firing devices, perhaps the most shocking revelation to emerge from the latest FOIA documents obtained by the Electronic Privacy Information Center.

After Union representatives in Boston discovered a "cancer cluster" amongst TSA workers linked with radiation from the body scanners, the TSA sought to downplay the matter and refused to issue employees with dosimeters to measure levels of exposure.

The documents indicate how, "A large number of workers have been falling victim to cancer, strokes and heart disease."

"The Department, rather than acting on it, or explaining its position seems to have just dismissed. I don't think that's the way most other agencies would have acted in a similar situation if they were confronted with that question," EPIC's Marc Rotenberg said.

In an email sent to Heather Callahan deputy federal security director at Boston Logan International Airport, union representatives express their concern about "TSA Boston's growing number of TSOs working here that have thus far been diagnosed with cancer."

Of course, if TSA workers who are merely standing near the scanners are already developing cancer, frequent flyers are also putting themselves in harm's way by standing directly inside the radiation-firing machines.

Newly released internal government documents, obtained via the Freedom Of Information Act by the Electronic Privacy Information Center, reveal that the TSA, and specifically the head of the Department of Homeland Security, "pub-

licly mischaracterized" the findings of the NIST, in stating that NIST had positively confirmed the safety of full body scanners in tests.

In erroneously citing both NIST and the Johns Hopkins school of medicine to claim that the body scanners are safe, the TSA has also deliberately misled the public on the dangers posed by the devices.

Documents show that, far from affirming their safety, NIST warned that airport screeners should avoid standing next to full body scanners in order to keep exposure to harmful radiation "as low as reasonably achievable."

Johns Hopkins study actually revealed that radiation zones around body scanners could exceed the "General Public Dose Limit," contradicting repeated claims by the TSA that Johns Hopkins had validated the safety of the devices.

At the time we pointed out that Dr Michael Love, who runs an X-ray lab at the department of biophysics and biophysical chemistry at the Johns Hopkins school of medicine had publicly stated two days previously that "statistically someone is going to get skin cancer from these X-rays".

TSA workers complained about the radiation dangers of the scanners back in December, saying they were being kept in the dark by their employers, despite repeated requests for information.

"We don't think the agency is sharing enough information," said Milly Rodriguez, occupational health and safety specialist at the American Federation of Government Employees, the union that represents TSA workers.

A study conducted last year by Dr David Brenner, head of Columbia University's center for radiological research, found that the body scanners are likely to lead to an increase in a common type of skin cancer called basal cell carcinoma, which affects the head and neck.

Following the study, Brenner urged medical authorities to look at his work, pointing to the dangerous notion of mass scanning millions of people without proper oversight.

"There really is no other technology around where we're planning to X-ray such an enormous number of individuals. It's really unprecedented in the radiation world," said Brenner.

"The Committee cited the IAEA's 1996 Basic Safety Standards agreement that protects people from radiation. Frequent exposure to low doses of radiation can lead to cancer and birth defects, according to the U.S. Environmental Protection Agency," reported Bloomberg.

## Water Rates to Increase

The Maui Department of Water Supply has announced new increases in water rates effective July 1, 2011. The rate increases were approved by the Maui County Council for the 2012 fiscal budget.


## Robert Cazimero releases new CD: HULA


