

64 Year old Leonard Peltier Just had a Parole Hearing July 28: RESULTS

In central Pennsylvania today, about 200 people gathered outside the walls of Lewisburg Penitentiary to support Native American activist Leonard Peltier during a parole hearing. Peltier's attorney, Eric Seitz of Hawaii, says Peltier should be released, because he has already served his 30 year mandatory minimum sentence.

"He, by the Parole Commission's own standards and criteria has served all the minimum time that is required."

Numerous witnesses testified in favor of Peltier's release during the 4-hour hearing; and although the government is calling for him to remain in prison, the hearing is seen as Peltier's best chance in more than 30 years to be released.

The hearing commissioner will make his recommendation within 48 hours, then the parole commission has up to 21 days to make a decision.

Background.....convicted and sentenced in 1977 to two consecutive terms of life imprisonment for the murder of two FBI Agents [ack R. Coler and Ronald A. Williams] who were killed during a 1975 shoot-out on the Pine Ridge Indian Reservation. [Bob Robideau and Darelle "Dino" Butler, AIM members also present on the Pine Ridge Reservation at the time of the shootings, were found not guilty on the grounds of self-defense by a federal jury in Cedar Rapids, Iowa. As Peltier fled to Canada and then fought extradition, he arrived back in USA too late to be tried with Robideau and Butler and was tried separately in United States District Court for the District of North Dakota in Fargo, North Dakota, where a jury convicted Peltier of the murders of Coler and Williams].

Peltier was incarcerated at the United States Penitentiary, Leavenworth until January, 2009, when he was moved to Canaan Federal Penitentiary in Waymart, PA. Jail officials did not prevent his brutal attack by younger inmates and reportedly also did not properly manage his diabetes condition. He is up for parole July 27, 2009.

"I AM but a common man, I am not a speaker but I have spoken. I am not all that tall, but I have stood up. I am not a philosopher or poet or a singer or any of those things that particularly inspire people, but the one thing that I am is the evidence that this country lied when they said there was justice for all...I am the evidence that they lied when they extradited me from Canada. I am the evidence that they can lie at your trial, they can manufacture evidence at your trial, they can intimidate witnesses at your trial, they can have back room conversations and agreements with the judge at your trial. I am the evidence that the attitude, the powers that be still hold us in a grip. They hold us in an emotional grip. They hold us in a poverty grip. They hold us in a cultural deprivation grip. I don't want to spend the rest of my life in this prison. And I don't want you to spend the rest of your life in some prison of the mind, heart or attitude. I want you to enjoy your life.

I'm always hopeful that I will be free at some point, perhaps in the latter part of July after my parole hearing, and perhaps I won't. The people that hold me, the FBI and the conglomerate corporations that have for so long controlled the resources of this country and others and for so long have done their best to stifle, to denigrate, and to vilify the voice of the oppressed are some of the most formidable well funded political people on Earth.

If I am freed next month or if I die in prison remember my words and remember we are evidence that the Creator made a beautiful people a people that respected the Earth and nature and each other. We are evidence on every level of goodness that when the Creator made us He meant for us to be free.

If nothing else give somebody a hug for me and say, "This is from Leonard." Leonard Peltier

Guns for Teachers for School Safety

One year ago August 08, David Thweatt, the superintendent of the isolated Harrold Independent School District, made history when he and his school board decided to allow select teachers and staff members at the 110-student school to carry guns on campus — a first for Texas and the nation.

The school, which sits in the middle of a prairie, was too far from law enforcement for police to come in time to fend off would-be attackers. The students and staff would be safer if trained and armed staff members were equipped to handle a crisis at a moment's notice, they decided.

Thweatt had already installed a \$100,000 state-of-the-art security system in the school. Now, arming certain unnamed school staff members by allowing them to strap a firearm under their clothing was the final defense system component.

In the year since that historic decision, there were no problems directly on the school grounds, Thweatt said, but, one week after school began, police busted a methamphetamine lab set up in an abandoned house adjacent to the school property.

A deputy had peered inside and "saw something in the walls and windows and called for backup," Thweatt said. "They made it to the abandoned house in 15 minutes. We had figured it would take 18 to 20 minutes in a typical situation."

Had that been an armed intruder at his school, response time would have been too slow.

"We're the first responders. We have to be," Thweatt said of teachers and school staff. "We don't have 5 minutes. We don't have 10 minutes. We would have had 20 minutes of hell" if attackers had targeted the school to kill.

These Texas school students, who grew up on ranches and in the middle of the North Texas gun culture, were unperturbed by the school district's new gun policy. "The kids just laughed about it," Thweatt said.

Thweatt himself is the son of a retired minister/missionary/teacher in Abilene and a 1978 graduate of Abilene High School and Hardin-Simmons University. Too small for athletics, Thweatt spent his time at Abilene High focused on his studies, particularly interested in journalism. He wrote music and played guitar in a Christian band on weekends and was active in his father's nondenominational Abilene Fellowship ministry.

Thweatt drove a school bus for the Abilene ISD and occasionally worked as a substitute teacher to help fund his education, graduating in 1983.

Worldwide media attention about armed teachers at his Texas continues. Only Finland and Switzerland reporters ignored the story; like Texas, they already have high gun ownership rates, he said.

Asked if he would instead post a sign at a school that says, 'No guns on this property'? Thweatt said "It invites nasty people to come. "That's what been done to every public school in the nation. That's why Columbine shooting happened. Schools have been turned into a dad-gum shoot fest. This is Texas. I have a magnet on my refrigerator of the state with a plastic gun glued to it that says, 'We don't call 9-1-1.' We find that funny in Texas.

When a London reporter asked Thweatt to explain why so murderers go into schools looking for easy victims, Thweatt said he couldn't explain such a devolution of society, but he did know a simple way to stop it — the same solution he chose for his Texas school: train and arm teachers and staff.

"Good guys with guns — good," he said. "Bad guys with guns — bad."

Crimes of Politicians Must Be Stopped by The People (You are The Militia)



Obama's DEA, FBI, Internal Revenue Service, Los Angeles County Sheriff's Department, Los Angeles Police Department, Torrance Police Department and Culver City Police Department took part in the raids on two Westside marijuana dispensaries Wednesday, and raided the residences of the owners who were not at home, and killed their dog.

The names of the owners whose homes were searched were not immediately available. During one of the raids, officers shot a dog, but the circumstances of the shooting remain unclear, a law enforcement spokesman said.

Authorities seized undisclosed items and are continuing their investigation, according to a DEA spokesman.

High Cost to MM Criminalization Continues

Medical Marijuana: Users, Growers Can Sue Police Raiders

In the first ruling of its kind, the California 3rd District Court of Appeal in Sacramento held Wednesday that medical marijuana patients and growers can sue police for illegally raiding their properties and destroying their plants. The ruling came in County of Butte v. Butte County Superior Court.

The drug remains illegal under federal law, but President Barack Obama's administration has said it will not target stores that comply with state law.

In that case, a Butte County sheriff's deputy went to the home of medical marijuana grower David Williams and demanded he destroy all but 12 of the 41 plants he was growing for a seven-person collective. Williams had complete documentation for his grow, but, threatened with arrest, he complied with the unlawful order. He then sued the county and won in Superior Court.

HMSA Denies Hawaii Woman Transplant Because Medical Marijuana

Waimea, Hawaii, resident Kimberly Reyes died July 27 at Hilo Medical Center, 10 days after her insurance provider denied the liver transplant she needed because she had tested positive for marijuana in a series of toxicology tests. Reyes was not a registered medical marijuana user, but her family said she had used it to deal with nausea, pain, and disorientation caused by the hepatitis.

Reyes' husband Robin, and her mother, Noni Kuhns, said the rejection by HMSA was based on failure to comply with a policy prohibiting drug use, but that neither HMSA nor her doctors had told her just what that policy was.

"Just because someone takes a hit off of a joint doesn't mean that it should be the end of their life -- this is not a reason to deny life," said Kuhns.

HMSA has refused to comment or provide a copy of their policies on drug use and transplant approval.

Denial of transplants to marijuana users has happened before. Last year, Seattle-area musician Timothy Garon died after being refused a transplant because of doctor-recommended medical marijuana use. In 2003, Oregon resident Dave Myers was removed from a transplant list merely for Marinol, a prescription medicine related to marijuana.

It is OK though to abuse your liver with alcohol until it can be used as a doorstep. First, this just another excuse for insurance companies who are unregulated to continue to protect their profits above human life. Second the government refuses to question the current paradigm of the war against it's citizen's or better known as the war on drugs.
