Engine 9 (Ho'olehua) Receives New Firefighting Equipment

The newest firefighting equipment acquired for Molokai is based at Engine 9, Hoolehua. Firefighter, Greg Jenkins was instrumental in the research and development of the plans for the custom firefighting needed for the unique terrain of Molokai. Jenkins described the Pierce Custom 2005 4WD truck made for "wild land" with "urban interface." The 700 gallon water tank is capable of pumping 1,000 gallons per minute and is the first engine that mixes foam and water for more effective flame penetrating material.

The truck, taller by one foot than other firetrucks at Pukoo and at Hoolehua was blessed by Wayde Lee, of the Hoolehua Ward of the LDS Church on Thursday, August 10th. Vanda Hanakahi, explained the significance of the name "Nininiwai."

Mo'olelo given by Kumu John Ka'imikaua to Vanda Hanakahi for the Ho'olehua Fire Station on July 28, 2006. "In ancient Moloka'i on the plains of Ho'olehua, there was a mighty famine. Cries of children, parents and kupuna were heard day after day -- cries of hunger. Living in the deep forest of Waikolu was the giant Ha'eha'eku his home a mystery to everyone.

From the top of Maunaloa, over Ho'olehua, down the Pane'ene'e cliffs and up through the valley of Waikolu, the Puhilohelohe wind carried the cries of the starving people of Ho'olehua. Upon hearing such pain, Ha'eha'eku took pity on the people. He gathered vines of the Lanikeha sweet potato and with a huge gourd of water and a digging stick, made his way to Ho'olehua. Between Pu'u Eleue and Pu'u Kanaio he planted sweet potato vines on individual mounds. He then poured (*ninini*) water from his gourd on the vines. within a short time, the field was ready to harvest.


The people were overcome with gratitude because they would live. they had food to eat -- the Lanikeha sweet potato. He placed one condition on the people -- that was to share the 'uala with strangers and anyone who passed through Ho'olehua.

Thus, the plains of Ho'olehua were named Nininiwai because of the pouring (*ninini*) of water (*wai*) on the sweet potato mounds. The same 'uala, the Lanikeha was a staple of our *kupuna* who first came to Ho'olehua to homestead from 1923."

Also present were County Public Works and State DOT crews who have given welcome support to Molokai firefighters during past big fires. A feast of Firehouse stew was served by the Engine 9 firefighters.

MAKAALA: Delphi Technique "Consensus Outreach" is PsyOps To Develop Laau Pt. Regardless

OPEN LETTER by George Peabody, candidate for governor [R]

Dear Mr. Chairman of Brierley's Molokai Ranch dba Molokai Properties, LTD.

We have seen the enemy, and the enemy is YOU — and all your slick corporate minions whose obviously intend to distract most Molokai residents who oppose your La'au Point development plans with that Orwellian Delphi Technique of "consensus building", coercion, political manipulations with governor Lingle, bribery and and facilitating the greed factor of OHA stooges — and now you hire John Sabas, too! HAhaa! Don't you know that Sabas and Ritte were run out of their political Waihee favorits positions as state Economic Development beaucrats on Molokai after so many of their scams ripping off Taxpayers were exposed by The MAN. It was a RICO operation! Good for you, though! Sabas lost job at Dept. of Labor back in 2001. He needs you, and will surely do your bidding. But he won't be able to fool Molokai people for you.

E kala mai! Now I realize the error of my previous criticism of your Outreach Consensus community meetings: I accused you of deceiving Molokai residents by creating an artificial concensus [appearance of consensus] to your preset agenda so you could vault with apparent communtiy support into the permit rubber stamp club. Boy, was I wrong. Its even WORSE! It is clear to me now that the purpose of your community outreach meetings does infact use the Delphi Techique PsyOps, but it is to disguise the fact that there is already a genuine Molokai community consunsus against your Laau Pt development plans! WOW! You are VERY clever, in a evil way!

You are trying to coverup the community consensus against development of Laau Pt for 200 homes for millionaires.....what are they, homeless now? Why don't they stay where they live now? And you bribe the people with offers of 25,000 acres you don't want, and watch the greedy OHA stooges scramble for musical chairs of power over that; and, your sycophant Dispatch and Makafee papers keep your image tidy. And you ignore the fact that there is no water out there for such development as you pass out money as if it comes from a spring in the ground to gain favor and influence instead of taking the high road advised by The MAN to develop your own fresh water system by de-salinization so that you add to Molokai's water inventory instead of depleting!

The Delphi Technique and consensus building is a continual evolution to "oneness of mind" (consensus means solidarity of belief). In thesis and antithesis, opinions or views are presented on a subject to establish views and opposing views. In synthesis, opposites are brought together to form the new thesis designed by MPL for the benefit of MPL. All participants in the process are then to accept ownership of the new thesis and support it, changing their views to align with the new thesis. Through a continual process of evolution, "oneness of mind" will supposedly occur.

In group settings, the Delphi Technique is an unethical method of achieving consensus on controversial topics. It requires well-trained professionals, known as "facilitators" or "change agents," who deliberately escalate tension among group members, pitting one faction against another to make a preordained MPL viewpoint appear "sensible," while making opposing views of Molokai residents appear ridiculous.

MPL needs to be in power to preserve the illusion that there is community participation in decision-making processes, while in fact lay citizens are being squeezed out by the facilitator who applies the basic strategy of "group dynamics". Basically, the facilitators encourage each person in a group to express concerns about the Laau development. They listen attentively, elicit input from group members, form "task forces," urge participants to make lists, and in going through these motions, learn about each member of a group. They are trained to identify the "leaders," the "loud mouths," the "weak or non-committal members," and those who are apt to change sides frequently during an argument.

Suddenly, the amiable facilitators become professional agitators and "devil's advocates." Using the "divide and conquer" principle, they manipulate one opinion against another, making those who are out of step appear "ridiculous, unknowledgeable, inarticulate." They attempt to anger certain participants, thereby accelerating tensions. The facilitators are well trained in psychological manipulation [PsyOps]. They are able to predict the reactions of each member in a group. Individuals in opposition to the desired policy or program will be shut out. The Delphi Technique works. The "targets" rarely, if ever, realize that they are being manipulated. If they do suspect what is happening, they do not know how to end the process. After nots of meetings, individuals from the divided group begin to adopt the MPL idea as if it were their own, and they pressure the entire group to accept their proposition. Voila! "The community supports MPL/s plans!"

The facilitor's job is supposedly neutral and non-judgmental, but she is there to direct the meeting to a preset conclusion, in the usual Delphi scam. But in this Laau Pt. situation, the community consensus is unalterably opposed to the Laau Pt. proposal based on solid environmental, cultural, resource depletion, subsistance, quality of life and social impact, and legal grounds, so MPL needed to try a variation, and disguise the fact that there is already a genuine Molokai community consunsus against their Laau Pt development plans! Nice try. No cigar!

The Delphi Technique is pure EVIL POLITICS! It is being used very effectively to change our republican form of government —elected individuals with limited Consitutionally defined authority to represent the people— into a "participatory democracy" in which citizens are facilitated into ownership of preset outcomes desired by the Elite and Powerful who sponsor the meetings. These citizens believe that their input is important to the result, whereas the reality is that the outcome was already established by people not apparent to the participants, e.g., Mr. Chairman.

How to Diffuse the Delphi Technique?

1. Always be charming, courteous, and pleasant. Smile. Moderate your voice so as not to come across as belligerent or aggressive. But, stay focused, and if the facilitator avoids or twists your questions, be persistant: "But you didn't answer my question. My question was . . ." and repeat your question. Anger directed at the facilitator will immediately make the facilitator look the victim. This defeats the purpose. The goal of facilitators is to make the majority of the group members like them, and to alienate anyone who might pose a threat to the realization of their agenda.

2. People with firm, fixed beliefs, who are not afraid to stand up for what they believe in, are obvious threats to the Delphi facilitator's scam. If a participant becomes a victim, the facilitator loses face with the crowd. This is why crowds are broken up into groups. It's called crowd control. At a meeting, have two or three people who know the Delphi Technique dispersed through the crowd so that, when the facilitator digresses from a question, they can stand up and politely say: "But you didn't answer that lady/gentleman's question."

A popular tactic of facilitators, if a session is meeting with resistance, is to call a recess. During the recess, the facilitator and his spotters will notice if the resistors congregate in one place, then when the meeting resumes, the facilitator will steer clear of the resistors. Do not congregate. Instead gravitate to where the facilitators or spotters are. Stay away from your team members. Act alone: this is a gruerilla war tactic that works against the Delphi Technique.

Giving Up Our Rights for "Security" ?

I have received e-mails and letters from people who expressed their support and solidarity with The MAN and other patriots who have chosen to place our nation, its Constitution, its liberty, thus the public's right to know, above their future security, careers and livelihood. I have also received e-mails from individuals who argued against the public's right to know when it comes to issues such as the names of government employees, or bigger issues like NSA warrant-less eavesdropping or mass collection of citizens' financial and other personal data by various intelligence and defense related agencies, and even gun registration which violates the 2nd Amendment.

The "security above rights" people unite in their argument that any measure to protect us from the terrorists is welcomed and justified. That is, except enforcing the Bill of Rights 2nd Amendment to ensure everyone who wants to keep a gun for self defense against terrorists, domestic or foreign. They don't believe security begins at home.

Giving up rights to have security goes like this: I have nothing to hide, so I don't mind the government eavesdropping on my phone conversations for my safety. Only those engaged in evil deeds would worry about the government placing them under surveillance. But how far can one let the government go based on this rationale?

How do we oblige our servant government to control itself? You may ask how NSA eavesdropping affects you when you have nothing to hide. If the governments only looking for "terrorist activity," still all your conversations have to be processed; have to be linked to other calls and sources of "possible" terrorist activity are compared. All it takes is an innocent phone call to a friend, who has placed a call to a friend or relative, who has legitimate business or personal contacts in a foreign country where there may be "suspected terrorists." You have just become a potential target of government investigation - you may be a terrorist supporter, or even a terrorist in the eyes of Big Brother.

The NSA program can easily mistakenly connect you to a terrorist. Like how people get put on Terrorist Suspect List NO FLY lists by mistake. Furthermore, since the program is being conducted without judicial oversight and under no recognized process there is nothing to restrict how the information obtained under the program is used.

To what other invasions of rights would such acquiescence to government authority inevitably lead? Our government will argue its right to break into your house and search it without warrant based on some tip, intelligence, or information that is considered classified, which you have no right or clearance to know about. It will argue that the search and the secrecy are necessary for reasons of "national security" and within the "inherent powers" of the executive branch, therefore not requiring congressional authorization or judicial oversight. All lies!

What is next in the name of national security? Will our government call out to all citizens in particular communities to turn in their guns to law enforcement agencies? Perhaps it will cite the following reason for such call: "We already know that several Al Qaeda cells reside in your communities. Our intelligence agencies have received credible information concerning these cells, intention to break into Americans, homes to obtain firearms, since they do not want to risk detection by purchasing firearms from the market." Would you be more than happy to give up your right under the Second Amendment for possible security promised by the government? When the agents show up at his door demanding your legally registered Colt, what will you do?

There are those who believe that our nation's security is somehow damaged when an employee of one of our "security" agencies comes forward to shed light on activities by our government that may be illegal, may be un-constitutional, and may be a danger to the nation's security. These Americans have accepted too easily the government's propaganda sold to them shrewdly packaged in a wrapping of fear of terror - that if you expose any government action, however misguided or un-constitutional, then you are jeopardizing our security; you are aiding the terrorists. Another government lie!

This quote from Benjamin Franklin sums it up well: "They that can give up essential liberty to obtain a little temporary safety deserve neither liberty nor safety."
