## Who are the FlashMob Thieves, Gangbang Racism, Sex Assault?



Photo: black flashmob thieves hit a mainland 7-11 Store in just 60 seconds Wisconsin Family Fair: They knocked him to the ground, and then a group of 15 black men kicked and stomped on him, Stikl said.

"My wife's brother jumped out of the car - his natural reaction was to try to break it up. Before you knew it, five or 10 guys were on him and started punching at him. My wife was able to pull him back in the car. So now they surrounded my car and just started punching through the windows, kicking and shaking the car, screaming racial things."

11 p.m., witnesses told the Journal Sentinel, hundreds of black youths attacked white people as they left the fair, punching and kicking people and shaking and pounding on their vehicles.

West Allis Mayor Dan Devine said he was disgusted by the violence. "It is appalling that a group of hoodlums has cast such a negative light on what is traditionally a safe and family friendly event."

Amidst riots in central Europe that have now spread to London, people wonder how low is the moral conscience of hoodlums like these three black men who gang raped a 8-year old mentally retarded girl then poured acid on her to destroy DNA evidence of their crimes on her body. # Home Owners RPTax 8-22 Big Penalty for Lateness: Lose Homeowner's Exemption !

WAILUKU, Maui, Hawaii – Mayor Alan Arakawa would like to remind taxpayers that Real Property Tax Bills are due on Monday, August 22, 2011. Recent changes to the law, states that delinquent taxpayers will lose their homeowner's exemption, resulting in high taxes.

Once you lose your homeowners exemption, you will not be allowed to reapply until you completely pay off your balance. Only then can a homeowner reapply for the following year. In addition, the parcel will not only lose the \$200K exemption, you will also be taxed based on the underlying land classification established by zoning. This means you will be taxed at a higher rate.

Real Property tax bills from the County of Maui have been mailed to property owners or the agents servicing their accounts. Property owners who pay their real property taxes directly and who have not received a real property tax bill should check on their taxes by contacting the County of Maui Real Property Tax Division by phone at (808) 270-7697, in person at the Maui Mall Service Center (Mon-Fri 8am - 4pm), or online at [www.mauipropertytax.com](http://www.mauipropertytax.com).

The Real Property Tax Division is offering electronic payment options for Real Property Taxes. Electronic payments are accepted via the internet or phone. This service is being offered through a private vendor Link2Gov. The service provider will be charging a convenience fee. These fees are not being collected by the County of Maui. To make an electronic payment it is a good idea to have your tax bill on hand because you will need your 13 digit tax map key number. To find out more about electronic payment options visit <http://www.maui-county.gov/departments/Finance/rptpayment.htm>. To make an online payment go to <https://gate.link2gov.com/MauiRPT/>. You must have an email address to use the online payment service. To make a payment by phone call 1-877-729-4775 and follow the voice instructions.

Property owners are reminded that failure to pay their taxes on time because of non-receipt of a tax bill will not excuse them from being assessed a 10 percent penalty plus interest at the rate of 12 percent per year. Unless hand delivered on time, the United States Postal Service cancellation mark is the date of receipt by the County of Maui. It is the taxpayer's responsibility when sending via postal mail to assure that all envelopes are timely postmarked by the USPS on or before August 22, 2011.

## Frank Marshall Davis in Hawaii was Communist Mentor to Obama


Frank Marshall Davis's words to the young Obama of Punahou High School: "...you may be a well-trained, well-paid nigger, but you're a nigger just the same."

## Why Don't Cops Understand 2nd Am?

American gun owner tempers are still hot over a disturbing police dash-cam video showing a profanity-laced encounter between a police officer and peaceful but armed citizen. The video should serve all police as an advisory on how not to handle this kind of situation. See the video at this link:

Gun rights activists are using the video as an argument for changing the statutory requirement that armed citizens immediately notify police who stop them for questioning that they are armed, or face criminal charges. In this case, the citizen tried at least twice but the cop told him to "shut up."

In contrast, there is no such requirement in Washington State, but police and sheriff's deputies, state troopers and game cops apparently presume that everyone they encounter is armed, and behave with respect, usually with a peaceful end.

In Canton, OH, notifying the policy when you have a firearm is required by Ohio Law, but when this individual in the video with a thirty-day old license tries to do that he is repeatedly ordered to look away, shut up, by the actions of an aggressive cop who maintains verbal control of the situation.

This video shows a two man police car dealing with three people put themselves at risk when one officer started what appears to be an illegal search of the rear of the car without extracting or securing the driver - which would have given the driver an opportunity to show police his gun permit. What follows is horrific example of a police officer losing all self-control, threatening to beat the female, threatening to beat the driver and eventually saying he should have executed him "and wouldn't have lost any sleep over it" that night.

If it were up to gun owners, there would now be at least one job opening in Canton's police department, and criminal charges might also be pending against the fired cop. After all, several gun rights activists have observed, if a private citizen made the same kinds of remarks, including the suggestion that "I shoulda taken two steps back, pulled my Glock 40 and just put ten bullets in your ass and let you drop" he might now be behind bars, and at the very least, his gun would be in a police property room.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

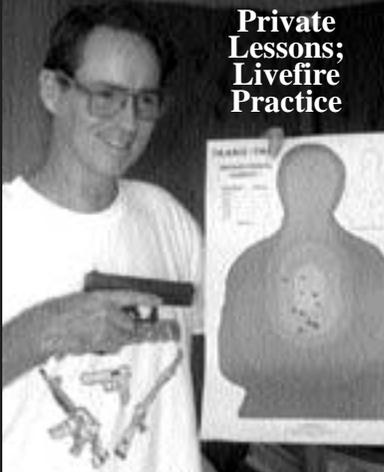

# SPEECH Rights 3 feet

A Michigan woman is suing her county over limiting her petition gathering to a 3-by-3-foot square of ground in a 135-acre park, a restriction one attorney said is in the running for the title of the "most unconstitutional [free] speech zone ever." Earlier this summer, The Detroit News reports, Denise Miller sat at a picnic table near the Linden County Park in Genesee County, Mich., gathering signatures as part of a campaign to recall Republican Gov. Rick Snyder.



A park ranger told her she had to leave, and the Genesee County Parks office later confirmed that she needed a permit to petition signatures at the park.

But after she applied for and received the permit, she discovered the parks officer had limited her to a tiny "Freedom of Speech Area" [see photo] that she says is located 20 feet from a

remote corner of a parking lot and far from foot traffic.

And, just in case she couldn't find the designated 3-by-3 foot zone, parks officers spray-painted an orange box in the grass to mark the spot. [see photo]

American Civil Liberties Union has filed a lawsuit in federal court, asking U.S. District Judge George Caram Steeh to strike the ban on petitioning without a permit and the rule restricting petitioning to the "Freedom of Speech Area."

"In a free society, citizens do not need the government's permission to simply petition in a public park," said Michael J. Steinberg, ACLU of Michigan legal director, in a statement. "Barring petitioning anywhere in a 135-acre park except for a tiny, isolated spot is a particularly egregious violation of the First Amendment."

## Miss America Smackdown Takes Obama to School of Character, Constitution

# Education cheating scores

There has been no further explanation for the low test scores that special education students turned in for this year's Alternative Assessment. In 2010, 62 percent of students who took the test were rated proficient in math and 70 percent in reading. This year the scores were four and eight percent respectively. This year, teachers were not allowed to prompt and were not scoring the tests themselves.

In the absence of a better theory, it seems clear that when Department of Education teachers were allowed to prompt students and were responsible also for scoring the tests, they over-rated the true proficiency level. "Prompting" is basically whatever the teacher wants it to be. It can go perilously close to providing the actual answer. Of course, the pressure is on to score these and other children as high as possible to meet the increasingly onerous and unrealistic goals of No Child Left Behind.

Judge David Ezra, who oversaw the decade-plus Felix Consent Decree, is fond of expounding from the bench that parents expect a Cadillac education for their students but that the law doesn't require the DOE to provide that. Those of us who work with or have worked with special needs students know that the Cadillac isn't even in the running. The DOE often provides nothing better than a Volkswagen up on blocks. Parents would settle for a used Ford, if it actually ran.

Both the DOE and DOH became good at acing the court monitor's special assessment methodologies ("service testing") toward the end of the Felix Consent Decree. There were clear and important improvements, but not so much in the processes that would assure students a free appropriate public education (or FAPE), which is what the federal law does guarantee. That the number of due process hearings soared to record levels during the life of the consent decree and that parents prevailed in most, was a better measure of how the DOE mindset remained basically unchanged.

Although the DOE, DOH and the state legislature desperately wanted to get the federal court off their backs, that did not mean that they would do it by actually providing the required assessments or services to students.

I found it shameful that even the named (initialed) plaintiffs in the case were in and out of due process themselves while the consent decree lumbered on.

With the end of Felix, many parents reported that services were increasingly denied. By "services" I mean remedies that a school team ought to have decided upon and provided in order to deliver FAPE to the students. Depending on the school, and variability was quite high, special needs students either made progress or did not. Depending on the familiarity of parents with the system and their willingness to challenge authority, schools continue to be taken to due process today. It's as though an attorney is needed just to get an education for these students.

Yes, many students did benefit from Felix. Of course they did. But the new test scores should lead us to question whether there has been significant backsliding.

The low scores on the new assessments still need to be adequately explained. If it turns out that prior test results were simply bogus, Hawaii parents would be wise to consider whether some kind of legal action might again be needed. If so, it should learn from Felix and provide true control of the process to the plaintiff class. That's tough with the common class-action lawsuit, and Felix was a great example of a process that took off on its own, leaving the class to fight for benefit even as the children lost out on the education that should have been theirs by right.

The class action ran in parallel with hundreds and hundreds of due process hearings. That alone should have been a signal. The plaintiff attorneys relied on parent input from arguably questionable sources, including a prominent parent who also happened to be a DOE employee. And towards the end, <http://archives.starbulletin.com/2000/05/26/news/story13.html> even the plaintiff attorneys were split on whether the DOE should be held in contempt (as it ultimately was) for not complying with the decree.

What we're left with, barring any further explanation, is no more Felix but four and eight percent competence levels. If valid, those scores represent a massive failure not only of Hawaii schools but also of the legal system.

## Subject: Akaka-Hawaiians?

kanaka maoli will be getting a different kind of shaft as Gov. Neil Abercrombie, who campaigned as a supposed champion of Hawaiians, signs Senate Bill 1520 into law. It sounds innocuous enough, even noble, the way it recognizes Native Hawaiians as the only indigenous, aboriginal people of the Islands, which bill co-sponsor Sen. Malama Solomon likes to claim finally puts kanaka on equal footing with their occupiers.

But what the bill in its final incarnation is really all about is giving the Office of Hawaiian Affairs, a state agency that many kanaka revile, the power to create a Hawaiian governing entity. Adding insult to injury, this state-orchestrated usurpation of native rights and privilege is being formalized at Washington Place, the former home of the illegally deposed Queen Liliuokalani.

The bill aims to do what Sen. Daniel Akaka could not: turn kanaka maoli into a tribe that forever relinquishes all claim to sovereignty while keeping those pesky upstart Hawaiians firmly under the state's thumb. Worse, it does so by using a divide and conquer strategy that will serve only to tear the Hawaiians apart, which is quite an effective way to delay justice for another century or so.

Specifically, the bill calls for the Guv to appoint a five-member Native Hawaiian commission — and who do you suppose might get those plum positions? — to determine just who is a kanaka and who is not for the purpose of creating a "roll." .....In other words, if you're already working toward sovereignty through Reinstated Hawaiian Nation or Kingdom of Atooi, you're out, because that's not the Native Hawaiian governing entity. So right off the bat, totally legitimate independence efforts are aced out.


