### Fluoride Is A Deadly Toxin

#### Why is it added into Your Toothpaste or Drinking Water?

Fluorine considered a toxin, one of the most reactive elements ever known.

Fluorine mixes easily with other chemicals, and is used in many "industrial" applications, such as in the creation of metal, glass, ceramics, Teflon, and even fertilizers, pesticides, rat poison and nuclear weapons.

#### Why is fluoride harmful?

Fluoride can damage enzymes which can result in a number of chronic diseases. Even small amounts can cause a breakdown of human collagen. It also leads to an irregular formation of collagen, which is a major structural component of the skin, ligaments, tendons, muscles, cartilage, bones and teeth.

Studies show the ingestion of fluoride can cause neurological damage, having effects on the brain and thyroid. It has been linked to cancer.

Fluoride can damage the immune system. It does this by inhibiting the white blood cells from migrating to infected areas. It interferes with phagocytosis, which is what destroys bacteria and other foreign agents by white blood cells. Fluoride also speeds up the release of superoxide free-radicals in the white blood cells that are resting. When this happens, the aging process is accelerated. In addition, fluoride builds up in the body as you age, so even smaller amounts than the EPA's recommendation can become harmful longterm.

Some side effects of drinking just one to two pints of fluoridated water a day include: Faintness, Stomach cramps, Tremors, Aching bones, Nausea, Skin rash, Stiffness, Weight loss. In spite of that, the EPA allows up to 0.8 milligrams per liter of water even though it exposes people on a "systemic" level. And because it's being added to the water supply, more and more people will be exposed to it whether they choose to or not.

Fortunately, Hawaii's public water systems are not fluoride contaminated, though a the DOH has made several efforts to force fluoridation here.

### Obama/McCain seek racist LaRaza votes


Presidential candidates John McCain and Barack Obama are longtime "open border" advocates, and now that both have their nominations virtually in the bag, they have been seeking the "Latino vote," by addressing the pro-amnesty and race based National Council of La Raza convention in San Diego.

Addressing the La Raza convention on July 13, Obama said that "we have to finally bring those 12 million people [i.e. illegal immigrants] out of the shadows" and "offer those who are willing to make amends a pathway to citizenship." Speaking to the same group a day later, McCain said that he "helped author with Senator Kennedy comprehensive immigration reform" — and remained "committed to fair, practical, and comprehensive immigration reform."

### Real I.D. Rejected

Refusing the federal regime's mandate for REAL I.D. cards for every person in America, Arizona will join roughly a dozen states that have vowed not to participate in the Real ID Act. Gov. Janet Napolitano signed a measure, House Bill 2677, barring Arizona's compliance. She called it an unfunded federal mandate that would stick states such as Arizona with a multibillion-dollar bill for the cost to develop and implement the series of new federal identification cards.

Real ID Act, passed by Congress and signed by Bush on May 11, 2005, mandates that all U.S. citizens will receive a National ID card by May of 2008.



## Hawaii's Concealed Carry Permit Law Violated by HPD

No Permit To Carry In Hawaii? 8 states allow their citizens to carry a firearm for protection, so whats up Hawaii?

"I am a Federal Police Officer, a U.S. Coast Guard Law Enforcement Boarding Team Member with a Tactical Counter-Terrorism Unit, a Self-defense and Firearms Instructor, a Use of Force and Deadly Force Instructor, a Chaminade University Criminal Justice Graduate Student, and a local born resident of Honolulu, Hawaii" writes Jeffrey Domingcil, "yet it is illegal for me to carry a concealed firearm in Hawaii."

Even the Most Trained Firearms Professionals Are Not Granted a Permit for Concealed Carry in Hawaii Law Abiding Citizens Should Have the Right to Protect Themselves

Editor's note: Two bills that would allow concealed carry and open carry of a firearm in Hawaii were deferred and held in the state Senate last session. Hawaii has a "may issue" law, which allows police chiefs of the state's four counties, total power to decide who gets a permit to carry and who does not. In the last 15 years, police testified at a recent hearing that no one has been granted a permit allowing them to carry a firearm - not domestic violence victims, not those whose life has been threatened, not even retired police officers. Lawmakers say they don't have any plans to change the law this year so that the chiefs would have to issue a permit unless the applicant is not mentally competent or has a criminal record.

I am a Federal Police Officer, a U.S. Coast Guard Law Enforcement Boarding Team Member with a Tactical Counter-Terrorism Unit, a Self-defense and Firearms Instructor, a Use of Force and Deadly Force Instructor, a Chaminade University Criminal Justice Graduate Student, and a local born resident of Honolulu, Hawaii ... yet it is illegal for me to carry a concealed firearm in Hawaii.

As a trained law-abiding citizen, I believe that I can confidently protect myself and others if and when imminent deadly force situations arise that requires immediate deadly force response before police can respond and prevent a criminal from acting.

I support a bill that allows concealed carry of firearms for law-abiding and trained citizens that have no criminal record, no history of psychological problems, and no history of domestic violence. Training must consist of safe weapons handling and security, and Use of Force and Deadly Force justifications.

With the problem of the ever-rising use of the illegal drug Crystal Meth or "ICE" and increasing violent criminal activity throughout Hawaii, it's about time that the State of Hawaii allows its people to defend themselves immediately when criminals attempt to violently hurt them and those they love.

Hawaii law prevents law-abiding citizens from carrying self-defense weapons, yet criminals are not deterred in carrying guns and knives, which are obtained through the black market and other criminal means, to commit crimes easier and effectively.

Why should law-abiding citizens be intimidated, afraid, and left with the only choice of "turn and run" while carrying our children or worrying if our elders can keep up?

We should make criminals think twice before committing armed and unarmed robbery, rape, home invasions, burglaries, car-jacking incidents, aggravated assaults, and murder of innocent law-abiding citizens.

Hawaii HRS 134 excerpts

Hawaii CCW Laws [Note: only "May Issue"].

§134-9 Licenses to carry. (a):

In an exceptional case, when an applicant shows reason to fear injury to the applicant's person or property, the chief of police of the appropriate county may grant a license to an applicant who is a citizen of the United States of the age of twenty one years or more or to a duly accredited official representative of a foreign nation of the age of twenty-one years or more to carry a pistol or revolver and ammunition therefor concealed on the person within the county where the license is granted.....NONE are GRANTED boast all of Hawaii police chiefs.

States that will Honor Hawaii's CCW Permit IF issued: Alaska, Arizona, Idaho, Indiana, Kansas, Kentucky, Michigan, Missouri, Oklahoma, South Dakota, Tennessee, Texas, Utah.

Oher State CCW Permits that Hawaii Honors: NONE

Regarding new gun laws: Primarily the bills introduced and passed in the state make Hawaii's gun and ammunition laws more restrictive and because of that, Hawaii is one of the least free states in the nation in terms of the Second Amendment laws.

HOWEVER: introduced is SB 2531, which changes Hawaii's law to read "shall issue" a CCW permit and when passed, Hawaii becomes the nation's 39th state to allow concealed carry of a firearm to law abiding American Citizens

### TSA Fascists Attack Legal Gun Owners at Airports

The TSA is considering a nationwide airports ban firearms in areas that currently allow for self-defense. What's at stake here is not the ability to take guns past surveillance points. What's at stake is the right of self-defense outside of these areas, where drivers are either dropping off or picking up passengers.

Drivers who have CCW permits are the ones who would be affected the most because they would now have to leave their guns at home -- thus contradicting the very reason they got a concealed carry permit in the first place... the fact that they wanted to carry their guns outside of the house for self defense.

## Impeach Bush Not Allowed?

Impeachment is on the table. But Congress is not allowed to bite.

The House Judiciary Committee will hold a hearing on one of Ohio Congressman Dennis Kucinich's 35 articles of impeachment against President Bush. Judiciary Committee chair John Conyers, suggests that the hearing will review evidence of "all the (Bush administration actions) that constitute an imperial presidency." Constitutional law expert Jonathan Turley says that Congressman Dennis Kucinich's 35 Articles of Impeachment against President George W. Bush is "a remarkably lengthy and thorough record of high crimes and misdemeanors" committed by President Bush et al.

But House Speaker Nancy Pelosi and other Democratic leaders in the chamber have signaled that they do not want the committee -- let alone the full House -- to take a vote on impeachment of President Bush.

This frustrates advocates for presidential accountability. And rightly so.

But the opportunity presented by the Judiciary Committee hearing ought not be dismissed or diminished. Conyers and his staff have been working for several years to quantify evidence of abuses, excesses and lawless acts committed by President Bush, Vice President Cheney and their aides.

Conyers and his staff have accumulated a lot of information -- more than enough to fill a book. A thoughtful review of that information, in a formal setting, will make clear the extent of which this president and those around him have engaged in precisely the sort of wrongdoing that the founders imagined when they gave the House the power to impeach members of the executive branch.

Achieving that clarity -- ideally on live television -- is an imperfect, yet essential, step in the arduous process of getting reluctant members of the House to uphold an oath of office that requires them to support and defend the Constitution for the united States against all enemies, foreign or domestic.

If the executive branch powers are not reigned back in there will be nothing to stop another president from taking things even further. W and Cheney should already have been thrown out on their asses, but that is not the point. What's to stop the next president from pretty much dissolving congress?

Bush pretty much rendered Congress useless with the help of Congress itself, but after a while the tax payers will see that congress does nothing but draw paychecks and nothing more. If that's all they do, then congress is no longer a functioning part of our government. The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!




