Home Owners RPTax 8-22 Big Penalty for Lateness: Lose Homeowner's Exemption !

WAILUKU, Maui, Hawaii – Mayor Alan Arakawa would like to remind taxpayers that Real Property Tax Bills are due on Monday, August 22, 2011. Recent changes to the law, states that delinquent taxpayers will lose their homeowner's exemption, resulting in high taxes.

Once you lose your homeowners exemption, you will not be allowed to reapply until you completely pay off your balance. Only then can a homeowner reapply for the following year. In addition, the parcel will not only lose the \$200K exemption, you will also be taxed based on the underlying land classification established by zoning. This means you will be taxed at a higher rate.

Real Property tax bills from the County of Maui have been mailed to property owners or the agents servicing their accounts. Property owners who pay their real property taxes directly and who have not received a real property tax bill should check on their taxes by contacting the County of Maui Real Property Tax Division by phone at (808) 270-7697, in person at the Maui Mall Service Center (Mon-Fri 8am - 4pm), or online at www.mauipropertytax.com.

The Real Property Tax Division is offering electronic payment options for Real Property Taxes. Electronic payments are accepted via the internet or phone. This service is being offered through a private vendor Link2Gov. The service provider will be charging a convenience fee. These fees are not being collected by the County of Maui. To make an electronic payment it is a good idea to have your tax bill on hand because you will need your 13 digit tax map key number. To find out more about electronic payment options visit <http://www.maui-county.gov/departments/Finance/rtpayment.htm>. To make an online payment go to <https://gate.link2gov.com/MauiRPT/>. You must have an email address to use the online payment service. To make a payment by phone call 1-877-729-4775 and follow the voice instructions.

Property owners are reminded that failure to pay their taxes on time because of non-receipt of a tax bill will not excuse them from being assessed a 10 percent penalty plus interest at the rate of 12 percent per year. Unless hand delivered on time, the United States Postal Service cancellation mark is the date of receipt by the County of Maui. It is the taxpayer's responsibility when sending via postal mail to assure that all envelopes are timely postmarked by the USPS on or before August 22, 2011.

Pain v Injury; gazpacho Recipe

As a fitness professional, I constantly hear about people's pain and suffering. My knee hurts, should I continue running? I hear popping in my shoulder when I swing my racquet, is there something wrong? My chest feels tight when I'm working out, should I see my doctor?

Sometimes it's difficult to determine whether you're hobbled with a serious injury or if it's just a nagging ache that's keeping you sidelined. There's a big difference between the two. If you're injured, you need to stop activity and seek professional help. Think of an injury as damage to your body that needs to be addressed.

If it's just a little pain, sometimes you can work through it and sometimes it's best to take some time off.

Just as there's a difference between pain and injury, there are different levels of the two. There are aches that are just minor discomforts you can work through, like a muscle cramp in your calf. And then there's the pain that just won't go away. It's short of an injury, but it continues to hinder your life. In this case, it's best to take a few days or a week off and rest.

If you suspect something more, you may have an injury. If that is what you have, you should seek medical advice. But again, there are different levels of damage. There a minor injury, like a sprain, that may require time off and some rehabilitation.

Then there's a more obvious injury, like a broken arm or leg. Obviously, in this case, you need immediate hospital attention. With this type of injury, there's healing time plus rehabilitation time to get back out on the bike trail or into the gym.

There's also an injury that many people don't catch until it's too late. Injury to internal organs, like heart disease may be harder to track down unless symptoms persist, so you need to pay close attention to feelings like tightness in the chest or numbness and tingling down the arms. The consequences of ignoring or overlooking these injuries are dire, so it is extremely important to adhere to your doctor's orders when dealing with internal damage.

Whether you just feel pain or suspect an injury, proceed with caution. If you're unsure and something doesn't feel right, seek medical attention.

For this week's easy fit mini recipe, try a simple summer gazpacho. Take six peeled and chopped vine-ripened tomatoes; add finely chopped onion, cucumber and red pepper. Dice up a couple stalks of celery and add some spices like parsley, chives, garlic and fresh ground pepper. Finally, add four cups of tomato juice, a quarter cup of red wine vinegar and virgin olive oil, 2 tablespoons of lemon juice and sugar. Combine all the ingredients with a couple dashes of Tabasco sauce and blend slightly. To allow the flavors to blend, let the soup sit in the refrigerator overnight and serve cold.

“People at the very top knew”: Sexual Abuse Arrests made at Hawaii's school for Deaf/ Blind

Police say several arrests of juvenile males have been made as an investigation continues into allegations of widespread sexual abuse between classmates at the Hawaii School for the Deaf and Blind. There are dozens of victims and several alleged perpetrators.

According to sources, the molestation which included rape began years ago, allegedly instigated by one young student.

The abuse worsened as other student victims were forced to become perpetrators themselves, fearing retaliation if they didn't follow suit....

No adults are suspects in the case, but victims and their families say the problems were known to adults on campus.

The principal has been placed on directed leave by the Department of Education, and an acting principal has temporarily been assigned to the school.

"The parents whose children were suspected of wrong doing and parents of children apparently were preyed upon were never told," says Michael Green.

While the criminal investigation is pursued through the juvenile justice system at this time, a civil class action lawsuit may be forthcoming.

"Because I am clear that some of the people at the very top knew I have no doubt about that," says Green.


The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

Overlooked Vegetables

The August 2011 edition of Consumer Reports featured results of a national survey of how often people ate vegetables, and what kind. Thirty three vegetables were highlighted. Results show that gender, age, and regional differences dictate what kinds of vegetables are eaten and how often.

This survey probably has nothing to do with our eating habits in Hawaii, since we're at the crossroads of east and west, and have very different eating habits. However, our eating habits are also evolving as health challenges dictate what we should be eating. The food experts at Consumer Reports highlighted five overlooked vegetables, and feature three of them plus some of my own. They are all cooking greens, and grow well on Molokai in the right season, which is coming soon.

The first is pak choy, a mild member of the Chinese mustards. There are white and green stems, and also dwarf types and large types. Stir fried or steamed with a little meat, Pak Choy is an excellent source of vitamin A, C, and K; a good source of calcium, folate, and potassium. Mustards contain a powerful antioxidant called Glucosinolates, phytonutrients that provide us with unique health benefits because they can be converted into isothiocyanates (ITCs) that have cancer-preventive properties. There are many kinds, with Mei Qing Choy as one of the most popular.

The second is a southern cousin to pak choy, Collard greens, and it has similar nutrients as its Chinese cousin, as well as fiber. Very popular in the south, varieties include Vates, Georgia, Champion, and Green Glaze. They can tolerate the hot weather better than mustard greens. Mustard greens, also grown in the south, has more of a mustard bite and usually grown in the fall months when the cold weather tames the mustard's heat. Popular varieties include Green Wave, Tendergreen, and Southern Giant Curled. Our own version of mustard greens is Kai Choy or mustard cabbage. Two varieties include Waianae Strain and also Hirayama, a white rust resistant strain developed by Chik Hirayama of Kawela. White rust is a destructive fungus with white pustules on the leaves, and humidity helps it to thrive. Kai Choy is great for clear or miso-based soup with a little meat or shrimp for ono broth.

The third is Swiss chard, a cousin to beets and daikon. All three have great greens, and are high in iron, magnesium, potassium, and Vitamin E. It's also an excellent source of Vitamins A, C and K, a good source of calcium and fiber. Swiss chard is very well adapted to our climate, even hot summers. Varieties include Bright Lights, a beautiful mixture of different color stem types, Rhubarb or Ruby Red chard, Fordhook Giant, Lucullus-a flat leaved type popular in Europe, and Rainbow. They're like beets but without the big roots. While you're at it, you might as well plant beets and eat the leaves as well. Beet is definitely an overlooked vegetable, and scavenges for food deep in the ground.
