Molokai Taxpayers Should Not Be Liable for Water Supply Costs to Kaluakoi Hotel, Condo and Phony “Ag” Developments When MPL Utility Abandons Promises to Supply Water & Sewer

Since the 1970's, Molokai residents, from Hawaiian Homesteaders to Farmers, Fishermen, laborers, unemployed, students and teachers have expressed concerns about real estate development in the arid west Molokai ahupuaa called Kaluakoi, and the lack of water to support human population was always the top concern. Government representatives who are supposed to insure a balance between development and the water resources needed to support the development —Linda Lingle, the State Land Use Commission, the Maui Planning Commission and County Council —approved hotels and condos, and phony agriculture subdivisions for wealthy “farmers” based on unverified and unenforceable promises by developers that water would be provided to all their approved developments.

Twenty five years later, the developments have surpassed the water resources available. It has also become very expensive for existing water resources to be collected and pumped to all those residential developments and swimming pools out in Kaluakoi. The house of cards built up over the two and a half decades by foreign owners of Molokai Ranch, now know as Molokai Properties, Ltd, is falling down onto the arid red dirt of this ancient ahupuaa. Victims of real estate developers here similar to swamp lands scams.

Westenders who still depend on the developer's incorporated Utility Companies for water and sewer services, are now faced with a serious problem: how to continue water supply services and sewer services after Molokai Properties, Ltd announced suddenly it was closing all Molokai Ranch operations, and that it could no longer afford to operate the water and sewer utilities. Linda Lingle who calls herself governor, wants Maui County Taxpayers to pay the bills and operate the services to the victims of MPL's real estate development scam. The State Public Utility Commission initiated a water rate increase of about 120% to support MPL. But MPL demanded a 178% increase minimum, and threatens to stop all water supply services to westend residences, condos after August if not approved. The next scheduled PUC meeting is August 14. Fortunately, Maui County Mayor and counsel Jane Lovell have rejected Linda Lingle's demands that Maui County Taxpayers accept the utility operation from MPL. Lingle has no authority through her DOH to require that the Taxpayers of Molokai bail out a private water utility company, while its parent company Molokai Properties, Ltd, retains all its real estate assets.

It is clear that people who purchased land from MPL expected and contracted with MPL for water services. This problem they now face is their problem because they chose to deal with the Devil, in the face of facts that clearly showed it was a risky investment because of the lack of water resources. Now the Devil is wearing no clothes. Everybody knows the Devil is in the details.

There are solutions to Westenders' water problem, but they are expensive solutions: solarized de-salinization is one. But those rich Westender's want everyone else to subsidize them.

Unfortunately, Mayor Tavares is playing the political game of equivocation, saying the county is willing to provide assistance in the event MPL Utilities abandon their responsibilities to provide water to their westend clients. “We are not going to abandon the [westend] Molokai residents. So, lets be sure to remind her that she has a responsibility to all Molokai, Maui, and Lanai residents to avoid encumbrances and fiscal malfeasance just like the issue at hand.

Hawaii Legislature senator Kalani English has stated his belief that Lingle's order for County liability, and he condemned Lingle's attempt to Order such burden onto Taxpayers.

It is clear that We The People [Militia] must not let Tavares or Lingle et al burden us with debts and costs that belong to the Westenders and the Devil through their contracts and Corps. If we allow MPL's utilities to abdicate and transfer costs to us, other developments will continue where they do not have water.

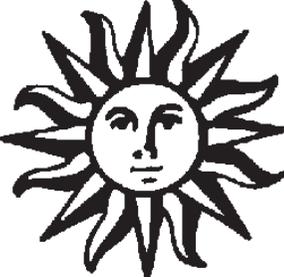
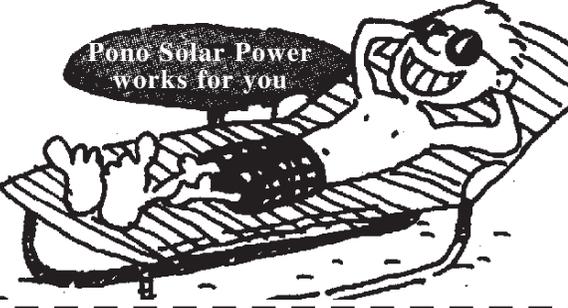



DEA Unlawfully Seizes Medical Marijuana from Seattle Police

Washington state has a medical marijuana law, and the city of Seattle has an ordinance making marijuana offenses the lowest law enforcement priority, but that didn't stop raiding of the Lifevine medical marijuana co-op two weeks ago, seizing hundreds of patient files, as well as 12 ounces of dried buds and several pounds of leaf.

King County Prosecutor Dan Satterberg declined to press charges against co-op operator Martin Martinez and ordered the return of the patient files. But police did not return the co-op's stolen medical marijuana. The Seattle Police announced that the DEA, acting at the request of US Attorney Jeff Sullivan, took the medicine. The DEA tersely confirmed: "Accordingly, the DEA has seized and processed the marijuana for destruction; that concludes this matter," said DEA agency spokesperson Jodie Underwood.

NRA Taking DC to Court again !

"The District of Columbia's so-called 'emergency regulations' prohibit law-abiding citizens from protecting themselves and their loved ones in their own homes," said NRA-ILA Executive Director Chris W. Cox. "The Mayor and City Council have proposed a list of regulations that violate the Supreme Court's decision."

The U.S. Supreme Court overturned the District of Columbia's gun ban last month, but the District, Mayor and City Council are being sued again over the District's thinly veiled attempt to continue its restrictions on firearm ownership. D.C. residents Dick Anthony Heller and Absalom F. Jordan, Jr., in conjunction with lawyers for the NRA, filed a complaint against the District of Columbia and Mayor Adrian Fenty challenging D.C.'s Firearms Control Emergency Amendment Act of 2008.

Only a few weeks after the U.S. Supreme Court's ruling in the Heller case, which struck down D.C.'s ban on handguns and having a firearm in operable condition at home as an individual right protected by the 2nd Amendment, D.C. has passed "emergency" laws and new police regulations intended to retain as much of the ban and storage requirement as possible. This ultra vires anti gun rights rule was crafted in consultation with the Brady Anti-gun Campaign, according to the Washington Post.

Though the Supreme Court ruled that D.C. could not ban handguns, the new rules would still ban all or most semi-automatic pistols. And in spite of the fact that the court ruled that D.C. cannot ban the use of guns for protection in the home, the District still prohibits having a gun loaded and ready unless an attack within your home is imminent or underway.

Without a public revolt and Congress' intervention, D.C. can violate the intent of the Heller decision indefinitely. That is because under "Home Rule," D.C.'s emergency bills are not subject to review by Congress, and D.C. can reinstitute "emergency" laws every 90 days. The city's officials are already thumbing their noses at the Supreme Court, the 2nd Amendment, and the Constitution for the united States of America.

GOOD NEWS: This week, in a bi-partisan effort, Congressmen Travis Childers, John Dingell, John Tanner, Mike Ross, and Mark Souder, along with 47 of their colleagues, introduced the "Second Amendment Enforcement Act". This critical legislation overturns D.C.'s recently enacted emergency laws that continue to defy the recent Supreme Court ruling by continuing to restrict District of Columbia residents' right to self-defense.

This NRA-backed bill is needed to enforce the U.S. Supreme Court's decision in District of Columbia v. Heller.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





Marijuana Tax Act: 70 years old

August 2, 1937: The Marijuana Tax Act is passed by Congress, enacting marijuana prohibition at the federal level for the first time. Federal Bureau of Narcotics Commissioner Harry Anslinger tells the Congressmen at the hearings, "Marihuana is an addictive drug which produces in its users insanity, criminality, and death."

August 2, 1977: In a speech to Congress, Jimmy Carter addresses the harm done by prohibition, saying, "Penalties against a drug should not be more damaging to an individual than the use of the drug itself. Nowhere is this more clear than in the laws against possession of marijuana for personal use. The National Commission on Marijuana... concluded years ago that marijuana should be decriminalized, and I believe it is time to implement those basic recommendations."

Police Raid Berwyn Heights Mayor's Home, Kill His 2 Dogs

Mayor Cheye Calvo, right, and his wife Trinity Tomsic were treated like drug criminals when a police SWAT team raided the home in Berwyn Heights on Tuesday, shooting and killing his two dogs, after he brought in a 32-pound package of marijuana that had been delivered to his doorstep by police. The package was addressed to the mayor's wife Trinity; both do not use any drugs.

Calvo described a chaotic scene, in which he -- wearing only underwear and socks -- and his mother-in-law were handcuffed and interrogated for hours. They were surrounded by the dogs' carcasses and pools of the dogs' blood, Calvo said.

Spokesmen for the police defended the way the raid was carried out, saying it was proper for a case involving such a large amount of drugs; the deputies who entered Calvo's home "apparently felt threatened" by the dogs, and shot them.

There are plausible ways in which the family can have had nothing to do with the package, despite it having been mailed to them, and Calvo and his wife seem unlikely lawbreakers. Police have yet to file any charges.

The idea that a man returning to his home and moving a package from his porch to his hallway, should trigger a SWAT raid, by a SWAT team that had literally been waiting in hiding to see him move the package, is criminally insane.

Police/SWAT/DEA could not figure out some way of being able to arrest the residents of the home without murdering their dogs?? They didn't even have to bring the package to the house -- they already had the address with which it had been marked. They could have simply called the individuals in for questioning, or, almost anything other than what they violent, murderous actions they did.

The town's police chief, Patrick Murphy, who was not involved in the raid or informed of it, had wise words to say in the aftermath: "You can't tell me the chief of police of a municipality wouldn't have been able to knock on the door of the mayor of that municipality, gain his confidence and enter the residence," he told the Washington Post. "It would not have been a necessity to shoot and kill this man's dogs." He really wishes the narcs had contacted him about it first, and the tragedy thereby prevented.

The truth is that entering a home in that SWAT fashion is unnecessary, and therefore wrongful, ALMOST ALL OF THE TIME. SWAT teams are meant for emergency or other high-intensity situations -- hostage situations and the like -- not routine drug enforcement. But even if there had been 2000 pounds of marijuana, there would still be no excuse. Invading a home in this manner endangers people and animals and property, for no good reason, if there is any other way of dealing with the situation.

Two dogs dead, a family traumatized, another day in the drug war.
