\$10,000 Reward Check Brought to Hawaii by Investigators Seeking copies of Obama-1961 Honolulu Advertiser or SB



Seeking the truth and official records about Barack H. Obama's birth place from Obama-loyal State of Hawaii Dept. of Health, Attorney General, and Governor Neil Abercrombie has been so difficult that a \$10,000 REWARD has been offered for a newspaper that reportedly has Obama's birth announcement published in the 1961 Honolulu Advertiser or Starbulletin for August. Photo above at Kapiolani Hospital, where Obama said is his birthplace, with the big check used for publicity this week is Dean Haskins and Miki Booth [formally Hawaii resident] who had children born at Kapiolani Hospital and wanted to obtain her birth records.

Mr. Haskins and Miki Booth had intended to witness and support Dr. Orly Taitz's federal court hearing scheduled for September 14 to compel Hawaii Director of Health Loretta Fuddy to produce Obama's original long form birth certificate for examination, but it was delayed again until November 21. They already paid for their airfares, so decided to use the opportunity to document their efforts uncover the Obama I.D. mystery, and publicize the \$10,000 REWARD.

Dean explained his frustration with the apparent State coverup for Obama.

Hawaii has been a lovely place to visit, but in dealing with people at Obama connected places like Kapiolani Medical Center and the Department of Health, it is more than apparent that they are absolutely involved in a covert operation to conceal the truth about Obama's I.D. Especially at the Department of Health, there was an almost palpable air of deception in the verbal exchange—as if someone were trying much too hard to prove his own innocence. We'll likely be back in a month or two, and we would love an opportunity to sit down with Mr. Onaka and/or Loretta Fuddy, and have an open and honest conversation about our questions; but, I'm not very hopeful that will ever happen. If they would be willing, they can certainly call me at 202.241.3648 to arrange it. But, because of what I've personally witnessed, and what we all knew already, I'm not holding my breath.

We've been told by a number of people about the overwhelming loyal support for Obama by the residents of Honolulu, but yesterday and today we talked with many individuals in open public places on the island, and while there was the occasional supporter, most of the people to whom we spoke were very open to what we had to say, and were not complimentary at all about either Obama or governor Neil Abercrombie—it seems many of them have become aware of the fact that they are receiving a very bad deal from both of them, said Dean Haskins, executive director of The Birther Summit planning a three-day "Birther Summit" in Washington, D.C., next March. He is fully prepared to present evidence that Barack Obama is not a "natural born Citizen," as required by Article II, Section 1 of the Constitution, and hopes the evidence will lead to a congressional investigation of Obama's birth origins for public record and law enforcement action as needed.

\$15,000 is offered to General Colin Powell for three hours of his time to review BirtherSummit evidence, but Powell rejected it saying in part "...some people are trying to persuade me to listen to their arguments as to why he [Obama] is not a citizen, and I don't choose to participate in that any longer. We've spent enough time on this issue. President Obama was born in the United States. He was born in Hawaii. He's shown his certificates, and the rest of this is just conspiratorial nonsense." [Powell also lied to United Nations about WMD in Iraq]

Haskins' response: "As to his original comments, it is clear Gen. Powell is still running cover for Barack Obama, as his statement is devoid of fact." The challenge statement to Powell included NO statement that Obama is not a citizen. "The fact of the matter is, the general public has no way of knowing whether or not Barack Obama is a 'citizen' because he has provided no evidence to settle that matter conclusively, as forgeries establish nothing factual," concluded Haskins.

Is Everyone President-Eligible?

Paul Hollrah, a freelance writer and Senior Fellow at the Lincoln Heritage Institute, wrote "The Rubio Eligibility Question," addressing just that issue. Fl. Sen. Marco Rubio was born in the United States to parents who were Cuban citizens, and yet, he is suggested as a 2012 nominee for vice president. Eligibility?

President and VP must be a "natural born Citizen," as required by Article II, Section 1 of the Constitution for the United States of America, Law of the Land.

Hollrah stated, "So if the place of one's birth is of no consequence, as in the case of Romney (who was born in Mexico to U.S. citizen parents) and McCain (who was born in Panama to U.S. citizen parents), and if the nationality of one's parents is of no consequence, as in the case of Rubio and Obama, we are then left with the absurd proposition that anyone ... male or female, born anywhere on the face of the Earth ... is eligible to serve as President of the United States, so long as they are 35 years of age and have resided in the United States for at least 14 years....That simply cannot be the case. It leads us directly back to the conclusion that the term 'natural born' means something far more than merely being born on American soil of mixed or foreign parentage, and far more than being born on U.S. soil with dual U.S. and foreign citizenship."

Back to Obama's lack of proof of eligibility, Dean Haskins of the BirtherSummit reported that "It was just this past May when Powell publicly stated that he enjoyed it when 'President Obama took out his birth certificate and blew away Donald Trump and all the birthers!'"

Haskins group offered Powell \$15,000 for three hours to hear and view the evidence against Obama, but Powell rejected the offer.

Haskins went on to say, "So, it appears that Gen Powell is willing to 'participate in that' on his terms, but refuses to be called out on the issue when it is understood he will be confronted with the facts, and those facts don't line up with his statements."

Retired Cmdr. Charles Kerchner, a plaintiff in one of the myriad lawsuits challenging Obama's eligibility, said "Powell is bringing much dishonor upon himself in not standing up to support and defend the U.S. Constitution in the face of the clear and present danger in having a person, Obama, occupying the White House and in command of our military, for whom we do not conclusively know, and proven to any controlling legal authority, his true legal identity. "

"In addition, Colin Powell is saying nothing about Obama's revealed history of engaging in criminal felonies and activities before and after his accession to the Oval Office, i.e., SSN fraud, draft registration fraud and forging birth certificate documents ..."

In pointing out Powell is clearly "shirking his oath as a commissioned officer to support and defend the U.S. Constitution," Kerchner stated, "I once admired and respected General Colin Powell. I no longer do. If I met him in his uniform at this point in time, I would salute the uniform but not the man! At some point in his life Powell has allowed the Washington D.C. political cesspool to totally corrupt him and any sense of honor he once had during his military career. He is disgracing and dishonoring his oath to the U.S. Constitution."

Haskins also mentioned retired Lt. Cmdr. Walt Fitzpatrick's extensive work exposing the numerous commissions of treason committed by Obama, and stated, "Whether Colin Powell is running cover for Barack Obama because of Obama's race or his politics is immaterial, as he is supporting an illegal president — one who has gone to great lengths to obfuscate his true identity. A true soldier, who respects his oath, as well as the principles of duty, honor, and country, would unequivocally oppose the current resident of our White House."

While the Birther Summit's original \$15,000 offer to Powell still stands, as well as the extension of that offer to four television commentators, Haskins said the Birther Summit is open to public suggestions as to whom else it should extend its \$15,000 challenge, which may be submitted by visiting <http://www.birther-summit.org/contact.html>.

Angry citizens with Guns protest Mayor's No gun Order

Armed citizens, upset by a government disarmament edict, confronted the Ruidoso, New Mexico city council Tuesday night in defiance of an executive order from the mayor banning guns on city property. Dozens of armed citizens carrying guns in defense of their rights, conducted themselves peaceably, controlling themselves and their anger against what activist and New Mexico Militia leader Bob Wright called the act of a "tyrant."

Larry Pratt of Gun Owners of America, who made a special point of flying in and appearing armed, offered a cogent rebuttal to Ruidoso Mayor Ray Alborno's Executive Order. Pratt said that if the Public is disarmed by executive order, that would leave meetings "unprotected"; furthermore, almost all of the mass murders in our country have occurred in areas just like this gun free zone.

Mayor Alborno, who naturally included an "Only Ones" exemption in his diktat contends: My responsibility is health, safety and welfare of our employees so if we're not going to be able to do these kinds of things I'm not sure I want to be sitting in this seat.

Actually, that's not correct. The mayor's lawful responsibility, that is, his statutory "powers and duties" per Ruidoso Municipal Code, "shall be in accordance with NMSA 1978, § 3-11-1 et seq." And the one thing Sec. 2-33 of the code (and Article VI of the United States Constitution) requires him to do, he's subverting: Each newly elected official shall, within ten days after his certification of election by the clerk, as provided by law, take an oath of affirmation to support the Constitution of the United States and the constitution and laws of the state, and to faithfully perform the duties of his office.

The one acting lawlessly here, unsurprisingly, is the government official usurping powers not granted to him, rights that belong to We The People.

And this is yet another example that peaceable armed citizens, determined to civilly protect their rights, aren't a threat to anyone but aggressors, and do not resort to "gun violence" when angered the way the citizen disarmament lobby would have people believe.

It's also worthy of notice that, when they perceive discretion is the better part of valor, the police will stand down as they did in this instance.

Hawaii Gun Rights Lawsuit vs HPD Chief, Gov. Abercrombie

HONOLULU -- A lawsuit filed in Hawaii U.S. District Court is bound to focus national debate on Hawaii's gun laws.

Several attorneys filed the suit on behalf of an organization known as The Hawaii Defense Foundation, founded by gun owner Christopher Baker. Named in the complaint are the Honolulu police chief, the City and County of Hawaii, the state of Hawaii, and Governor Neil Abercrombie.

The suit alleges Hawaii's license to carry statute and various other firearms regulations are unconstitutional.

Many states allow residents to carry guns legally in public, and many gun owners claim the second amendment to the U.S. Constitution guarantees that right. In Hawaii it is not legal to carry a gun.

State law mandates citizens may be provided licenses to carry only in "exceptional circumstance" or "where a need or urgency has been sufficiently indicated," at the discretion of the county's chief of police.

The complaint asserts that this language violates the Second Amendment, which secures the right of all responsible, law-abiding citizens to bear arms for the purpose of self-defense.

"We have the ability to defend ourselves. And we have the ability to use arms to do that, specifically firearms. So the question is, why do we have that ability? It was decided a long time ago that everyone, every person has that ability. So it isn't really up for discussion any more than any of the other amendments are," said Attorney Kevin O'Grady.

Attorney Richard Holcomb said the suit was filed now because recent U.S. Supreme Court rulings have upheld citizens' rights to carry guns in public.

The so-called "War on Drugs" has been used as a cover for government crimes:

1) violating Constitution rights, 2) raising money for illegal wars and other criminal activity, 3) rewarding cooperative gangsters, 4) militarizing the police.


The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

Maui Charter ?

The Maui County Charter Commission will start the process of deliberating on the many proposed charter amendments it has received at its next meeting, Monday, Sept. 12.

The commission has received in excess of 70 charter amendment proposals from the public, as well from County Council Members, the Mayor and various County Departments. The commission held countywide series of public hearings in its process to encourage input from the Maui County public.

"The commission has been primarily in listening mode for the last four months. Now it's time for the rubber to start hitting the road as the commission starts the process of deliberating and sifting through all of these great ideas the public has offered to us. We will continue to accept proposals or refinements on proposals as we work through the list of proposals we have," said Commission Chair Josh Stone.

"Because we only have about a year to work through this process, it is critical that we begin to analyze and prioritize," Stone said.

The Charter Commission is an 11-member board appointed by the Mayor and approved by the Maui County Council to conduct a review of the County Charter. The charter is the equivalent to the County's constitution, the blueprint that sets the structure of county government. The Commission may make recommendations to amend the charter to the voters in the next election.

The commission will also take testimony from the public on any subject related to the County Charter.

The Sept. 12 meeting will be held from noon to 4 p.m. at the Planning Commission Conference Room in the county complex on High Street in Wailuku. 


Priority will be given to applicants with completed application forms and required certified documents. Applications without these documents cannot be processed, and no I.D. card issued.


Mayor Arakawa Meets Molokai 9-22
