Who Owns Molokai's Water?

Open Letter Complaint Filed by Jill Laffin with State of Hawaii Water Commission, DLNR Laura Thielen, Maui Land Trust, and Forestry Division For the Water From Mountain to Ocean

Aloha. For the past 18 months I have had the honor and privilege to live on east Molokai. During this time I have been curious why certain streams don't flow, even after a heavy rain. Having lived on west Maui for many years I am no stranger to rivers that don't flow and why.

Some say let sleeping dogs lay. And still there are those who can't help but open a can of worms. So I took a walk up the dry Kahawaiiki stream bed.

I'd like to apologize in advance to those said to own the land upon which I traveled in order to discover the truth about stream water of Kahawaiiki [a tributary of Waialua] diverted into a private reservoir, reported here with photos.

Regardless of any possible trespass on my part in seeking the truth, the cement structure to which the Kahawaiiki stream bed led me, violates the principles and goals upon which the laws governing water in Hawaii are based.

The 1972 Federal Clean Water Act, and the 1987 Hawaii State Code gives all water the right to flow from origin to ocean. Those owning land, said feet from an instream flow of a river or its watershed have riparian water use rights to that water. No entity, either public, corporate, or especially private, can stop instream flows from those downstream with "riparian water use" rights.

In addition to the cement structure, signed and dated Dunbar Kainalu 95, the diversion sandbags and fresh green waste that was used to dam the water flow over to the West side of Puniu'ohua Nui Gulch, is apparently evidence that it is stolen water that fills the private reservoir below.

Apparently a permit application for a dam or complete diversion, has never been filed for Kahawaiiki Stream, Kainalu Stream, Puniu'ohua Nui Gulch, or Waialua River. A partial diversion for livestock" was "registered" with the

State in 1989 for Kahawaiiki stream by said owner of (Tax Key Map 25007003062. No water diversion permits have ever been issued to TMK 257003062 or the several TMKs controlled by the same owner.

After speaking to residents down stream who remember the water flowing, I decided to file a complaint/dispute resolution form with the State of Hawaii Water Commission. Unfortunately, the updated maps in Honolulu don't match the stream flow reality of the stream beds before years of illegal diversion that their maps now say Kahawaiiki is just a dry river bed.

Did the water in Kahawaiiki Stream and Kainalu Stream flow to the ocean before the Dunbar 1995 cement diversion structure and pipelines? It appears the lawful riparian water use rights of the landowners downstream from this structure are being profoundly violated. Where has all this water gone? How has the health of the reef and its life force been affected?

While waiting for an investigation by the short staffed Water Commission, the Party said to own the land containing the cement structure is about to receive a substantial amount of Grant money for conservation easement.

How many similar structures are diverting water on the many TMK controlled by the said owner? After years of exhausting fights with corporations for water rights on west Maui, I am shocked and disappointed to learn this east Molokai Kahawaiiki stream diversion travesty is by a single Private Party.

It is a criminal act to steal water. A federal, state, and county investigation should be implemented immediately. Grant money of any kind should not be issued for any reason to the criminal Party responsible for stealing water from the land, the People, and the ocean.

The truth is the truth! All water has the right to flow to the ocean.

Obama's Harry Reid Adds Immigration Amnesty DREAM Act to the National Defense Bill

Washington (CNN) - Senate Majority Leader Harry Reid said Tuesday he will add the DREAM Act, a controversial immigration measure, to a defense policy bill the Senate will take up next week.

The decision means the defense bill, which often passes with bipartisan support, will be home to two major, thorny political issues - the other being the repeal of the military's "don't ask, don't tell" policy.

Reid called the DREAM Act "really important" and said it should be passed because it provides a path to citizenship for young illegal immigrants who go to college or serve in the military. DREAM is an acronym for Development, Relief and Education of Alien Minors Act.

Many Hispanic voters are angry with Democratic leaders for not doing more to pass an immigration overhaul. The decision by Reid to add the DREAM Act now could help soothe that anger and keep Voters in Democratic Party camp.

Every pro-amnesty religious group, pro-amnesty leftist group and pro-amnesty conservative group in the country has mobilized their memberships today and through the week in a last-ditch effort at some kind of amnesty.

The open-borders organizations and leaders in Congress are in a panic that if they don't pass some kind of amnesty during the next month they may not have another opportunity for several years. Desperate politicians are always a threat to the citizenry.

War Crimes: 12 U.S. soldiers killed Afghans, mutilated corpses

WASHINGTON - Twelve U.S. soldiers face a variety of charges in what military authorities believe was a conspiracy to murder Afghan civilians and cover it up, along with charges they used hashish, mutilated corpses and kept grisly souvenirs.

Five soldiers face murder charges, while seven others are charged with participating in a coverup. All of the men were members of a 2nd Infantry Division brigade operating near Kandahar in southern Afghanistan in 2009 and 2010.

According to the military documents, Staff Sgt. Calvin Gibbs and four other soldiers were involved in throwing grenades at civilians and then shooting them in separate incidents. Three Afghan men died.

Authorities allege Gibbs kept finger bones, leg bones and a tooth from Afghan corpses. Another soldier, Spc. Michael Gagnon II, allegedly kept a skull from a corpse, according to charging documents. Several soldiers are charged with taking pictures of the corpses, and Spc. Corey Moore stabbing a corpse.

Staff Sgt. Robert Stevens is charged with lying to investigators about the deaths, saying the civilians posed a threat.

Other soldiers are charged with assaulting Afghan civilians by shooting at them, and several soldiers face charges of failing to properly account for and dispose of weapons.

Eight of the soldiers also are charged with using hashish and beating a junior soldier in an attempt to stop him from reporting them for misconduct, including hashish use.


