

Economy: yesterday, today, ? This is about Molokai, too!

This is why prices exploded higher in the last 40 years. Most commentators claim it was inflation. That's a crock. Yes, the dollar has lost 80% of its value.

Put another way, the cost of "things" has soared exponentially higher than the dollar has fallen. This is due to excessive credit. When everyone is buying things they can't really afford, demand soars, which pushes prices higher. Indeed, one could easily argue that the period 1971-2007 was the largest period of inflation in history (remember inflation is CREDIT and MONEY growth, not merely currency devaluation).

This process of issuing more debt (credit) to achieve growth came to a screeching halt in the late '90s/ early '00s when the Tech Crash occurred (it was largely fueled by easy money courtesy of Alan Greenspan). However, old habits die-hard and the Feds went all out trying to get the US debt machine back on track. Greenspan cut interest rates effectively to 0% and we had a "jobless recovery" fueled largely by the one of the largest speculative frenzies in history: investors were speculating on HOUSING, and on Molokai you now see the results.

Buying and selling stocks does not require a lot of money. Buying and selling houses DOES. The period of 2000-2007 represented the pinnacle in the government's funny money policies: people were able to buy the largest single asset available to man (a home) for \$0 money down. How you figga?

This all came to a screeching halt in 2007 when we hit a point of debt saturation: meaning that the level of debt creation was now unsustainable because most money was already going towards debt repayments. By that point it took \$5 of new debt to create \$1 of new GDP growth. The US private sector was more in debt than at any other point in history (\$52 trillion). Consumer debt was \$2.5+ trillion: an amount equal to 20% of GDP at the time.

This is why pumping the system with more debt WILL NOT work. Even a 10 year old used to know that you cannot solve a debt problem by issuing more debt. However, because our government and the Fed are dominated by academics who have never run a real business and so have no clue about actual real world economics; have never dealt with real confrontations other than cowardly students who need to get a good grade and so cannot actually call "BS"; and DID NOT see the crisis coming !!!, we have the problems we have today.

The government is, essentially, prescribing the same medicine that got our economy sick in the first place. And it will not work. Review the last few pages of this issue and ask yourself "why, if they're spending trillions, have things not improved for housing, jobs, etc?" You know now the answer. Things CANNOT improve via the issuing of more debt.

I don't why the following is so difficult for the powers that be to understand: Mass unemployment + increased savings/ credit contraction = **NO recovery**

Consumers are doing the only sensible thing (paying off debt) while OBAMA continues to spend like a drunken sailor propping up businesses that should have failed (banks and autos and stocks). This will end very, VERY badly. And Americans will be paying for it for generations into the future.

War on Kids Video Documentary

In 99 minutes, THE WAR ON KIDS exposes the many ways the public school system has failed children and our future by robbing students of all freedoms due largely to irrational fears. This film includes disturbing police footage is shown from a 2003 SWAT team raid on Stratford High School students in Goose Creek, SC when the principal suspected illegal drug activity. In spite of the aggressive search involving guns and dogs, no drugs were found. The raid highlights the persistent scrutiny that students are under and the complete lack of boundaries that exist when children are involved.

THE WAR ON KIDS begins with the history of Zero Tolerance policy. Children are subjected to prison-like security, arbitrary punishments, and pharmacological abuse through the forced prescription of dangerous drugs. Even with these measures, schools not only fail to educate students, but the drive to teach has become secondary to the need to control children. School children are interviewed for this film as are high school teachers and administrators, and prison security guards, plus renowned educators and authors.

Schools have become obsessed with security and THE WAR ON KIDS shows how none of the profoundly invasive measures are effective. Security cameras were present at Columbine High School, for example, and did nothing to mitigate the massacre. From the students interviewed in the film, it is clear that cameras are unwelcome and breed paranoia and fear and may actually contribute to creating a hostile environment. Locker searches and metal detectors have been shown to be ineffective and contribute to creating an oppressive environment.

THE WAR ON KIDS is directed by Cevin Soling who won the NYIIFVF award for best experimental feature film, THE WAR ON THE WAR ON DRUGS, in 2005. The Music in the film is performed by The Chumps, Tommy Gardner, John S. Hall, and Laura Mayer with Scott Grinthal.



Techniques for Shooting Accuracy

Proper stance, grip, trigger finger placement, trigger reset, focus, follow-through, etc. are all important to shooting accuracy. But the target shows the results and is evidence of corrections that needed to be addressed by the shooter.

After the shooting is done, go to the target to "read" the target as it will further diagnose any flaws in the student's shooting technique. Look for where the student's shots are "grouping."

A "group" is 3-5 shots that are grouped together in an area of the target. If you line up the front and rear sights with the same point on the target for each shot, and then bring your focus back to the front sight as you press the trigger until a surprise trigger break is achieved, you should have a nice "group" of shots. We can then further diagnose and fine tune your shooting technique.

If you don't have a group and your rounds are all over the target, then you are usually doing one of three things wrong:

You are either not keeping the same aiming point on the target; or you are not consistently lining up the front and rear sights with the same aiming point on the target while focusing on the front sight as you press the trigger until a surprise trigger break is achieved; or you are shooting way too fast for your skill level.

What we like to see is a hand-span group in the center of mass. This shows you have the correct balance between speed and accuracy. You should only shoot as fast as you can deliver a hand-span group at the distance you are shooting.

If your group is very small, you should speed up. If your group is too large, you need to slow down and work on perfecting your presentation from the holster, sight alignment, sight picture and trigger control. As you become smoother, your speed will naturally increase.

If your group is low, you generally have a trigger control problem in that you are "making" the gun fire when you think everything is lined up instead of "letting" the gun fire as you press the trigger.

If your group is high you may lack follow-through, meaning you are looking up to see where your hit is instead of remaining focused on the front sight until the shot is completed. Or, you may also be allowing the front sight of the gun to align slightly above the rear sight. This is common with dots on your front sight. Your eye focuses on the dot, but the top edge of the front sight is actually slightly above the rear sight. Make sure you are focusing on the top edge of the front sight and not the dot. Or you may be pushing forward with the heel of the hand (known as "heeling") in anticipation of the recoil.

Barring an improper grip, if your group is left or right of center, this normally indicates improper trigger finger placement on the trigger. Make sure the pad of your trigger finger is squarely on the trigger and you are not pushing or dragging the trigger in either direction with the rest of the trigger finger.

It is noted that shots grouping in high or low, left or right patterns can also be the sights needing adjustment, but trust me on this one: 99.9% of the guns don't need a sight adjustment. The shooter needs a technique adjustment.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!







Obama's War on Medical MJ Broken Promise, Violate Rights

Earlier this year, Obama's Attorney General Eric Holder announced that the federal government would no longer prosecute marijuana offenses that are legal under state medical marijuana laws. Since then, the DEA has raided three dispensaries in San Francisco and L.A., but without making any arrests.

In other states, over 100 medical marijuana defendants have been charged under federal law. "California already has enough federal marijuana criminals," says Cal NORML coordinator Dale Gieringer, "It's time for concrete changes in federal law." So far, the Obama administration has announced no changes in federal laws or regulations, and marijuana-hostile Bush appointees continue to serve at the DEA and the U.S. Attorney's Office in Northern California.

But one judge speaks of the greater HARM OF PROHIBITION of marijuana: James P. Gray is a retired judge of the Orange County Superior Court, the author of Wearing the Robe - the Art and Responsibilities of Judging in Today's Courts, and he can be contacted ... via his website at www.judgejimgray.com

Judge Gray wrote that for the past 17 years, I have, as a sitting judge, been trying to call everyone's attention to the failures of our nation's policy of drug prohibition. In fact, the truth is that we are "taking it on the chin" in every way imaginable, such that we literally couldn't pursue a worse policy if we tried. With prohibition of a substance, we give up all of our ability to regulate or control it. That means that we concede all of the controls about quality, age restrictions, places of sale, price and everything else to the illegal dealers. And they are the ones who want to glamorize the use of all of these drugs and get our children hooked -- so they can make more money off them. That is the greater harm of prohibition. Prohibition has caused marijuana growers to be forced out into remote areas, and usually onto public lands, because if their operations are discovered, the land can't be forfeited. Ending drug prohibition as Mexico just did, will reduce the gross revenues of Mexican drug cartels by taking away their U.S. market. And it will also reduce violence and corruption in this country, and, most importantly, make marijuana less attractive for children than it is today.

Protests across the Nation against Obama's socialist health care program and his continuation of the Bush-era DEA anti-medical marijuana policies increase.
