Swimmer Drowns at Waialua Keiki Surfing Beach 8/30



A male swimmer about 40 years old was found unconscious near shore at Waialua Beach on the afternoon of August 30. A 10yr old boy reportedly found the apparently drowned man in the calm shallow water near the river mouth. He alerted friends and family of the victim nearby who pulled the body onto the beach and started CPR [photo above]. Neighbors called 911 for Ambulance.

A local paramedic, ambulance personel, and police arrived shortly to assist in reviving the man. Police later called for transportation services to take the body to the morg.

The official cause of death and the victim's identity were not released. He was know to be a Molokai resident.

SAFETY REMINDER:

1. There is NO beach! Safety precautions and vigilance are required to reduce the risks of injuries, rip currents, dirty water infections, and drownings!
2. even at "safe" beaches, always swim/surf with a buddy, or have a responsible person keep watch and ready to assist if someone needs help in the water.
3. even at "safe" beaches, there are water currents that can over come a swimmer, even small waves can obscure a swimmer in trouble, a surfer can be injured in a wipeout or hit by a surfboard, or hit a rock in shallow water, discarded fishing hooks and lines, and broken bottles have caused numerous injuries at Waialua.
4. Keep your beach visit PONO in all ways: aloha aina to keep beach clean; aloha Nature's peace and quiet, its the Hawaiian way to respect other people at the beach promote safety for everyone, for a safe fun time in the sun.

Swine Flu Home Remedy

Dr. Vinay Goyal is a renowned doctor who visited last week to lecture on the topic H1N1 (SWINE FLU), its origin and precautions.

To summarize, Dr. Goyal reported that virus H1N1, like other Influenza A viruses, only infects the upper respiratory tract and proliferates only there. The only portals of entry are the nostrils and mouth/ throat. In a global epidemic of this nature, it's almost impossible not coming into contact with H1N1 in spite of all precautions. Contact with H1N1 is not so much of a problem as proliferation is.

Will a face mask protect? What most N95 respirators are designed to filter is about 95% particulates of 0.3, while the size of H1N1 virus is about 0.1. Hence, dependence on N95 to protect against H1N1 is like protecting against rain with an umbrella made of mosquito net.

Tamiflu drug does not kill the virus, but it prevents H1N1 from further proliferation till the virus limits itself in about 1-2 weeks during the virus' natural cycle.

While you are still healthy and not showing any symptoms of H1N1 infection, in order to prevent proliferation, aggravation of symptoms and development of secondary infections, some very simple steps not fully highlighted in most official communications - can be practiced:

1. Frequent hand-washing.
2. "Hands-off-the-face" approach except to eat, bathe, etc.
3. Gargle twice a day with warm salt water (use Listerine if you don't trust salt). H1N1 takes 2-3 days after initial infection in the throat/ nasal cavity to proliferate and show characteristic symptoms. Simple gargling prevents proliferation. In a way, gargling with salt water has the same effect on a healthy individual that Tamiflu has on an infected person. Don't underestimate this simple, inexpensive and powerful preventative method.
4. Clean your nostrils at least once every day with warm salt water, swabbing both nostrils with cotton buds dipped in warm salt water is very effective in bringing down viral population.
5. Boost your natural immunity with foods that are rich in Vitamin C, or Vitamin C tablets that contain Zinc to boost absorption.
6. Drink as much of warm liquids as you can. Drinking warm liquids has the same effect as gargling, but in the reverse direction. They wash off proliferating viruses from the throat into the stomach where they cannot survive.

Buy the poppies USA, and save American lives. Bring the troops home alive!





The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!


