Taro Field Workshop Brings Farms to homes

Open fields UH workshop gave locals a chance to take samples of taro varieties to home gardens



Three generations of the Kapuni Ohana were among the over one hundred who heard from kalo experts. The “shaka sign” they give is also a measure, “tip to tip,” for depth of planting huli, according to Uncle Jerry Konanui.

Molokai Taro Variety Field Day

Buckets, tools, marking pens and labels in hand, more than 100 Molokai residents were at the MCC Farm early on Saturday, September 18th.

Featured speaker Big Island taro farmer, Mr. Jerry Konanui, inspired the audience with descriptions of varieties of taro and their significance to the Hawaiian culture. Uncle Jerry's story and sample of a bicolor Lililihimolina, once thought lost, inspired some to seek it out for home planting. Konanui's stories and experience learned from kupuna were rich. He said the book is a guide, getting out and “talking with the kalo”, observing and knowing the varieties and your environment are key to successful crops.

Cooperative Extension Agent, Alton Arakaki explained, “Planting these native Hawaiian varieties will help preserve and perpetuate these rare culturally significant plants, and help clean and prepare the field for the next project.” Before inviting participants into the field, Arakaki demonstrated the preparation of huli for avoiding surface soil pathogens (nematodes).

Delicious table taro samples prepared by CES staff and kulolo prepared by Castle Adolpho were evaluated and enjoyed. Among the CES and CTAHR staff attending and offering information were Glenn Teves, James Boswell, Faith Tuipulotu, Kelsey Davis and Koddie Purdy-Kaai. Participants from Na Pua Noeau began the morning festival. They are available at the CES-Applied Research and Demonstration Farm at MCC Farm in Hoolehua.

A book, *Taro Mauka to Makai, A Taro Production and Business Guide for Hawai'i Growers*, is available from the University of Hawai'i and is a guide with photos, charts and recipes. At the end of the day, the field was almost ready for the next project. People went home to cook and plant some taro -- for the future.

Company Offers Free Solar

A mainland company is offering an option to local homeowners who want to generate their own electricity with rooftop solar panels but can't afford the upfront costs.

San Francisco-based <http://www.sunrunhome.com/> SunRun Inc. is expanding to Hawaii with a business model in which it installs photovoltaic systems at no cost and sells the electricity back to the homeowner at a fixed rate over 20 years.

Until now, so-called purchase power agreements like SunRun's have been available in Hawaii only on a commercial scale. SunRun will partner with local PV installers Sunetric and RevoluSun in the venture.

SunRun said the rate it charges for the electricity varies depending on the market, but "is generally lower than what you're paying your utility today."

In its marketing materials SunRun also notes that by locking in at current rates customers are protecting themselves from future utility rate increases.

After 20 years, SunRun customers would have the option of buying the system from the company or renegotiating their fixed rate.

SunRun's entry to the Hawaii market follows a failed attempt by the Legislature this year to authorize a similar, government-sponsored program.

Upfront costs can be a barrier for many homeowners interested in solar, despite federal and state tax incentives. Prices for PV systems vary depending on size, but one large enough to power a typical Hawaii home using 600 kilowatt hours per month of electricity could cost \$15,000 or more after state and federal tax credits.

In addition to Hawaii, SunRun operates in Arizona, California, Colorado, Massachusetts, New Jersey and Pennsylvania.

Mark Duda, founder of RevoluSun and president of the Hawaii Solar Energy Association, welcomed SunRun's entry into the local market.

"Our partnership with SunRun is a major shift in the market that will make solar affordable to as many Hawaii homeowners as possible," he said.

Alex Tiller, chief executive officer of Sunetric, said the structure of the SunRun program eliminates the financing issue that had been preventing many homeowners from installing PV systems.

Sandwich Isles Communications poised to go into bankruptcy

The Federal Communications Commission is set to rule any day on the future of Sandwich Isles Communications, a politically connected company that built its entire business around receiving taxpayer funds to install internet and phone infrastructure on Hawaiian Homelands.


Top of the headlines on yesterday's Democracy Now shows that US combat troops are still active in Iraq: **7 Civilians Killed in US-Iraqi Raid**

Anti-gun rights Statue Knotted Gun Display planned for U.H.

A plan is afoot to unveil a bronze replica of the "knotted gun" statue as a symbol of peace and nonviolence at U.H. Community College, and symbol of the United Nations/Clinton/Obama anti-gun rights policy against the 2nd Amendment is raising questions of the role of provocative art on public campus.

Reuterswaerd created the "knotted gun" in 1980. Copies of the cocked, .45-caliber revolver -- with a twisted barrel rendering it useless for self defense against criminals and Tyrants in government offices -- have been installed around the world, including at the United Nations Plaza.

So a grassy patch of HCC that has come to be known as a quiet place for reflection seemed like the perfect spot to some anti-self defence faculty members for an Oct. 3 groundbreaking and a Dec. 8 dedication of the "knotted gun" which is a 40-inch-wide, 27-inch-tall version of the original.

But the grassy area at HCC also is adjacent to the college's Keiki Hauoli Children's Center and its outdoor playground, and student Body President Howard Kam III this week said, "Children will look at a giant gun without knowing the symbolism of a twisted barrel," and he could have added that such a damaged handgun created by anti guns for self defence laws would blowup upon firing and injure the person trying to defend himself or family from criminals.

Public art, especially on a college campus, should encourage discussion and debate, said HCC art history professor Marcia Roberts-Deutsch, who sits on a committee considering the location of the "knotted gun."

But even Roberts-Deutsch questions whether the "knotted gun" should be installed anywhere on campus, partly because she teaches women's studies courses that include students who have been victims of violence.

"I'm definitely a proponent of free speech and of provocative art, even art that can be troubling," Roberts-Deutsch said. "But this has the potential to cause discomfort on campus." How about a free killing field because everyone on campus is prohibited from being armed for self defense !??

The copy of the "knotted gun" intended as a donation to HCC has been taking up valuable space for the last two years in the Capitol offices of state Rep. John Mizuno (D, Kamehameha Heights-Kalihi Valley-Fort Shafter).

Miscommunication between Mizuno's staff and the peace group Soka Gakkai International resulted in Soka Gakkai delivering the 350-pound "knotted gun" to Mizuno's office two years ago, with no ultimate destination, Mizuno said.

He looked for a new home for the "knotted gun" at the state Capitol, the University of Hawaii at Manoa and the East-West Center and was turned away by "too much red tape," Mizuno said.

Another idea to install the "knotted gun" on city property at a busy intersection of Bishop Street was voted down by the Neighborhood Board, Mizuno said.

Voters Too Gullible

Believing whatever the President or other politicians tell us, especially when they want our vote, isn't terribly different from believing those ads in the newspaper which want to buy your gold, or cure you with crystals or magnets. Fly Molokai \$39 Free Baggage on Pacific Wings

Airlines are slashing fares to the Friendly Isle following the latest round of price reductions by Maui-based Pacific Wings.

Fares dipped as low as \$49 last week, and Pacific Wings announced today it is selling all seats on Hoolehua flights for just \$39 through the airline's web site at <http://pacificwings.com/>.

"People want true low fares," said Pacific Wings President Gabriel Kimbrell. "It's disappointing when you want to buy a ticket and only a few seats are available at the discounted price, or the discount fare is not available at all."

Kimbrell says Pacific Wings' everyday low \$39 fare is "less hassle" for travelers than restrictions, blackout dates and deadlines associated with promotional fares offered by other airlines. "If we have a seat available, it's yours for \$39." He said.

Pacific Wings has also eliminated baggage fees on Hoolehua flights, while other airlines charge \$10 or more for checked bags. "It's just another way to simplify things," says Kimbrell. "Easy, inexpensive flights, that's the whole idea."

Kimbrell described Pacific Wings' new low fares and free baggage policies as a way to "re-position" his brand in Hawaii. "There have been a lot of promising developments recently, and I felt it was time to try something different." He said. If the new pricing strategy is successful, Kimbrell says he will "definitely" consider expanding discount fares to more of Pacific Wings' Hawaii destinations.




