“Auntie Oming” Garces Passes On

SALOME C. “OMING” GARCES passed peacefully in the presence of her children, grandchildren and immediate family members on Oahu on September 4, 2011. She now joins her beloved husband, Mariano F. Garces who passed away in 1991.

She was born in Narvacan, Ilocos Sur in the Philippines in 1936. She resided in Maunaloa town (from '68) and in Kaunakakai (from '79 to current). She is survived by her sons Marlon (Elizabeth), Mario and Marino (Bernette) and grandchildren, Celina, Joshua, Marlyssa, Jaylyn, Michael and Marcus. She is also survived by her brother Gerardo (Emma) Dela Cuadra, sisters Iniana Cabanting, Guadalupe Javier, Bibiana Taasan, Dionisia Dela Cuadra and numerous nieces and nephews. She was affectionately known as “Auntie Oming” to students who learned Filipino folk dances from her and to friends who were involved with various community events and family celebrations.

She was an active member of the Kaunakakai Filipino Association and the Blessed Damien Catholic Parish. She is a retired housekeeper and seamstress from the former Sheraton Hotel at Kaluakoi. Also, she worked as a laborer for the Dole Pineapple Company in Maunaloa town before working for the Sheraton Hotel at Kaluakoi.

As one of her last wishes, she sends her love and Mabuhay to all her friends and family on Molokai including former residents from the Maunaloa community and she thanks to all of them for their love and support throughout her living years.

Her services will be held at the Mililani Memorial Mortuary Mauka chapel at 5:30 p.m. on Thursday (10/6/11) and her funeral services will be held at 9:00 a.m. on Friday (10/7/11) at the St. Joseph Catholic Church in Waipahu and her burial will follow at the Mililani Memorial Cemetary.



Keeping Kalaupapa's History & Respect, AND the Post Office? Next Meeting October 18-20 in Honolulu

Kalaupapa established in 1860's by King Kamehameha V, which is now also the site of a 10,700-acre national park.

The Hansen's disease patients remain eligible for lifetime food, housing and medical care after they were exiled to Kalaupapa. Fourteen of them still live in the 1,200-acre settlement, where the youngest patient is 70.

After its founding, the colony became home to more than 8,000 exiled patients.

A three-day private meeting of patients and state and federal officials in Honolulu Oct. 18-20 will consider all of the public input so far to help shape a draft plan that likely will be unveiled later next year, said Stephen Prokop, the park service's superintendent for Kalaupapa National Historical Park.

But after 40 community meetings across the state and thousands of comments regarding the future, the consensus has been clear, Prokop said: "Keep Kalaupapa Kalaupapa."

"That means no new development, no dramatic increase in visitors," he said.

The park service is responsible for managing the buildings, marine life and historic nature of the settlement, and also has law enforcement and firefighting responsibilities for the entire peninsula, which is visited by as many as 10,000 tourists a year.

Prokop and others believe the settlement needs

to be preserved after the last of the patients dies as a reminder of the deeds of the past.

"People are still ignorant," Marks said. "We need to educate the public."

The unforgiving place continues to face modern-day problems because of its isolation.

Kalaupapa remains accessible only by boat, plane or mule, or by foot for those who can hike the spectacular, 1,600-foot cliffs that cut off Kalaupapa from the rest of the world. Cell phone service is non-existent and Internet connections are unreliable.

Dozens of axis deer continue to run wild throughout the settlement despite the installation of fences, which bother some residents who were once restricted from their own families by barricades out of fear of spreading the once-dreaded disease.

Many of the patients grew old together, married and divorced one another and buried their dead together.

The patient population had been in steady decline after state health officials lifted a quarantine on Kalaupapa in 1969 and patients were allowed to leave.

At a meeting last week, Mark Miller, the settlement's administrator, read from a letter from the U.S. Postal Service, which is considering shuttering Kalaupapa's post office, which receives its mail by plane.

The U.S. Postal Service invited everyone who relies on the service to instead acquire post offices boxes "topside" on Molokai in Kaunakaki.

As the postal service considers its own future, two of its officials from Honolulu will fly to Kalaupapa on Tuesday to get an earful from patients who rely on their few links to the outside world.

The letter Miller read also invited Kalaupapa residents to find other retail services by visiting www.usps.com, which generated even more head-shaking and laughter from the crowd.

"Anybody that's tried to use a computer here knows it's on a cable modem system and it usually gets bogged down," Miller said. "If I were you and I ever wanted to do mail again, I would go to that meeting."

Honolulu postal service spokesman Duke Gonzales told the Star-Advertiser that the letter was essentially a computer-generated form letter from the mainland based on the service's intention to consider closing 3,653 post offices across the country.

"Everything in the letter is taken from a huge database of information that relates to each office," said Gonzales, who will make his first visit to Kalaupapa on Tuesday. "We're going to be there to listen to the residents of the community. We understand the unique nature of their needs."

CCP is gun registration scam

Some well-meaning, but in my opinion very misguided pro-gunners are working to pass a bill that could turn into a Trojan Horse for more gun control.

Of course, I'm talking about H.R. 822, the so-called "National Reciprocity Act," which could open the flood gates of gun control.

I'm calling it the National CCW Registration Act.

While the idea that all states should recognize a concealed weapons permit is sound public policy, the use of the anti-gun federal bureaucracy to implement it is very dangerous as well as foolish and anti-Constitutional.

Once the Federal Government is in the business of setting the standards for concealed carry permits, it's only a matter of time before they start using that power to restrict our rights.

Once this bill starts moving, anyone can amend the bill with anything ... and no legislation can bind a future Congress in any way. And that doesn't count what Obamacrats in the Department of Justice might dream up as the "regulations" to carry out the legislative "intent."

I believe I should be able to carry concealed -- without a permit -- in all 50 states. That's what "bear arms" means. Believe me, that's a long-term policy goal for the National Association for Gun Rights.

H.R. 822, the National CCW Registration Act, will become nothing more than a Trojan Horse for even more federal gun control.

But the devil is truly in the details... and the details are where H.R. 822 gets sticky. This bill isn't just about the right to carry for self defense -- it's a battle over the role of government and the ability to restrict our Second Amendment rights. Once gun owners let the Obamacrats start mandating whether states recognize permit reciprocity, they will want to mandate what it takes to get and keep those permits: More onerous standards to acquire a permit, like New York's permit system so biased that only FBI agents can qualify; Higher fees; More training requirements; A demonstration of "Need" for a permit; More frequent renewal periods; Federally-mandated waiting periods; A national database of all permit holders, accessible by Attorney General Eric Holder; An extensive, federally-created list of Criminal Safezones, where only criminals will carry and where law-abiding gun owners are vulnerable; The list of potential problems is endless!

This legislation would also shred the Constitutional Carry provisions that are on the books in Arizona, Alaska, Vermont and Wyoming.

It doesn't stop with just concealed carry. They'll co-opt the bill to expand the national Brady Registration Check system to block military veterans with PTSD or individuals with misdemeanor convictions from even OWNING firearms -- much less use them for self defense.

Many statists in Washington will co-opt H.R. 822 as part of their grab for more federal power for them and less individual liberty for gun owners.

Even now, the statists in Congress are trying to adopt a National ID card, complete with biometric data that they've forced the states to conform to their mandated drivers license "standards."

The National Association for Gun Rights has been part of a group of liberty-minded organizations that have passed state legislation forbidding cooperation with the federal National ID. Don't let CC become a government issued privy.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!



Maui county Wants to Dredge Lahaina Harbor shoal created by recent Tsunami

LAHAINA, Hawaii (AP) - Lawmakers and Maui business officials voiced their concerns about Lahaina Harbor in a meeting with state land managers over the weekend, saying the working harbor needs to be dredged to make it safe for vessels navigating Maui waters.

Democratic West Maui Rep. Angus McKelvey says since the March 11 tsunami created a sandbar there, the harbor channel is only 7 feet deep in some places.

The harbor is used by ferries that run between Lahaina, Molokai and Lanai, as well as fishing charter and dinner cruise boats.

A manager for the Lahaina Cruise Co. told state Department of Land and Natural Resources officials the sandbar was dangerous for navigation at a listening session Saturday on Maui.

McKelvey is seeking funds to dredge the working harbor.



Obama's Night Raids in Afghanistan provoke backlash; Reflecting on 9/11 and before.

The number of night raids on civilian homes by international forces in Afghanistan has increased substantially, according to a study. The Open Society Foundation found that the five-fold increase in raids had caused a storm of protest.

The biggest grievance of the Afghan government against US military forces is the civilian casualties they cause. The foreign US Coalition military forces say the raids are a valuable weapon against the insurgents.

Despite the political pressure from Kabul, the number of people questioned in their homes in night raids has risen rapidly in the last two years, up five-fold between 2009 and 10 and increasing still further this year.

Nigt raids actually 'Creates violence'

Researc assessed that in recent months there may have been 40 raids a night happening across Afghanistan. They quote one Afghan as saying: "Americans claim to be against terrorists, but what they do is terrorism, creates violence."

The raids are justified by international forces as a valuable tool in their fight against the Afghan insurgency, in gathering intelligence and arresting suspects.

But public recognition of these improvements has been overshadowed by mounting anger over the higher number of raids.

The report says that the increase in raids has provoked anger and is marring Afghan relations and complicating long-term strategic discussions.



Jews Run USA !!??!!

Americans may believe that US policies are designed to address American needs, America's new Ambassador to Israel explains that this is far from the case.

In a recent speech before the Jewish People Policy Institute (JPPI), Ambassador Daniel Shapiro clarified what drives US policies:

"The test of every policy the Administration develops in the Middle East is whether it is consistent with the goal of ensuring Israel's future as a secure, Jewish, democratic state. That is a commitment that runs as a common thread through our entire government."

Shapiro went on to say: "This test explains our extraordinary security cooperation, our stand against the delegitimization of Israel, our efforts on Iran, our response to the Arab Spring, and our efforts on Israeli-Palestinian peace."

It also explains a factor in the downward slide in American prosperity and our negative standing in the world, because the US is funding Israel and its weapons industry. "Israel will receive over \$3 billion in U.S. funding for training and equipment in the coming fiscal year. This assistance allows Israel to purchase the sophisticated defense equipment it needs to protect itself, by itself, including the world's most advanced fighter aircraft, the F-35 Joint Strike Fighter. Our assistance has also helped boost Israel's domestic defense industry."

On top of this, Shapiro pointed out, "Congress, at the request of President Obama, provided \$205 million to accelerate production and deployment of the Iron Dome short-range missile system, a project to which I devoted particular attention during my tenure at the White House."

Shapiro failed to note that this system competes with American defense firms, causing still further job loss for Americans, who have a higher unemployment rate than Israel.

Shapiro said that one of his first visits as Ambassador to Israel was to see an Iron Dome battery deployed near Ashkelon, where he "had very moving visits with the victims of rocket attacks in Ashdod." Palestinian rocket attacks have killed approximately 20 Israelis. There is no report that Shapiro has visited the victims of Israeli shelling attacks on Gaza, where over 1,400 people have been killed.

Opposing international initiatives, undermining US needs

Shapiro continued: "The test of our policy – that it advances Israel's status as a secure, Jewish, democratic state – also explains our commitment to vigorously battle against those who would attempt to isolate or delegitimize Israel in the international community."

As a result, Shapiro said, the US withdrew from the South African conference on racism in Durban and vetoed UN efforts on Israel, which otherwise would have passed. Currently, he said, the administration is "doing everything we can" to oppose the Palestinian bid for UN membership to come later this month. "We are taking our opposition to capitals around the world."

This campaign is reminiscent of previous pro-Israel campaigns, including the original pressure brought by Israeli partisans in 1947 on the UN General Assembly to pass a recommendation to give over half of Palestine to a Jewish state.

It could also be a major blow to the US.

Prince Turki al-Faisal, a member of the Saudi Royal Family who headed up its intelligence service for many years, has just published "Veto a State, Lose an Ally", in which he warns that if the US vetoes Palestinian UN membership, "Saudi Arabia would no longer be able to cooperate with America in the same way it historically has."

He writes that it would "provoke uproar among Muslims worldwide," further undermining American relations with the Muslim world (over 1.2 billion people), "threaten regional stability," and increase "the chances of another war in the region."

In 1973 Saudi Arabia, which has been an extremely important US ally, issued a warning based on a similarly reasonable request (that Israel obey international law – see discussion below). When Henry Kissinger ignored it, the US was thrown into a major recession and thousands of Americans lost their jobs and homes.

Author and international attorney John Whitbeck wrote that "the adverse consequences for the United States of blocking Palestine's membership are dazzlingly obvious. An American veto would constitute a shotgun blast in both of its own feet, further isolating the United States from the rest of mankind and outraging the already agitated and unstable Arab and Muslim worlds (notably including Egypt, Iraq, Afghanistan, Pakistan and Turkey).

Since 120 nations have already recognized Palestine, such a veto would outrage countries all over the globe.

Policies on Iran based on Israeli concerns

Shapiro went on to say:

"The test of our policy – to advance Israel's status as a secure, Jewish democratic state – explains our persistent efforts and the President's determination to prevent Iran from acquiring nuclear weapons.

"Since 2009, the United States has led the world in imposing the toughest sanctions ever against Iran, through U.N. Security Council Resolution 1929, through the Comprehensive Iran Sanctions and Divestment Act, and through additional sanctions imposed by European and other partners beyond those mandated by the U.N. Security Council... We are working to increase pressure on Iran through additional means, and have taken no option off the table.

Twenty years ago similar pressure on Iraq created a humanitarian catastrophe in which, according to the World Health Organization, over 5,000 children under the age of five died each month from "embargo-related causes."

Arab Spring actions predicated on Israeli interests

Shapiro explained that concerns for Israel also drive the Obama's actions about the Arab Spring: "The test of our policy explains President Obama's original outreach to the Muslim world, and his response to the Arab Spring.

"Israel's interests were not served by the deep anger felt toward the United States in many Muslim communities..." declared Obama
